The Summer Camp is an excellent chance to participate in practical and interactive sessions on various topics organized specifically for the participants, as well as to join open lectures from guest speakers which will focus, this year, on “the Legal Leader of Tomorrow” (i.e., the impact of Artificial Intelligence on the Legal Profession, Behavioral Persuasiveness, Data Protection, the changing Sociology of International Law, etc.).
