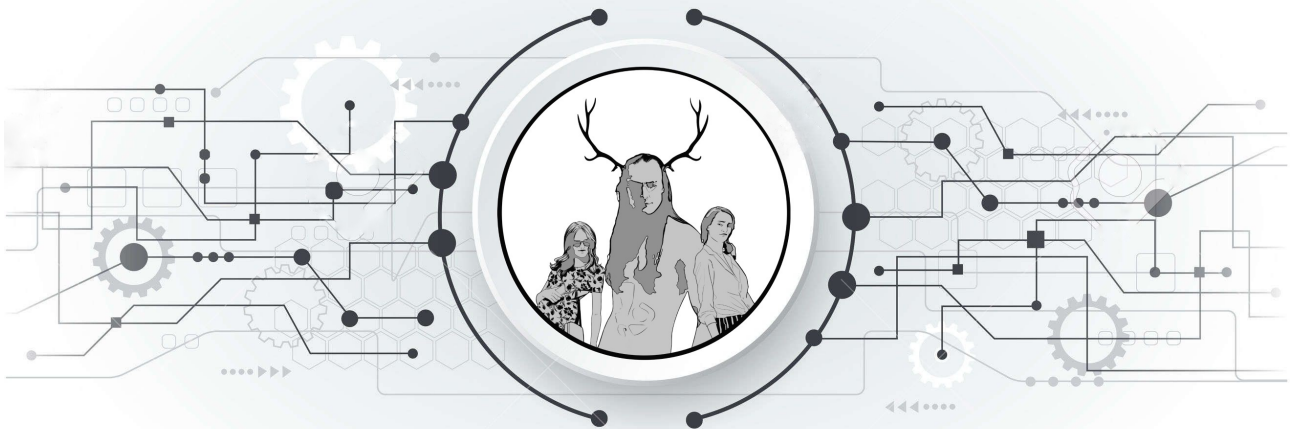

Business Engagement Agreement

2023-06-12

This engagement agreement is between Marquise Museum, a Sweden corporation (Registration No. 620423-4239) ("Advisor"), **Mr.Rons De La Fressange**, an individual citizen and resident of Sweden, who owns all issued and outstanding capital stock/Tokens/NFTs, and **Mr.Fumitoshi Tawara** , an individual citizen of Japan.

Advisor owns 440m-450m fungible ABTx-M2 tokens listed on Waves Exchange, a website available at <https://www.marquisemuseum.com/>, and related NFT assets on Rarible & wishes to complete a Business Sale Transaction (as defined below). Advisor wishes to engage Client on an exclusive basis to assist Client to solicit indications of interest in, analyze, structure, negotiate, and close Business Sale Transactions with Advisor as the prospective counterparty.

The Parties therefore agree as follows:

1 ENGAGEMENT

Client hereby engages Advisor to provide the Services.

2 BUSINESS SALE TRANSACTION

"Business Sale Transaction" means any transaction that any Party undertakes as seller, issuer, or otherwise with a view to directly or indirectly transferring ownership or control over the Assets including all or any portion of the NFTs and Vault tokens to any other person including by means of:

- (a) Any one or more buyers' direct or indirect acquisition of a substantial portion of any Advisor Party's then outstanding voting capital stock/Tokens/NFTs or other equity interests by way of a tender or exchange offer, negotiated purchase, or otherwise.
- (b) Any one or more buyers' direct or indirect acquisition of a substantial portion of any Advisor Party's assets (including any of the NFTs or Vault Tokens) by way of a negotiated purchase.

3 EXCLUSIVITY

Advisor does grant Client by this agreement or otherwise, exclusive and majority rights to the acquisition of 440m-450m Marquise Museum Vault V.2 trading on Waves Exchange plus a newly minted assortment of 23+~30 NFTs published in the near future on Rarible.

4 INDEMNIFICATION

Client will indemnify Adviser with respect to and hold Adviser harmless from and against all liabilities, expenses, damages, amounts paid or payable in settlement, or other losses of any kind (including those arising in connection with third-party claims) Adviser may incur in connection with any matter based upon, resulting from, arising out of, or relating to this Agreement or the transactions it contemplates, including the Services and the Other Services, or any Client Party or any action or omission thereof, except to the extent any such Losses are directly and solely attributable to Adviser's own gross negligence or intentional misconduct.

5 NO THIRD-PARTY BENEFICIARIES

Except as this Agreement otherwise expressly provides, this Agreement is for the sole benefit of the Parties and their respective heirs, administrators, legal representatives, executors, successors, and permitted assigns, and nothing in this Agreement is intended to or will confer upon any other Person any legal or equitable right, benefit, or remedy of any kind.

6 GOVERNING LAW

The laws of the Designated Jurisdiction will exclusively govern the application, construction, validity, interpretation, and enforcement of this Agreement, and all other matters based upon, arising out of, or relating to this Agreement, whether sounding in contract, tort, or statute. The Parties intend that the rights and remedies provided to each of them under this Agreement be fully enforceable for their respective benefit, whether any such right or remedy would be enforceable under the laws, or by the courts, of Sweden.

7 PRICE

\$50 000 initial cash payment and up to \$450 000 in consecutive installments upon Adviser recommendation primarily based on price performance of Waves native token into which majority of funds will be allocated to produce 10% annualized interest intended for exit liquidity after raising the vault market cap from present day \$200 000 to \$30m near term (minimum \$50 000 capital requirement) and \$500m-\$5bn over 24 months (minimum \$200 000 capital requirement).
