Blackjewel has done us miners really terrible with our pay and has shown us there is no hope for us on our payday's to be fixed. We have called every one of them to help us fix our checks where they bounce and they just show no interested or help with it.

We hope you can help us fix this because the company has shown no interest in doing so.




