CORE CHILD PROGRAM - NABLUS CENTER: THE TYO CORE CHILD PROGRAM OFFERS NON-FORMAL EDUCATION ACTIVITIES IN ART, HEALTH, IT, MUSIC, ENGLISH AND SPORT FOR 4-8 YEAR OLD CHILDREN FROM THE MOST DISADVANTAGED AREAS OF NABLUS, WEST BANK (THREE REFUGEE CAMPS, OLD CITY AND KHALLET AL AMOOD). FULL-TIME TYO TEACHERS DEVELOP THE CURRICULA WITH INPUT FROM UNIVERSITY PROFESSORS, AND A CERTIFIED FAMILY THERAPIST. ALL ACTIVITIES ARE DESIGNED TO TEACH CHILDREN SELF-EXPRESSION, PRACTICAL SKILLS, AND COPING STRATEGIES IN A SAFE ENVIRONMENT.
