Personally came [REDACTED] [REDACTED] who on oath says that to the best of his/her personal knowledge and belief, **Jasmine Chartel Camp** did, on **Jun 07, 2020** at approximately **12:45 AM** in **RICHMOND** County, **GEORGIA**, commit the offense of: **CRUELTY TO CHILDREN IN THE FIRST DEGREE - Felony** in violation of **O.C.G.A 16-5-70**, a **Felony** under the laws of the state of **GEORGIA**, in that said accused on the above stated date and time, **did maliciously cause a child under the age of 18, namely: Derrick Camp, he being 12 years old, cruel physical pain. The accused did strike the victim multiple times with a belt on his butt, upper back and inner thighs. The accused also had the victim do military squats while holding a heavy book and do pushups until he was too exhausted to stand up on his own. Following these events, the victim vomited and rattling was heard coming from his chest while he breathed. The victim was taken to Augusta University Medical Center, is in critical condition in the ICU and has been placed on a ventilator. This offense occurred at 610 Forest Ridge Place in Augusta, Richmond County, Georgia. The victim and the accused live at the same residence. The accused is the mother of the accused.**

Personally came [REDACTED] [REDACTED] who on oath says that to the best of his/her personal knowledge and belief, **Jasmine Chartel Camp** did, on **Jun 07, 2020** at approximately **12:45 AM** in RICHMOND County, GEORGIA, commit the offense of: **MURDER WHILE IN COMMISSION OF FELONY - Felony** in violation of O.C.G.A. 16-5-1., a **Felony** under the laws of the state of GEORGIA, in that said accused on the above stated date and time, **while in the commission of a felony, to-wit: Cruelty To Children in the First Degree, in violation of O.C.G.A. 16-5-7(A), did cause the death of another human being, namely: [REDACTED]** The accused struck the victim multiple times with an extension cord all over his body, slammed him into a wall at least twice causing his head to hit a wall, slammed him into a corner of a door frame by his hair, and kicked him in the chest twice. The accused also forced the victim to do military style squats while holding a book and push ups until he collapsed. Said offense occurred at **610 Forest Ridge Place in Augusta, Richmond County, Georgia.** The accused is the mother of the victim.
