# <u>Contribution regulations – as of August</u> 2023

According to § 7 of the statutes, the club charges annual fees and admission fees, graded according to member groups. In addition, fees are charged for the use of the lockers and safe deposit boxes. We charge a deposit fee for the access keys if a key is issued.

The following applies:

#### 1. Contributions

The contributions are collected in the debit procedure at the beginning of each month for the respective month.

#### 2. Definition of member groups

#### a) Full members

All members who have reached the age of 18 and are actively involved in tennis in the club, as long as they do not belong to one of the lower contribution groups. In the case of married couples/registered civil partnerships/cohabitations, one partner is listed in group a).

#### b) Couples

In the case of married couples/registered civil partnerships, cohabiting couples, one partner is listed in a) and one partner in b).

#### c) Students, trainees, pupils aged 18 and over

All members between the ages of 18 and 27 who are in education or vocational training. (Proof of training must be submitted independently each year.)

#### d) Young people up to the age of 18

#### e) Supporting Members

All members who belong to the club and use its facilities and events, but who are not actively involved in the sport of tennis in the club. In accordance with § 5 of the statutes, a change to supporting membership is only possible at the end of a year upon written application. If a supporting member wishes to be reactivated in the course of a year, the fee must be paid as an active member from the month of reactivation.

#### f) Families

Families are married couples/civil partnerships/cohabiting couples with at least one child living together in a community. The child(ren) must not have exceeded the age of 18.

#### g) Honorary members according to §3 of the statutes Honorary members are exempt from dues and other payment obligations.

#### 3. Fee rules for new members

New members do not pay an admission fee at the moment.

#### 4. Contributions

The amount of contributions, usage and admission fees will be determined at the Annual General Meeting. The Annual General Meeting may also decide on a levy and the payment date

#### 5. Payment amounts

Contributions and levies are payable from the date of entry. In the event of termination, the fee must be paid by the end of the notice period.

Collection of such payments take place in December. Dates and registration modalities for work opportunities are announced in due time.

### Appendix to the application for admission

#### Data Protection/Personal Rights

(1) The Siemens Tennis-Klub Blau-Gold 1913 e.V. collects, processes and uses personal data of its members (individual information about personal and factual circumstances) using data processing systems (EDP) to fulfil the purposes and tasks permitted by the association's statutes, for example in the context of the general meeting.

- (2) As a member of the Tennis-Verband Berlin-Brandenburg e.V. (TVBB) and the Landessportbund Berlin e.V. (LSB), the Siemens Ten-nis-Klub Blau-Gold 1913 e.V. is obliged to report certain personal data to them. For example, the name and age of the member, the name of the board members with function, address, telephone numbers, fax numbers, e-mail addresses are transmitted to TVBB and LSB.
- (3) Within the framework of the statutory provisions of the Federal Data Protection Act (in particular §§ 34 and 35 BDSG), each member has the right to information about the data stored about him/her, its recipients and the purpose of storage, as well as to correction, deletion or blocking of his/her data.
