### To Discuss The Authority's Relationship With Charlestown town programs, also want to insure that Charlestown

Several Charlestown residents have expressed concern over the relationship the town has had with the Massachusetts Port Authority. more commonly referred to as Massport.

As one of the six communities impacted by Massport operations, namely from the Mystic Tobin Bridge, Logan International Airport, and the waterfront, residents are wary that Charlestown may not be receiving its 'fair shake' from the Authority

Among the other affected communities are East Boston, Revere, Chelsea, Winthrop, and South Boston. Charlestown residents, while expressing their appreciation to Massport for their financial contributions to various is receiving as many benefits from Massport as the other five communities.

Residents And Massport Officials Meet

On Friday, February 22, 1985. Massport officials, at the invitation of the John F. Kennedy Center Board of Directors, met with a handful of residents as well as Jay Ashe of State Representative Richard Voke's Office and Charlestown resident David Flanagan from Mayor Raymond Flynn's Office, at the Mary Colbert Apartments to discuss the Authority's present relationship with and commitment to Charlestown.

In the past, this relationship has been strained, but it has been the attempt of both the Authority and the Kennedy Center to change that.

Last year, a similiar meeting was held between the Kennedy Center and Massport, at which Massport was asked to support the community in terms of financial aid to programs as well as provide jobs for local residents.

Massport officials. David Davis, the Executive Director, and Patrick Moscaritolo, the Director of Public Affairs,

both stated Charlestown receives more than "it's fair share" from the Authority.

According Moscaritolo, Massport, as a result of last year's discussion, has "delivered a lot of those things' requested of the Authority by Charlestown.

Charlestown resident, Ed Johnson, addressed the issue of summer and permanent jobs for local residents. According to Johnson, Massport's Moran Terminal in Charlestown "could stand a few of our young people for summer jobs.

Moscaritolo told Johnson that the manager at Moran Terminal "has a budget he has to live with" and if the budget can not support the hiring of summer help, individuals could work at another Massport Terminal.

"There is no rule that states, 'If you live in Charlestown, you can only work at Moran," " stated Moscaritolo.

Davis stated in addition to budget restraints, there must also be a job to do. The Director continued to state that Massport would not hire individuals for the sake of providing a job. "I won't have people standing around. I don't want to teach people bad work habits

Mrs. Margie Kent asked if Charlestown youths were receiving as equal a chance for summer employment as the other communities.

According to Davis, Massport provided a total of 110 summer positions this past summer.

"I suppose we (Massport) never can do enough terms of employment)." stated Davis. "Because there are (continued on page 5)



Massport presently has an internship program which runs during the academic school year with 16 positions offered. According to Moscaritolo, a 1983 court desegregation ruling requires that 12 of the positions be allotted to students of either the Umana School or East Boston High School.

Despite this ruling, Charlestown students received six internship positions last year, stated Moscaritolo.

Overall, Moscaritolo stated that Charlestown "did better than anyone in terms of jobs."

Another area of concern discussed at the meeting was the financial contributions made by Massport to the Charlestown community.

No one present denied Massport's generosity to Charlestown, however, concern was expressed as to, once again, how Charlestown compared to the other communities, specially East Boston.

Using the first six months of Massport's 1985 budget for illustration, Moscaritolo reported that the Authority has set a total of \$22,500 aside for

Roughly one third of this figure, or around \$7800 has been slated for Charlestown programs.

Moscaritolo confessed that he, like many others, believed community contributions were divided between jobs and money, however, "that is not the case."

The budget figures "reinforce that this is not the case." stated Moscaritolo.

Joseph Kent, while thanking Massport for their increased community support, asked the officials for a comparative analysis of all community donations

"We're a small community," stated Kent, "but we get a lot of Massport." Kent cited the Massport operations of the bridge, waterfront and airport.

Among the contributions questioned by Kent, was the renovation of the Dom Savio High School ball field in East Boston.

Davis stated that Massport bought the former Dom Savio field in order to build "factory" housing on the lot for East Boston residents who were forced to move from their homes as a result of Massport's activities at Logan.

According to Davis, Massport, in a joint effort with Dom Savio, is building a new field adjacent to the old one. Sections of East Boston, namely Neptune Road, which abuts a runway are, according to Davis, "badly affected by Massport, such as traffic and airplanes," and added that "80% of all airport accidents happen at either end of the runway."

Kent asked Davis, "What about the accidents on the bridge? Of the accidents, how many were charged to Charlestown (insurance premiums)?"

The question. "Of the total number of accidents, how many involved Charlestown residents?" was also asked by Kent.

According to Kent, Massport "is making money" from 'their operations while Charlestown "is being charged for it."

Davis admitted that he had never investigated the accidents in terms of insurance premiums. Davis guessed that since there was no toll plaza on the lower deck of the bridge to slow speeding motorists, many of the accidents "probably" occured on the Chelsea side.

Kent rebuked, "There have been 14 deaths on the off ramp to Henley Street and of the 14, none were from Charlestown."

The third question raised at the meeting was where did Massport make its money. Both Davis and Moscaritolo stated that the money was made at Logan.

Resident John Kelley disagreed.

Kelley, who has been employed on the waterfront for years stated he felt Massport was "playing hard ball" with their waterfront property.

"Massport is doing pretty well as a landlord," stated Kelley, "the whole area is prime property."

According to Kelley, laborers are in a position were they work "paycheck to paycheck" while Massport "is making all the money."

Others in attendance also expressed concern that Massport, who claims that their profit is from the airport, may abandon their waterfront operations, citing the recent leasing of the Hoosac Pier as for office uses.


According to Davis, Hoosac became outdated as a "serviceable" pier, but assured "no plans have been made to change the uses at Moran Terminal, and I'm not kidding."


Davis added that Massport would expand the Moran Terminal if the adjacent Gypsum Company decided to move their operations. He continued stating that Massport recently invested \$11 million at Moran Terminal for new equipment.

"The proof is in the pudding," stated Davis, "You don't do that if you're not committed."

Robert Wallace asked Davis to make a long term committment to Charlestown.

"I'll give you the best committment that an Executive Director can give. There are no plans to change the maritime uses (at Moran Terminal)," promised Davis. "I will also tell you straight out that there are no pressures on Massport (to sell any) properties."







## Columbus Wins Third Catholic League Championship

If you picked Christopher Columbus High School to win the Catholic Central League Title in 1985, you were certainly in the minority, but you were right! On Wednesday of last week, the Friars defeated Fenwick 9-2 for their eighth straight win to take the title by one point over rival Xaverian on the last date of the regular season.

This remarkable group of young men weren't suppose to win. How could they? A large Jim Vesey-led senior delegation was gone, Coach of the Year Tom DeRosa had retired, and superior netminder Bob Cuddyer was declared ineligible by the MIAA, and Xaverian with 14 returning seniors was the odds on favorite to dethrone the Friars

Rookie Coach Paul Cedorchuk and Captains Bill Nolan. Alan Caparella and Brian Ward certainly had their work cut out for them, but in the end they were there when it counted, and a team that wasn't rated is now picked to do quite well in the Tournament.

December 12 - The Friars take the ice as the defending State Champs, and the feeling is unique to any past CC team. What will happen? The opponent is Division I Walpole and Brian Ward quickly showed that Columbus is still in charge. Scoring 14 seconds into the period, Ward and team mate Marty Mullen both have two goals and one assist in the 7-3 win.

December 19 - Home to BU for the League opener against Xaverian, the "contender" for the Crown. The Hawks went home stunned. Sophomore netminder Pat Manning was brilliant in his debut, as the Friars got three second period goals. Xaverian came back, but CC held on for a 4-3 vic-

December 22 - The opening round of the Hingham Christmas Tournament saw the Friars face off against Weymouth South. Down 5-2 early in the third period, Columbus roared back to tie the score on goals by Bill Nolan, Bill Vraibel, and Brian Ward. Senior Captain Alan Caparella got the game winner at 3:48 of the second overtime. Dennis Collins was inmense in both OTs. Three ingredients that key mark this team this season - GUTS, TALENT. AND PRIDE shone brightly in this one. At 3-0-0, you get the feeling that the '85 Friars could be heard from.

December 24 - Weymouth North drops Columbus from the unbeaten ranks in the finale of the Christmas Tournament. Alan Caparella had both CC goals in the 6-2 loss.

December 26 - A four goal performance by Brian Ward and a Hat Trick by Bill Nolan paced Columbus in their 11-2 victory over Pope John, but the game becomes only a one

December 29 - Arch-rival Dom Savio flattens the flat Friars 7-3. The next day headline reads: "Savio Upsets State Champions!

January 2 - Six different players got goals in the 7-2 win against Pope John. Junior Marty Mullen leads all scorers with a goal and three assists.

January 5 - Billy Nolan picks off another Hat Trick and Alan Caparella adds a pair in a 7-1 win versus Fenwick. January 9 - Marian has upset on their minds when they

come to BU, and the Friars are forced to get their "hardest point of the year." At 11:57 of the final period Marian goes ahead 5-4, but with just 15 seconds to go, Bill Nolan takes a crisp pass from Brian Ward and rapidly improving defenseman Vin Pino and sends the puck home for the tying goal for what could be the most important point of the yearremember those three ingredients: GUTS, TALENT, AND

January 12 - Rematch with Xaverian. The Hawks roll it up as the Friars chuck it up. Four unanswered first period goals by the Hawks. Columbus' comeback was shortlived. Nolan, Ward, Caparella are ejected. Columbus reaches a low point. The final Xaverian 7, CC 4.

January 16 - After a week of searching for some explanations, and Senior Captain Brian Ward's immortal cry of "REFUSE TO LOSE," the team fires back at all the critics. Pope John is the first to feel the sting. Freshman goaltender Bill Vacha gets his first win. Seniors Matt Mahoney and Alan Caparella have a pair of goals each in the 7-1 victory.

January 23 - Little elation this time for the Savio Spartans, and no more headlines. Columbus posts a 3-0 shutout behind a sparkling Dennis Collins. Brian Ward gets two goals, but Jimmy Donovan, a freshman, gets what proves to be the "game buster" early in the third period.

January 26 - Marian falls 9-4. Sophomore Tim Connolly

and Bill Nolan score two each and Nolan picks up two more

February 2 - Alan Caparella puts on a show getting six points (five goals - one assist) as the Friars defeat Marian again. This 8-1 win shows that the Friars have certainly made up for that missed point.

February 13 - SHOWDOWN AT BU. Xaverian wins, they get the Championship. The League Trophy is on display and each player knows that a loss removes the award. You know Brian Ward would have no part of that, nor would any Columbus player. A loud Xaverian delegation was soon silenced. Brian Ward got a Hat Trick, and Vin Pino and Tom Connolly got their biggest goals of the season in the 6-3 win. Dennis Collins didn't do too bad in the nets, either!

February 19 - Dom Savio returns and their comeback fell short. Brian Ward and Alan Caparella get two goals each in another must win. The Friars triumph 4-3, and Xaverian can only watch. Their season is over.

February 20 - A win here and the Friars are the Champs. With the Don Bosco stunner over Matignon in their minds, the Friars take the ice and very quickly trail 1-0, but these kids won't be denied. Brian Ward picks up a Hat Trick in the 9-2 win, but more important the team picks up THE Hat Trick-three Championships in three years!







### Facts About Drugs -F.A.D.

"I know someone who is hooked on alcohol. He goes to A.A. but he still drinks. He's even worse than before. What can I do to at least slow him down or make him stop drinking?"

Many people who go to Alcoholics Anonymous because they know they have a problem with alcohol. but they still want to drink. They haven't surrendered yet. The first step in A.A. is to realize "you are powerless over alcohol and that your life has become unmanageable." This person continues to drink because on some level he feels he can control it, "if I only drink beer...". "if I don't drink before 5:00 etc. These are excuses that go along with the thought that "I'll quit tomorrow.

It is essential for an alcoholic to come to the point of saying he can not help himself and he cannot drink. Before that day comes there are often many relapses. With each relapse the disease progresses. It is important for people who live with alcoholics to know that relapses are common and the family is not to blame. The hope is that there may come a day when, because of the pain in his life, he will reach out and take that help that is offered in A.A. It is important for you to know that he is not fooling the people in A.A. Alcoholics have an almost impossible time fooling other alcoholics, because they have played the games too. There will be people there for him when he is ready

What can you do? Learn about alcoholism. Remember you are dealing with a disease that is chronic and progressive. Keep into your own life as much as possible not picking up the pieces or responsibilities for the alcoholic. Pain is the drinking alcoholic's best friend. It brings him more and more into the reality of his disease. But try to remember that he is not a bad man, but a sick one. If you are an adult. Al-Anon is a great help. Alateen is for teenage children who are dealing with an alcoholic relative. Their numbers are in the phone book.


