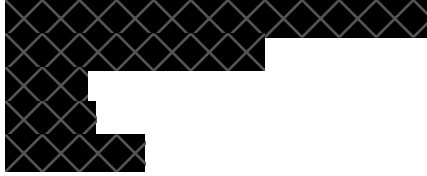

## NOTICE OF REJECTION OF REPRESENTATIONS

Cyngor Bro Morgannwg / Vale of Glamorgan Council have considered your representations dated 21/06/2022 about the penalty charge issued on the 26/03/2022 and have taken into account everything you say. However, there are not sufficient reasons to cancel the penalty charge, which is now payable.

## 1. Our reasons for rejecting your representations:

The Penalty Charge Notice was correctly issued as your vehicle was parked in a residents parking place or zone without clearly displaying either a permit or voucher issued for that place.

### More reasons.....

I understand from your email you parked in the location in question in order to visit the beach and say there were no signs or road markings indicating a parking restriction.

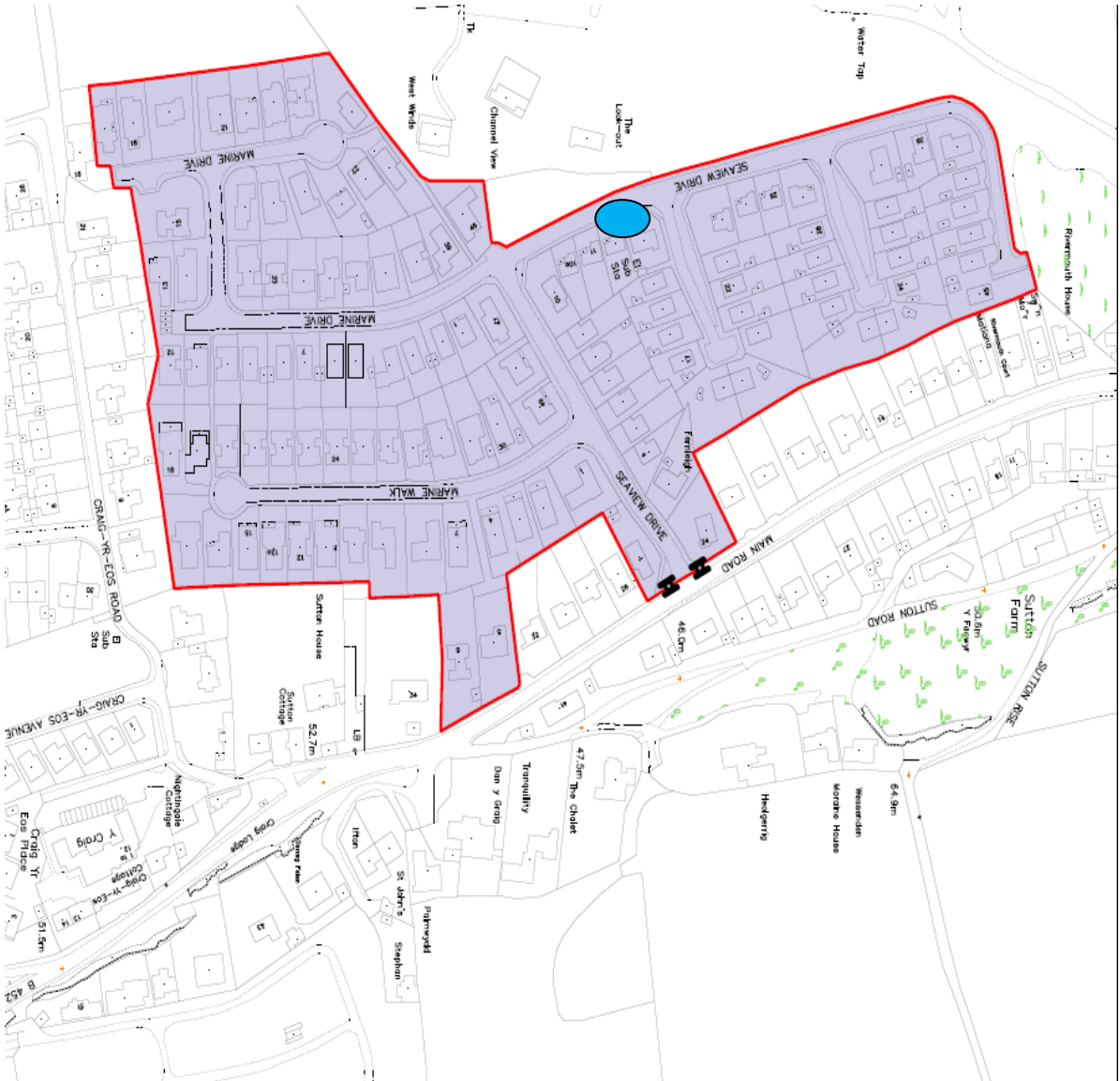
Whilst taking your comments into consideration, as previously advised, it is the driver's responsibility to ensure they are parked so as not to contravene the parking restrictions in place.

Please see the photographs of the two signs upon entry to the area in question which state "*resident permit holders only parking past this point*".

As also previously advised, there is no requirement for the restriction to be marked on the road. The attached map shows the location of the signs in the area in which the vehicle was parked with the approximate location of the vehicle marked in Blue. Your reasons are therefore not accepted as grounds for cancellation of the charge.

## 3. How to pay:

**The outstanding penalty charge is £70**

**This must be paid BEFORE the end of 28 days, beginning with the date of service of this notice (date of service is 2 working days after the date of production/posting of this Notice as stated on page 1).**

- **By Telephone:** Credit / Debit Card Payments only.  
Automated payment line 0345 6032877 (24 hours / 7 days a week).  
Please have your card, vehicle registration mark and PCN number to hand. Please note: We do not accept AMEX.
- **Online:** At [www.wppp.org.uk](http://www.wppp.org.uk) selecting the payment option.
- **By Post:** Cheques or Postal Orders made payable to 'WPPP' – include the PCN number with your payment and allow two working days for 1st class post; five working days for 2nd class.

## 4. How to appeal your decision:



**If you disagree with the council's decision, you can appeal to the independent adjudicator at the Traffic Penalty Tribunal.**

The adjudicators are independent lawyers and their decision is final. You can appeal online by visiting the tribunal's website: [www.trafficpenaltytribunal.gov.uk](http://www.trafficpenaltytribunal.gov.uk). The website explains further what the adjudicator can consider and how to appeal.

**If you are unable to appeal online**, you may request a paper form (and find further information) from the Traffic Penalty Tribunal by calling **0800 160 1999**, leaving your name, address, telephone number, vehicle registration mark and penalty charge notice (PCN) number.

**There is no charge for appealing** and costs are not normally awarded. Details about when an order for costs can be made can be found on the website, or by calling the number above.

*You should appeal within 28-days of delivery of this Notice of Rejection (this is usually two working days after the "Notice of Rejection" date above). Our website will explain this further.*

## 5. What happens next if you do nothing:

If, after 28 days, you take no action, WPPP (acting as the agent for Cyngor Bro Morgannwg / Vale of Glamorgan Council) may send you a **Charge Certificate** increasing the charge by 50%, from £70 to **£105**. You will then have 14 days to pay this increased charge. If after 14 days this charge has not been paid, we may apply to the County Court to recover the money, plus court costs from you.
