you go to church, when you pay your taxes. It is the world that has been pulled over your eyes to blind you from the truth. In the backstory of the movie, humanity had lost a war against robots and individual humans were now used as bioelectric energy sources to power the robot's world. To pacify the humans, they are kept sedated inside a virtual reality known as "the Matrix," inside of which they are under the illusion that they are living in "the real world" of 1999. Taking the red pill would allow Neo to wake up and re-enter the actual real world, in which a few humans were disconnected from the matrix and fighting a rebellion against the robots. Choosing the blue pill, on the other hand, would return Neo to his blissful computer generated simulation.

This analogy is used because it is a very good approximation of what we see around us. Practically our entire society is fed a false reality and distractions by the media, the education and propaganda complex, the government, the entertainment industry, and practically every other source of information. The worst thing is, people don't attempt to educate themselves to learn the truth or to think critically, they're content with the way things are, passively accepting what they hear, basically being told what to think; ignorance really is bliss. Like Neo prior to getting red-pilled, most people live their whole lives without ever really thinking for themselves or questioning the information they're being fed by these sources.

Fundamentally, to be "red-pilled" is simply to be able to think for one's self, to recognise, and to be able to reject the false narratives that we are fed by the information sources around us and to have the moral courage as well as fortitude to speak and spread the truth even when the world system is against it; being willing to 'wake up' and see beyond the "social constructs" meant to "domesticate" us.

Plato's allegory of the cave

What Plato suggested in his allegory of the cave, found in Book VII of "*The Republic*", in which the Greek philosopher envisions the ideal society by examining concepts like justice, truth, and beauty. In the allegory, a group of prisoners have been confined in a cavern since birth with no knowledge of the outside world. They are chained facing a wall, unable to turn their heads, while a fire behind them gives off a faint

light. Occasionally, people pass by the fire carrying figures of animals and other objects that cast shadows on the wall. The prisoners name and classify these illusions, believing they're perceiving actual entities. Suddenly, one prisoner is freed and brought outside for the first time. The sunlight hurts his eyes and he finds the new environment disorienting. When told that the things around him are real while the shadows were mere reflections, he cannot believe it. The shadows appear much clearer to him, but gradually his eyes adjust, until he can look at reflections in the water, at objects directly, and finally at the sun, who's light is the ultimate source of everything he has seen. The prisoner returns to the cave to share his discovery, but he is no longer used to the darkness and has trouble seeing the shadows on the wall. The other prisoners think the journey has made him stupid and blind, and they violently resist any attempts to free them. Plato introduces this passage as an analogy of what it's like to be a philosopher, trying to educate the public. Most people are not just comfortable in their ignorance, but hostile to anyone who points it out. It's not easy to accept that everything you know might be wrong...

The Matrix is a system. That system is our enemy. But when you're inside, you look around, what do you see? Businessmen, teachers, lawyers, carpenters. The very minds of the people we are trying to save. But until we do, these people are still a part of that system, and that makes them our enemy. You have to understand, most of these people are not ready to be unplugged. And many of them are so inert, so hopelessly dependent on the system, that they will fight to protect it.

Be wary of cognitive biases during research, especially confirmation bias which is the tendency to search for, interpret, focus on and remember information in a way that confirms one's preconceptions. Other cognitive biases that affect rational thinking you should try to avoid are anchoring bias, availability cascade, backfire effect, bandwagon effect, conservatism bias, and selective perception bias. Failing to interpret information in an unbiased way can lead to serious misjudgements. But don't fall for the blind spot bias just because you're aware of our brains' heuristics.

The Hegelian dialectic, usually presented in a threefold manner, was stated by Heinrich Moritz Chalybäus as comprising three dialectical stages of development: a thesis, giving rise to its reaction; an antithesis, which contradicts or negates the thesis; and the tension between the two being resolved by means of a synthesis. In more simplistic terms, one can consider it: problem → reaction → solution. To put it in even simpler terms, "manufacturing consent": many world events are engineered to make a population accept something it wouldn't have if it weren't for that event.

III/.....The reality of life

There are four main sources of power: democracy (rule of the people), oligarchy (rule of few), autocracy (rule of one), and anarchism (rule of none). The most widely used model nowadays is democracy, but it is only popular because of the illusion of free choice and participation it provides. When you live in a society where people are dumbed down and kept in the dark, democracy becomes a very dangerous idea. Until people are properly educated and informed, instead of indoctrinated to be ignorant mindless consumers,

A desire for power often correlates with negative personality traits such as selfishness, greed, and a lack of empathy. What people must realize is that authority doesn't exist. What gives someone else the right to rule over you? The State has no moral legitimacy: we are under no obligation to obey the State, and the State has no right to command individuals. Do not submit to anyone's tyranny. Live free or die.

Learn about philosophical anarchism. Anarchism is the hardheaded realization, based on five thousand years of experience, that we cannot entrust the management of our lives to kings, priests, politicians, and generals. Absolute power absolutely corrupts and humans are inherently a little bit selfish: even someone who rises to power with the most noble of intentions will become corrupted by his power.

"Power tends to corrupt and absolute power corrupts absolutely. Great men are almost always bad men, even when they exercise influence and not authority; still more when you superadd the tendency of the certainty of corruption by authority." -**Lord Acton**

Anarchy is neither a solution, a system, nor an ideology. It is merely the natural order of human life; consensual, voluntary relationships among humans without the greatest problem in history: the dystopian idea that some humans should have the right to control and rule over their fellow men under the threat of violence and imprisonment.

The basic principles of anarchism are the following:

Individual autonomy: The sovereignty of the individual person and their freedom to do whatever they want as long as they're not harming anyone else or infringing on anyone's rights and their property.

Voluntary association: The idea that all relations and institutions should be organized voluntarily with the guarantees that any individual or group can disassociate / secede from an association whenever they choose, and join another or found their own.

Mutual aid: The practice of positive reciprocity; or helping others out just as they help you out, building common bonds and providing the basis of solidarity. Recognition that no act is fully-interested (egoistic) or self-negating (altruistic), but contains concern for both the self and for others.

Self-organization: Organizing within associations being done through horizontal cooperation and participatory decision-making by all members involved, also called participatory democracy. Though this is only as long as it is on the basis of voluntary association and respects individual autonomy.

Free federation: Organizing things on a large scale through federations / confederations of voluntary, directly-democratic associations, with each component unit remaining self-organizing while also being part of a larger whole that cooperates to take care of issues that require a bigger geographical scope than local autonomous associations allow.

Direct action: This means accomplishing tasks without mediation. Removing representation and bureaucracy from activity, replacing both with immediate (direct) self activity of people doing stuff for themselves and by themselves.

But for some reason, the word "anarchy" has become almost synonymous with chaos, disorder, and lawlessness...

"All men are equal and free: society by nature, and destination, is therefore autonomous and ungovernable. If the sphere of activity of each citizen is determined by the natural division of work and by the choice he makes of a profession, if the social functions are combined in such a way as to produce a harmonious effect, order results from the free activity of all men; there is no government. Whoever puts a hand on me to govern me is a usurper and a tyrant; I declare him my enemy." -**Pierre Joseph Proudhon**

Everything you know is but social constructs and man made concepts existing outside of the natural order. Do not care for any laws as many are unjust, something being legal doesn't make it morally right. We have no need for constitutions or laws to tell us what are our natural rights, what we can and can't do. Free men care not what tyrants put on paper, our rights are ours and cannot be legislated away. Good men will be good and bad men will be bad regardless of the law anyway. Follow your moral compass. Strive to be good. Try to be self sufficient, to minimize dependency on anyone and especially the government. Seek knowledge. I suggest you try to educate yourself as much as you can in as many domains as possible. Read and learn philosophy, politics, history, science, mathematics, literature...etc instead of giving in to the futile distractions of 'panem et circenses'. But this does not mean you must forego fun in your life. Your life is precious, do not waste it.

III/....Money: What makes the world go round

1)....What is money and where does it come from?

Money can be defined as serving a few essential functions:

- Medium of exchange
- Measurement of value
- Standard of deferred payments
- Store of value

Money measures the value of various goods and services which are produced in an economy. In other words, money works as a unit or standard of value. In a barter economy it was very difficult to decide as to how much volume of goods should be given in exchange for a given quantity of a commodity.

Money, by performing the function of common measure of value, has saved society from this trouble. Now various goods and services have their value expressed in terms of money. In this way, money works as a common measure of value by expressing the exchange value of all goods and services in money in the exchange market. By working as a unit of value, money has facilitated modern business and trade.

Right from the beginning, money has been performing an important function as a medium of exchange in society. Money facilitates transactions of goods and service as a medium of exchange. Producers sell their goods to the wholesalers in exchange of money. Wholesalers sell the same goods to the consumers in exchange of money.

In the same way, all sectors of society sell their services in exchange of money and with that buy the goods and services they need. Money, working as a medium of exchange, has eliminated the inconveniences of barter transactions. However, money can operate as a medium of exchange only when it is generally accepted in that role. Bank money can be treated as money simply on the basis of their general acceptability for which they are highly useful. But be careful of money illusion, the cognitive bias to think of money in nominal, rather than real terms. In other words, the face value (nominal value) of money is mistaken for its purchasing power (real value). Viewing purchasing power as measured by the nominal value is false, as modern fiat currencies have no intrinsic value and their real value depends purely on price level (consumer price index).

Modern economic setup is based on credit and credit is paid in the form of money only. In reality the significance of credit has increased so much that it will not be improper to call it the foundation stone of modern economic progress. Money, besides being the basis of current transactions, is also the basis of deferred payments. Only money is such a commodity in whose form accounts of deferred payments can be maintained in such a way so that both creditors and debtors do not stand to lose. It is legal tender, declared by a government as being the standard of repaying public and private debts

It was virtually impossible to store surplus value under the barter economy; the discovery of money has removed this difficulty. With the help of money, people can store surplus purchasing power and use it whenever they want. Saving in money is not only secure but its possibility of being destroyed is very less. Besides, it can be used whenever need be. By facilitating accumulation of money, money has become the only basis of promoting capital formation and modern production technique and corporate business facilitated there from.

It is fascinating and almost magical how money appeared on our planet. Unlike most developments we enjoy, which can be traced back to a source, civilization or inventor, money appeared in places then

unconnected all over the world in a remarkably similar way. Consider the American Indians using Wampum, West Africans trading in decorative metallic objects called Manillas and the Fijians economy based on whales teeth, some of which are still legal tender; add to that shells, amber, ivory, decorative feathers, cattle including oxen & pigs, a large number of stones including jade and quartz which have all been used for trade across the world, and we get a taste of the variety of accepted currency. There is something charming and childlike imagining primitive societies, our ancestors, using all these colourful forms of money. As long as everyone concerned can agree on a value, this is a sensible thing for a community to do.

After all, the person who has what you need might not need what you have to trade. Money solves that problem neatly. Real value with each exchange, and everyone gaining from the convenience. The idea is really inspired which might explain why so many diverse minds came up with it.

Money, in some form, has been part of human history for at least the last 3,000 years. Before that time, it is assumed that a system of bartering was likely used, a direct trade of goods and services. Slowly, a type of prehistoric currency involving easily traded goods like animal skins, salt and weapons developed over the centuries. These traded goods served as the medium of exchange even though the unit values were still negotiable. Sometime around 770 B.C., the Chinese moved on to the first ever coins which were made of bronze. In 600 B.C., Lydia's King Alyattes minted the first official currency. The coins were made from electrum, a mixture of silver and gold that occurs naturally, and stamped with pictures that acted as denominations. By then, the Chinese were already using paper money. Around the 16th century, Europeans started using banknotes (IOUs: An IOU (abbreviated from the phrase "I owe you") is a type of obligation. It's an informal document acknowledging debt) that were redeemable for their face value in silver or gold coins. Nowadays, the currency we use, called fiat money, isn't backed by any physical commodity. Its value comes only from the trust we have in the issuing government's central bank. Fiat money risks losing its value due to inflation or even becoming completely worthless if the people were to lose faith in it.

2)....Debt and usury

Now that you know what money is, you must understand how debt and interest work as it is this that has made banks so powerful. One thing you must remember is that debt = money and money = debt.

Debt is money borrowed by one party from another. Many corporations and individuals use debt as a method of making large purchases that they could not afford under normal circumstances.

In a debt-based financial arrangement, the borrowing party gets permission to borrow money under the condition that it must be paid back at a later date, usually with interest.

Interest is payment of an amount above repayment of the principal sum at a certain rate. A charge for borrowing money, so basically buying money. The practice of selling money which is lending money and charging interest on it is called usury. In most cultures and religions, usury is forbidden. It's considered a sin and is viewed as morally wrong. This is why this practice was outlawed across most of history.

In his work "*Politics*", Aristotle described usury as 'the birth of money from money', and claimed it was unnatural because money was sterile and should not 'breed'.

In Judaism, usury is allowed towards non-jews. As jews were ostracized from most professions by local rulers during the Middle Ages, the Western churches and the guilds, they were pushed into marginal occupations considered socially inferior, such as tax and rent collecting and moneylending. Natural tensions between creditors and debtors were added to social, political, religious, and economic strains which led to anti-semitic sentiments.

Cleansing of the Temple

Jesus was so upset by the sight of the money changers in the temple, he waded in and started to tip over the tables and drive them out with a whip, this being the one and only time we ever hear of him using force during his entire ministry. So what caused the ultimate pacifist to become so aggressive?

For a long time the Jews had been called upon to pay their temple tax with a special coin called the half shekel. It was a measured half ounce of pure silver with no image of a pagan emperor on it.

It was to them the only coin acceptable to God. But because there was only a limited number of these coins in circulation, the money changers were in a buyers market and like with anything else in short supply, they were able to raise the price to what the market would bear. They made huge profits with their monopoly on these coins and turned this time of devotion into a mockery for profit. Jesus saw this as stealing from the people and proclaimed the whole setup to be 'a den of thieves'. Once money is accepted as a form of exchange, those who produce, loan out and manipulate the quantity of money are obviously in a very strong position. They are the 'money changers'.

3)....*The creation of banks*

Banking activity existed in ancient times and in the Roman Empire but was limited. Banking, in the modern sense of the word, is traceable to medieval and early renaissance Italy, to rich cities in the north such as Florence, Venice, and Genoa with the emergence of merchant banks. Debt became essential to fighting wars, which both monarchs and the Pope needed to fund. Eventually kings, politicians, and business people embraced usury wholesale, and the Church looked the other way. The Pope went on to approve ever more kinds of financial instruments, until lending with interest was effectively allowed.

Europe's first real private bank had been founded in the 1100s by the Knights Templar, a Catholic military order that fought in the Crusades. The Knights protected pilgrims who travelled to the Holy Land, and this protection included safeguarding their funds by allowing pilgrims to deposit money in Europe and withdraw it in the Holy Land. Over time, the Templars offered a greater range of financial services. The Knights Templar disbanded in 1312, but other bankers extended the practice of lending until, by the 1500s, merchants were buying and selling business debts in fairs across Europe. By the end of the 16th century and during the 17th, the traditional banking functions of accepting deposits, moneylending, money changing, and transferring funds were combined with the issuance of bank debt that served as a substitute for gold and silver coins.

New banking practices promoted commercial and industrial growth by providing a safe and convenient means of payment and a money supply more responsive to commercial needs, as well as by "discounting" business debt. By the end of the 17th century, banking was also becoming important for the funding requirements of the combative European states. This would lead on to government regulations and the first central banks. The success of the new banking techniques and practices in Amsterdam and London helped spread the concepts and ideas elsewhere in Europe.

The first bank to begin the permanent issue of banknotes was the Bank of England in 1695. Initially hand-written and issued on deposit or as a loan, they promised to pay the bearer the value of the note on demand. By 1745, standardized printed notes ranging from £20 to £1,000 were being printed. Fully printed notes that didn't require the name of the payee and the cashier's signature first appeared in 1855.

In the 18th century, services offered by banks increased. Clearing facilities, security investments, cheques and overdraft protections were introduced. Cheques were invented in the 1600s in England and banks settled payments by direct courier to the issuing bank

One of the biggest scams perpetrated by banks is what they call 'fractional reserve banking'. Goldsmiths were offering to keep other people's gold and silver safe in their vaults, and in return gave people a receipt (IOU) for the amount of gold they kept for them. These paper receipts soon became popular for trade as they were less heavy to carry around than gold and silver coins. After a while, the goldsmiths have noticed that only a small percentage of their depositor's ever came in to demand their gold at any one time. So cleverly the goldsmith's made out some receipts for gold which didn't even exist, and then they loaned it out to earn interest. They then incorporated this into the banking system. They even gave it a name to make it seem

more acceptable, 'fractional reserve banking' which translates to mean, lending out many times more money than you have assets on deposit. It is done to theoretically expand the economy by freeing capital for lending. LENDING MONEY THEY DO NOT EVEN HAVE FOR INTEREST. Some banks even practice 'no reserve banking' which means they lend money with no assets on deposit.

4)....The central banking cartel

"Give me control of a nation's money and I care not who makes its laws." -quote attributed to **Mayer Amschel Bauer Rothschild in 1790**, or said to be a 'maxim' of the House of Rothschilds, or, even more vaguely, of the "money changers of the Old World" (jewish usurers)

Most people don't realise that the issuing of money is essentially a private business, and that the privilege of issuing money has been a major bone of contention throughout history. Wars have been fought and depressions have been caused in the battle over who issues the money; however the majority of us are not aware of this, and this is largely due to the fact that the winning side became and increasingly continues to be a vital and respected member of our global society, having an influence over large aspects of our lives including our education, our media and our governments.

While we might feel powerless in trying to stop the manipulation of money for private profit at our expense, it is easy to forget that we collectively give money its value. We have been taught to believe printed pieces of paper have special value, and because we know others believe this too, we are willing to work all our lives to get what we are convinced others will want.

"There is but one power in Europe and that is Rothschild" -**Niall Ferguson**

A goldsmith named Amschel Moses Bauer opened a counting house in Frankfurt Germany in 1743. He placed a Roman eagle on a red shield over the door, prompting people to call his shop the Red Shield firm, pronounced in German as "Rothschild". His son, Mayer Amschel Bauer, who later changed his name to Rothschild, born on February 23rd 1744 and died September 19th 1812, was a German Jewish banker and the founder of the Rothschild banking dynasty. He is referred to as a "founding father of international finance". He inherited his father's business and immensely grew it after finding it much more profitable to loan money to governments and kings when he started doing business with a general who acquainted him with Prince William I. It always involved much bigger amounts, and repayment was always secured from public taxes. Starting out in Frankfurt, Mayer established each of his five sons in the financial capitals of Europe at the time, Frankfurt, London, Paris, Vienna, and Naples.

The war between England and France was really important for the Rothschilds because the five brothers work to supply gold to both Wellington's army (through Nathan in England) and Napoleon's army (through Jacob in France), and begin their policy of funding both sides in wars. The Rothschilds love wars because they are massive generators of risk free debt. This is because they are guaranteed by the government of a country, and therefore the efforts of the population of that country, and it doesn't matter if that country loses the war because the loans are given on the guarantee that the victor will honour the debts of the vanquished. Whilst the Rothschilds are funding both sides in this war, they use the banks they have spread out across Europe to give them the opportunity to set up an unrivalled postal service network of secret routes and fast couriers. In 1803, instead of borrowing from the bank, Napoleon sold territory west of the Mississippi to the 3rd President of the United States, Thomas Jefferson for 3 million dollars in gold; a deal known as the Louisiana Purchase.

"When a government is dependent upon bankers for money, they and not the leaders of the government control the situation, since the hand that gives is above the hand that takes. Money has no motherland; financiers are without patriotism and without decency; their sole object is gain." -**Napoleon Bonaparte**

Three million dollars richer, Napoleon quickly gathered together an army and set about conquering much of Europe. Each place he went to, Napoleon found his opposition being financed by the Bank of England, making huge profits as Prussia, Austria and finally Russia all went heavily into debt trying to stop him. Four years later, with the main French army in Russia, Nathan Rothschild took charge of a bold plan to smuggle a shipment of gold through France to finance an attack from Spain by the Duke of Wellington. Wellington's attack from the south and other defeats eventually forced Napoleon into exile. However in 1815 he escaped from his banishment in Elba, an Island off the coast of Italy, and returned to Paris. By March of that year Napoleon had equipped an army with the help of borrowed money from the Eubard Banking House of Paris. With 74,000 French troops led by Napoleon, sizing up to meet 67,000 British and other European Troops 200 miles NE of Paris on June 18th 1815, it was a difficult one to call. Back in London, the real potential winner, Nathan Rothschild, was poised to strike in a bold plan to take control of the British stock market, the bond market, and possibly even the Bank of England.

Rothschild couriers were the only merchants allowed to pass through the English and French blockades. It was these couriers who also kept Nathan Mayer Rothschild up to date with how the war was going so he could use that intelligence to buy and sell from his position on the stock exchange in accordance with that intelligence. One of Rothschild's couriers was a man named Rothworth. When the outcome of the Battle of Waterloo was won by the British, Rothworth took off for the Channel and was able to deliver this news to Nathan Mayer Rothschild, a full 24 hours before Wellington's own courier.

At that time British bonds were called consuls and they were traded on the floor of the stock exchange. Nathan Mayer Rothschild instructed all his workers on the floor to start selling consuls.

This made all the other traders believe that the British had lost the war so they started selling frantically. Therefore the consuls plummeted in value which was when Nathan Mayer Rothschild discreetly instructed his workers to purchase all the consuls they could lay their hands on. When news came through that the British had actually won the war, the consuls went up to a level even higher than before the war ended leaving Nathan Mayer Rothschild with a return of approximately 20 to 1 on his investment. In this way Nathan Rothschild captured more in one afternoon than the combined forces of Napoleon and Wellington had captured in their entire lifetime. This gave the Rothschild family complete control of the British economy, now the financial centre of the world following Napoleon's defeat, and forced England to set up a new Bank of England, which Nathan Mayer Rothschild controlled. In 1815, Nathan made his famous statement *"I care not what puppet is placed upon the throne of England to rule the Empire on which the sun never sets. The man who controls the British money supply controls the British Empire, and I control the British money supply."*

The Rothschilds used their control of the Bank of England to replace the method of shipping gold from country to country and instead used their five banks spread across Europe to set up a system of paper debits and credits, the banking system of today. By the end of this century, a period of time that was known as the, "Age of the Rothschilds," it is estimated that the Rothschild family controlled half the wealth of the world. The Congress of Vienna, taking place from 1814 to 1815, was one of the first steps towards world government political control over much of the civilized world. Many of the European governments were in debt to the Rothschilds, so they figured they could use that as a bargaining tool. However the Tsar Alexander I of Russia, who had not succumbed to a Rothschild central bank, would not go along with the plan, so the Rothschild world government plan failed.

Enraged by this, Nathan Mayer Rothschild swore that some day he or his descendants would destroy the Tsar Alexander 1st's entire family and descendants. Unfortunately he was true to his word and 102 years later Rothschild funded Bolsheviks would act upon that promise.

In America, the colonies issued their own money. It was called Colonial Script, issued in proper proportion to the demands of trade and industry to make the products pass easily from the producers to the consumers, and made the colonies prosperous as well as giving them a sense of identity.

"In this manner, creating for ourselves our own paper money, we control its purchasing power, and we have no interest to pay to no one" as said Benjamin Franklin.

America had learned that the people's confidence in the currency was all they needed, and they could be free of borrowing debts. That would mean being free of the Bank of England.

In Response the world's most powerful independent bank used its influence on the British parliament to press for the passing of the Currency Act of 1764. This act made it illegal for the colonies to print their own money, and forced them to pay all future taxes to Britain in silver or gold.

In one year, the conditions were so reversed that the era of prosperity ended, and a depression set in, to such an extent that the streets of the Colonies were filled with unemployed.

"The colonies would gladly have borne the little tax on tea and other matters had it not been that England took away from the colonies their money, which created unemployment and dissatisfaction. The inability of the colonists to get power to issue their own money permanently out of the hands of George III and the international bankers was the prime reason for the Revolutionary War." -**Benjamin Franklin**

By the time the war began on 19th April 1775 much of the gold and silver had been taken by British taxation. They were left with no other choice but to print money to finance the war. What is interesting here is that Colonial Script was actually working so well, it became a threat to the established economic system of the time. The idea of issuing money as Franklin put it "in proper proportion to the demands of trade and industry" and not charging any interest, was not causing any problems or inflation. This unfortunately was alien to the Bank of England which only issued money for the sake of making a profit for its shareholders.

In 1781, congressman Robert Morris suggested he set up the Bank of North America, the United States' first central bank. The Bank was given a monopoly privilege of its notes being receivable in all tax payments to state and federal government, and no other banks were permitted to operate in the country. It "graciously agreed to lend most of its newly created money to the federal government," wrote Rothbard, and "the hapless taxpayers would have to pay the Bank principal and interest.". Despite these monopolistic privileges, a lack of public confidence in the Bank's inflated notes led to their depreciation and the Bank was privatized by the end of 1783. Its charter was not renewed. But Morris did not give up on his scheme. He recruited a young Alexander Hamilton to serve more or less as his political puppet within the Washington administration. In fact, the reason why Hamilton became Treasury secretary, despite having no reputation at all in the field of finance, was the recommendation by Morris to George Washington. (During the Revolutionary War, when he was an aide to Washington, Hamilton took the time to write Morris a 30-page letter proclaiming that he agreed with every one of his ideas about protectionist tariffs, corporate subsidies, and a government-run bank to finance them.)

Morris and his fellow Nationalists wanted a king-like chief executive who would rule over a mercantilist empire, just as the king of England ruled over his mercantilist empire. They, of course, would be the ones to advise and instruct the "king" and benefit financially from such an empire. So their young protégé Hamilton commenced his seven-year crusade to overthrow the first US constitution by calling for a new constitutional convention to supposedly "revise" the Articles of Confederation. At the convention, Hamilton laid out his (really Morris's) plan: a permanent president who would appoint all the governors and who would have veto power over all state legislation. Under such a plan, state sovereignty would have been destroyed, and there would have been no escape from the central government's high taxes, protectionist tariffs, heavy debt, and foreign-policy imperialism — the agenda of the Nationalists.

The Hamilton/Morris plan was defeated, of course, as was the proposal made at the convention to include a central bank among the delegated powers to the federal government. But the government was more highly

centralized, as "the Nationalist forces pushed through a new Constitution" and "were on their way to re-establishing the mercantilist and statist British model...". They begrudgingly acquiesced in a Bill of Rights in return for the anti-Federalists' support for the new Constitution. In making his case to President Washington for the constitutionality of a central bank, which had been explicitly rejected at the constitutional convention, Hamilton invented the idea of "implied powers" of the Constitution. These were "powers" that were not expressly delegated to the federal government in the document, but could be "implied" by clever lawyers like Hamilton. This of course became a roadmap for the total destruction of constitutional limitations on the powers of the federal government.

The First Bank of the United States promptly fulfilled its inflationary potential, it issued millions of dollars in paper money and demand deposits "pyramiding on top of \$2 million in specie." The Bank invested heavily in the US government, and "The result of the outpouring of credit and paper money by the new Bank of the United States was ... an increase [in prices] of 72 percent" from 1791–1796.

"History records that the money changers have used every form of abuse, intrigue, deceit, and violent means possible to maintain their control over governments by controlling money and it's issuance." -**President James Madison**

Fed & money trust

They connive at centralization of government on the theory that a small group of hand-picked, privately controlled individuals in power can be more easily handled than a larger group among whom there will most likely be men sincerely interested in public welfare.

These international bankers and Rockefeller-Standard Oil interests control the majority of newspapers and magazines in this country. They use the columns of these papers to club into submission or drive out of office public officials who refuse to do the bidding of the powerful corrupt cliques which compose the invisible government." -**John Hylan, Mayor of New York City, March 26th 1922**

The term "politico-media complex" is often used as a pejorative, to refer to the collusion between governments, individual politicians, and the media industry, in their attempt to manipulate rather than to inform the general public.

"If you tell a lie big enough and keep repeating it, people will eventually come to believe it. The lie can be maintained only for such time as the State can shield the people from the political, economic, and/or military consequences of the lie. It thus becomes vitally important for the State to use all of the lie, and thus by extension, the truth is the greatest enemy of the State." -**quote attributed to Joseph Goebbels, Minister of Propaganda of Nazi Germany**

Whether or not Joseph Goebbels is indeed behind that quote, it remains true. Availability cascade is a self-reinforcing bias within our brains in which a collective belief gains more and more plausibility through its increasing repetition in public discourse. Another cognitive bias I should mention is the illusory truth effect, which is a tendency to believe that a statement is true if it is easier to process, or if it has been stated multiple times, regardless of its actual veracity. These are specific cases of what is called 'truthiness', the belief or assertion that a particular statement is true based on the intuition or perceptions of some individual or organization, without regard to evidence, logic, intellectual examination, or facts.

"How easy it is to make people believe a lie, and how hard it is to undo that work again" -**Mark Twain**

When one continually controls the information, one controls the people absorbing the information. The manufactured and controlled information on TV can be referred to as the signal and that constant signal is what shapes and guides the masses to their conclusions. In order to take back our minds, we must first learn to "Unplug the Signal." By turning off your TV you will realize the world that you're living in is suddenly very unfamiliar to you. You will see that news of no importance is constantly debated and analyzed, and as you listen to the conversations of people around you, you realize they're talking robots just repeating what they've heard on the news. This is exactly what Zbigniew Brzezinski talked about in his book "Between Two Ages". He said, *"Shortly, the public will be unable to reason or think for themselves. They'll only be able to parrot the information they've been given on the previous night's news."*

"We are grateful to the Washington Post, The New York Times, Time Magazine and other publications whose directors have attended our meetings and respected their promises of discretion for almost forty years. It would have been impossible for us to develop our plan for the world if we had been subject to the bright lights of publicity during those years. But the world is now more sophisticated and prepared to march toward a world government... The supranational sovereignty of an intellectual elite and world bankers is surely preferable to the national auto-determination practiced in past centuries." -**David Rockefeller, Bilderberg meeting of 1991 speech**

The control of the opinion-molding media is nearly monolithic. All of the controlled media - television, radio, newspapers, magazines, books, motion pictures - speak with a single voice, each reinforcing the other. Despite the appearance of variety, there is no real dissent, no alternative source of facts or ideas accessible to the great mass of people that might allow them to form opinions at odds with those of the media masters. They are presented with a single view of the world. It is a view of the world designed by the media masters to suit their own ends -- and the pressure to conform to that view is overwhelming. People adapt their opinions to it, vote in accord with it, and shape their lives to fit it. And who are these all-powerful masters of the media? To a very large extent, they are Jews. It isn't simply a matter of the media being controlled by profit-hungry capitalists, some of whom happen to be Jews. If that were the case, the ethnicity of the media masters would reflect, at least approximately, the ratio of rich Gentiles to rich Jews. The preponderance of Jews in the media is so overwhelming, however, that we are obliged to assume that it is due to more than mere happenstance. You will understand why later on in this document.

Operation Mockingbird

Operation Mockingbird was a fully implemented secret CIA program intended to spread disinformation and use the news media as a means of psychological warfare. Over 400 CIA agents were disseminated within mainstream television, newspaper, and magazine companies to control information. I believe this program or another like it is still going on to this day as the news media is very obviously controlled by a single entity. Headlines are always oddly similarly worded. The words spoken or written are precisely chosen to influence the public, which are obvious signs of a psy op if you pay attention.

"We'll know our disinformation program is complete when everything the American public believes is false" -**William Casey, CIA director, 1981**

Another problem with the news media is fake news. Fake news is written and published usually with the intent to mislead in order to damage an agency, entity, or person, and/or gain financially or politically, often using sensationalist, dishonest, or outright fabricated headlines to increase readership. Similarly, clickbait stories and headlines earn advertising revenue from this activity. The relevance of fake news has increased in post-truth politics. For media outlets, the ability to attract viewers to their websites is necessary to generate online advertising revenue. Publishing a story with false content that attracts users benefits advertisers and improves ratings. Easy access to online ad revenue, increased political polarization and the popularity of social media, primarily the Facebook News Feed, have all been implicated in the spread of fake news, which competes with legitimate news stories. Hostile government actors have also been implicated in generating and propagating fake news, particularly during elections.

Cover up by the Belgian authorities? Marc Dutroux case study

Marc Dutroux is a Belgian serial killer whose case provoked outrage at the lax response of law enforcement agencies. So intense was the public's reaction that more than one-third of Belgians with the last name Dutroux changed their names.

Dutroux had a lengthy record as a juvenile delinquent and petty criminal, and the seriousness of his crimes increased as he grew older. Later, as an unemployed electrician, he acquired various landholdings with money gained through auto theft, pimping, mugging, and drug dealing. In 1989 Dutroux was convicted of five sexual assaults, having abducted and raped 5 young girls and sentenced to 13 years in prison, though he was released on parole after only three years. After his release, Marc Dutroux was able to convince a psychiatrist that he was disabled, resulting in a government pension. He also received sleeping pills and sedatives from the doctor, which he would later use to quiet his victims.

During the next four years he abducted and sexually assaulted an unidentified number of girls, some of whom he allegedly murdered. Along with several accomplices, Dutroux also purportedly sold children into slavery in other countries. As an unemployed man, he came to own seven houses, most of them vacant, and he used three of them to torture the girls he kidnapped. In his house in Marcinelle near Charleroi (Hainaut), where he lived most of the time, he started to construct a concealed dungeon in the basement. Hidden behind a massive concrete door disguised as a shelf, the cell was 2.15 metres (7 feet) long, less than a meter (3 feet) wide and 1.64 metres (5.38 feet) high.

The Dutroux case aroused popular suspicions about the inefficiency and corruption of Belgium's law enforcement and political establishments. The police were denounced for not pursuing leads in the investigation and for ignoring information provided by various individuals—including Dutroux's own mother, who in 1995 claimed that her son was holding girls in one of his vacant houses. In the following year, the police searched one of the houses and found two teenage girls confined in a cell; two other girls, both eight years old, were found buried at another house a few days later.

After Dutroux's arrest, one of his accomplices, Michel Nihoul claimed to have hosted a party that was attended by government officials and police officers. This assertion, together with allegations of a cover-up and suggestions that Dutroux may have been providing girls to government officials, caused outrage

throughout Belgium and led to a demonstration in Brussels of some 250,000 people—one of the largest demonstrations in Europe since World War II. In 1997 a commission appointed to investigate the crimes found indications that some suspects, including Dutroux, had been protected, further fueling suspicions of a cover-up.

In 1998 Dutroux escaped for three hours after being allowed to leave prison to examine files for his impending trial. In 2002 he reportedly admitted to being responsible for the deaths of at least two girls. In 2004 he was convicted on charges of murder, kidnapping, and rape and sentenced to life in prison. The total number of his victims is unknown.

Despite a lot of evidence suggesting that Dutroux worked for a Belgian elite pedophile ring, the media has tried to paint him as a deranged lone wolf acting on his own.

b. Lithuania

Neringa Venckienė, a story of corruption and injustice

Neringa Venckiene is a former judge, politician, and a member of the Seimas (Parliament of Lithuania). Known for exposing a pedophile ring within the highest ranking officials of the country. Facing serious charges, she fled to the United States in 2013 and asked for political asylum. In November of 2019, she was extradited back to Lithuania, where she awaits her trial.

Venckiene's brother, Drašius Kedys, had an out-of-wedlock daughter (Deimante Kedyt) with his ex-girlfriend, Laimutė Stankūnaitė in February 2004 before splitting up in 2006. Stankūnaitė had originally obtained the custody of the girl but will lose it later.

On 29 November 2008, Kedys submitted a formal complaint to the police, claiming that Andrius Ūsas, an advisor to the speaker of the Parliament, had paid Stankūnaitė sexually molest his 4 year old daughter. Because of this, in December 2008, Kedys obtained full custody of his daughter with no visitation rights for Stankūnaitė. The pre-trial investigation against Ūsas continued and, in February 2009, Kedys further pressed accusations against Violeta Naruševičienė, a sister of Stankūnaitė, claiming she had also let men molest his daughter.

In July 2009, Kedys accused Jonas Furmanavičius, a district judge, and an unidentified individual known only as Aidas, of partaking in the molestation. All of these people (except for the unidentified Aidas) declared themselves innocent, and accused Kedys of slander. Frustrated with the lack of progress in official investigations and convinced that the case was being deliberately stalled, Kedys sent out about 200 DVDs to Lithuanian politicians, media outlets, and law-enforcement agencies, featuring homemade video footage of Deimante's explicit testimony against three "uncles" describing what they did to her. 4 separate commissions determined the girl's testimony as truthful; but some people argued that Kedys had coached his daughter on what to say.

On 5 October 2009, Furmanavičius and Naruševičienė were shot dead in Kaunas. Kedys quickly became the prime suspect. On the same day, a nationwide search for him was launched, soon followed by the search turning international, as he was thought to have left the country shortly after the murders. A friend of Kedys, Raimundas Ivanauskas, and his wife Eglė Barauskaitė, were charged with accessory to murder. In 2016, Barauskaite was found to be innocent, while Ivanauskas was found guilty and sentenced to 8 years in prison.

After all of this, the custody of the girl was then given to Kedys' sister, Venckiene.

This story caused an uproar in Lithuania, with much of the public siding with Kedys: the case was seen as a father trying to protect his daughter and his futile attempts to pursue justice, having been driven to desperate measures by his anger at the lack of it. In February 2010, General Prosecutor Algimantas Valantinas resigned over public criticism of how he handled Kedys' case. After six months of police search, Drąsius Kedys' body was found near Kaunas Reservoir on April 20, 2010. According to the official report, the cause of death was "choking on his own vomit" whilst heavily intoxicated. However, his relatives were convinced that Kedys that this was simply a cover up, with him being murdered, pointing to some wounds on his body, and the fact that there was no vomit found on the scene.

On April 24, the body of Kedys was buried in Jonučiai cemetery, with various media reports saying there were between six and ten thousand attendees at the funeral ceremony.

Ūsas, the main suspect in this whole pedophilia case, was officially charged with sexual molestation of a minor. However, he was found dead in June 2010. According to the police, he fell off his all-terrain vehicle and drowned in 8 inches of water. The death was ruled an accident. The court case against Ūsas continued and he was found innocent in November 2012. In May 2010, a court order gave custody of Deimante to her biological mother, Stankunaite. Outraged by this decision up to 2000 people surrounded Venckiene's home to not let the police pass, who were coming to take the child by force.

After the continued protests and demonstrations against the court decision, it was reversed; but in 2011, custody was once again awarded to the biological mother. The vigil outside Venckiene's house started again.

On March 23, 2012, police surrounded the house and attempted to take Deimante by force. The girl refused to go. The ordeal was broadcast on national TV. People were outraged at the footage of the mother and her bodyguard attempting to pull the screaming girl away from the grandmother. Luckily, this was stopped by child protective services, stating that it was traumatizing the child. Deimante developed

PTSD as a result of this failed attempt of taking her away. At 6 AM on 17 May 2012, 240 police officers went to Venckiene's home. The police shut down the roads, closed the local school, and enforced a lockdown of a 2-mile perimeter around Venckiene's house. The protesters were pulled aside, 39 of them arrested. Police used rubber sticks, electric shock, police dogs, tear gas and rubber bullets. After a failed attempt to get in the house through the main entrance, the police broke the side glass door. Police turned off the security cameras inside the home. The girl was carried away screaming.

After the girl was transferred, the footage of the police operation went viral. Around 200 people spontaneously showed up to protest at the Presidential Palace in Vilnius. Smaller protests occurred in other Lithuanian cities as well.

The parliament approved the prosecutors' request to remove Venckiene's legal immunity on April 9, 2013, and on the same day, she fled to the United States.

In June 2014, Venckiene was impeached and her mandate removed. She was the first person ever to be impeached without being present or legally informed about the proceedings. Gintaras Aleknonis, who was supposed to take Venckiene's place in parliament, refused to be sworn in, in protest. She was arrested in Chicago at Lithuania's request in February 2018. The 7th U.S. Circuit Court of Appeals ruled that if the U.S. didn't fulfill its obligations under extradition treaties by returning Venckiene to Lithuania, "the United States risks losing the ability to obtain the extradition of people who commit crimes here and flee to other countries."

Top director James Gunn was fired over very questionable tweets about pedophilia but was back at work only a few weeks later. Nickelodeon producer Dan Schneider also lost his job because he couldn't keep his hands off of young girls and was even ousted by Isaac Kappy (more on him coming up) as a pedophile. Brian Peck is a convicted child molester who only spent 16 months in jail before going right

back to working at Disney. Jason James Murphy kidnapped and sexually assaulted an 8 year old boy in 1996, served five years in jail and then became a casting director for child actors.

The list of sexual predators in Hollywood is very long with some big names we know about such as Bill Cosby, Kevin Spacey, Harvey Weinstein... but most victims never dare to speak up against their aggressors especially those with high social status within Hollywood. Thankfully, there have been good people in Hollywood speaking out for them.

Corey Feldman was one of the first people to do so, saying that Hollywood's biggest problem is, was, and always will be pedophilia. He and his best friend Corey Haim became actors at a very young age but their success came at a price, the pair were sexually abused by various adults they worked with and were passed around at Hollywood parties. Both Coreys turned to alcohol and drugs to numb their trauma, which eventually led to Corey Haim's death at the age of 38. Corey Feldman had vowed to expose their abusers and released a documentary called "My Truth: The Rape of 2 Coreys" on March 9th 2020 in which he reveals Charlie Sheen, Marty Weiss, Jon Grissom, and Alphy Hoffman as some of their childhood abusers. Other actors like Elijah Wood, Robert Downey Jr, and Brad Pitt have made statements corroborating Corey Feldman's claims about Hollywood being a pedophile den.

The infamous actor Mel Gibson who was blacklisted for around over a decade from Hollywood has called it an institutionalized pedophile ring, a den of parasites who feast on the blood of children, and that all Hollywood were not only bought and paid for with the blood of innocent children but also drenched in it. He said that it was an open secret there, that those people had their own religious teachings and social/moral frameworks, that they couldn't be more at odds with what America stands for, that they harvested the blood of children and ate their flesh, and that they thrived on pain, trauma, and suffering, among other horrible stuff.

Isaac Kappy is another actor who spoke out against the pedophilia going on in Hollywood, and he paid for his life for doing so. Although he has said that he was not suicidal, his death was "suicide" by jumping off a bridge into uncomming traffic. He has said that his best friend, Seth Green, admitted to him being a pedophile. He outed Tom Hanks as also being a pedophile and talked about Sarah Ruth Ashcraft, a girl who claims Tom raped her when she was 13. Tom Hanks has published a post on Instagram captioned 'Historic Route 66. Roadkill? I hope not! Hanx.' which is a clear play on words that predicts exactly how Isaac Kappy was gonna be suicided. Isaac also talks about Marina Abramovic and tells people to look into her, he mentions John Podesta and calls him absolutely disgusting, he ousts Steven Spielber and Dan Schneider as pedophiles, and strongly hints to Oprah Winfrey also being a pedophile and says that he's got a feeling that *"she's very high up in the cult"* before continuing with *"make no mistake, this is a cult. There is a widespread cult that is worldwide, and it's fucking bad, guys."* He says that Jimmy Savile raped and murdered hundreds of kids over the course of three decades or longer and that no one ever looked into it before pointing out that he hung out with the royal family and even was knighted. *"The news is fake, it's because it's run by these people who are into some very very very very sick stuff. We have been brainwashed. For our whole lives. [...] It's scary guys, people get killed over this shit, it happens all the time"* Isaac even talks about MK Ultra and asks viewers to start researching because he wants everyone to 'wake up'.
