## (4) Mandatory USTA Medical Release Form:

All players are required to submit a USTA Medical Release Form. You can save time at check in by printing and filling out this form and bringing it with you to player check-in on Friday, January 19th. # (5) USTA Southwest Section Dress Code, USTA Southwest Overrule Policy, Reffkin Tennis Center Video Policy, Smart Watches:

**DRESS CODE:** All players are required to wear appropriate tennis attire. Cut off shorts, bare midriffs, and compression shorts alone are not allowed. Shirts should not reference sex, drugs, alcohol, or tobacco.

**OVERRULE POLICY:** Once a player has been overruled a second time, they will be cautioned that after another overrule, they will be penalized for unsportsmanlike conduct under the Point Penalty System: (point, game, default.)

**VIDEOTAPING POLICY:** Jim Reffkin Tennis Center requires that you obtain permission from the parent(s) of the other child prior to videotaping a match. If the other child's parent(s) does NOT agree to you videotaping their child, all videotaping must cease immediately. This includes cell phones if they can be construed as videotaping.

**SMART WATCHES & CELL PHONES:** No smartwatches allowed and cell phones must be turned off. The only exception is between a 2nd set and a match tiebreaker.

#### (6) USTA SOUTHWEST ENFORCEMENT OF THE SUSPENSION POINT SYSTEM:

If a player withdraws, has a walkover or defaults from any sanctioned tournament in the Southwest Section, after entries have closed, that player will be assessed **4 suspension points** unless medical documentation of the injury or illness is provided to the Tournament Director within **48 hours after the completion of the tournament. (Wed. January 24th 3pm)**After entries close, no refunds will be given. Regardless of the reason for the withdrawal.

#### (7) Draw Types & Match Formats:

Singles – 32 Draw – Feed-In Championship Though Round of 16 (FIC). The quarterfinal losers will be fed into a separate draw to playoff for 5th and 6th place. Semi final losers playoff for 3rd/4th.

Doubles – 16 Draw – Single Elimination (3rd/4th Place Playoff as well)

Singles Main Draw & Consolation Matches -- Best of 3 Tiebreak sets with a 10-Point Match Tiebreak in Lieu of a 3rd Set. Normal ad-scoring.

Doubles Matches -- 8-Game Pro Set with a 7-Point Tiebreak at 8 games all. Normal ad-scoring.

#### (11) Event Check-in:

All players & parents must be present to check in on Friday, January 19th between 6-7pm at Reffkin Tennis Center inside the tournament building (located by court 12). The check-in process takes 5-15 minutes total. Player/parent will turn in their photo waiver release form, verify contact info, sign a player oath form (player reads and signs), sign a parent oath form(parent reads & signs this), let us know what hotel you are staying at, and receive the player gift. There will not be a mandatory meeting, reviewing the information in this email counts as your parent's meeting.

Absolutely can't make the player check-in on Friday January 19th between 6-7pm? Please reply to this email and let me know the reason why. I will reply to your email and send you a link to an online form to fill out to be excused from check-in. The deadline to email me about missing check-in is Wednesday January 17th.

#### (12) Practice Courts:

Practice courts available at the Reffkin Tennis Center (Host Site) from 8am to 4:30pm and 6:30pm to 9pm on Friday, January 19th for FREE (first come first serve basis for 1.5 hours, must check-in at pro shop for court assignment).

During the tournament (January 20-22) all courts will be available first come first serve starting an hour before the tournament first round begins (8:00-9:00am Jan. 20th and 8:30-9:30am Jan. 21st&22nd). PLEASE WARM-UP FOUR(4) TO A COURT.

During the tournament, 3 courts (19-21) MAY be available at the facility for practice. We do not guarantee any practice courts during the tournament. See practice site recommendations below. PLEASE WARM-UP FOUR(4) TO A COURT.

Courts will be available for practice during the tournament at these locations (no reservations): Catalina Magnet High School (10 courts, 2 miles from Reffkin) – 3645 East Pima Ave, Free Himmel Tennis Center (8 courts, 2.6 miles from Reffkin) – 1000 North Tucson Blvd, \$2.50/person Ft. Lowell Tennis Center (8 courts, 5 miles from Reffkin) – 2900 North Craycroft Road, \$2.50/person

## (13) Racquet Stringing:

Stringer will be on site at Reffkin Tennis Center during the event. (Racquet turnaround time is anywhere from 30 minutes to 24 hours depending on how busy it is)

If you need to purchase tennis shoes, racquets or other miscellaneous tennis supplies we recommend going to Tucson Racquet Club, Racquet Shack or Dick's Sporting Goods.

#### (17) Date Draws Made & Date Draws Posted:

Draws are published online. All matches are scheduled from round of 32 to finals, singles & doubles. Doubles is played first each day.

Match times will ONLY be changed for one of the three reasons below:

- (1)We need to give players enough rest if their match went long
- (2) If there is a conflict with doubles and singles at the same time, then the singles will be pushed back (doubles played first).
- (3)If there is a rain delay

Please note: We will NOT take any match schedule requests. All players are required to be available all day January 20th, 21st & 22nd (the three tournament sanctioned dates).

All players are instructed to Check-In at the tournament desk 15 minutes prior to all scheduled match times throughout the tournament.
