1. On 8 September 2022, the Pre-Trial Judge ordered the parties, pursuant to Rule 95(3) of the Rules, to file notices indicating where points of agreement on issues of law and/or facts have been reached in relation to their respective proposals by 18 November 2022.¹

2. Counsel for Hashim Thaçi, Counsel for Kadri Veseli, Counsel for Rexhep Selimi, and Counsel for Jakup Krasniqi (together, "the Defence") hereby notify the Pre-Trial Judge that on 31 October 2022, they submitted a joint proposal for agreement on 135 facts related to crimes committed by the Serbian forces in 1998/1999 in Kosovo,² such as the details of the massacre of the Jashari family in Prekaz in March 1998,³ the Reçak/Račak massacre of January 1999,⁴ the Çikatovë e Vjetër/Staro Čikatovo massacre,⁵ and the Mejë/Meja massacre of April 1999.⁶

3. On 10 November 2022, the SPO informed the Defence that it will not be agreeing to the proposed facts in the Joint Defence proposal.
