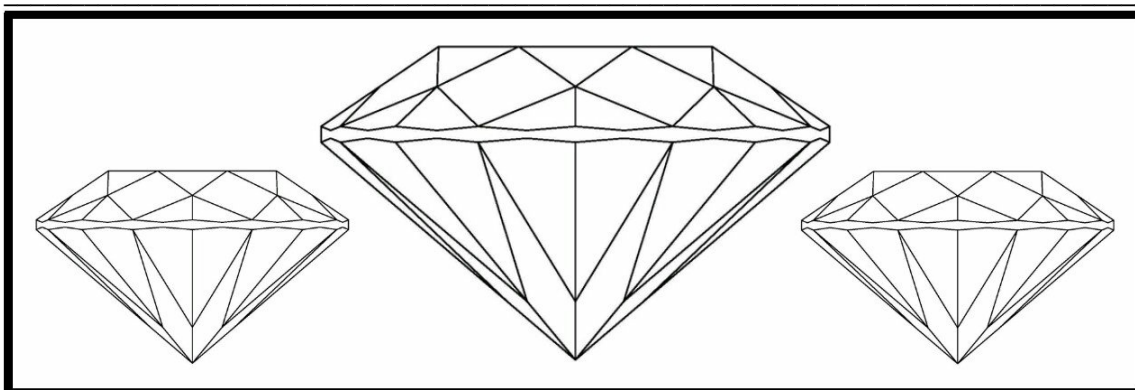



**Basic meaning of the contract:**

The institution is made up of Private Companies in the field of military, security and protection, espionage and detective activities. Groups of these forms of private companies can be, trade companies, independent movements, and as state security constituencies of states in the form of multilateral functions.

Any government of the country can use the right to obtain independent membership in Institution ID's GSCPC, thereby ensuring the employment of its own military and security forces in order to protect private targets of public clientele as independent gainful employment, independent peaceful goals.

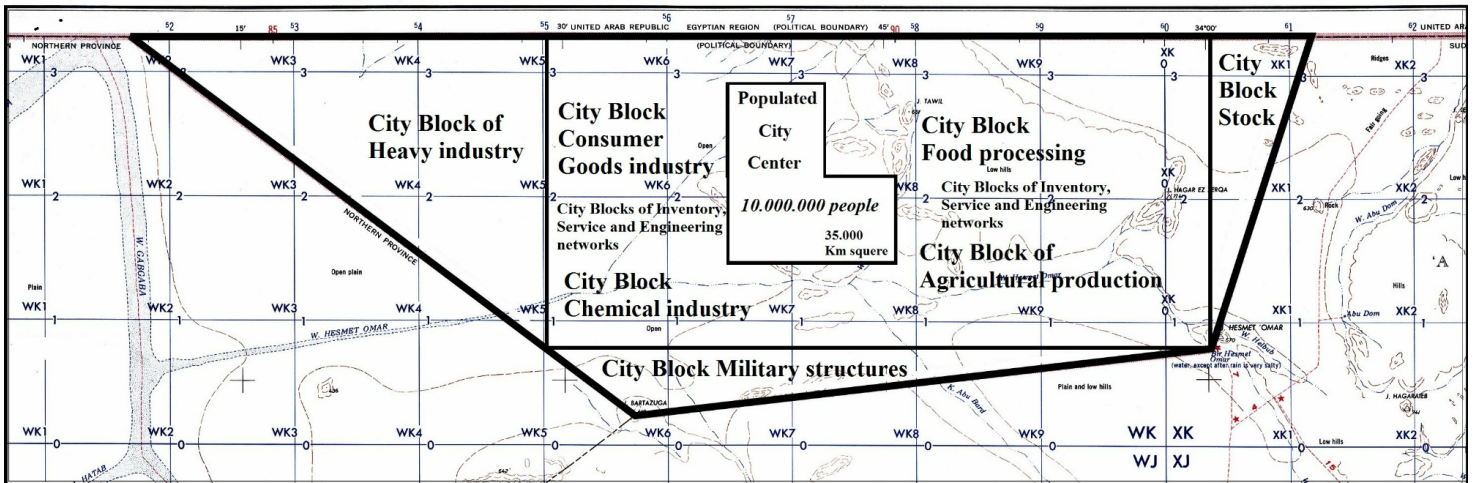

**Additional Note.**

The agreement is not based on the purpose of the crime and the violation of International rules.

International law prohibits the exercise of mercenary activity. A mercenary means the execution of a person who is active against the freedoms, law and justice of others, and thus the mercenary fights criminally and aggressively and armed for the purpose of his own profits from the theft, or the payment from his criminal employer, which is the center of stealing stolen property.

Contrary to the importance of mercenary, therefore, as a Private Security Protection is the performance and service of persons who are financially profitable for the provision of their services to clients and the enforcement of the security in full accordance with the principles of the jurisdiction of the State of performance of contracts created with clients who have such a security service freely request.

The institution only allows the exercise of the Private Security Guard in accordance with International law and the principles of the jurisdiction of the States.
