Update on Adult and Dislocated Worker Services & Youth Services & One Stop Operator by Ryan Follett & Recie Small

- April 30, 2018, Moving Forward Agency will not be extending their services
- Chris asks Ryan & Recie to be in contact with the City of Petersburg as a possible vender to provide Adult & Dislocated Worker services.
- Ryan has also been in contact with the Virginia Employment Commission as a provider for Adult and Dislocated Worker Services as well.
- Recie received technical support from the Virginia Community College System about utilizing case workers (one in Emporia & one in Petersburg) to avoid a loss of services in the Adult and Dislocated Worker Services
- This is an interim stop gap measure while simultaneously trying to procure a permanent Adult & Dislocated Worker Services.
- Draft contract has been sent to Pathways, awaiting feedback from them as well as, the city of Petersburg Procurement office.
- It is a six month contract, while simultaneously procuring a permanent Youth Service provider
- Ryan will provide CEOs & Board members with a list of local One-Stop Operators
