Judges also did not object when legislators banned lobbying. In 1877, Georgian legislators **wrote** "Lobbying is declared to be a crime" into the state constitution. A number of state legislatures took similar action—for a time, lobbying was a felony in California—and in 1852, Congress **passed a law** banning anyone "employed as an agent to prosecute any claim pending before Congress" from being present during legislative sessions.

As one judge **wrote**, a lobbyist is "induced to use his influence for the money he is to obtain; when, as a patriot and a citizen, he should only act for the good of his country."

The company has an extensive lobbying operation that cost \$2.6 million in 2014 and \$1.5 million in 2015. CoreCivic also spent \$1.1 million in 2014 and \$781,800 in 2015 on political donations, according to company reports. CoreCivic doesn't have a specific dollar goal to spend on lobbying for its new campaign. CoreCivic also said its lobbyists will note their efforts to gain policy changes in state and federal lobbying reports.

Legally, there *is* an official cooling-off period: departing senators have to wait two years to become a registered lobbyist and do business with their former colleagues; representatives a year. Some have suggested making the bans longer, perhaps as much as six years. Not a bad idea, but the reality is, many of them don't bother registering at all, getting away with calling themselves consultants or advisers — a lobbyist in all but name.

Taken as a whole, more former lawmakers are influencing policy and public opinion now than before the reform was enacted: in a six-year period before the law, watchdog group Public Citizen found 43 percent of former lawmakers became lobbyists.

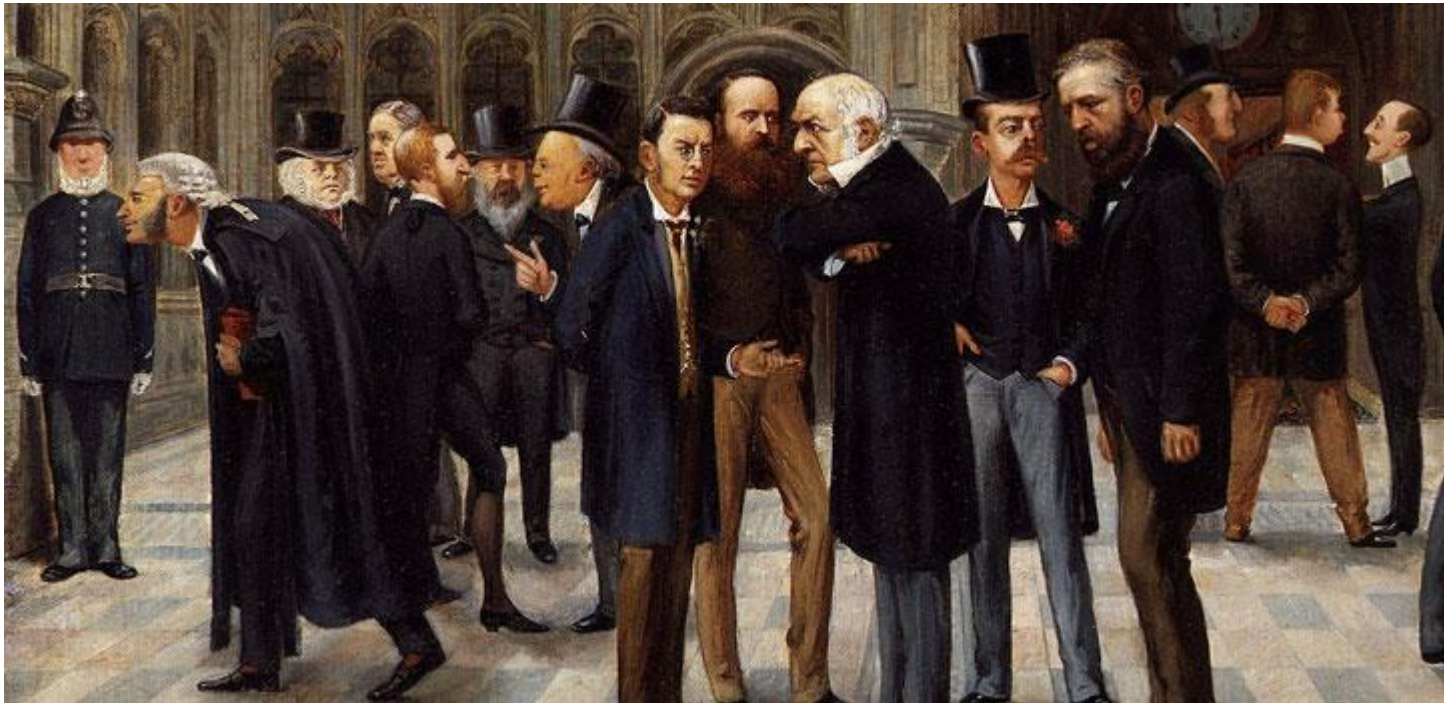
## What is a lobbyist?

Lobbying is attempting to influence decisions made by a public official — usually to pass or defeat legislation. **Lobbyists are professionals hired by a special interest group to represent their interests to Congress.**



*The term “lobbyist” harkens back to the days when people hung around in lobbies waiting to get a word in with legislators heading to vote.*

All kinds of groups hire lobbyists — from corporations and private companies to nonprofits and unions — to try to persuade the government to pass legislation that’s favorable to them.

## **Lobbyists get a bad rap — is lobbying bad?**

There is nothing inherently wrong with lobbying. Lobbying encourages people to play an active role in their government — it’s protected by the First Amendment as our right “to petition the government.”

The problem is when lobbyists use money to buy influence with our government. **Lobbyists today funnel millions of dollars into the hands of Congress.**

Because they’ve become dependent on money from lobbyists to fund their political careers, Congress ends up passing laws to keep the lobbyists and their clients happy, instead of laws that benefit the American people.

Those of us who **can't afford to hire a lobbyist** or make big campaign contributions are out of luck.

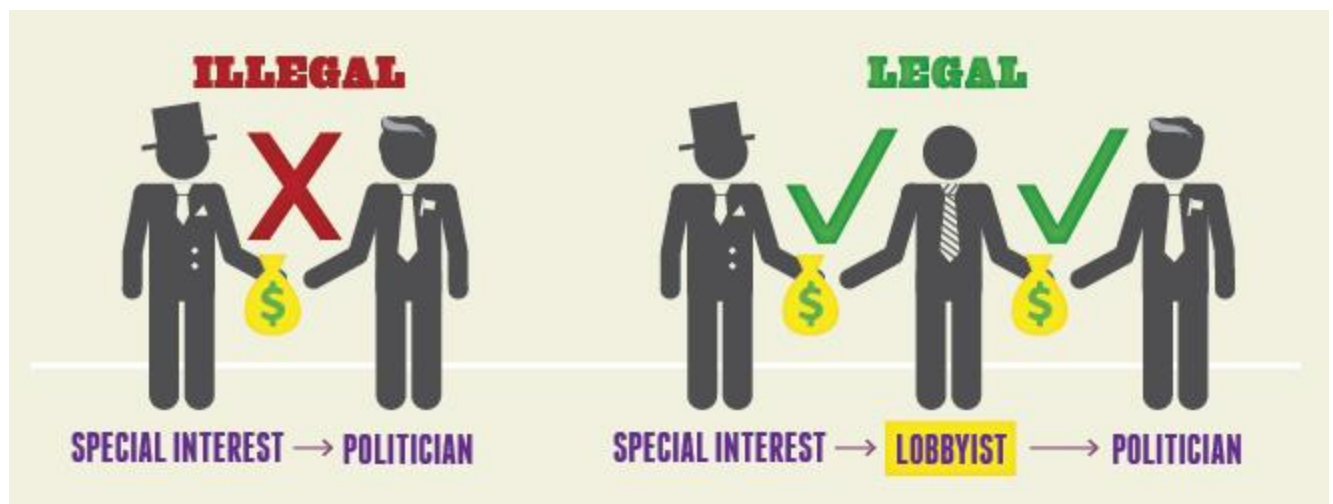
*A lobbyist can't just walk up to a lawmaker with a briefcase full of cash and say, 'Hey, Senator, I'll give you \$100,000 if you vote our way on this bill.' But lobbyists can still give the congressman \$100,000—and much, much more—without breaking any laws.*

If it seems like the government isn't working for the people, part of the problem is they're effectively being bribed, very often by lobbyists. Here's how it works:

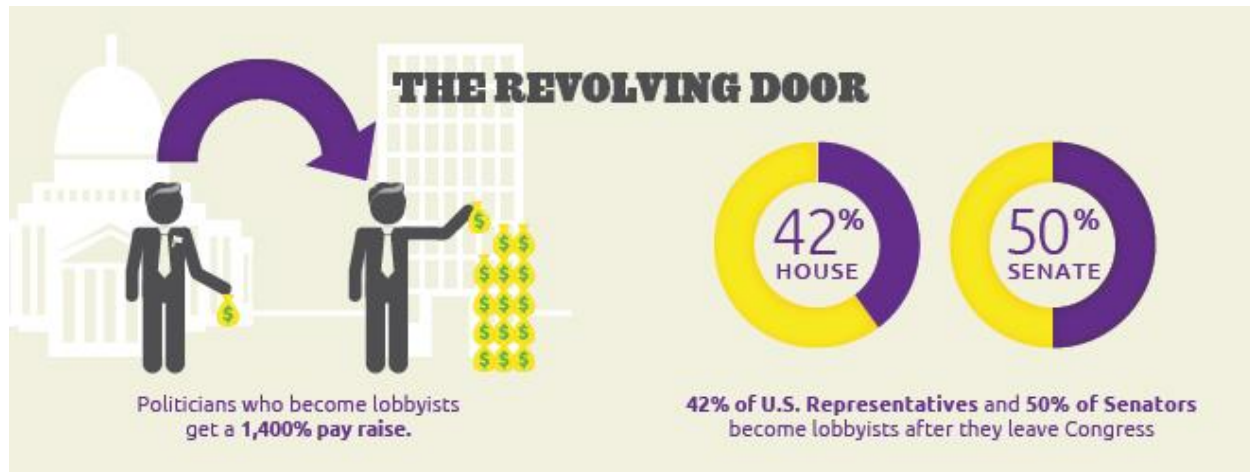
#### 1. Lobbyists Raise Millions for Congressmembers' Campaign Funds.



Getting into and staying in Congress takes a ton of money these days: **On average, a candidate has to raise more than \$14,000 a day, 7 days a week to win a Senate seat. And a candidate needs upwards of \$1.6 million to win a seat in the House.**

In September 2013, Serco was accused of extensive [sexual abuse](#) coverups of immigrants at [Yarl's Wood Immigration Removal Centre](#) prison in [Bedfordshire](#), England <sup>[33]</sup> In August 2014, Serco was criticised for using immigrant detainees as cheap labour, with some being paid as little as £1 per hour.<sup>[34]</sup> The decision to give the firm a new £70 million eight-year contract to run Yarl's Wood has been criticised. [Natasha Walter](#), of Women for Refugee Women, said "Serco is clearly unfit to manage a centre where vulnerable women are held and it is unacceptable the government continues to entrust Serco with the safety of women who are survivors of sexual violence."<sup>1</sup>

Serco held a ten-year contract with [Bradford](#) City Council between 2001 and 2011 to manage and operate the [local education authority](#),<sup>[63]</sup> providing education support services to the City's schools. This period was marked with "real problems" according to senior council officials and was taken back in house by the local authority after this period.<sup>[64]</sup> Serco similarly manages and operates [Walsall](#)<sup>[65]</sup> and [Stoke-on-Trent](#) local education authorities.
