BRA Has Approved Tentative Designation For Four Navy Yard Buildings

The Boston Redevelopment Authority has approved the tentative designation for four buildings in the Charlestown Navy Yard. Several proposals for each of the four buildings were submitted, and on Thursday April 4, the BRA Board of directors tentatively approved proposals for Buildings 75, 106, 114, 266.

Basilica Associates has been tentatively designated as redeveloper of Building #75 in the Charlestown Navy Yard. As developer, they will be responsible for the restoration and renovation of the exterior of the building as

well as the construction of certain public improvements to the Second Avenue Pedestrian Mall directly adjacent to the building. Basilica Associates' proposal calls for the construction of 25,000 square feet of moderately priced office space all located at street level. The total development cost of the project is \$3,380,000.

BRA Director Stephen Coyle said, "The developer has agreed to conditions very favorable to the city and to the community of Charlestown. Not only will the property be fully assessed for taxes and will pay \$82,500

annually to the city, the developer will also make additional payments of \$.50 per square foot to support worthwhile social and neighborhood activities. Also, the developer has agreed to comply with the Boston Jobs Policy and will work to employ neighborhood residents both in the construction phase as well as in the permanent jobs.

Building #106 will also be redeveloped by Basilica Associates. This proposal calls for the construction of 71 residential units and 87 interior parking spaces. The

Public Hearings

CITY OF BOSTON CITY COUNCIL COMMUNITY DEVELOPMENT BLOCK GRANT PUBLIC HEARINGS

Under the Housing and Community Development Act, the City of Boston is expected to receive approximately 22.4 million dollars in Community Development Block Grant funds for Fiscal Year 1985. A series of hearings will be held by the Boston City Council to obtain views and recommendations of citizens. The hearings will provide citizens the opportunity to discuss the housing and community needs of their neighborhoods.


All hearings will be held in buildings that are accessible to handicapped people and all buildings will be open one half hour early for citizens to sign up to speak. Remarks will be limited to five minutes.

Eligible programs and activities under CDBG include: 1) commercial areas and housing rehabilitation, 2) acquisition, construction or rehabilitation of neighborhood centers, parks, streets and similar facilities, 3) demolition of dilapidated buildings, 4) modernization of publicly owned low-income housing, 5) housing code improvements and 6) neighborhood security and human services programs.

Needs Of Charlestown Elderly Topic Of Recent Meeting

In an effort to "maximize" participation in Charlestown, Commissioner of Elder Affairs for the City of Boston, Michael Taylor and his staff recently met with local residents, clergy and elderly service agencies to discuss elderly service needs which are unique to Charlestown.

According to Taylor, the Commission has set aside money to aid Charlestown senior services. This meeting afforded the Commissioner, as well as those in attendance, the opportunity to

establish priorities as to how the Commission and the agencies themselves may best service the community.

Charlestown, like the entire City of Boston, is experiencing a rise in elderly population and with the construction of three new elderly developments slated to open in the near future, this number is expected to increase. Presently, 20% of Charlestown's 13,500 residents are over the age of sixty, which is above the average of 15.8% for the entire city.

In order to service this

growing population, a plethora of agencies have emerged at the local, city and state levels.

These agencies include such services as legal council, nutritional, health, recreational and social programs, as well as transportation. In some instances, these services are duplicated by various agencies while other needs have been unaddressed.

Recent government cutbacks have forced many agencies to reassess their services. While some say that limited funds have forced agencies into a ring of competition, others state there is a real attempt to establish a better cooperative effort.

Here in Charlestown, those in attendance told the Commissioner and his staff that the common problem was the lack of communication and awareness between the various agencies and individuals in Charlestown who service the elderly.

Lack of funds has mandated an economical necessity for agencies to pool their resources. However, such

attempts have been hindered by this lack of awareness and communication.

According to Ellen Parker from the Commission, Charlestown has a reputation of "helping her own" thus "the connection between Charlestown and City Hall is not as strong as in other parts of the City."

Parker states the Commission has a neighborhood senior program in which an individual is assigned to a neighborhood in order to link elders with City Hall.

"Sometimes what works in one neighborhood doesn't work in all neighborhoods,"

stated Parker. In an effort to improve communication between communities and the Commission, staff members are assigned to work with the neighborhoods and be advocates on behalf of local elder concerns. Currently, a staff member has been working with the Charlestown Interagency Council on Aging (CIA).

Unfortunately, while the CIA, which was established five years ago, is intended to be a town-wide forum for all the elderly service in Charlestown, several present

were not aware that the organization existed.

"I have never heard of the CIA," stated resident Ellie Marino, an activist in local elderly concerns.

Sister Nancy Rowen of St. Catherine of Siena suggested that there was a need in the community for a "management person," which she termed "the missing link."

Parker agreed with Sister Nancy, stating one individual could coordinate all the agency efforts and pool available resources thus decreasing the duplication of services - saving time, effort and money.

Hank Sikkema, social worker at the Bunker Hill Health Center and active member of the CIA, stated, "Sometimes I don't know who to call or where to call," explained Sikkema, "One person would be better than having to go through 39."

The consensus of many present were expressed by Brian Murdoch, the new pastor of St. John's Episcopal Church.

"As I listen and as the new kid on the block, I'm adrift," stated Murdoch, "and from what I see here, I am not alone."

Murdoch stated he did not know where "the power base" of Charlestown was.

"Who is representing who?" asked Murdoch. "There seems to be a need

Facts About Drugs - F.A.D.

There are many questions that are asked over and over again about cocaine.

1. "Is cocaine addicting?" Unequivocally, yes, if by addiction is meant an irresistible compulsion to use the drug in increasing doses even in the face of serious physical/psychological harm and the change in a person's relationships and system of values.

2. "Why can some people use it without becoming addicted?" No one knows if this is true. The causes of addiction are unknown.

3. "Is cocaine pure?" It is almost never pure!

4. "Where do people get cocaine?" Usually from friends and co-workers. Also from dealers who hang out in parks, bars, and restaurants.

5. "How can I tell if my child is using the drug?" If he/she becomes secretive, shows extreme mood swings, loses interest in school/work/activities, has new friends, loses considerable weight in a short period of time, seems to be broke all the time, you notice things missing that belong to you (watches, rings, etc.)

6. "I try to quit, but I can't; why?" It is extremely hard to stop without help. You have to cut yourself off from friends who are using, from sources who sell, and you have to find support and new activities to occupy yourself.

7. "I had a seizure while on cocaine. If I use less, will it happen again?" It could, and seizures can lead to death. This is one of the serious side effects.

8. "I am going for a physical. If they check for drugs, will they be able to detect coke in my urine or blood?" Yes, there are very accurate tests these days. Traces can be found in the body for about a week.

9. "I feel addicted, even though I only use coke two or three times a month. Am I addicted?" You've given the answer: if you feel addicted, you are addicted.

for an evaluation here to see where a liaison may be needed."

Taylor told the pastor that the field of elderly services is an "overwhelming process" and while the commission is "trying to streamline as well as coordinate an effort mix, it is difficult to answer your question on a black board."

The Commissioner told those present elderly services exist in a realm which is "bureaucratic, complex, and overwhelming."

In addition to a management person, the suggestion was made for a centralized location.

The Kent Community School, which in the past has been utilized to house various senior recreational programs, was recommended.

According to Michael Griffin, the Director of the Kent Community School, building disrepair originally was responsible for the discontinuance of program-

ming.

"The Kent is a great resource," continued Griffin, "We would like to see it used again." Beginning next week, recreational programming will commence again.

Presently, the Kent is facing similar financial situations that the agencies are facing. Griffin stated that if funds were available, he would like to open the facilities on weekends, "maybe something that is built on a volunteer system which is widespread in this town," stated Griffin.

According to Taylor, the Community Schools programming once allocated money for custodial services for the weekends.

Griffin explained that funds from the City were restricted, but suggested, "Let's talk to people and address the issue on what people do on weekends."

Once established how the Kent could best be utilized by the Community, Griffin

stated the question of funding will be answered.

Among the other problems facing Charlestown seniors discussed at the meeting were the luncheon and nutritional programs, transportation, lack of affordable housing and a possible outreach program.

Sister Nancy asked the commission representatives where they obtained their information on Charlestown seniors.

According to Parker, the Commission utilizes demographics, government benefit workers and other "various providers" to the elderly as resources.

Resident Margie Kent stated her experience is that there are elderly in Charlestown who are left unattended.

Griffin agreed that "there are seniors who can't get out but want to get in touch with the world."

Sister Nancy suggested the possible establishment of a senior outreach program.

"Maybe we need a monitor-type thing," stated Griffin. "We have to look out for each other."

Another major problem which is facing a great number of elderly in the Charlestown community is the lack of affordable housing.

Charlestown is currently experiencing a dramatic increase in real estate activity.

As a result, property values as well as property assessment have increased.

Sister Nancy asked the representatives for assistance in the area of housing for Charlestown seniors. Some of the elderly who live in Charlestown are facing high rent and even evictions as property owners sell in order to jump on the condo conversion wagon.

With the median rent approximately \$400 per month, some elderly "have lived here all their lives and because of escalating prices they can't afford to stay," stated Sister Nancy.

Others, who own their homes are reassessed as the property value in Charlestown increases. However, according to those present, the elderly are not in the real estate business and

ty of the service, stated Taylor.

Margie Kent suggested that the Commission post the availability of the service in the various emergency rooms of the local hospitals.

Also discussed at the meeting was lack of attendance at the daily senior lunches, sponsored by the Kit Clark Senior House, at Elderly Lounge on Rutherford Avenue.

According to Joe Kent, President of the Board of Directors of the J.F. Kennedy Family Service Center, the luncheon site is only visited by approximately 18 persons.

"Why can't the lunch program work?" Kent asked, "There is something wrong when people would rather go to Woolworth's for lunch."

According to Ellie Marino, many Charlestown seniors have traveled to Somerville to partake in their elderly meals program.

Margie Kent stated that the number of seniors in Charlestown are there.

"We put on a senior luncheon at Thanksgiving and 300 people show up," Mrs. Kent stated.

Taylor stated there could be a lack of awareness on the part of the seniors regarding the program.

"Maybe people don't know about the program," stated Taylor. "Once something is there doesn't mean everyone knows about it."

Taylor also stated that there is the problem of stereotyping who is eligible for which programs.

"There is no income limit for the transportation or nutrition programs," stated Taylor. "It's up to us to break the stereotyping."

Kent refuted, "If they don't want to go, you can't force them."

Taylor told the group, "There is so much wrong information out there."

Margie Kent told the Commission, "That's because there is no communication."

In the end, the major problem which surfaced at the meeting was the communication barrier.

"We don't really get together and talk to each other," summarized Sikkema, "what I experience is a distance."

According to Sikkema, this "distance" is one which lies not only between the Commission and the agencies in Charlestown, but also between the agencies themselves and between the agencies and the population that they are serving — the elderly.

are not intending to sell their homes, nor do they intend to move from their homes where their memories are.

Resident Kay Whelan stated that as a result of the increasing property value, she lost her widow's abatement.

"I can't eat my house," Mrs. Whelan told Taylor.

Reverend Isaiah Sears, Pastor of the First Baptist Church, told Taylor that the elderly are caught in "a capitalist system."

John Ballard from the Bunker Hill Tenants Task told those present that while the task force was not town-wide, they have compiled information concerning condo conversion and would be happy to share.

"It's no great labor," Ballard told the group, since he has already assembled information on condominium conversion laws, as well as relocation benefits.

Sikkema stated he has never considered calling the Task Force.

"This is a case in point," stated Sikkema. "The CIA knows the Task Force exists, but I never thought of them as a resource."

Another concern raised at the meeting dealt with the issue of transportation.

Presently, the Commission has a Senior Shuttle Program in which 25 vans transport seniors throughout the city at an average of 12,600 rides per month.

The service, which is free of charge, provides seniors door to door rides throughout the city Monday to Friday from 8:00 a.m. to 4:00 p.m. and reservations must be made five days in advance.

However, since life is not nine to five, Taylor reported that Charlestown is one of four or five communities which will have extended van service in a pilot program.

Taylor stated that seniors may need additional hours to accommodate late doctor appointments or social events.

Medical trips will still remain the number one priori-



Massport Adopts New Two-Year Commuter Sticker Program

Massport Executive Director David W. Davis has announced that beginning on April 15, 1985, the Authority will offer a new two-year Commuter Sticker Program on the Tobin Memorial Bridge.

Current Tobin Bridge commuter stickers, which expire on Tuesday, April 30, 1985, are valid for a one-year period only. The new two-year sticker will go on sale on Monday, April 15, and will be valid from May 1, 1985 through April 30, 1987.

"Basically, the sticker program will remain exactly the same. Daily Bridge

commuters will still pay 30 cents to travel over the Bridge, but their commuter stickers will now cost \$2.00, instead of \$1.00, and they will now be valid for two years instead of one year," Davis explained.

In an effort to speed traffic flow, Tobin Bridge Director Joseph Greene said the other change in the program will require vehicle owners to remove old commuter stickers from their windshield. "This year Massport toll officers will not be removing old commuter stickers from vehicle windows. This should go a long way toward minimizing

back-ups and traffic delays during the commuter sticker sales peak, between April 15 and May 1," Greene said.

Tobin Bridge Director Joseph Greene also suggested commuters could avoid long lines at toll booths by purchasing their stickers during off-peak hours.

According to Greene, during fiscal 1984, more than 80,000 passenger car owners purchased the commuter stickers.

Members Of The Bunker Hill Tenants Task Force Attend Senate Hearing

On Wednesday, March 27th over 700 public housing residents jammed a legislative hearing at the State House in which the joint committee on Housing & Urban Development unanimously passed a bill that would essentially prevent the sale of state public housing developments. The bill moves next to the House of Representatives for further action.

The Committee's quick approval of this bill was prompted by the large turnout, which included over 40 residents of the Bunker Hill Public Housing Project, and near unanimous testimony in support of the bill (Senate Bill 948). Since 1979, this bill has been annually filed but has failed to pass the state legislature.

Mayor Raymond Flynn and Boston City Councillor Robert Travaglini were among the many city and

state officials urging the Committee's approval of this bill. However, it was the testimony of Boston Housing Authority Administrator Doris Bunte that finally moved the Committee into recess, whereupon they approved the bill.

In her testimony, Bunte

said that there are over 10,000 households, representing over 25,000 people, on Boston's public housing waiting lists. "The sad truth is that the Boston Housing Authority has become the only source of housing for the poor," said Bunte. Turning to the public

housing residents in the audience, Bunte continued, "No public housing will be sold while I'm the Administrator of the BHA. They'll have to get to me before they get to you."

In testimony submitted to the Committee, Mary MacInnes of the Bunker Hill

Tenants Task Force, outlined the common fears shared by residents of state and federal public housing developments. "We are afraid that the sale of state public housing will create a dangerous trend for the sale of federal public housing." She went on to state, "All

public housing residents face many uncertainties in their lives. The threatened sale of any public housing is a grave uncertainty that we should live without."

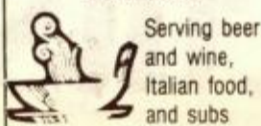

Italian-American League Names Nucci "Man Of The Year"

Boston School Committee President John A. Nucci has been named the 1984 "Man of the Year" by the Italian-American Civic League of America. The award will be presented at the annual banquet to be held at Caruso's

Diplomat in Saugus on April 19. Committee President Nucci, a first term member of the School Committee, will join the ranks of other former recipients including; Congressman Silvio Conte, Senator Edward M. Ken-

nedy, former Governors Sargent, Volpe, and King, and former U.S. Senator Leverett Saltonstall.

John A. Nucci is a member of the Boston School Committee representing District One, which consists of the neighborhoods of East Boston, Charlestown, and the North End. He is a

life-long resident of East Boston.

Nucci attended Boston Latin School where he played varsity basketball and participated in a significant number of extracurricular activities. Following Boston Latin, Nucci went on to earn a Bachelors Degree in Arts and Science from Boston

College in 1974. In 1979, Nucci earned a Masters Degree in Public Administration from Suffolk University and was nominated for Pi Alpha, the National Honor Society for Public Administrators.

Nucci has long been active in civic and community affairs.

Last year Nucci was elected, as a first-time candidate, to the Boston School Committee by an overwhelming margin. Political observers have noted that Nucci received a record total of votes in East Boston, exceeding any political candidate, proportionate to population, in the history of that community.

As a member in his first year on the School Committee, Nucci held a position of leadership as Chairman of the important Committee on Rules and Regulations, Vice-Chairman of the Committee on Intergovernmental Affairs and as a member of the Vocational Education committee.

Nucci was elected on January 7, 1985 as President of the Boston School Committee; the first district member to hold that office.

Nucci is married to the former Peggy Noons, a teacher of special needs children in Boston for eight years. They currently reside on Orient Avenue in East Boston.

apartments will be a mixture of one, two, and three bedroom units and the total development cost is estimated at \$10.7 million. This property will be assessed annually at \$104,000."

Mr. Coyle added, "Both proposals took into account the Harborpark guidelines and objectives, both in terms of design and use. The public improvements the developers have agreed to are needed and welcome."

The general partners of Basilica Associates, are NAGE Housing, Inc. of Dorchester, and Paul May of Brookline. Over the past few years, NAGE Housing Inc., has completed 267 residential units in Dorchester, Framingham and Canton.

Housing Associates has been given tentative designation as developer of Building #114. Housing Associates has proposed a mixed reuse with 70,000 square feet of professional office space and 10,000 square feet of retail space located in a portion of the ground floor. Total cost will be \$6.3 million. Primary office tenants are expected to be professionals in the law, architectural, engineering, and similar fields. The developer has also expressed a willingness to locate a community based group in the building at a reduced rent, thereby establishing a special and permanent presence for the community in the Navy Yard. Housing Associates, Robert H. Kuehn Jr., President, is a developer of mixed income housing and associated with retail space, which has completed developments in Boston, Chelsea, Pittsfield and Wayland, and currently has projects underway in Boston, Cambridge, and Nantucket.

The Conroy-Heafitz Development has been tentatively designated as developer of Building #266. Their proposal calls for the construction of approximately

25,000 square feet of office space, divided over four suites located in the building. Conroy Development Company and Heafitz and Company plan to relocate their offices in one of the suites, demonstrating, which, according to BRA Director Coyle, states "their commitment to the area."

Director Stephen Coyle summarized, "These four developments in the former Charlestown Shipyard will result in the creation of 130,000 square feet of new office and commercial space plus 72 units of housing. These projects will pay almost \$400,000 a year in real-estate taxes and nearly half that in annual rents. Community contributions by the developers will total in excess of \$144,000. Total construction costs will exceed \$20,000,000. Finally, the completion of these projects will go far toward providing the Navy Yard with the housing, commercial and employment space necessary to attract additional development interest."

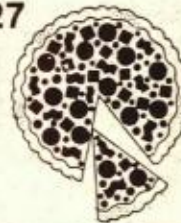
