Historic Steamship 'Nobska' At The Charlestown Navy Yard

The USS Constitution has a new neighbor, giving Charlestown residents and tourists another reason to visit the Charlestown Navy Yard. For the next two years, the SS Nobska, the last surviving coastal steamship in the U.S., will undergo restoration in Dry Dock 1, just 100 yards from USS Constitution. Visitors can observe work in progress as the historic steel vessel is repaired and upgraded in preparation for her return to service in 1998.

Launched in 1925 at Bath, Maine IronWorks, the 210-foot Nobska spent 48 years in service, mostly between New Bedford, Nantucket and Martha's Vineyard. As the only remaining coastal steamer, she was recently named one of America's 10 Most Endangered Maritime Resources, and her rare four-cylinder, triple-expansion

steam engine is listed on the National Register of Historic Places. It is fitting, therefore, that restoration is being done in the Charlestown Navy Yard, which is part of Boston National Historical Park.

"The Charlestown Navy Yard, with its historic setting and its preservation, education and interpretive functions, is the perfect place for Nobska's restoration," said John Burchill, superintendent of Boston National Historical Park. He noted that Dry Dock 1, Nobska's home for the next two years, was the first dry dock in the northeast, and that the USS Constitution was its first occupant in 1833.



Visitors to the Charlestown Navy Yard will be able to watch as Nobska's hull is surveyed and repaired. If safety permits, the ship may be opened for board-

ing, to give a closer view of her interior spaces and the work in progress.

The work is being done by the New England Steamship Foundation, a not-for-profit group that plans to return Nobska to passenger service between New Bedford and "the islands." According to NESF President David G. Pritchard, Nobska will be restored to "better than new condition." The vessel will be equipped with a first-class dining room, restorations of fine furni-

ture, wood trim, and specially designed carpeting, all in the gracious style of Nobska's original owner, the old Fall River Line. The ship will also house a museum of the history of the American coastal steamship.

"We invite the public to observe the restoration process," said Pritchard. "Nobska will be a living demonstration of a bygone form of transportation, a valuable educational tool, a practical method of passenger transportation, and a symbol of our nation's maritime heritage." Pritchard noted that once back in operation, Nobska will be self-sustaining and will not rely upon government funding.

Nobska can be viewed at the Charlestown Navy Yard every day from 9 a.m. to 6 p.m. Admission is free. Boarding the ship is not permitted at this time.

Charlestown Resident Lassoos Her Dreams

When the graduates fell in line to march to the traditional ceremonial music of "Pomp and Circumstance" at Bunker Hill Community College's graduation ceremony on May 31, among them was a graduate reminiscing about the circumstances that brought her to this significant milestone in her life. Luisa Guerra of Charlestown could visualize her childhood days and was secure in the fact that she was achieving her goal of a better life through a college education.

Born in Guatemala and raised in Mexico, she found that having a father who was an American citizen and a mother of Cuban descent instantaneously transfixing her into two cultures. She enjoyed the best of two worlds; living with an extended family in Nuevo Laredo, Mexico, while enjoying the advantages of traveling across a bridge to Laredo, Texas each day to receive an American education.

Luisa married her childhood sweetheart and settled in that small community until moving to the United States where their two sons Mauricio and Juan were born. Within a few years, however, her husband died, leaving her

alone to raise the boys. Faced with a new and challenging life, she and her sons traveled to Massachusetts to start a new life, finally finding herself settling in on High Street in Charlestown.

Over the years, the support of her family and, most importantly, that of her new husband, Noe, has sustained her. That support would be tested when she decided to quit her job and devote her time and energies in the pursuit of an education. Although Noe and her sons were understanding, she felt isolated when she no longer could take the time to visit her family in Mexico or find the money to send the customary gifts at Christmas time, birthdays or other memorable dates. This has been hard on Luisa, but she feels that all will be worthwhile when she fulfills her ultimate goal of becoming a physical therapist.

Luisa's academic perseverance at BHCC has resulted in her acquiring high honors in an associate in arts, Biological Science concentration degree. Her desire to excel has been discharged with energy, passion and enthusiasm, not only for her studies, but

toward her classmates, instructors and all others she has come in contact with, as well. Her generosity with her time and talent as a tutor has benefitted at-risk students in the college's Student Success Program as well as students of the Science Department. Further, she was selected by the Science Department to assist and mentor students of the Fenway Middle College High School participating in the grant for Science Laboratory Enrichment Program.

Additionally, her ability to speak fluent English, Spanish, and an understanding of Portuguese, enables her to volunteer as a mediator, representative and interpreter in legal and medical issues for refugees in Chelsea, many of whom come from El Salvador and Nicaragua in search of a better life. At Bunker Hill, she is a member and former officer of the Alpha Kappa Mu Honor Society, and serves in the capacity of Senator for the student activity group, "Older, Wiser, Learning Students" (O.W.L.S.). She has also been selected by the BHCC Dean of Students to be the student representative for the Presidential Search

Committee.

Luisa's ability to combine home, school, work and community service, has accorded her the 1996 Rosann Sperduto Memorial Scholarship. The award is given by the BHCC Alumni Association in memory of 1988 graduate, Rosann Sperduto, who exemplified a deep commitment to the mission and philosophy of the college through a record of academic excellence, despite personal challenges. The

award is presented to a female graduating student who has demonstrated "outstanding academic ex-

cellence and leadership abilities." Luisa truly possesses these virtues.

Accepted at Northeastern University this fall, she has been awarded a full grant package by NU to continue her studies in the demanding cardiopulmonary physiology program, with hopes of transferring to her chosen field of physical therapy in the future.

Luisa states that she is "excited, overwhelmed and thankful for her family's support in allowing her to achieve her dream to continue school and obtain a professional degree." She added, "It was hard to explain to my family why I wanted to pursue an education, because this was so unusual in my cultural background. They won't understand until I finish my dream." Today, that dream is closer to fulfillment.

Modica Attends National Security Seminar

District One Boston City Councilor Diane J. Modica participated in a week-long National Security Seminar sponsored by the U.S. Army War College at Carlisle Barracks, Penn.

Modica was one of approximately 140 business, government, media and academic leaders from across the country who took part in the seminar. The seminar was the capstone of the 10-month curriculum at the Army War College, the Army's senior educational institution.

"This was an excellent

opportunity not only to learn about the strategic planning process for national security, but to be given an opportunity to enter into dialogue with military representatives, civilians and foreign officers and get to know some of the prospective leaders of the American Armed Forces," said Modica. "This in turn, will enable the students of the U.S. Army War College to better understand the society they serve," she concluded.

Members of the War College Class of 1996, including officers from the

Army, Navy, Air Force, Coast Guard, Marine Corps, 38 foreign officers and senior civilian employees of the federal government, met in small groups with seminar participants during the week to discuss national security issues.

While the principal purpose of the seminar was to permit the War College student body to hear a "civilian viewpoint" on defense matters and domestic issues, it also gave participants an opportunity to meet and exchange views with the nation's future military leaders.

A NEW LAW AFFECTS PENSION BENEFITS

Suppose Joe spends all of his working life in State A. Upon retirement, he moves to State B and begins drawing his pension, which he earned in State A. Should State A (the "source state") be able to impose income tax on Joe's pension?

Before President Clinton signed H.R. 394 into law early this year, a number of states were doing just that. Effective Jan. 1, 1996, however, states are prohibited from taxing most of the pension benefits of non-residents.

This issue has been relevant to many retirees, especially those who have moved from high-income tax states, such as New York and California, to states which have no income tax, such as Nevada and Florida.

Protected by the new law from source-state tax are all benefits paid by qualified retirement plans and by state and local government retirement plans. Benefits paid by non-qualified retirement plans are protected if they meet either a "payout" or "excess plan" test.

The "payout" test is satisfied if the non-qualified benefits are payable in substantially equal amounts at least annually over the life or life expectancy of the retiree (and of a beneficiary, if designated), or over a minimum of 10 years. The "excess plan" test is met if the non-qualified plan is designed solely to provide a participant with benefits that could not be provided in a qualified plan because of statutory limits. For example, only a limited amount of compensation may be taken into account in determining an employer's contribution to an employee's qualified plan. If the employer makes up the difference by providing a highly-compensated employee with additional benefits under a non-qualified plan, that would be the type of "excess plan" covered by the new law.

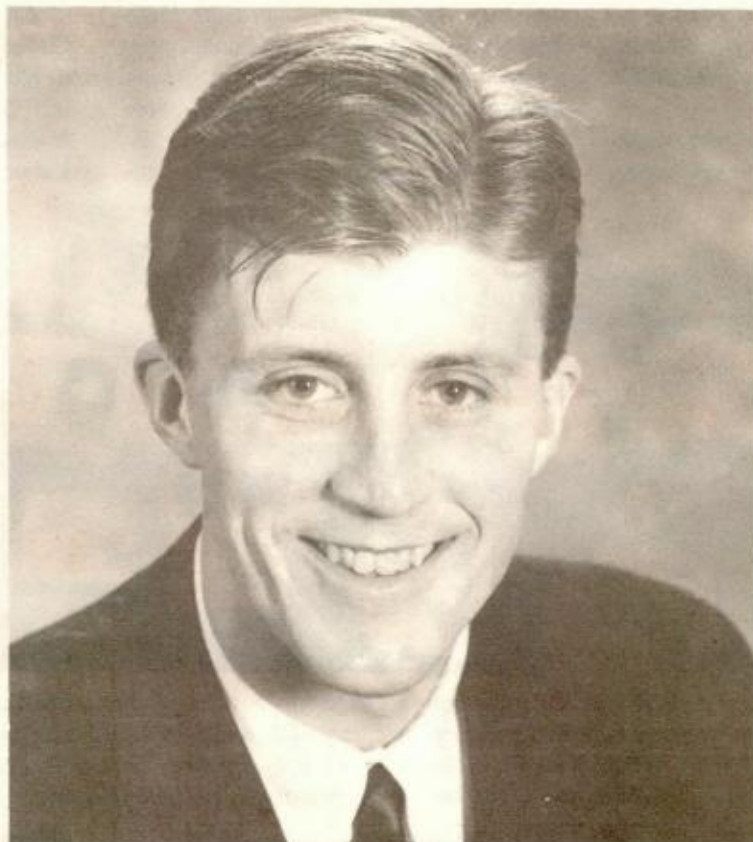

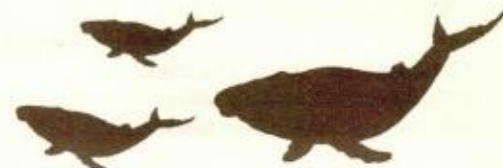

HELMETS ARE KEY TO BICYCLE SAFETY FOR CHILDREN

Warm weather signals the return of bicycle season for approximately 20 million children across the country. Ralph Minear MD, chief of Pediatric Medicine at the MGH Bunker Hill Health Center, wants to remind parents that a little prevention goes a long way in ensuring that children do not suffer from bike injuries.

Each year, approximately 500,000 children are hurt in biking accidents. "Most of the injuries are minor; scraped knees and elbows, small cuts and lacerations," said Minear. "But some injuries, particularly those involving head trauma, can be very serious."

Although head trauma is the most serious of biking injuries, it is one of the most preventable. Minear encourages children and adults, who bike ride to wear a bicycle safety helmet every time they ride. By doing so, they can reduce their risk of head injury by as much as 85 percent.

Bicycle helmets have an outer shell of hard plastic or fiberglass and an inner liner of hard styrofoam to help cushion the head during an accident. Chin straps and proper fit are essential to ensuring the correct positioning of the helmet for each individual. When purchasing a helmet, parents should look for an approval sticker from the American National Standards Institute or the Snell Memorial Foundation, signifying that the helmet meets proper safety standards.

Because some children may resist wearing a helmet while biking, parents may find the following tips helpful:

- Set a firm, non-negotiable rule: No helmet - no bike;
- Be a good role model and wear a helmet while biking;
- Explain as simply as possible to the child the dangers of head injuries;
- Make sure that even young tricycle riders wear their helmets. Children are never too young to begin wearing helmets; and
- Teach children the rules of the road.
