

GOING ON IN ERETZ YISROEL \equiv

Until now -

>1999

Every Chareidi is exempt from the IDF.

There are no laws in existence at all regarding who will receive a postponement. A Dichui is granted to any individual who affiliates themselves as " torasi Umnusai".

1999

The Isreali High court rules that a draft law for the bnei hayshivos must be put into place.

September 1999-A committee is formed to draft the new law. (known as the Tal committee)

April 2000

Tal report is released. The report states that the government will do what it takes to integrate the chareidim into Israeli Society. (i.e. The IDF, The workforce)

July 2002

Tal Law is passed.

The law states that every yeshiva bachur is entitled to a dichui.

The law also states that the government will be opening chareidi friendly units in the IDF to encourage the chareidim to enlist.

Rosh Chodesh Adar 2014

Rabbonim, Gedolim and Roshei Hayeshivos lead the ייעצרת המליוןי. The million man protest takes place in Yerushalayim. All gather to protest against this terrible new decree.

2014

The government is headed by the leftist Yesh Atid party.

A new law is passed known as Tikun 19 which requires army service for all chareidim.

2012 - 2014

No laws regarding Bnei hayeshivas are in place. All Yeshiva Students are to be drafted.

2012

The Israeli High Courts annuls the Tal Laws due to its ineffectiveness in getting the chareidim to join the military.

2007

The Tal Laws are extended for another five years.

December 2015

A new law is passed. (Tikun 21)

Tikun 21 is a basic repeat of Tikun 19 with minor changes and additions.

It states that all draft laws will begin in 2017 and continue to be put in place over the next six years. This period of time will be known as the Tekufat Hastaglut. (adjustment period)

7017 - '18

Tekufat Histaglut begins.

Sept. - Tikun 21 is rescinded. If not replaced by legislation within 12 months every chareidi will be drafted for military service excluding 1800 "exceptional students", who will be eligible for deferment.

Facts and numbers that are bound to surprise you...

By the Numbers:

- **5599** חרדים have served in the IDF in the years 2010-2013.
 (תשובת המדינה לבג"ץ אלול ע"ו)
- 4774 חרדים have served in the IDF in the years 2014 and 2015.
- Since Feb 2017 more than 500 בחורים and Yungeleit sat in prisons for refusing to enlist in the IDF after registering as required. (972.2.6745054
- 20 בחורים are presently (FEB 22018) sitting in military prisons

- for refusing to enlist, after loosing their מעמד בן ישיבה. (718.355.9116)
- 3200 The required number of בחורים needed to fill the quota of חרדים in the army for this year. Another 2000 are required for שירות לאומי (Civil Service) חוק תיקון)
- *are lurking in our ציידים *are lurking in our חרדי circles to recruit the most vulnerable of בחורים and .
- 5474 cases have reached the

desks of the following organizations this year. These organizations are there to help those who are having difficulties receiving their דיחוי (postponement).

3019 מרכז הצלה cases in the past year, of those 219 for girls.

1455 איגוד בני התורה הספרדים cases in the past year, of those 128 for girls. (2025 since its founding)

1000 הצלה לאחים cases in the past year (1800 since its founding) and have assisted approx. 500 imprisoned individuals.

Besides the overflow of phone calls for basic guidance and consulting.

חרדים Recruiters hired and trained specifically for the purpose of recruiting חרדי: *ציידים.

These recruiters are taught to look out for the בחורים that either come from homes with financial difficulties, יתומים or the like that will not be able to stick up for themselves.

By the Laws:

- During תקופת ההסתגלות (adjustment period) (present-2023), the annual quota of חרדים required for military service will increase every year. (21–12)
- Every Yeshiva will get three surprise inspections by the Defense Ministry throughout the year to ensure that the number of דיחוים reported from that year is accurate. (צוות בין משרדי עמוד לפול משרדי עמוד Besides their right to show up with out any notice and ask any for their documents.

 (מוק 19-21 סעיף 49, אור בחור)

The following is part of the sub-laws called the תקנות מוד which have been signed into law in recent months.

- בולל ישיבה A כולל or ישיבה building that was built without a legal permit will lose its right as a recognized Yeshiva. (Meaning: they lose their right to give postponements (תקנות הנלוות ב טעיף 6 אינ)
- בולל A כולל that doesn't have a minimum of 5 draft age students (under 24) will not be considered

- a recognized Yeshiva. (סעוף 4. 1,א,ב
- One who is not registered in yeshiva for 14 days loses his status as a ben yeshiva.
 (תקנות הנלוות סעיף 8)
- From the year 2020 a yeshiva of less than 40 תלמידים loses its status as a registered yeshiva.

 (תקנות הנלוות בי סעיף 4 אי 2)
- בחור A בחור learning in a כולל for married men loses his status as a ben Yeshiva. (תקנות הנלוות בי סעיף 1)

Chilling Facts:

- The creation of all the tens of laws regarding who is considered a ben yeshiva is only with the intent to get as many בחורים to lose their privilege to a דיחוי.

 This leaves the בחורים in a bureaucratic mess which makes them easy targets.

 (יחוק תיקון 1-12 סימן ו)
- All lawyers representing clients in the military courts say that almost never in the past did they see חרדים in military court. Today, it's a weekly occurrence.
- They are specifically looking to target בני הישיבה and not just working boys or half day learners. (22 עמוד 6298/07 עמוד 6298/07)

- Tens of professionals sit in the draft office seeking vulnerable targets.
- A monetary reward is given to those yeshivas that have בחורים enlisted in the army.
 (צוות בין משרדי עמוד 23)
- A separate, חרדי only, draft recruitment office was opened, where all the חרדים go to register every year, called the מרכז מיון. It is widely known as the ממ"ח.
- Over the years, tens of committees have been formed to deal with the problem called "
 The חרדים and the IDF"

- The Government is working hard to do what it takes to make the eye accustomed to seeing מרדים in uniform. (תשובת המדינה לבגייץ)
- The Israeli Government expects it to take thirty years to change the face of Charedi Jewry in ארץ ישראל. They have unlimited time and funding and are totally committed to getting the job done right. (אוועדה עמוד 8)
- The military never enforced the laws on who is eligible or not for a מעמד בן ישיבה. when a complication occurred they soon closed the case for lack of public interest (22 הוועדה עמוד 22)

Where we stand today....

Let's explain.

Never did one dream, that the situation would look the way it does, as a result of the new laws.

Of course no one wants to see the authorities drafting our frum ehrliche brothers.

No one likes to hear about those who are entangled in a bureaucratic mess and are having difficulties obtaining the necessary exemptions.

We cannot bear to hear about those sitting in prisons al Kiddush hashem because of their refusal to enlist after trying to obtain a מעמד בון ישיבה

So why all the confusion?

The law stating that quotas need to be filled every year, is not the obligation of one specific individual or group. That leaves it with the government looking to recruit those whom are the most vulnerable and easy targets.

So yes, your uncle, cousin or relative living in בני ברק or בני ברק probably had no issue obtaining their דיחוי. Those with strong community ties, those learning in standard are getting their ישיבות easier than ever. Ask them, they'll tell you times are better than ever.

But now you know the untold story. The story of איתמר and איתמר. The story of those living on a small מושב or city such as מושה or city such as . Of those that don't have money, ties, or connections. It is those and yungeleit who are calling out for our help. (Names taken out of files in מרכז הצלה office)

Be aware, that three quarters of the חרדי population is spread out in over 180 small cities and towns other then Yerushalaim, Bnei Berak, Bet Shemesh, etc. חוברת יישום חוק טל עמוד)

On an average day, the various organizations field approximately 25 such phone calls.

(תשובת המדינה לבגייץ תשעייה עמוד 76) "ממה אנחנו הכי מפחדים? שהדבר יתפס אצל הציבור כגזירת אנטיוכוס" . To quote

"only quietly will we be successful"

The Israeli Government realizes that the more public interest, the more we protest, the more unsuccessful their plans are likely to be.
