





Tokenization is the next evolution. Tokenizing an asset involves issuing a digital token on a blockchain, whereby that token represents an underlying tangible or intangible asset. In this way, the economy value of the asset is conferred to the token. Ownership of the asset is represented by ownership of the token on the


