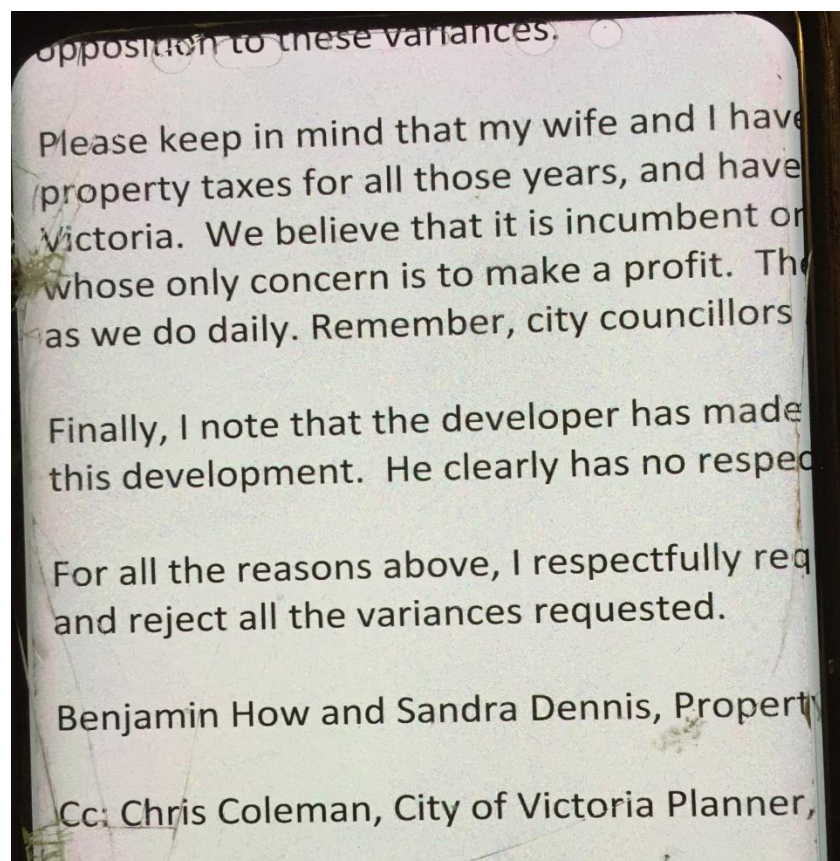

This paper' is concerned with an examination of the powers and obligations of the private prosecutor in Canada and with assessing the viability of retaining such a role in the light of modern judicial developments.² For the purposes of this study, a **private prosecutor is taken to be an individual, group, or corporation (other than a public authority) not acting in any public capacity.**³ Although theoretically most prosecutions are "private" in the sense that they are pursued by various **public officers** who **have no powers beyond those of the private citizen**, they are not private prosecutions in the sense of the term as used here ⁴

⁴ Cf. Howard, *Criminal Justice in England: A Study in Law Administration* (1931). At p.3, Howard refers to Maitland: "Professor Maitland thought that it was misleading to speak of the English system as one of private prosecutions. 'It is we who have public prosecutions', he wrote, **for any one of the public may prosecute**; abroad they have state prosecutions or official prosecutions'."

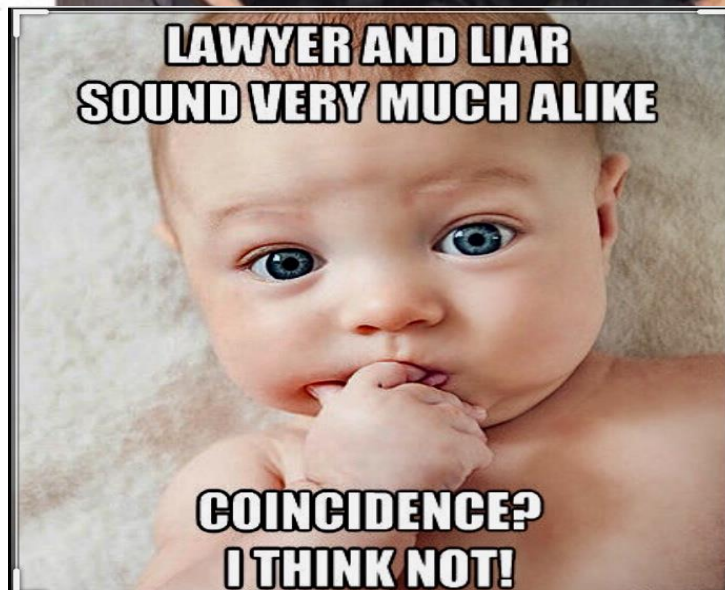
