

**WBISR RANGE WAIVER**



(Must be completed upon your first visit to the range, expires 1 year prior to signing)

I, my agents, assigns, executors or administrators, for the consideration of being allowed to enter and use the facilities, gun range and/or other products or services of WINDING BROOK INDOOR SHOOTING RANGE, LLC, do now hereby absolutely and unequivocally release and hold harmless WINDING BROOK INDOOR SHOOTING RANGE, LLC, its agents, lessor, officers, employees, instructors, assigns, owners and successors from any claim, demand, injury or liability, whether claimed by myself or another, arising out of such use of the facilities, products or services of WINDING BROOK INDOOR SHOOTING RANGE, LLC. I am fully aware that there are substantial risk to my person in the use of firearms, ammunition, indoor ranges and related products or services that these risks include gunshot wounds caused by myself or by another, or by ricochets, inhalation of lead vapor or other poisons, **(IF PREGNANT OR BELIEVE TO BE PREGNANT YOU ARE NOT ALLOWED ON THE RANGE)** and damage to my hearing from the high sound levels, or to my vision or skin from gunshot flashes and other dangers not listed herein. I do hereby accept full responsibility for my own safety, I understand that I must abide the posted rules of the range, and wear eye and ear protection at all times that I am inside the range area. My signature below confirms acceptance of this waiver of liability.

In the event that minor(s) are accompanied by me, I hereby affirm that I am the parent/legal guardian of said minor(s) below the age of twenty one (21), and further affirm that on behalf of said minor(s) I absolutely and unequivocally agree on his/her/their behalf to the conditions of release stated above

**THE FOLLOWING ACTIONS WILL CAUSE YOU TO BE REMOVED FROM THE RANGE IMMEDIATELY:**

1. INITIALS \_\_\_\_\_ Shooting the range equipment, walls, floor and/or ceilings, or target CARRIERS
2. INITIALS \_\_\_\_\_ Pointing any firearm at anyone – even unintentionally
3. INITIALS \_\_\_\_\_ Handling a firearm behind the safety line and/or out of the shooting booth
4. INITIALS \_\_\_\_\_ Disruptive/combatative behavior with range staff or any range patrons

### **General Gun Safety Rules**

1. Always treat every gun as if it were loaded at all times.
2. Always keep the muzzle pointed in a safe direction. For this facility, the only safe direction is downrange!
3. Always keep your finger off the trigger and out of the trigger guard until ready to fire.
4. Always know your target & what is beyond it (walls, floor and/or ceiling).

### **Range Specific Safety Rules**

1. **Ear and eye protection MUST be worn BEFORE entering the range and at ALL TIMES while inside the range firing area.**
2. Open footwear is **PROHIBITED** on the range
3. Proof of valid Tax stamps for NFA classified firearms must be provided if being shot on the range
4. Range owner, management and staff assume no responsibility for **ANY** firearm brought onto the range or any actions resulting from the use/misuse of those firearms
5. If any problem should occur while on the firing line, leave your firearm at the position and contact the Range Safety Officer immediately
6. Smoking inside the building is prohibited
7. No food or drink are allowed inside the range firing area
8. Black powder firearms are prohibited
9. Tracer and steel core/steel jacketed ammunition is strictly prohibited and grounds for being removed from premises
10. Rapid fire must be limited to 5 rounds or less
11. "Bump Fire stocks", "Gat Cranks" and devices designed to allow for an approximation of automatic fire are prohibited
12. Only holsters that provide for the dominant side carry and with a covered trigger guard will be permitted. If the muzzle points up range at any time during the draw the holster will not be allowed. The Range Staff's decision will be final
13. No one will be allowed to go forward of the firing line at any time under any circumstances
14. Children must be supervised at all times and will not be allowed to roam freely about the premises. No one under the age of 21 may fire without an adult on the lane with them
15. Firearms and range bags may/will be inspected by the Range Staff at any time while in the range facility. Any firearms the Range master deems unsafe will not be permitted in the range firing area
16. You may only clean up your own brass. DO NOT remove brass from the brass buckets or brass previously left by other shooters
17. Only those persons who have purchased range time are permitted inside the firing area. Observers may watch from the observation area only.
18. Up to four persons may be assigned to each lane, however only one person may fire or handle a firearm at the firing position at a time
19. Alcoholic beverages and illegal substances or persons who have been consuming alcoholic beverages or illegal substances will not be allowed on range premises.
20. Firearm(s) may only be holstered/un-holstered, cased/uncased at the firing line, the muzzle must remain pointed downrange. Firearm(s) may only be carried behind the firing line to transport in and out of the range, if you do not have a case, bag or holster. Any firearm(s) carried in this manner must be cleared by the Range Safety Officer first.
21. Point shooting/Instinctive Shooting/Hip fire are prohibited at this facility.
