On September 09, 2021 at approximately 1110 hours, I, Deputy Cody Baker #554 along with my Field Training Officer J. Rose #544 with the Henderson County Sheriff's Office, were dispatched to make contact with Misty Kennedy. HCSO Communications provided phone number for Misty.

Communications advised Misty wants to file a report for adult type photographs being solicited to minors. Communications advised Misty has the pictures that where sent.

I made contact with Misty Kennedy (W/F 03/10/1984) via telephone. Misty stated she has an Only Fans and posted photographs of her breast on the website. Misty said someone purchased a membership to her profile on Only Fans and took screen shots of her photographs from her profile. Misty said the person then created a Snap Chat profile and sent friend request to several juvenile males in the 9th grade that attend Eustace High School along with herself. Misty said once she added the profile on Snap Chat the owner of the profile posted her pictures onto the Snap Chat story to where everyone that is friends with the account can see them. I told Misty that I would come speak with her at her residence.

Upon arrival, I made contact with Misty and asked her what happened. Misty stated that she made an Only Fans profile and posted photographs of her breast onto it. Misty stated someone bought a subscription to her profile and took photographs of her photographs she had posted onto the profile. Misty said the person then created a Snap Chat profile and sent friend request to approximately 31 juvenile boys that are in the 9th grade at the Eustace High School along with her. Misty stated as soon as she added the Snap Chat profile as a friend the creator of the account posted her photographs onto the Snap Chat story to where everyone that is a friend of the account could see them.

Misty said she had the name of the account that took photographs of her photographs off of her Only Fans profile, in which she stated the name for the account is Davey Crockett and the user name is U170669168. Misty stated the name on the Snap Chat profile is Christian Shepard and the username is Badmomsleaked69. I asked Misty what her user name is for her Only Fans profile in which she stated it is Sassypants16. I asked Misty what day the pictures where added to the Snap Chat story in which she said approximately August 28, 2021. I asked Misty if she knew who might have done this. Misty stated her son, who she identified as Justice Pinker, told her that a Cody and Grady Mclemee have been bragging to his girlfriend, who she identified as Diamond Bowls, that their mother, who she identified as Crystal Ream, had taken the photographs and posted them on Snap Chat while they were sitting in the living room watching her. I asked Misty if she had a phone number for Crystal in which she said it is

I asked Misty if she knew the names of all the juveniles that were added by the Snap Chat account. Misty stated she could not remember all of the names at this time, but said she could get them once Justice got home from school. Misty stated the names she could remember were

Grad and Land

Misty stated this was happening, because some mothers brought kids over to her house to jump her son in July and when they could not beat her son up they started going after her.

Misty completed a voluntary sworn written statement form. I took photographs of the screenshots Misty stated were posted on Snap Chat and asked her to email them to me as well. I then provided Misty my email address.

I then attempted to make contact with Crystal via telephone at the number Misty provided with no success. I left Crystal a voice mail asking her to call me back.

I then went to the Eustace High School and spoke to the School Resource Officer Amy Hillhouse. Amy stated Misty contacted her about the incident. Amy stated Misty could not provide any pictures that were supposedly sent to the juveniles. Amy stated Justice informed her that the incident that happened in July were he was jumped did not happen at his house. Amy stated Justice informed her it happened at the mail boxes located at Morningstar and County Road 2938.

Later in the afternoon of August 09, 2021, I got a call back from Crystal Ream (W/F

Crystal stated she knew of the Snap Chat situation due to moms calling her about their sons seeing the photographs. Crystal stated she did not have a Snap Chat nor does she know how to work Snap Chat. I asked Crystal if she had two sons by the names of Chat nor does she know how to work Snap Chat. I asked Crystal if she had two sons by the names of Chat nor does she know how to work Snap Chat. I asked Crystal if she stated she does. Crystal stated and Shap do not get along with Justice. I asked Crystal if she knew the names of the moms that called her. Crystal stated their names are Okemah Neeper, Angelia Burelsmith, and Leticia Carpenter. I asked Crystal if she had phone numbers for them. Crystal stated she was currently with Angelia. I asked Crystal if I could speak with Angelia in which she said yes and handed the phone to her.

I spoke to Angelia Burelsmith (W/F was added by the Snap Chat account and he showed her the pictures. I asked Angelia if she remembered the day in which the showed her the pictures. Angelia said she does not remember the day but it was approximately 1 or 2 weeks ago. I asked Angelia if she had any more information about the incident in which she stated that she did not. I asked Angelia for her phone number in which she said it is told Angelia if I had any further questions I would give her a call. Angelia then handed the phone back to Crystal.

I then told Crystal that if I had any further questions that I would give her a call and made sure the number that I had was a good call back number.

I made contact with Leticia Carpenter (W/Formal). Leticia stated she is friends with Misty and Misty posted something about the incident on FaceBook and she saw it. Leticia said she then asked her son told her that he was and showed her the pictures. Leticia stated she took photographs of the pictures and was going to go to the school to see if they knew about the incident. Leticia stated her husband Kenneth Carpenter the outdoor education teacher at the Eustace High School told her to just let the School handle the incident. Leticia stated after she talked to Kenneth, she deleted the photographs from her phone. I told Leticia if I had any further questions I would call her back.

I did not make contact with any of the juveniles associated with this case at this time.

All photographs obtained will be attached to this report.

This case will be active pending further investigation.


