He, with the help of our organization, took initiative to sow paddy with SRI method in his one Katha of agricultural land. Before doing this, he underwent our training on 'Paddy Cultivation through SRI method' and then planted paddy nursery with 250 gram of PRH 10 seed provided by our organization. After this, harvesting of paddy was done under supervision of our organization. Sunder was very happy to see the return on his investment. Total 106 KG of paddy was produced with this kind of investment in 1 katha of land. This gave him a confidence to grow more and more paddy's in future by using SRI method and PRH 10 seeds. This particular incidence has generated interest and created positive environment among other villagers to grow paddy with the same kind of seeds and techniques. Now, villagers are demanding and requesting us to ensure availability of sufficient quantity of PRH10 seeds during next sowing period of paddy so that real ray of development can arrive.

### **Agriculture SRI Programme**

Improvement in land crop productivity of small and marginal farmers resulting in increase food security and income to small and marginal farmers.



- To promote SRI and SWI among 400 small and marginal farmers.
- To increase paddy and wheat productivity.
- To increase food security and agriculture income.
- To develop a community cadre of 20 community resource persons (CRPs) for sustaining the knowledge and practice.

#### **Achievements**

- 300 Small and marginal farmers have done practice change to SRI –SWI and have increased crop productivity and improved the household food security.
- 20 community resource people are trained to provide continuous support to farmers towards practicing SRI way of farming.



#### **Use of organic manures:**

Organic matter is the food for life forms teeming in the soil. When organic matter is added the microorganisms in the soil multiply manifold. The microorganisms bring nutrients into available form and are made available to them as and when they are needed.

#### **HEALTH AWARENESS PROGRAMME**

The programme was conducted in Muzaffarpur district of Bihar state to ensure health awareness among the community at the lowest rung of the society on the economic ladder. To provide better health services, some of the key components of the Health training programme were to make the SHGs women have a perspective on life skill education and psychological interventions and ensure knowledge about RH issues, Health and hygiene habits etc.

The organisation organized Health & Family welfare programme for poor. The health of a nation is a sum total of health of its citizens and communities. To achieve this goal total participation of its Citizens, Communities, NGOs and the government is essential. There is a considerable challenge for optimising the existing rural health infrastructure through the country. Health care is a matter of People. Let us make it matter to people through NGOs.



Towards building an enduring rural society, the breaking of the Vicious Cycle of malnutrition and ill-health necessitates formulation of a set of distinct but mutually related strategies to combat the inextricably linked socio-political and economic factors that cause ill-health, and adversely affect the livelihood. Therefore, Critical Public policy making and Strategic programming, cast in partnership and network mode, can alone bring about overall health development of communities and individuals. The bottom line of all prosperity and health in future should be a development process and outcome that is essentially facilitated by

development partnerships and networks, which nurture as well as further the goals of health and human development with focus on 'putting health into the hands of the people.'

The basic objectives of Health Care Programme, run by OUR society are:

- Develop and implement a community based, low cost primary health care programme for communities, supported by the partnership of private doctors, & referral services.
- Organize effective action oriented health workers, who will initiate and manage health care programme.
- Train the health workers, for the community.
- Nutritional feeding, health education and training, functional literacy and primary health care compliment each other.

The family welfare programme was started by the society with the objective of reducing the birth rate to the extent necessary to stabilize the population at a level consistent with the requirements of the National Economy.

Society organised family welfare programme in many places of Bihar state. The literacy rate of the states are very low and the need of aware of the people fact that a small family is a healthy one. The effectively couple protected.

About this programme main view of the society is to provide family planning services within the broader context of maternal and child health care. It disseminates information and education to enable couples to make voluntary informed choices regarding size of the family and spacing through contraception.

### **Rural Development Program**

To promote self governance we have formed and strengthen 5 Farmer Club in the intervention area of the project. They have capacitated for accessing their rights in the community. Community people, stakeholders, service providers and parents have also sensitized on the issues. Inclusion in the society, cooperation, self governance & self decision for development are the main concern of this activity. Apart from this thrift and saving habit also promoted among disabled, parents and non disabled people. The grass root level organizations have to be integrated with Block and District level network for effective advocacy for realization of the rights to the PWDs. They have act for all aspects of rehabilitation such as accessibility, coordination, advocacy, and policy influencing for the PWDs. Capacity building training to SHGs Members and leaders organized on the purpose of group roles and responsibilities of each members for socio economic development of the members, leadership development, saving & credit, accounting and book keeping and on purpose of group formation, role & responsibilities, role of good leaders, community development . These activities motivate the SHG and DPO leaders.



### **Plantation programme:-**

The Organization conducted Environmental Purification awareness programme in which people were advised using of less polluted fuel, garbage- containers, environmental sanitation and plantation work in the using of environmental friendly goods. They also suggested to tree plantation in the society.
