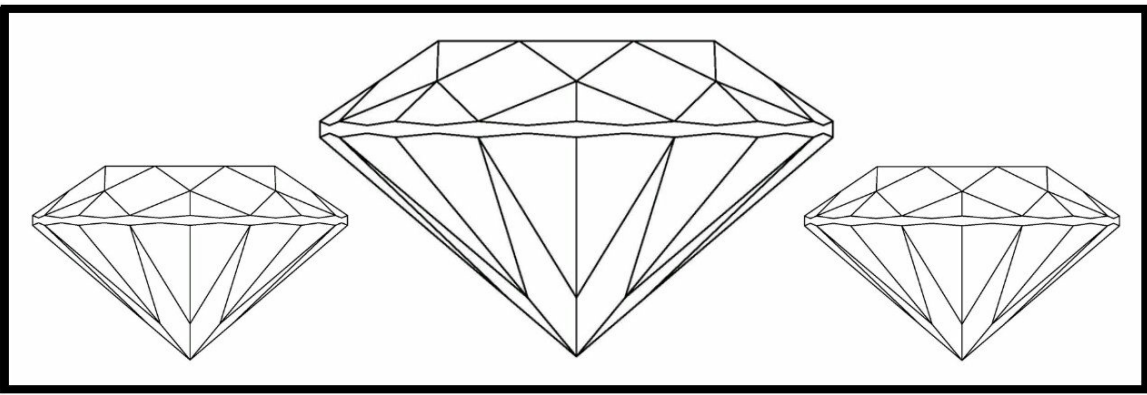



ID's Silvester Declaration for Global Motivation & Act

1. Each state declaring these document therefore confirms its own genuine interest in supporting the growth of our world and a network of world politics is always for the purpose of peace and security, always just over the horizon combating and preventing crime, to eliminate terrorism and those who commit crimes and they are therefore harmful to our entire world.
2. Declaration own basic rules as the format of the International and the National System of Governments and States parties declarations and, therefore, the system ensures our common security and certainty of success in co-operation against crime as an act of a global nature, in order to expand our rights, freedoms and equality policy states.
3. System Declaration divides the interaction of subjects according to their composition and naturally available power official and physical performance, so that the group could collectively sync and thereby create a common step that will expand our joint strategies and measures to prevent crimes and terrorism, which are based on bases in the structure of our International Politics and government bonds Nations.
4. States therefore agree a jointly and thereby affirm that their aim will be to cooperate in the interest of states' rights around the world, and their interest is purely political and strategic for a really good purpose which is based only on justice and legal essence. Governments of countries therefore always refuse to follow the practices of friendship and dependence with devotion for his own party closed entity which is active in crime and in the interest of its own stability criminal activities, and such entity is abusing its friendly and ideologically simmlar Network therefore to enable the criminal to continue to expand its own actions crime and benefit or criminally develop over the loss of all of us, and in record numbers throughout human future.
5. Each country's government because it has never confirmed prefer their friendship before principles and policies and duties, since such duties are of major importance for the future and development of our entire world!
6. Governments of countries will jointly meet the act of declaration therefore confirmed that every function of our system and also the rights to serve for the continuous development and mobility for a global expansion of our forces applying common and interactive steps to prevent the growth of crime and such use.
7. Declaration system and deals with the rights of states, such as defining strategy multilateral cooperation Governments and the achievement of full isolation and global forms of isolation and spacification of criminal entity, thereby allowing enforcement, investigation and immediate punishment.
8. Governments of countries therefore will jointly declare their interest in a joint declaration therefore represents interactive act for the realization of the natural principles of prevention, and the states will not accept any claims arising from the principles of criminal law created entity, and for his defense of these activities.
9. Governments of countries jointly declared and thus perform that anyone

- who is suspected as an actor in political crime at the level of a breach of a bilateral, multilateral principles reference to any law, or the realization strategy entailing the development of crime and terrorism to damage the rights of states, nations, human rights and justice, States will then jointly implement strategies sanctions and isolation against any such criminal entity, and it will be applied to performance and opens the possibility to enforce criminal and replace the importance of other, be the official or person responsible for office profesion or in educating their professional and management position.
10. Outlaw is a politician or a civil servant and employee who violates the rules of International reference to the declarations and obligations of the responsible State and the criminal system violates International policy cooperation of several states who are therefore unable to take legal claim on principles agreed upon by treaties and agreements Declaration.
 11. Outlaw is a politician or a civil servant and employee who abuses the government positions for their own benefit is, thus damaging the principles of the constitution and laws of the state and start constitutional disfunction in country, or that harm legally claimed justice of another entity, groups and individuals.
 12. Outlaw is a politician or a civil servant and an employee which extends its own interactive network of alliances at the state level, governments and International politics and implying an act of abuse of power networks for exercising their own illegal interests for profit and activation of group movement as an organized criminal group.
 13. Outlaw is a politician or a civil servant and employee who abuses their own state position to achieve such activity is designed to support another group at a level of organized crime.
 14. Outlaw is a politician or a civil servant and employee who supports, promotes or produces movement in the form of genocide, occupation of state discrimination at International level against apartheid entity with legal interest and purpose.
 15. Everyone who is active in the crime must first be convicted of a crime, therefore, to be launched system of punishment and deprivation of any legal capacity.
 16. Anyone who is suspected of a crime must always promptly and voluntarily undergo a police investigation trilateral way, and supervision of International and Independent party.
 17. Anyone suspected of a crime always own the full right to self defense, and all evidence. If the rights are damaged, the investigation and its outcome is losing legitimacy.
 18. If the resolution as criminal responsibility of the crime, the criminal will be primarily discussed Authority created the multilateral side, and that a decision on the ratification of the strength and class of crime and a criminal liability.
 19. In the case of low category of crime because of inadequate capacity to provide prevention, as an act of efforts to redress the damage caused from crime by the International party declarations thus recognize the right to prosecution under the Declaration, thus stopping also the process of determining criminal responsibility, but the suspect had not a crime repeat, and the suspect must also attend regular checks to investigating police.

20. If criminal surpasses the value of first degree criminal, and his responsibility will be on the level of strong criminal and anti-national character, the villain will be put into immediate liquidation process using a strategy of global declarations.
21. Spare a person is elected immediately when selecting a group of parties in the management of a single legal unit which is based on having a criminal infiltration actor detrimental to the rights and claims of safety and justice.
22. If a replacement official person not realize be elected party management group, then that means that management group as a single legal entity or a coordinated system that acquires criminal responsibility for crimes committed in internal party, act as accomplices and crimes doeth. Therefore, the option may take a second body as a form of global system of states and governments of the countries participating declaration. Party Declaration therefore have a right to make their own choice of operators who will carry spare surveillance and maintain a strategy for security and crime prevention. The new elected body is a figure based on its own network membership management group in the same state or origin, possibly abroad. Chosen subject because create their own responsibility, meaning immediately assume the office of interests and broaden its objectives and the strategy of stabilization.
23. Strategy eliminate crime in every way interaction between all structures always based upon the obligations of all parties Declaration, to ensure full disslegitimation against criminal entity and this instantly and immediately apply sanctions blocking performance, meaning legal rights, commercial law, media law, social law.
24. This means that the criminal loses authority and legitimate value clerk this and at the same time any claims to participate in the activities of the authorities, and in the same manner implies a suspension of all rights and trade agreements at the level of markets and contracts with other traders or institutions, blocked accounts in the bank and full blocking access to any of their own possessions. Blocked person because of the crime, thus losing the right to move media or use any right which means the ability to influence society and the people or state and international policy, any act and subject to public text and the report must be audited by the Commission of the creation of the special representatives of international structure declaration states. Felon can not use intercourse in the social structure or within their own family and close friends, until when will release. Criminal must be immediately isolated and locked in a controlled area.
25. States in the volume declaration therefore further have a common duty to motivate other players in close of criminal networks or management location, because together managed to create opposition against crime, support the protection of the innocent, to ensure the function of the media, uncensored and fully informing and mobilizing the society and also promote the transformation of society in order to create Public equilibrium means that maintaining stable relations and rights, thereby ensuring an independent ability to act for the purpose of peace and elimination of criminal threats without delay.
26. Everyone who will be invited to the cooperation must therefore immediately and instantly achieve the full interaction and without delay or

respect for the hand crime because of any kind of affection. Crime can not be supported in any way and thus must each with full readiness to support the full ensure stability among all states and parties, and thereby also create the ability to instantly create an act of immediate dismantling a criminal organization.

27. If a crime is active in the management structure of one group, the group is liable for the removal of a criminal organization. If the group does not own sufficient capabilities for specification and removal of criminals, the group owns the rights to request international assistance.
28. If the group is not active in order for the removal of criminal networks in the structure of the management, it will be open access and the right to breach the integrity of the body and the state party in the act of global forces all governments which are jointly activated in order to eliminate crime. The Declaration also affirms so that each state owns the rights to integrity but criminal entity therefore lose the rights of membership in state and national representation, and therefore criminal entity also loses the right to own integrity and protection of such claim.
29. States reference to a declaration not to support any act constituting blocking media freedom, in order to restore and stabilize the injured persons and entities crime, acts detrimental to the application of justice and freedom to states.
30. States' rights may be exercised on behalf of international organizations, which affirmed their interest in cooperating in this document in the act of declaration of the democratic majority of the Member States or the main deciding authority.
31. As a special imunity, any loss of property caused by the act of the crime, and thus the global interaction in order to suppress the crime, it will always be the responsibility for full compensation and interest to everyone who carried out the crime and the crime and cooperated or refused to support measures to ensure the security and justice.
32. As special imunity, but such is not entitled freedom of movement to prevent such an act on the principle of full accountability criminals, if the movement prevention is not reasoned, or excessively abused target solution, meaning violation of states' rights and justice of every individual, if it is not of primary importance are justified.
33. Each country's government owns a duty to support the operation of the system immediately to prevent loss of the reasons for co-dependence, and it will be assigned to a new office or official who replaces the performance of the criminal entity, or possibly obtain certification that replaces the legitimacy of business and financial resources that are owned entity Crime.
34. Gain certification as a substitute for having a criminal business capital or performance of the system means the right to take responsibility, and thereby expand their own management and strategy shifts and trade, and temporary or operational forms investment guarantees after dislegitimation of criminal properties. This creates a strategy to develop alternative certification for management and printing for the budget state financial and currency management accounts, determination of the sale of commercial materials and products, but also other raw materials earmarkable value.

35. Each state and government of the country therefore undertakes, always will enforce justice and promote the recovery of all the criminals in order to allow pacification and international act to punish or full liquidation.
36. Parties declaration jointly confirm that this will be treated on a range of multilateral volume, as well as when you created the ideology and the same look to foreign parties.
37. Declaration of a cooperation agreement for the purpose of enforcement and punishment, and especially full weakening of powers political criminals and means of creating a multilateral authority.
38. Authority in this respect composed of Constitutional courts of the governments of countries that are members of the declaration. This gives rise to the format of the International Tribunal.
39. An alliance of all the courts and enforcement cooperation judgment. This creates a format capabilities globally enforce all political criminals and political dissidents, traitor.
40. If the policies of political crime, that by all governments of the countries participating in this Declaration, will jointly mobilize logistics courts of their own country, and it will be claimed, meaning power entitling every court in the country for the calculation of relative political crimes in the interest of their country and so, in this dimension the judgment of the court on behalf of each separately according principles of country jurisdiction.
41. In the act of issuing judicial rulings, it will open an International tribunal composed of representatives of all the major Constitutional courts, and therefore will be created Judicial Council over the foundation of the unity of all court rulings from the Constitutional court.
42. Courts countries will jointly form a union that will represent the common judgments as a single act, and thereby gain the right to use the joint forces in multilateral frameworks, in order to immediately enforce all criminals and those responsible for the crime.
43. The first execution of the sentence performs the country who own jurisdiction as the state becomes a place of crime and damage a country or as a main objective for criminal damage.
44. Each member of act Declaration also own claim to support the development of intelligence act and thus in their own proposals and strengthen the growth and development of a system guaranteeing our strength and success in a global organization, but always with the proviso that the rights of the Declaration must not be influenced and changed the level and format meaning that damages ability to apply the measures of prevention and politically criminal entity, and may not be changing or in any way affected for the purpose of giving special rights to dominate the bureaucracy and entitlement abuse for their own benefit, to any other subject who is a member or not a member of this act, the declaration on combating and liquidation crime!
45. Act declaration may be made by any party of government, without distinction of membership in an international organization or at the level of ideology, culture, race or national nature of the system and state system.
46. When the Declaration, the Treaty shall enter into force on the first day of the declaration. If Democratic Force government decides to defer the validity, therefore, it may be time to form a first force adjourned to a

maximum of six months.

47. State that declares the document must ensure also store it in the hands of the person responsible national scale, and thus ensure legal handling of the document by the obligations and rights of the state and the constitution of such management.
48. Declaration document also implies the creation and the position of the Official Secretary which therefore will supervise and document management secretariat.
49. Stopping the validity of the Declaration and the termination of cooperation can only state that does not contradict international investigation of the reason apart, and the investigation on suspicion of an attempt to silence the responsibility of the crime.
50. In the case of confirmation of successful investigations and impunity for crime, can then be applied to the termination declaration six months from the date apart from the declaration.
51. Governments of countries have the right to ratification and the declaration of a cooperation agreement against crime.
52. Political people have a right to rule, the country presentations agreements offering the Declaration, and that political parties have the right also to mobilize cooperation at the government & state level.
53. Political parties have the right to use the document agreement to create a coalition of political parties that determine the strength of democracy obligation of the government to declare a document.
54. Political parties and jointly have the right to motivate people, because a nation to determine the state of democracy, meaning a decision at all International law obligations to act government recognition of the country as an entity representation for the state.
55. State's own right to create a petition to expand media cooperation and support with the motivation to organize cooperation with by the state associations and communities to exercise powers of the national movement as entitled The State of democracy decisive on the state of self-determination of sovereignty, and thus also the results and the rights of governments, as well as government declarations.
56. Political parties, together with the state party movement have every right to ask for the formation of groups and supervisory committee for human rights and democracy and justice and the legitimate function of the state. The Commission will be based on the elected representatives representation for political, security and humanitarian organize declared state, and that together and with the right performance of this members of foreign parties. The Commission is determined over rights observers act as a reporter and organizer of the movement of world politics.
57. State party movements and political parties can use the generated power of democracy and a network of global support for the purpose of stability civil rights, the ability to secure their own democratic stability for the organization in the direction of opposition against corrupt parties in the government, creating a bureaucratic opposition and infringement of democracy in order to maintain stability own political network active for the purpose of crime.
58. The country's government does not own any rights to determine and the decision to block the petition or national movement, all rights are reserved

and recognized by International law. If in this case the government of the country in any way harm the free development of the state of democracy, media freedom, the rights of freedom of association and movement, or violation of Human Rights of any individual, then the government of the country in such a case, announced their own opposition to the International rights and above all, a natural consequence and damage stability own sovereign rights. Therefore, the government of the country could lose International recognition and respect, and the nation has the right to use the state of democracy for the purpose of electing a new government.

59. The process does not entitle exploit the situation for the separation of territories integrity as an act of self-determination of the state. The act of dividing the territory as national self-determination can be exercised only in the period of the function of the legitimate government of the country and, together with the common peace agreements in accordance with principles of International law.



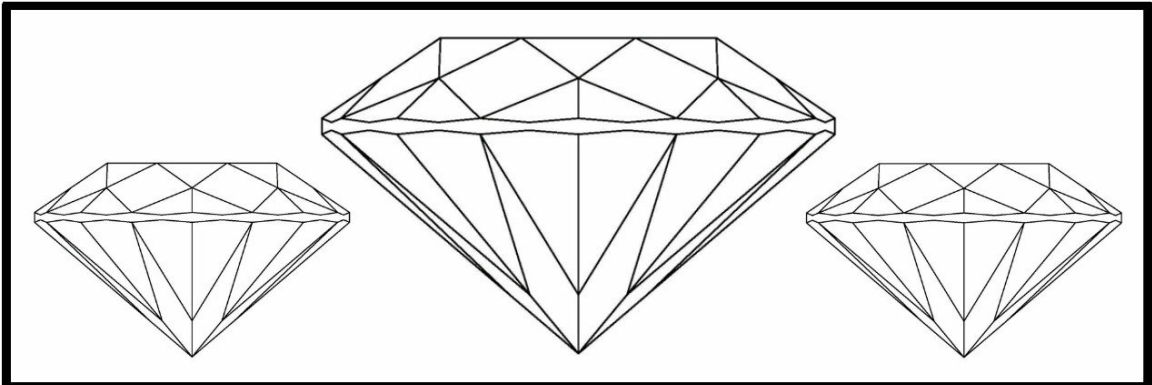


