SUBJECT: **Award of Contract No. 1220-040-2023-006
2023 Pavement Restoration – Operations Management**

RECOMMENDATIONS

The Engineering Department recommends that Council:

1. Award Contract No. 1220-040-2023-006 to Grandview Blacktop Ltd. in the amount of \$1,669,556.91 (including GST) for annual pavement restoration services for a one-year term;
2. Approve the option to extend Contract No. 1220-040-2023-006 for two additional one-year terms at the City's discretion to provide annual pavement restoration services;
3. Set the annual expenditure authorization limit for Contract No. 1220-040-2023-006 at \$1,800,000 (including GST and contingency); and
4. Authorize the General Manager, Engineering to execute Contract No. 1220-040-2023-006 and approve all optional extensions within the approved annual expenditure authorization limit.

INTENT

The intent of this report is to seek Council's approval to award Contract No. 1220-040-2023-006 for annual pavement restoration services required as part of the Engineering Department's annual maintenance and rehabilitation program. The Contract is for a one-year term with the option to extend the contract for up to two additional one-year extensions at the City's sole discretion.

DISCUSSION

Scope of Work

This Contract provides the supply and delivery of labour, material and equipment for asphalt pothole repairs and minor utility trench repairs on arterial, collector and local streets at various locations throughout the City. The repairs will prolong the existing road structure, as well as provide smoother and quieter travel for both vehicle and cyclist movement along these roads.

Quotation Results

A Request for Quotations was posted for the subject Contract on the BC Bid and City websites in January 2023. The quotations were opened on February 6, 2023, with the following results:

Evaluation

The quotations were reviewed for accuracy and completeness. Grandview Blacktop Ltd. submitted lowest quotation and their submission was compliant with the Contract specifications. Grandview Blacktop Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. Therefore, it is recommended that Grandview Blacktop Ltd. be awarded Contract No. 1220-040-2023-006.

Project Schedule

The project work will be completed by December 2023.

Funding for this contract is available in the proposed 2023 Transportation Budget.
