with the offense of

MALICE MURDER, O.C.G.A. 16-5-1(a)

For that the said accused, on or about the 14th day of August, 1991, in the State of Georgia, County of Bibb, did unlawfully, with malice aforethought, cause the death of Sabrina Long, a human being, in a manner unknown to the Grand Jury, contrary to the laws of said State, the good order, peace and dignity thereof.

COUNT NO. 3: And the Grand Jurors aforesaid, upon their oaths aforesaid, in the name and behalf of the citizens of Georgia further charge and accuse

MELINDA HILL MCSWAIN

with the offense of

FELONY MURDER, O.C.G.A. 16-5-1(c)

For that the said accused, on or about the 14th day of August, 1991, in the State of Georgia, County of Bibb, while in the commission of the offense of Kidnapping, a felony, did cause the death of Sabrina Long, a human being, by means unknown to the Grand Jury, contrary to the laws of said State, the good order, peace and dignity thereof.
