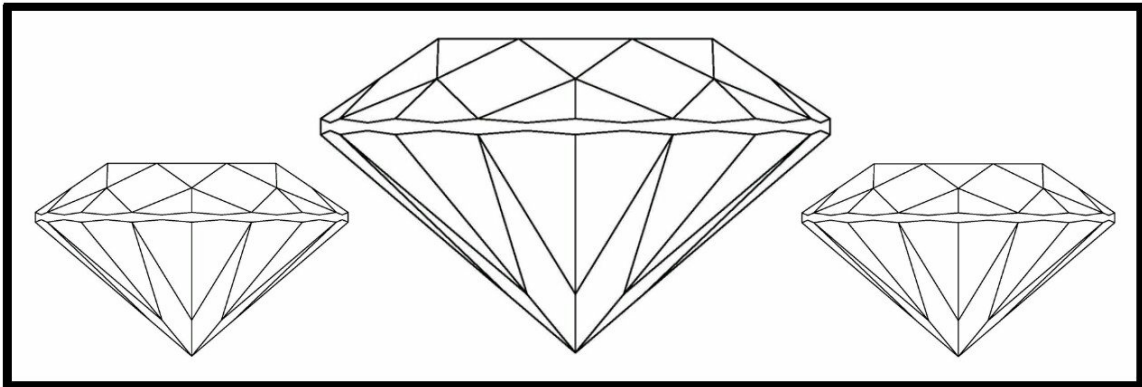

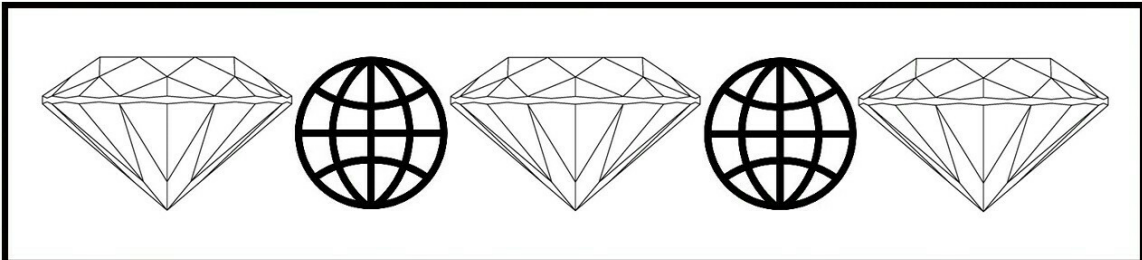

My performance, King Gottwald Peter, representing the Imperium of Diamond's federal government, with the right of claim since 1998, is now under the illegal blockade of European Terrorist States, which violates the international rights of states and nations, So also with the security rights and principles of political moralism.

Therefore, it is part of my text, also a request to answer the question of what your policy interests are in terms of today's European Terrorism. Today, I have to really point out the fact that your country's government is getting into confrontation because of contact with a terrorist entity, as well as full support for the protection of such a criminal, and a strong suspicion of co-organizing the steps of terrorist strategies and espionage against a legal entity.

That is why, repeatedly, my fundamental request to resolve the dispute of conflict and stop cooperation with terrorists. European governments are active in crimes that go beyond statistics of World War II crimes.

Subsequently, my application for resolving legal interests in corporate relations and ID's copyright for strategic development. My own loss only from the International market is already at the level of € 1,000,000,000,000 in a minimum range. Therefore I really need to stop your act of violation my patent and business claims.

In the same interest, I affirm that if your party does not want to respect my copyright, then I, in this case, will also point out that I will be forced to use International arbitration or multilateral relations development that guarantee full demands for unlimited execution. Therefore, it is certain that such debts are legally enforceable and, simply because of the incurrence of debts, your government has the full right, in the interest of your jurisdiction, to exercise the right to punish all persons liable in the United States of America.

In the same case, if your party rejects its own function in accordance with the principles of International legitimacy and the nature of your current position of cooperation and support for a terrorist entity of the European States, this may lead to a full act of International law renouncing the legitimacy of your government, of each country, to assume the trade and patent rights of your country, to all corporations and businesses that are active under the jurisdiction of the United States of America.

That is why I hope your party will build on legal procedures and respect for the stop relationship with terrorist parties, because it is most important to prevent the growth of other unnecessary problems and crimes or terrorism.

Today's European systemic genocide already exceeds 350,000,000, and more than 2,000,000,000 people from all over the world are in full decentralization to know about their rights. Today, there is a threat of the First Global War, which is a life risk for up to 7,000,000,000 people around the world, and the stability of all peoples and governments.

My interests are open for friendly purpose and for the development of Peaceful Interest, I do not want to extend the problems between our parties, but I also do not want your USA Government party to be active in crime and support for the stability of a terrorist entity that is a threat to the world.

Therefore, I am asking for stabilization in accordance with the Charter of the United Nations and the rights of the first two articles, with my request to inform the US trade corporations and trade associations of the right to compensation for terrorist blockades of development, which in that case can theoretically bring to your state US economy up to € 100,000,000,000 to € 1,000,000,000,000 in basic dimensions.

The financial amount is intended to stabilize the ID's civilization and hence ensure the function of the state, also under the authority founded, for example, at the UNGA conventions on Political and Civil Rights, at the same time by the UNGA Convention on the Rights of the Nations for their Economic, Social and Cultural Rights, and according UN principles of Charter articles 1, 2.

If there were any grounds for damaging my business cooperation rights to the International rules on the right to free trade, then such objections do not legitimately exist because their justification is not real, or if such an opinion is created above the basis of a terrorist and criminal monopoly. Strategy of defend for criminal group site.

In the same case of development law, I would like in this interest to open the right of cooperation with the American Banks and the Banks in USA jurisdiction for ID's purpose of stabilization consumption with the base of the first investment of € 1,000,000,000,000 (DMD currency) in the first year as the Bank, So we are able to benefit from development projects from the previous year which therefore allows a budget of € 10,000,000,000,000 (DMD currency) as the basis of the common market by ID's government if trade and development cooperation agreements are established between us.

I offer in the next the possibility of investing in cooperation over the bases of the army, and opening up the possibility for the USA corporations, as well as with other corporations from foreign states, to expand cooperation on the basics of the common military industry's Act in ID's Territories. Intelligence ID's government allows for the production of, for example, 1,000,000 pieces of heavy military technology, and therefore also means the real ability to immediately cooperate to establish the strength of world peace without any risk.

I have been offering such capacities for many years, but your country government does not respect me responsibly, so there are often world-wide complications with terrorist and radical groups such as ISIL, ISIS, Al-Kaida, and other terrorist movements that have already had be removed long ago.

I offer a great deal of possibilities for our security cooperation, and I am able to guarantee you today that I can be responsible for the multiplicity of cooperation at NATO level but also for the formation of other USA supranational and bilateral security relations.

Today, however, it is of utmost importance for me to ensure my own official stabilization, and I therefore really ask, as well as the political parties of your states, as well as Congress and the USA Court of Justice, for the possibility of establishing cooperation with the USA Law Offices and Advocacy Associations.

My Call is for USA advocacy associations to be informed about the possibilities of collaborating on the basis of the International Advocacy Intelligence Council (IAIC). That is why my open communication capability and

the development of a full format of political logistics are opened without radical constraints on the part of the European Terrorist States.

Today, an illegal form of media blockade is being imposed against me, and I am, therefore, really in full possession of the inability to stabilize and use political rights and / or claims founded as a strategy established by international law.

That is why I am asking for the complete elimination of blocking in the media and for ensuring my ability to promote ID's development projects in the media as well as opening up information on confirmed crimes of European terrorist states. Your support for media censorship causes stability for the development of an organized terrorist movement in the structure of European politics and the state. Media censorship helped for a false turnaround in Turkey and the imprisonment or dismissal of all major state actors who do not support anti-terrorist interests. Similarly, media censorship supported the falsification of the Turkish elections for the support of the presidential power, the elections were fully publicly falsified, and in order to develop terrorist networks and maintain the stability of the terrorist entity.

In the same case, your USA government also supported the act of occupying and disrupting the integrity of my territories in puppet infiltration of the interests of the USA citizen who declared sovereignty in the territory of my country while being internationally falsified.

This citizen uses a consulate in the territory of your country. That is why I am asking your courts for the death penalty sentence in order to punish cooperation on monopolies, which also violates the legal image of your government, the level of the highest dissident and treason against the USA.

The USA publicly supports global terrorism and the severe damage to the rights of states. Your duty is to stop such practices and at the same time ensure the ability to eliminate criminal interests and such consequences.

Like my other, I request unblocking communication on media and social networks, stopping all forms by regulating the number of friends and followers, or any monitoring and other practices contrary to International law.

I confirm that because of my political interests, it is not my interest to visit the USA and any other country as a civilian. My interest is only at the political level and according to such agreements. That is why I immediately ask for all forms of monitoring my person to be stopped and for storing such data about my person. All possible data about my person is acquired and owned illegally.

I apologize for my criticism of the USA, but my personal knowledge suitable for use is based only on monitoring of constant fraud at the trade and copyright level, cooperation with European terrorist states, and many insults by your internal policy infrastructure and the state.

The USA Constitution is a document that gives the order of death to all state treasurers who are activated for the purpose of the rise of crime and deliberate state indebtedness. If your government ignores International law obligations and therefore your government is allowed to activate in this way for cooperation with terrorist actors of the European governments of the countries, then it means that the political people of your government, those who are responsible for such contacts, can therefore be judged As the treasurer of the state.

It is therefore necessary to inform all USA political parties, as well as the authorities. Europe's crime rates outstrip the highest level of the Second World War crime statistics. Therefore, it is also important to follow this dimension.

In the interest of the relationship between my person and the United States,

it can sometimes be complications with the basics of my strong emotional scene of hatred of racism and opposition, in my own closed. Today, I am under hypnotic dismanipulation and for the purpose of illegal monopolies, it is not easy for me at certain times to maintain my ability to concentrate in a personal, my own natural way, and therefore I often have to go for a short time for unjustified interests of emotional character.

At the same time, it is also certain that such problems are active here only because today I am illegally blocked on the territory of terrorist states, and in the same case, this is the reason why your constant support for the stability of European terrorist entities is supported by their own function of corruption according to strategic interest, and thus with the foundations for enabling the development of terrorism.



Today, your government is already aware of such a fact, but it does not try to take advantage of this opportunity, and at the same time it just follows the acts of robbing my party for business claims. 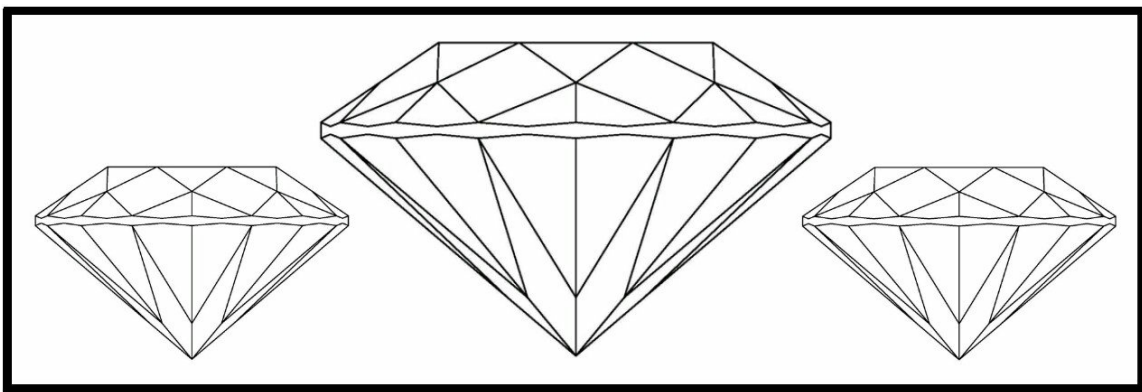

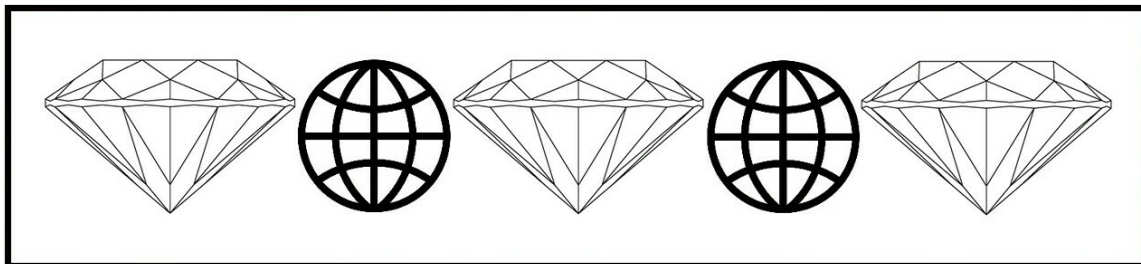
