\$250,000 Apprenticeship Grant Announced For Public Housing Youth



A CHECK in the amount of \$250,000 from HUD, which will be utilized to develop partnership between public housing youth and labor unions, was presented at a ceremony on Friday at the Bunker Hill Housing Development. The Department of Housing and Urban Development (HUD) has awarded a grant in the amount of \$250,000 to the Boston Housing Authority (BHA) in a partnership with the Laborers International Union of North America in an apprenticeship program directed toward youth living in public housing.

According to BHA Assistant General Counsel Stephen Holmquist, the program would initially involve approximately 20 youth between 16 and 24 who are residents of public housing. He said the grant will be used to pay wages, support services and training.

Holmquist said that 50 rcent of the time in the program will be directed toward educational services and activities. There will also be workshops focusing on life-skills, along with general construction skills utilizing the laborers' training facility in Hopkinton,

The BHA intends to place program graduates in permanent positions in the BHA's own operations and maintenance staff. He noted that this is a unique partnership between labor and public housing.

At this time, Holmquist stated that there is no timetable for applications, but it is hoped that it could get underway in the fall. He said that the BHA would be working with the development's tenants task force in accepting applications and screening candidates. He could not give a definitive number of candidates that would be accepted from the Bunker Hill Development.

Mayor Thomas M. Menino thanked HUD for this grant that he said would give young people who live in public housing a chance to be part of the "future of the city."





Voke And Birmingham Save Elders In Nursing Homes

Again taking up the fight for seniors in need of appropriate medical attention, Rep. Richard Voke and Sen. Thomas Birmingham recently led the charge to override two gubernatorial vetoes restricting nursing home access.

"The health and welfare of our seniors should not come under the attack of heartless budget cutters. Although try as they may to make it more difficult for seniors in need to gain lifesustaining medical attention, I have been able to again defeat these plans," said Voke, the House Majority Leader and a recognized leader in senior ad-

Birmingham, pleased that the Senate unanimously agreed to override the gover-

nor's veto, agreed: "Especially during periods of fiscal restraint, it is vital that we do what we can through legislative language and program design to maximize the options and benefits provided to seniors."

Legislative action was again necessary to protect nursing home residents from losing their beds when they are absent from the facility and to maintain clinical eligibility for Medicaid-funded nursing home care at its current level.

The administration wanted to kick patients out of their beds after 10 days of being absent for medical reasons or 15 days for non-medical reasons, and wanted to limit Medicaid-funded care to only the most severely disabled. Neither of these

provisions are in the best interest of our seniors as both would jeopardize the services they need to maintain a higher quality of life. I would never allow such a travesty to occur," stressed Voke.

"It is becoming increasingly clear at the federal level that many are considering major cuts to health care services for the elderly," noted Birmingham. "The Weld administration apparently has similar intentions. But in Mass., the legislature fought and won the battle to preserve current levels of care and maintain present nursing home standards."

The victory marks the second time Voke and Birmingham have had to protect seniors' rights to nursing home access. Back in 1992, the administration first attempted to implement these two provisions, only to be overridden then as well.

In arguing for the override, the Mass. Extended Care Federation expressed lose their homes or be denied access to necessary

"Constituents are often overwhelmed and bewildered by the programs and options governing the health care choices of the elderly," said Birmingham. "I am pleased that we can inform them that the governor's efforts to limit nursing home eligibility and access were successfully stopped."

"Having twice prevailed for seniors, I hope the administration gets the message," said Voke.



Consumer Affairs And Licensing Hands Down Decision On The Warren Tavern

The Charlestown Neighborhood Council Basic Services Committee, chaired by Bill Galvin, met on June 19 to allow neighbors to review the request and express concerns relative to a petition set to go before the Mayor's Office of Consumer Affairs and Licensing on June 21. The new owner of The Warren Tavern, Club Dining Concepts Inc., managed by Robert Seabury, had petitioned the Office of Consumer Affairs and Licensing for a seven-day entertainment license.

Following the meeting, a letter was sent to the Licensing Office by the Neighborhood Council summarizing complaints from the neighbors, and several abutters attended the hearing on June 21.

On July 5, Donna Mueller, director of the office, responded to that petition to operate and maintain a radio, cassette/compact disc player, TV, and instrumental/vocal music (no more than three musicians) daily until 1 a.m. at 2 Pleasant St., Charlestown, Mass. 02129, also known as the Warren Tavern.

Mueller wrote: After careful evaluation of the evidence proffered at the hearing, the Mayor's Office of Consumer Affairs and Licensing GRANTS a provisional entertainment license subject to the following conditions:

- 1. The request for radio, cassette/compact disc player and TV is granted with a cessation time of 1 a.m.
- 2. Amplified, live instrumental/vocal music (not to exceed three musi-

cians) is allowed only on Wednesday evenings. During any amplified performance the licensee shall install acoustical panels behind the band as represented in the letter dated June 26, 1995 from Custom Entertainment De-

- 3. Unamplified, live instrumental/vocal music (not to exceed three musicians) is allowed all other nights of the week.
- 4. Live instrumental/ vocal music, amplified or unamplified, must cease no later than midnight.
- 5. The grant of live instrumental/vocal music is a provisional licensing grant subject to review at any time, but no later than Sept. 30, 1995. During this time, the licensed premises shall be closely monitored for sound emanation problems. At the conclusion of the provisional period, the licensee may petition for a revision of the above conditions. It is recommended that the licensee continue to work with a sound design expert to reduce the potential of sound emanation.

6. A Disc jockey is currently denied, but may be considered for private functions if the above provisional period is completed without incident.

A review of the Licensing Division's file (which dates to 1987) for the premises known as the Warren Tavern, located at 2 Pleasant St. in Charlestown, reveals that the Tavern has operated with virtually no police citations issued to it except on the issue of music emanat-

Since 1987, the Warren

Tavern has been licensed for live instrumental/ voice music (three instruments). Although the license did not restrict the instrumentation to nonamplified music, the licensee indicated traditional unamplified instruments on its renewal applications for the years 1987 and 1988 (piano, harp and clarinet). Sometime in 1989, the format changed to include amplified live music. There has never been a condition that limited the live music

Beginning in 1989, the Licensing Division began receiving complaints about the music emanating from the Warren Tavern. This appears to have coincided with the switch from unamplified music to amplified instruments. The Licensing Division called a meeting of the licensee and residents.

to Wednesday only.

The licensee agreed to cease all live entertainment by midnight, keep the doors and windows closed and to monitor the volume (and change to a softer blues style of music). The next hearing on the complaint of music

emanating was in late 1991, for which the licensee received a warning.

Three years later, in late 1994, a police citation for music emanating was placed on file, on the condition that the air conditioner was repaired and the windows and doors would remain closed. Now in 1995 with the air conditioner again not working, a citation was issued for music emanating. The licensee has since installed a new air conditioner.

While the above history

indicates an ongoing problem associated with music emanating, four hearings in five years is not overly egregious, especially in light of the licensee's continuing effort to respond to the problem. However, as the residents noted, the problems with music emanating has been more consistent than indicated by the number of police citations and hearings.

Base on the above considerations, the Licensing Division will not issue an increase in the number of days for which the previous licensee actually offered amplified live entertainment. However, the provisional grant for Wednesday live amplified music will be closely monitored for emanation to the neighboring residences. It was noted that the licensee should be particularly mindful of the drums and bass which are more easily audible outside the premises.

Mueller concluded by listing the statues, codes and standards on which the decision was based.



EFL Notebook

Entering Saturday's Eastern Football League season opener against the Boston Cowboys, Charlestown Townies' Head Coach Jack Green didn't know what to expect from his ball club. After all, the Townies had not hit the field since the fall of 1993, and Green and Co-head Coach Jack Morris had not coached the Townies since the 1992

You can throw all those factors out the window, because if the Townies continue to play like they did this past weekend, they will give their opponents throughout the league fits all season long.

And, despite being on the short end of a 16-12 score, Green was pleased with the performance of his troops. "You guys did very well out there," Green said to his players after the game, a statement audible on the Cowboy sideline. "We have some things to work on, but you guys gave it all you had out on the field."

Charlestown, which held a 12-10 halftime advantage, fell behind in the latter stages of the third quarter when Boston quarterback Aaron Kelton trotted into the end zone from four yards away, giving the Cowboys the lead for good.

The Townies had grabbed the lead shortly before halftime when Eddie Sullivan hooked up with receiver Derek Tammaro on an 11-yard pass play, giving Charlestown the two-point advantage.

It was Boston that scored first, as Kelton broke the scoreless deadlock nearly four minutes into the ballgame on a five-yard run. Joe Caruso's extra point kick boomed through the uprights, giving the Cowboys a 7-0 lead. Boston gained possession of the ball after the Townies had a punt blocked in their own territory.

Charlestown would come right back. On the ensuing drive, Sullivan would put the Town Team on the board when he found Danny Ryan in the corner of the end zone from 17 yards out, cutting Charlestown's deficit to one point.

The Cowboys were not done there, though. Midway through the second period, Caruso booted a 17-yard field goal to put his team ahead 10-6. About six minutes later, Sullivan threw the pass to Tammaro that put the Townies ahead entering the intermission.

Ball movement was a problem for both teams, as the Cowboys were able to muster up only 117 yards of total offense, including 49 yards passing. Meanwhile, Charlestown did slightly better, as Sullivan threw for 128 yards on nine of 24 passing. The Townie ground game averaged slightly over two yards per carry.

Charlestown resumes action tomorrow, July 14, when they travel to Marlboro, (a winner last Friday), to take on the two-time defending National Champion Shamrocks at Kelliher Field at 8 p.m.


