

Three-Alarm Fire Damages Trenton Street Homes


FIRE FIGHTERS and fire apparatus fill Trenton Street on May 22, battling a threealarm fire that caused in excess of $\$ 250,000$ in damage to four homes at 7-13 Trenton.

Fifteen people were left homeless as a three-alarm fire struck four homes on Trenton Street on May 22.

According to Boston Fire Fighter Dave Walsh, the fire started in 9 Trenton St. and traveled through the attics up to 7 Trenton and down to number 11. He said that ceilings were pulled at number 13 to make sure that the
fire was out.
The first alarm was sounded at 6:17 p.m. Engine 50 called for a second alarm at 6:21 p.m. Edward Lorenzo, District Chief for Charlestown, was the first chief to aarrive. Deputy Chief Kevin Mocken was next to arrive and he called a third alarm at 6:46 p.m. Fire Commissioner Marty Pierce
arrived at the scene to direct operations. The all out was sounded at 8 p.m.

Damage to numbers 7 and 11 was estimated $\$ 50,000$ for each home and the damage to 9 was listed as $\$ 150,000$. There was no damage amount listed for 13 .

Walsh said the fire is of "undetermined origin" and is under investigation.

## Boston To Tow Large Commercial Vehicles And Trucks Parked Overnight On City Streets

Boston Mayor Thomas M．Menino has ordered that the city of Boston＇s Traffic and Parking Regu－ lations be amended to en－ sure that large commercial vehicles and trucks will not park ovemight on local res－ idential streets．

The new regulation gives the city stronger en－ forcement authority over an existing regulation that prohibits commercial vehi－ cles and semi－trailers hav－ ing a capacity of one ton or over from being parked on city streets for more than one hour ovemight or any time on Sunday．Vehicles parked in violation of this regulation can now be tow－ ed away rather than simply ticketed．Previously，tick－ eting was the only enforce－ ment measure that could be taken．

The towing component
was adopted in cooperation with neighborhood resi－ dents who complained about large commercial vehicles narrowing the tra－ vel lanes on local streets．
Other concerns includ－ ed reduced visibility，aes－ thetic issues，rodent infes－ tation caused by full dump trucks and a lack of on－ street parking spaces due to one semi－trailer or con－ struction vehicle taking up several parking spaces on residential streets．

Menino said，＂The top priority of the Transporta－ tion Department is to maintain safety on Bos－ ton＇s streets．Large com－ mercial vehicles and trucks create a public safety pro－ blem simply by being too wide for the narrow road－ ways of many of Boston＇s residential neighborhoods． The associated visibility
problem creates a hazard for both other drivers and pedestrians．I am pleased that we are taking this aggressive step toward im－ proving public safety for Boston residents．＂
Boston Transportation Commissioner Jack Magee added，＂It is estimated that there are now four cars reg－ istered in Boston for every resident parking space in the neighborhoods．The competition for an on－ street parking space in Boston＇s neighborhoods is tough enough without adding semi－trailers and construction vehicles to the equation．These trucks be－ long on private property in areas appropriate for this type of commercial activi－ ty＂．

The actual Boston Traf－ fic and Parking Regulation reads：＂Article X．Section

2，Part 2 （General Prohibi－ tions－Tow Zones）＂is amended by adding the following：
No driver shall park or stand any commercial veh－ icle or semi－trailer having a capacity of one ton or over for more than one hour between 9 p．m．of one day and $8 \mathrm{a} . \mathrm{m}$ ．of the following day，or at any time on Sunday，on any part of any street，way，highway，road or parkway under the con－ trol of the city，where park－ ing or standing a vehicle is not otherwise prohibited provided that this regula tion shall not apply during the actual loading or un loading of materials．＂
Enforcement of this regulation by both the Bos－ ton Police Department and the Boston Transportation Department is expected to begin in early summer．

## Somerville Rejects Cambridge Street Off－Ramp

In a rebuff to Central Artery／Tunnel（CA／T）Pro－ ject officials，Somerville aldermen voted unani－ mously at a public hearing to reject ramp CL（Char－ lestown to Local）that is currently under construc－ tion from Route $\mathrm{I}-93$ north to the Sullivan Square area． They also criticized CA／T officials for not coming to Somerville before this late date to discuss this ramp．
In 1994，the city of Somerville，in a letter to the project，rejected this ramp but had not heard any more about it until very recently． The aldermen and residents strongly criticized the lack of process and were upset that 1,500 vehicles during peak hours（p．m．）would be added to the already stop
and go traffic on Cam－ bridge／Washington streets， a location where Somer－ ville had tumed down a re－ cycling plant because of the number of trucks that would be using the road，a number small in compari－ son to the off－ramp traffic． CA／T officials had respon－ ded that whether the traffic comes from Rutherford Ave－ nue or Cambridge Street，it will still be there on Cam－ bridge／Washington streets．
In addition，Somerville officials let it be known that they were upset with the unsightliness of the salt piles owned by Mass． Highway that are located under the overpass between the Mt．Vernon Restaurant and the street to Assembly Square Mall．

The aldermen asked that the Rutherford Avenue Corridor Study include Somerville＇s Washington Street．
The aldermen also pas－ sed an order that the City Clerk notify the Mass． Highway Dept．of the Board of Aldermen＇s complete and unified opposition to the I－93 northbound off－ramp onto Cambridge Street， Another order was passed relative to changes that will impact on the flow of traffic into Somerville and also that a task force be appoint－ ed to study the affect of the off－ramp on Somerville．
CA／T Project officials promised to take the com－ plaints from Somerville un－ der consideration and re－ turn at a later date．

## I Am The Boys \& Girls Club - I NEED YOUR HELP

(continued from page one) been around long enough to have provided the same opportunities for your parents, your grandparents, and perhaps even their parents.

I have held my place at the current High Street location for over seventy years. That High Street building then became the Charlestown Girls Club, and in 1980 when the two organizations combined to create the Charlestown Boys \& Girls Club, I continued to serve the youth of this community from the High Street address. All of this history can be found on my facade which in one place reads "Charlestown Boys Club", in another, "Charlestown Girls Club," and finally in another, "Charlestown Boys \& Girls Club."

I guess what I am trying to say is that for some seventy years of my more than one hundred years of existence in the Charlestown community, I have served the youngsters from this High Street building.
The plan called for expansion, and with open area behind me, it seemed logical to move in that direction. My new wing would include, among many things, a badly needed, improved swimming pool. My library, computer center, art room and many other important program areas will be vastly improved. And I would finally be handicap accessible.
Just when it seemed that the wheels for my rehabilitation had been properly set in motion, though, something totally unexpected happened. A petition opposing the plan and signed by some thirty abutters reached the club's administrators. Although this petition may have contained the names of thirty different people, they represented only a dozen or so houses, mostly on High, Wood and Main streets, and Hathon Square.

A couple of the issues the petition signers wanted addressed included potential traffic problems, shade problems and human traffic problems. Oh, there were certainly other issues the signers wanted to address, but lack of time and space here prevents me from going into more detail.
The members of the Advisory Board of Directors bent over backward to have experts conduct studies in these areas, and their findings concluded that, and I quote directly from a memorandum from Vollmer Associates, the group hired to conduct the traffic study and dated March 17, 1997: "As a result of the consolidation, all Boys \& Girls Club activities at the High Street building, no significant impacts to traffic operations would be expected on High Street. With a designated pick-up/drop-off zone in front of the building on High Street, traffic impacts would be negligible. Green Street traffic operations, correspondingly, would be expected to improve, as no vehicles would be stopping to pick-up or drop-off passengers. Additionally, pedestrian safety would be improved at the High Street location."

Another issue the abutters chose to address was the effect of 'shade" on their residences should the extension be constructed. Again, the Advisory Board of Directors hired a professional to conduct a study on any impact that "shading" due to loss of sunlight might have on a couple of the resi-
dences. It is my understanding that the adverse effect of "shading" would be minimal.

People also voiced some concern over what they referred to as the negative effect of "human traffic." Now let me ask you this. What is "human traffic" as it applies to a boys and girls club? Is itnot boys and girls? Can there be a boys and girls club without there being boys and girrs? Does the ques tion of having youngsters going to and coming from their club make a person who raises the question of "human traffic" anti-youth?

Was the person who asked about "human traffic" at a boys and girls club bom an adult?
"Humar traffic!"... give me a break!

Now let me get back to that petition for a few minutes Those responsible for this document went door to door explaining their opposition to the renovation and expansion of the Chalestown Boys \& Girls Club at the High Street location. The document was addressed to Mrs. Myra H. Kraft, chairman, Boys \& Girls Club of Boston, 50 Congress St. Boston, MA 02109.
I would like to quote from the first paragraph: "We write you as concerned abutters and neighbors to the renovation and expansion plans for the Charlestown clubhouse at the present High Street facility. There is no question in our minds of the need for a new Boys \& Girls Club facility. It is long overdue. The current proposal to expand and enlarge the High Street gymnasium will result in an inefficient and very costly club facility and the construction of the proposed building will cause the neighborhood significant and economic personal damage."

When they say that "There is no question in our minds of the need for a new Boys \& Girls Club facility,"I think they say this only to make themselves appear to be the good guys and that they are in favor of the boys and girls club concept. First of all, I do not think any of the signers have children who attend the club, and I think what they really mean is go ahead and have a club if you think you need one, but I don't want it near my house.

I think it is really ironic that the club was here when they moved into their homes (they would have had to be there for some seventy years otherwise), and it didn't seem to bother them at that time. Now I think they see the proposed expansion plan as a possi-

I further contend that first paragraph, which was quoted from the abutters petition a few lines above, was written purposely to mislead people into thinking that the proposed plan was not adequate enough to meet

Boys \& Girls Club Neighbor Sues To Block Club's Renovation Plans

Abutters of the Boys \& Girls Club's High Street property have filed suit in Suffolk County Land Court in an attempt to block the club's proposed renovation and expansion of its facility at 60 High Street.

In the suit, the abutters claim to have utilized a portion of the Boys \& Girls Club property (approximately 200 square feet) for their backyard since 1959 and therefore the club has forfeited any rights to that land. If successful, this suit would prevent the club from proceeding with its $\$ 4$ million proposal to modernize its current club facilities.

This plan, which has been the subject of numerous public meetings, involves a complete renovation of the club's High Street building with a new addition built onto the back of the building. All of the club's operations will be moved into this location and the Green Street facility will be sold.

Club Director Jerry Steimel has said that Boys \& Girls Clubs of Boston is taking the suit as a "serious challenge" but remain "confident that outstanding issues will be successfully resolved and hopeful that our plans, which have extensive support throughout the community, will be realized." signing the petition to Mrs. Kraft. I really feel that what was said by you was not what I thought the petition was for. From what you said, I thought it was to obtain further funding to improve the Club even more than the existing plans.

I would like to go on record as saying that $I$ am FOR the expansion and renovation of the Charlestown Boys \& Girls Club as put forth by Jerry Steimel and the Board of Directors. My son, Zachary, is an active member of the Club, and I cherish the impact that it has on the youth of Charlestown.

I do not want my name counted among the signors of this petition, in fact, I would like my name removed. Please do not use my name in any further issues that you have with the Boys and Girls Club:"

I can only wonder how many other people who signed the petition were misled.

Since the petition was first presented some of the original signers indicated that they will not oppose the expansion plan. I am reluctant to name the other signers of this petition as I know the club is still hopeful of working with them and gaining their support. Once they file a lawsuit in an attempt to stop the project, however, then their opposition is a matter of public record and the community has a right to know who these people are.
It is hard for me to believe that a community of thousands of residents representing so many youngsters can be held hostage on a boys and girls club issue by so few peo-
ple who may represent NO youngsters, but that is exactly what is happening here.
I am your club. I need your help. If these people bring suit as they seem prepared to do, the courts could possibly rule in their favor, and I could be prevented from receiving the much-needed improvements my friends have recommended. This could ultimately result in my demise.

For more than thirty years, I have purposely tried to avoid dealing with controversial topics in the Patriot, but my fifty year association with the Charlestown Boys \& Girls Club prevents me from avoiding such a topic at this time. I am not, nor have I ever pretended to be, a rocket scientist, and I do not wish to debate anybody on these issues. I am just a guy who grew up in the Charlestown neighborhood who developed a passion for the club and who has seen, first hand, the sort of impact an organization like the club can have on its young people.

The club has given so much to us over the years, and now it wants to give even more. I think it is time for everybody in this community to stand up for the club.

What can you do to help? On Tuesday, June 3, at 9:30 in the morning at City Hall, representatives of the Charlestown Boys \& Girls Club will appear before the Zoning Board of Appeals with their plan. It is important that community support be given to the expansion plan, and having a strong contingent of residents from the community present to support the club would be ideal. You can bet that the opposition will be there, and if their voices are the only ones heard, you can be assured that they will win. In addition to suing the club, they may decide to sue the Zoning Board of Appeals, if the necessary variances are granted. It is important the they ZBA understand what the real feelings of the community are so, if you can appear at the hearing, please do so!

I know that 9:30 on Tuesday moming is generally right in the middle of the working day for most people, and to be at a Zoning Board meeting would be impossible, but I have a suggestion.

## Stuart Shares Her Beliefs In BNN-TV Religious Program

Nancy Stuart's life changed after the death of her 29 -year-old sister, Karen, from AIDS.

She was at a very low point in her life in 1987 when a girlfriend asked her to attend a religious retreat.
"I didn't know what to expect," she said. The minister's sermon was about his brain-damaged sons who were in near fatal car accidents but "they were miraculously healed."

The sermon struck a chord with Nancy because her son, too, was brain damaged.

From that experience she felt "God was calling me back into a relationship with Him and to surrender my life to Him." She now had hope for herself and her son, she said.

Her first experiences with a video camera was with Outreach Ministries as a volunteer. In 1991 she leamed that BNN-TV provided television production workshops for Boston residents. She graduated from the workshop and has been a television producer ever since, adding BNN-TV advanced courses at the public access station which operates Channels 3,23 and 24 .

Her weekly one-hour program on Tuesday nights at 8 p .m. on Channel 3 is called "Evangelical Explosion."

Nancy travels with a BNN-TV camera to record revivals, evangelical preachers, pro-life programs and religious seminars.

She has produced programs on The Church and Homosexuality and AIDS, and segments on battered women because of her own personal experience. Featured in one was Eugenia Moore, one of the Framingham Eight, who killed her boyfriend but was released from prison because of his consistent abusive treatment.

Nancy focuses on Christian events: Catholic, Baptist, Evangelical and Pentecostal when they convene in prayer meetings together. Although
these denominations have different methods of worship, she said, they all "demonstrate unity through the love of Jesus."

Nancy was a hairdresser on Boston's Newberry Street, but had to give up her career to care for her son, Alexander, now 18 years old. He came home to her Charlestown Navy Yard apartment in December 1990 after a 10 -year stay in a nursing home. He now attends a special school, returning home each night.
Nancy has faith that Alexander will continue to improve. He can "now talk with his eyes which has opened a whole new channel of communication. All progress has been due to miracles in his life after three near-death experiences."
"If my life continued the way it was before finding God I would have been dead in about five years. Jesus saved me from dying prematurely and gave me a reason to live with God who is Number One In My Life," she said.

Nancy has established a telephone prayer line in her home "to help anyone in crisis." She has come to terms with her life with faith and is willing to help others.

ARE YOUR BUSINESS COMPUTERS READY FOR THE YEAR 2000?
By now you've probably heard that many big companies and the federal government are trying to get their computer systems to accommodate the year 2000. Is there anything you need to do to prepare your computers for the change?
Mostly a mainframe problem
The problem is huge for institutions with mainframe systems that use software dating to the 1960s and 1970s. Programmers of that era generally used only a two-digit code to identify a year. Such software will read the " 00 " in 2000 as a reference to the year 1900 - a serious error if the computer is keeping track of payment due dates, making interest calculations, or performing other tasks involving dates. The older software is written in computer languages little known to the programmers of today, prompting companies with older systems to spend millions of dollars to pull retired programmers back into the work force.
The problem is serious enough that some attorneys are gearing up to represent clients who may be harmed by businesses that didn't fix the " 2000 " problem in their computers. Insurance companies are writing policies to cover potential negligence. What about your personal computer?

The major vendors of personal computer products are also dealing with the problem. For example, Microsoft Windows 95 and Windows NT already recognize the year 2000 automatically, and Microsoft is working on fixer programs for Windows 3.1 and DOS.
Do you have the problem with your personal computer? To find out, try this simple test. Reset the time and date on your computer to two minutes before midnight, December 31, 1999. Turn off the machine for five minutes and then turn it back on. If it doesn't show early AM on January 1, 2000, you may have a problem, and all of your software that relies on dates will be affected. You might want to start looking for a solution now.
