*I don't see any money.***

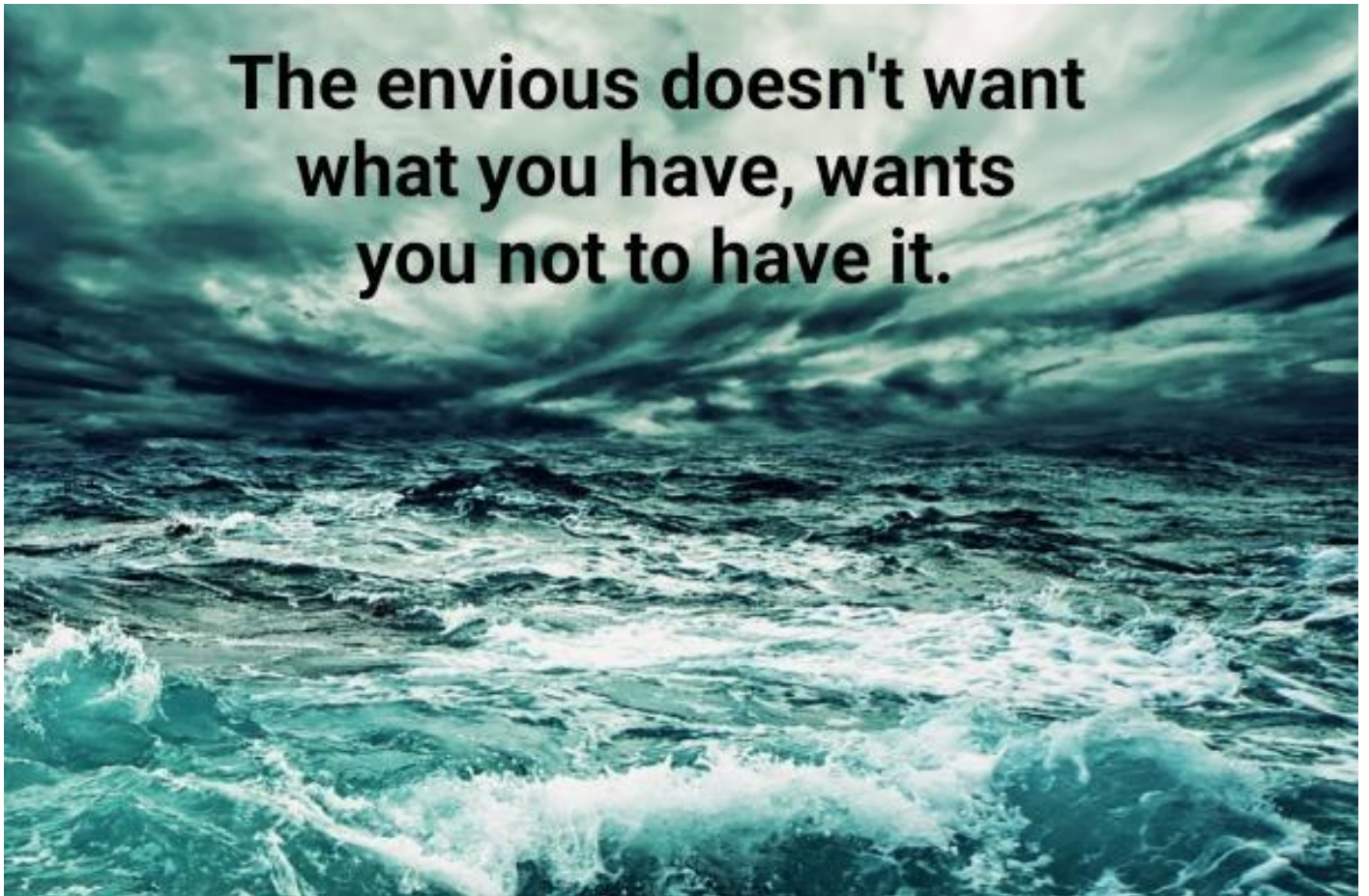

calle Victor Concas, número [redacted] de [redacted], contra [redacted] y [redacted] denunciado anteriormente en este mismo juzgado por mi mismo, por robo de obra de arte, ha entrado e invadido donde yo vivo en dos ocasiones, la última este 14 de Diciembre de 2017, causandome ello una enorme ansiedad y sensación dolorosa de inseguridad y falta de protección. También una impotencia terrible [redacted]. El malestar subjetivo es enorme despues de años de soportar injusticias por parte de mi hermano y su actual mujer. Hablo de más de 16 años que sufro esta situación. Ya hubo en su día juicio por pelea y lo gané por mi parte.

Por ser mi hermano en su día le dejé, a él y a su actual pareja, que llevaran un bar en una propiedad que el día de mañana mi padre tenía previsto dejarme si este le pasara algo. Pero mi generosidad se ha visto pronto mal agradecida.

Mi hermano, que todos estos años vengo denunciando a la policía por diferentes situaciones, molesta y muestra una falta de empatia y sensibilidad enorme hacia mi. Además, llega a actuar como un mentiroso compulsivo en todas las situaciones conflictivas. Hasta la policía misma me ha dicho que no dice la verdad. La policía lo conoce por ser maltratado por su pareja actual. A consecuencia de esa relación actúa en contra de mi persona.

Las llamadas a la policía se podrían contar por docenas en estos años. En esas actas se puede comprobar que nunca miento y son hechos veridicos y en los que nunca empiezo ninguna pelea. Y que nunca he empezado algo y recibido denuncia por que mi comportamiento es el correcto.

Se denunció las amenazas de muerte de un hijo de esa mujer hacia mi madre aproximadamente en el año 2000. Al final la denuncia no se siguió porque la policía me aconsejó así.

En este continuo molestar se puede ver que hace años y años vengo quejándome de los ladridos de su perro muy molestos procedentes de la vivienda vecina de mi hermano. Este mismo año he llamado en varias ocasiones por las molestias de su perro. Anteriormente, a través de peleas se había

conseguido sacar el otro perro que tenían. Pero volvieron a comprar otro pese a que mi padre se lo había prohibido. El 18 del pasado mes de Octubre llamé también a la policía por que su mujer golpeó en la pared de mi domicilio para intimidar y me insultó. Hoy a las 15'30h se ha vuelto a repetir. Ese día 18 de Octubre les dije a la policía que lo denunciaria pero al final no lo hice por lo engorroso de la burocracia y el poco éxito que preveo. Mi madre al oír los golpes y gritos ese día, exclamó. Qué miedo!!

Ahora pues, siguiendo estando molestado por ellos, denuncio aquí también a su mujer, [redacted]. Hoy mismo ha golpeado e intimidado en la pared y la he oído desde mi habitación.

También este pasado verano me he venido quejando del ruido que hacia esta mujer, al menos provenía de estos mismos vecinos, sobre las 7 de la mañana todos los días, arrastrando camas sin tener cuidado. Pero ello es solo una muestra de lo que semana tras semana o mes tras mes se viene sucediendo año tras año, y sin escrúpulos siguen molestando a pesar que me queje.

I always and I understand and respect not come him. From the moment I knew that our father would not come, I had lost him (or rather "**not won**").

Father that before disappearing the art work, in reference to the place where it was deposited

reproached me and threatened with his character (poor -I do not like to explain this) that *if I didn't help him to order all that place in the warehouse he would call my brother to help him.* Later, *the place was more orderly and the art work had already disappeared.*

And now the father, as he always hides him all the misdeeds, still refuses to tell me anything about to order there ... *but if the area is orderly* (and when he said it there was a

man from Olot, witness who didn't have to use if not the father came to trial) who was surprised in the way he told me.

THINKING.**

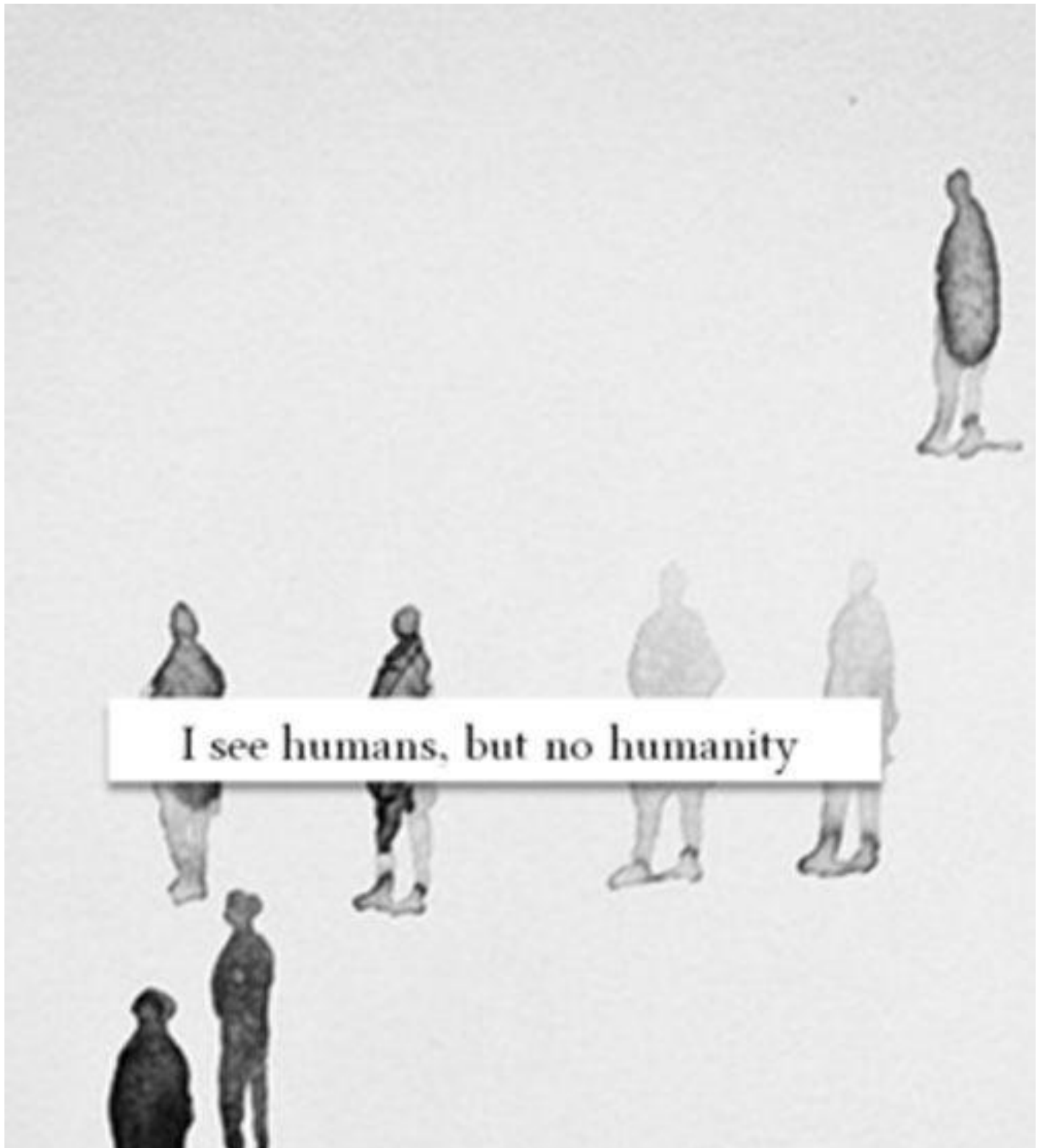

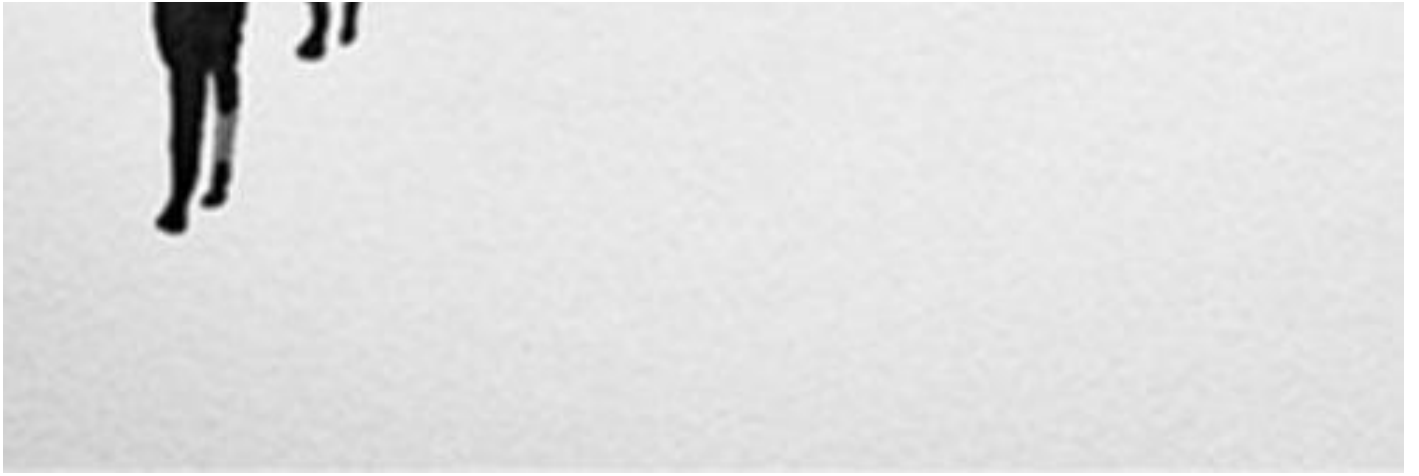
