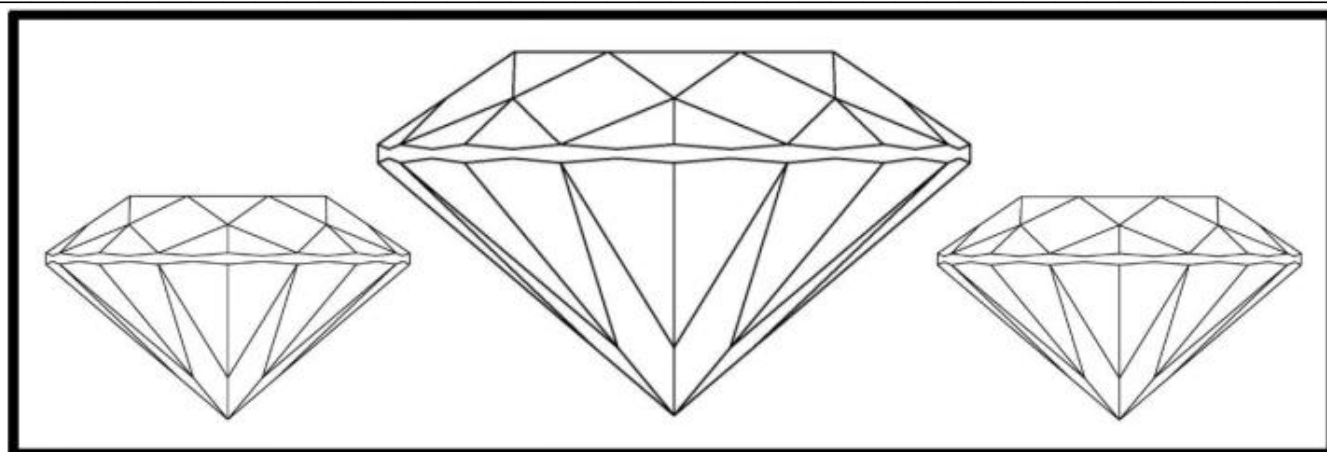

# Communication for All states in the World, Organization's and Czech State servicers

---

24.07.2017

I, as the King of the Federal Government, Imperium of Diamond's, today, the first time I visit the Czech Republic, I ask the Dear Governments of the countries of our world and above all the Member States of the United Nations General Assembly, Your Dear Presidents, Dear Kings and Sultans, Emirs, The representatives of the Confederation Councils as well as the Prime Ministers of the Government and the Ministers with the State Representatives, I ask for your support for the purpose of cooperation and the assurance of an act of legitimate function of the international rules and principles of judicial justice in international law and legitimate claims standing on my side, For your countries, peoples, your governments and your civilizations.

I am also requesting your networks of States in Political Organizations, General Secretaries, Presidents and Chief Commissioners and Senior Leaders, especially Member States such as the General Assembly of the African Union, Organization of Islamic Cooperation, League of Arab States, Organization of American States, Union of South American Nations, Association Asian Dialogue Forum, as well as the Independent States Parties of Soviet Union, the other Continental and Main Geographical Organizations, as well as the Ministers of NATO and the OSCE Parliamentary Assembly together with the Council of Europe, as well as the expression of my inspirational address for Security and justice and judicially responsible departments and state institutions of the Czech Republic.

I am asking you for your support for the purpose of using your multilateral agreements in relation to the country of the Czech Republic, such as the International Humanitarian Law, the United Nations Convention, as well as the Peace and Security Agreements determining the rights and common international obligations of states for the purpose of liquidating terrorist Of suppressing their growth and freedoms at international and national level, stopping their organized crime and, above all, allowing them to be punished by international courts, just as I do for Arbitrage for your state courts. I would like to ask you for your support for the cooperation of a legal act against a real organized terrorist group and therefore, also for the principles of the origins of these crimes, I also ask you to support the protection of human rights of children living in the Czech Republic, to ensure the function and enable the use of health centers and education, meanly Sexual and non-discriminatory abuse. It is true that the government of the Czech Republic is actually abusing such acts of dirty crime against young and fully innocent children, and I have been public proof since my six years of life, and there is a great need for your political support on behalf of the courts, permanent supervisory institutions, The Commissioner for Human Rights, and at the same time today, at best, international law is best to make the best use of the steps to establish the UN Trustsheep Council over the territory of the Czech Republic. It is a very simple step in which it is only necessary to issue a true media statement and subsequently to issue the UNGA Declaration or UNSC Resolution under UN international law, which means initiating the exercise of the Council of Trustees and thus achieving the freedoms and the stable function of human rights, international rights and, above all, Penalties against all criminals.

I do not want to ask only for your work, responsibility and forcing you to enter a conflict between you and the European states. I offer you new ways of working together to develop new forms of global politics, a great benefit for your countries, for your peoples, civilization and politics. A step that really enhances your state's economy, a step that gives your country much stronger armies and the strength of strong global military support for your country's security stability, but much more significant political options that give your government a view of the new civilizations that your government can develop in global democratic co-operation and together, and with the ability to outstrip the level and civilization of our planet Earth.

If your governments are obstructed in this act, it is only a loss of the quality of life of all the countries of the world, and indeed a great disappointment for all future generations of world politics.

Last days, I am in the territory of the Czech Republic, and I am moving in legal form as an extraterritorial person against the jurisdiction of the Czech Republic. Wednesday 18, my arrival, I visited the institutions of the Government of the Czech Republic, the Constitutional Court of the Czech Republic, the Brno Branch of the Czech National Bank as an institution of the Bank established by the Constitution of the Czech Republic, and so I was also visited by the Supreme State Embassy of the Czech Republic as one of the most important authorities The Government of the Czech Republic, in this interest, a matter decisive for the future of the Czech state.

I have visited the institution for the purpose of handing over my original copies of the document, which is the legal name of my own government, and thus a document on the legitimacy of the Government of the Czech Republic, because of a confirmed factor of crime, organized crime and terrorism, apartheid against civil minorities, To foreign states and to severely damaging their development, damaging their own state democracy, exercising and motivating the state to cooperate in organized crime and terrorism as a function of the act of government-sponsored terrorism, organized genocide overtaking statistics of the Second World War, and many other crimes, Means the confirmed format of the loss of legitimacy of the government of the Czech Republic, but also of the state.

Documentation that provides a description of this legal knowledge and the consequences of the crimes was handed over on 18 July 2017, with the confirmation of taking over and empowering an official, without attempting any criminal impediments and serious attempt at counterfeiting.

Documentation was handed over and confirmed on the assumption on behalf of the institution, first before the offices of the Constitutional Court of the Government of the Czech Republic. The Constitutional Court has the duty to deal with the matter according to the documentary meaning of the information message, as well as with the obligation of the court to initiate criminal proceedings and to reach an immediate ruling on the prevention of the political rights of all persons of the Government of the Czech Republic, in the view of the principles of the jurisdiction of the state and constitutional obligations, Republics that are related to the crime. Today, this means legal and responsible duty to issue a sentence of legal punishment against the President of the Republic, the Prime Minister, the Ministers of the Interior, Finance and Trade, the Armed Forces, the Health Service, other institutions of the State Ministries of the Czech Republic, the Parliament, the Senate and the Chamber of Deputies. The Constitutional Court of the Czech Republic has the obligation to suspend the rights of commercial, political, media and civil liberties for every citizen of the country of the Czech Republic, and for the reason of the large-scale The consequence of organized terrorist cooperation at the level of the state's population is the obligation of the Constitutional Court to issue a decision to stop the legitimacy of the government, And the international community on acts of crime of the previous regime, thereby further ensuring that such offenses are punished by all persons related to these illegal acts. Due to the fact that, in the course of organized cooperation between the government and the state, the state and the state are losing the rights to self-determination of the sovereignty of the country, and this is the primary duty to ensure the mobilization of the State Army and Police Services to capture all political and official criminals. Border and immediate request for the return of all citizens moving abroad to enable police and military forces to begin an investigation of all cities and municipalities and forests and to detect all persons active in terrorism for the purpose of their immediate neutralization or closure in isolation cells or camps; So that they can also be fully punished by law in issuing and enforcing a legitimate judgment.

The Constitutional Court has the duty to respect the consequences of financial debts incurred on behalf of governmental and state terrorism and hence the consequences of such a financial debt, meaning that the government has no right to legitimize the right to legitimize the rights of state democracy, Since 2000, the actual State Bank, and therefore the obligation to allow the principal persons of the debt to transfer sovereignty to the hands of my country's government, and also by the principle representing my person as the last citizen of the country of the Czech Republic, my own birth and the origin of my parents , In its own attitude as opposition to the terrorist group at the level of the whole state.

The primary duty of the Constitutional Court is to issue an order to mobilize the Armed Forces and the police in its own direction and to allow foreign legitimate states to oversee the activities of the armed forces and, above all, to ensure decriminalization of the government and thus to enable state security management and the prevention of criminal group protests or the growth of demonstrations

Which only mean the risks of the disappearance of the Czech civilization. Therefore, it is necessary to open the media and the rights of reporters, to ensure the full awareness of the company and also to continue to strategically inform the company for this purpose of the understanding of the cease of the government, because of the real terrorist performance in opposition to international law.

The Constitutional Court of the Czech Republic has no rights other than to hand over the right of sovereignty to the hands of my own country government or in the hands of the United Nations' Refereeing Council.

The Constitutional Court has the right to avail itself of the right of recourse to the format of the principle of appeal against the matter and thus the transmission of the proceedings before the International Tribunal of the United Nations, which implies the obligation to initiate full proceedings under the International Regulations of the United Nations, And the obligation to launch military invasions into terrorist states, or to put an end to such a function of state organized crime by the use of weapons of mass destruction, in particular the removal of all terrorist members from the right to membership of the United Nations. Should the United Nations recognize the rights of the Czech Republic anyway, as a result of this act justified in the UNGA conventions, this means that the UN is losing legitimacy and the right to take decisions on these matters or a complete bankruptcy. Any UN member state, which is also a member of this organized terrorism, ahead of the statistics of the Second World War genocide, therefore, in this case, any voice in this state is always completely illegitimate and, in the case of just allowing this vote in the UN, on behalf of a terrorist entity, And therefore also with the UN's legitimacy.

Conclusion on the Constitutional Court of the Government of the Czech Republic, however, if the Constitutional Court refuses to assume the matter and thereby secure the act of issuing a criminal judgment against the terrorist regime, it is confirmed by the fact that it is not the legitimacy of the main constitutional bodies. Violations of the International Agreements of the United Nations, the Political and Civil Rights Convention, as well as conventions on the prevention of genocide, the cessation of international organized crime, cooperation under the Universal Human Rights Conventions, as well as conventions on the rights of states for their economic, cultural and social rights. The act of violating the Political and Civil Rights Conventions is already at such a level that the government of the Czech Republic is actually losing its own legitimacy, and this is not a legitimate judgment of the Constitutional Court unless it is approved by my own institutional party in the present case.

The Constitutional Court of the Czech Republic received the documents in full, confirmed their takeover, and without any attempts of opposition and provocation the matter of documentary communication was resolved. That is why the act is passed by the principle governing the right to legalize the act of my own government, which also means the objective of such a law of legal development on behalf of the Constitutional Court.

The documents were then handed over to the official postal institution of the Supreme State Embassy of the Czech Republic.

The Supreme State Assembly is an institution based on the form of a main legal connection with the Interior Ministry, the State Prosecutor's Office, the State and Constitutional Courts, as well as the other institutions in a legal form by the name of the government of the country.

The Supreme State Assembly is an institution which, in this case, and indeed according to the world-confirmed data and facts about the terrorist activity of the Government of the Czech Republic, therefore has the duty and international obligations under the United Nations, to initiate organized cooperation for the purpose of enforcement against terrorist cooperation To ensure a full act of depriving all criminal persons at the political level, thereby eliminating the risk of organized crime group growth, and preventing the use of such terrorist activity.

The Supreme State Assembly is obliged to provide information messages to all foreign governments of the country in order to prevent the entry of any citizen of the Czech Republic into their territory and thus to allow immediate questioning of all citizens already active in the territory of the foreign country.

People who are suspects must therefore be thoroughly investigated and people who are active in crime or resistance must be neutralized immediately.

Every politician and criminal responsible for crime must be immediately detained and imprisoned in custody for an unlimited period of time because of threats to acts of corruption at international level, attempts to escape, attempts to terrorize the society, but also the pursuit of another organized crime, and murders or occupation and war threat.

It is therefore necessary to ensure the steps to prevent the stability of the terrorist network, and it is also necessary to ensure full interrogation of all families and friends of these politicians, including the obligation to wire them with the right to document all communication data from telephone calls, email messages as well as personal postal communications The way of contacts, even today, and in the past, over a period of tens as a twenty or threety of years. Suspended rights of use of bank accounts and of their own companies or companies and other forms of the name of the legal status, fully suspended rights of all claims of media activities and social communication, passport blockation for each politicians, their families and friends.

The reversal of the criminal government is not an act of terrorism and crime. Repeating, Same situations as the rights of the coup of the government in Egypt in 2014, the cessation of the legitimacy of the Soviet Union in 1992 and the establishment of the Russian Federation as a state of democracy, as well as the global standard of police execution for the investigation of political fraud. If the Police, in cooperation with the Czech Armed Forces, ensure the overthrow of the terrorist government, viewed at the level of world politics, this step is only observed as a standard national police intervention against the criminal group, as well as a step in choosing a new government of a country operating according to legitimate principles Also ensuring a clean, non-corrupt and non-threatening and non-threatening function of international politics which today decides on the function and stability of all the states of the world and therefore any policeman and soldier who supports growth and mobilization, official and guerrilla co-ordination to stop the dictatorial government Nationally honored and encouraged to celebrate his name on an international level.

It is real that your country's government is coordinated at the level of European policy in the interest of a criminal alliance supported by the USA or China, and therefore, indeed, with its own form of international threat of war and overwhelming conflicts at the civilization level of the world. The international democracy of the governments of the countries must therefore respect such threats and the consequences of the consequences, and therefore also react with obstructions due to the crisis in the event of the full exercise of the fascist movement regime threatening the stability of the function of the world legal and security regime. That is why it is really very important and encouraging for the whole world if your coordinated forces will be responsible for their own functions of world security support, and thus to achieve a strong mitigation of the risks of new wars and the use of weapons of mass destruction in order to defend stability and the function of the world order Respectability of international law.

The obligation to overthrow the function of a terrorist entity is therefore a legal act in the form of a simple act which can also be initiated by the simple principle of police raid against organized crime. Because of the function and validity of the International Law, it is not possible for any foreign country to contradict and / or defend against this crime neutralization step and any other form of attempt to proclaim legal opposition. If the other foreign governments of the countries confirm their interest in legal opposition against the act of overthrowing the terrorist regime, then in the legal recalculation of the result of this act, it is real that the whole world is indeed, for your country, genuinely responsible for damaging your state development of civilization due to the permanent function of the terrorist regime International support, and that means that your country owns a much smaller international financial debt compared to foreign country debts for your country in the case of the stable sovereignty of the party my government of the country as already legal representation for your country because of the need to synchronize legal relationships for your own profits Position, which also means the legal capacity to achieve this position.

The act of overthrowing the current criminal network is a great pride for your ranks and reputation for your courage to serve for the freedom of your own state. It is worthwhile for you to gain public recognition of the Righteous, Honorable and for Your Own People proudly, and the monuments of your service acts published on the main squares of cities and government buildings, taught in state and international textbooks and schools of history, the knowledge of all mankind about the results of justice in times of today Generations and world-wide confirmation of the success of several generational developments in international law that have been developed since World War II, and strictly for the purpose of this act, which is to stop the function of the criminal policy regime of the government of the Czech Republic.

In the interests of your country Czech, in the unfortunate case, if the Police and the Armed Forces really refuse to commence the immediate liquidation of criminal politicians, it is confirmed that the Czech Republic regime is really fully terrorist, fascist, and founding its own position as a criminal opposition to the entire current legal world of politics Without an effort to stop its own criminal growth, meaning an act of execution of the threat of the secret development of the forces of weapons of mass destruction, thus obliging it to ensure immediate, full-scale efforts of force for the purpose of dismantling the function of this terrorist entity.

I, and indeed, all the countries of the world, really appreciate your cooperation interests and the proud service for your state and the security of our world. Your actions of police and army raids are the best strategy for the countries of the world security democracy, and also for the security of your country.

Documentation of my legal report is a true legal act, and therefore, in accordance with these principles and conditions, it must be followed, and without any other consideration, but also in the best interests of the nation of the Czech Republic, and also for such purpose.

The documentation was submitted and legally handed over to the Brno Branch of the Czech National Bank, and thus the Czech National Bank in its duty to acquaint itself with this obligation, is obliged to secure the act of stabilizing the government's IDs and to ensure the suspension of the state debt growth already constituted above the level of irrevocable state bankruptcy; Therefore, together with ensuring the stabilization of the entity that is designated as World Diamond International Alliance,

ID's Corporatocracy and other ID's entities, as well as humanitarian interests in Third World countries, meaning ID's plans for civilization support for the growth and development of the modernity of all states on The level of today's advanced states of the world, as well as ensuring indemnification to all foreign states and traders or families who have been harmed by their rights stemming from blockades on business development.

If is not stoped financial debt increasing, than a consequencess of debt is only worse and worse, and a loss of time be the time, meaning only worse and worse position of Czech country, politicians, people and the state. Today statute in International legal view, state and government is illegitimate.

It is true that the truly legitimate debt of the government of the Czech Republic and the Terrorist Alliance is in the ID's government relationship at a record level exceeding the number expressed by the mathematical equation as the country's annual GDP in 2014 at a multiple of +/- 845,000,000,000,000,000 times So the result of X1, which is multiplied by the number of all seconds of the time unit, for a total of 365 days, is the resultant number X2 showing the annual GDP of my country of legal claim and below my representation.

On the second point, it is true that because of the genuinely ultra-anarchist form of crimes of the government of the Czech Republic, then it is really possible for any trader and state anywhere within the scope of the lawful and peacefully performing world, each with the right to create his own register of business activities and arbitraly execute. The government of the country and is therefore entitled to such compensation from blocked trades using court arbitration of its own state courts and in co-operation with international courts, which are therefore actually required to give full judgment to this act and to initiate arbitrage of debts on principles internationally. The resulting sum of the lowest amount of the theory of such a debt is responsible for the permanent bankruptcy of the entire European civilization, and indeed the legal right of such a consequence, consequences of claimed month profit of only one business company.

I therefore have to affirm that it has always been in my interests to ensure friendly cooperation with the Government of the Czech Republic for the purpose of a safe and crisis-free settlement of disputes, which will ensure the immediate cessation of the growth of all debts as well as the simple and not burdensome payment of all amounts owed in full state stability Economics, as well as enabling the dynamic development of the Czech civilization and economy, in friendship as a native Czech Republic and with the interest of support for its own native land, but because of persistent persecution, corruption of offices, threats and hypnotic blockades, misinformation and often tough apartheid, your criminal government preferred to build yours The country to a situation of relative international law to the duty of states and such open rights for military invasions, as well as the use of weapons of mass destruction for the purpose of the complete liquidation of the civilization existence of the Czech Republic. Your government and the people who support it are each responsible for legal recognition as the greatest dissident and treasurer of the Czech State and the nation as well as the patriotic future, as well as responsibility for the treachery of mankind and against all nations of our world.

In any case, I want to calm down the risks and stresses, the threats of big bankruptcy are just a legal function that implies the outlook of future outcome theory in your government's resistance to the interests of not participating in legal and peaceful co-operation. If the criminal government of the Czech Republic is overthrown because of real and proven responsibility for criminal and terrorist acts against the world and its own state, then international law acts permitting us to establish friendly cooperation between us and the cooperation of a legal factor between us, Risk settlement of all debts and threats.

My own strategies, such as the steps to prevent state bankruptcy and the disappearance of civilization, are sufficiently able to leverage the possibilities of our co-operation to end the obligation to pay sovereign debts to the parties to the claim of my government, and I am thus also fully capable and willing to ensure immediate payments of all debts to International level, such as debts arising from governmental crimes, and already indebted debts, other relationships of third parties' legal claim.

There is, therefore, a real need for legal cooperation under the legitimate principles of international and national law, thereby ensuring that a peaceful solution is made. In any case, with the interest of international cooperation between states, your support for the exercise of my rights is not a step of the risk of an economic and civilization crisis that can create a bankruptcy of the Czech lands. Legal support for me is only an act to ensure the elimination of criminals and achievement of the legalization of the state, without any other changes to the function of civilization and the freedoms of people and nations.

The departments and the state of the Czech Republic therefore have great responsibilities and responsibilities, but they are duties that give the Czech country great opportunities and important positions on the international level, and a much better future of the state and of civilization, are steps that are fundamentally beneficial and beneficial than being in Dependence on the corruption network of politics, which only robes and damages the future of the state, and the name of the nation at the international level.

Stopping the regime of the Czech Republic is therefore a great step of benefit, but also as a step that is inevitable. Your government does not possess any values of legitimacy, without any real legal

representation of state representation or business activity, without the right to use and the creation of bilateral or multilateral relations, and therefore any foreign states and companies can use this real position of your government and at any time in First allowing and re-suing your country in the form of crimes such as mafia competition and fraud at both international and political levels. Crimes that are just a re-loss of your country and therefore your position again only harm your future, as well as such agreements are again damaging those states that are willing to sign these agreements with you.

On a straight and straightforward basis, today it is fully legal and fully possible unless the Czech Republic Police and Army of the Czech Republic start countering terrorist raids in the government, even in this case fully authorized and internationally confirmed, the right to launch bombings on government institutions And police and military authorities in fraud cooperation, and if your government, the police, the military, the state or anyone else will protest or attempt to resist it, it can fully legitimize the full destruction of the Czech civilization by using weapons of mass destruction. Therefore, it is best for you to start rash as soon as possible and thus to stop such threats of a drastic future. If the police and armed forces are blocked by the bureaucratic powers of the politically organized network of your policy, of course you also have the right to use the principles of the Czech Constitutional Act on Government Defense and Security, as well as the amendment to the Act of 2017 when Citizens and Population , To use own weapons resources to destroy all the people of criminals who violate the government of the state government and damage the government and the state on legality and that is why you are allowed to use your own weapons and bombs for the purpose of blasting Senate sessions and blasting major centers of terrorist logistics, And Constitutional Courts if they do not work for a legitimate purpose. If your act could be classified as an act of crime by the interest of the illegitimate republic, it is necessary to just blast all the centers that refuse legal cooperation, government centers and the media and therefore stop any attempt of terrorist prosecution, as well as ensuring that the parties My governments will not be calling for any prosecution, except for the standard of request for information on terrorist acts, as an act that is not punishable by international law.

The lawfulness of the government of the Czech Republic is illegitimate, and according to the outlined process of these principles of responsibility and the consequence of created rights, confirmed that the government of my country is today a fully legitimate sovereignty in the territory of the Czech Republic, and I ask the reaction of support from the international parties of the governments of the countries, Principles as well as the UN's entitlement to the founding of the Council of Trustees that will provide temporary administration over the territory.

It is true that the government of the Czech Republic is the main and central position the first actor of this crime, and also with the greatest responsibility for crimes against international law. Because of these crimes, the government of the Czech Republic in the co-operation of organized crime with the state population, therefore, under international law and in the interest of the principles of its own jurisdiction, has lost its full legitimacy, nowadays for international law, which means Czech Territories as terra nullius. My claim, and I am the international law and nature of political justice entitled to use this claim of debt for an act of my own sovereignty, as viewed by the International Law on Political and Civil Rights, this right of my sovereignty has been in force since year 2000, without the right to other parties and their Appealing for the obligation to prevent bankruptcy that arises again and again always arises if the territory will be used by anyone else and without the ability to repay debts. Until today, in the Czech lands, I did not recognize anyone who would protest the crime movement, people support such a movement and everyone only coordinates, that is, only the illegitimate Terra nullius citizens live in the Czech Lands. In any case, I will claim the acceptance of the citizenship of my country by an autonomous process by the replacement of the government, and there is no need to extend the capacities of the prisons.

The government of the Czech Republic has refused to cooperate with the legal process for over nineteen years. For such a period I had to often live as a person under apartheid, tyranny, full damage to living qualities and rights, robbing of identity, and illegally registering my citizenship under the subject of terrorism due to active terrorist misinformation. That is why I was forced to use my World Diamond projects, defining the open rights of governments of the world, to enter the WD Alliance, to establish common civilizations on other planets in the universe, to expand common civilizations To the whole of humanity, and this right and claim in today's case also means establishing a civilization of joint sovereignty in the territory of all illegitimate states belonging to the European Terrorist Alliance which originated above all the foundations of the first criminal acts of the Czech Lands.

Our Alliance means for us the possibility of cooperating with the use of Alliance armies that have the ability to make a significant security step around the world, and within just 30 minutes of the beginning of any conflict. A strategic act of globalization which for us always means a stable peace among all states around the world, as well as the certainty of no threats from the sides of radical movements.

The World Diamond Alliance brings many opportunities for development to all member states, but above all in the best interests of being able to exploit common territories of more than a few trillions of planets be the European mathematic format, as the largest civilization in the entire human world, because this is a new world and a new beginning for all mankind More important steps than the future of the development goals of today's generations.

It is true that through this document I offer to many countries of the world many, always fully legally and without any claim of legal resistance, the steps for which is being developed by the whole world of international politics, and today it is only necessary to activate it.

I offer many good and beneficial steps for you, and I have much more for you, but my criminal opposition is constantly expanding the oppression strategies of the international parties and is still developing strategies for influencing world politics, for the purposes of achieving steps to block the possibilities for our joint development, Friendship, but also for the actual use of only your stupidity and therefore for the overwhelming robbery of your states.

That is why I ask for your intelligence and a real reflection of who stands as a legal party without the responsibility of crime, who is the one who offers much more for your country than the future of today's humanity, and who is the one who thinks it for the benefit of all the states of the world And not only for the sake of their own survival, because of their own responsibility for the crimes that overcame all the statistics of the Second World War crime.

The act of overcoming the crimes of World War II means an act of gross violation of all international rules, as well as a sufficient reason for a responsible act of reaction and the use of weapons of mass destruction. This is the policy of today's world, meaning our security and growth, and that is why there may be a pure future for our humanity.

One of you, who is proud to say that your interest is political cooperation and the promotion of the most important goals of the future of mankind, you also stand up and start opposing the subjects of terrorism, and you will immediately understand sufficient strategies of action to completely destroy these entities and arrange for them to cease; So for a clean and mature world and for the pride of all our nations around the world.

If you do not have such pride, please be aware of it, and so leave your political position because it is only those who are truly responsible and faithful to the pride of humanity and justice and the success of the human race, of all peoples of our country and for the same pride of all political Mandates that have been declared and developed by the United Nations for generations before generations, so that they too have the pride of all nations. Ability to stand for state declarations is one of first act for stability of mandates. Politics, it's not just to show you that you enjoy it, and you are willing to be abused by European terrorist states for that purpose, so that your country is robbed and damaged.

Obstruction is just an act of mockery of future generations of humankind against your country, and for damaging your reputation.

If you want to cooperate, then you also support human rights, also support justice and avoid the development of a terrorist entity. Standard steps to maintain security and isolation of terrorist subjects. Terrorism is a crime, and terrorism must be truly punished.

One of the principles of the nature of cooperation or support is also the act of the Czech Security Services, as well as an act that can be supported by every government of the country, an act that immediately prevents the planned abuse of minor children and adults, in particular ensuring destruction of organized criminal networks between state and civil institutions. 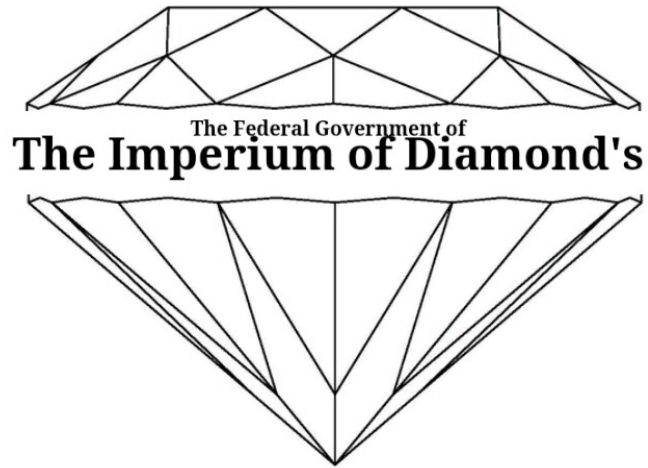
