Sail Free — A Unique Therapy Program Feature Of Life Focus Center Open House

The Life Focus Center, Charlestown's multi-service agency for physically handicapped and mentally retarded individuals, and the Courageous Challenge for the America's Cup have joined forces to bring a new concept in wheelchair sports to Charlestown.

The program, called Sail Free, is a unique therapy technique, utilizing radio controlled model sail boats to teach persons restricted to a wheelchair the basics of sailing. Participants learn how to control these 18 inch model boats through fan generated winds.

Jack Millerick, Executive Director of the Life Focus Center, is a strong advocate of the program since it teaches individuals the same

skills as those needed to maneuver actual sailing vessels on the open waters. Millerick explained that the participants learn how to "zig and zag", in other words, to take advantage of the wind, whether they are sailing into or against the wind.

Currently, there are eight individuals from the Life Focus Center involved in the program. However, thanks to the generosity of the

Courageous Challenge, along with donations received locally from City Councillor Robert Travaglini, the Trimount Bituminous Products of Everett, and the State Street Bank, the program will be expanded to twenty participants later in the fall.

As part of the Life Focus Center's Annual Open House to be held on Wednesday, October 9th, there will

Community Meeting On Residential Permit Parking Program

BHA And Tenants' Associations Reach Temporary Agreement

Attorneys for the Boston Housing Authority (BHA) and for the Bunker Hill Tenants Task Force in Charlestown and the Orchard Park United Tenants Association in Roxbury, reached an interim agreement prior to yesterday's (Wednesday, October 2, 1985) hearing at Boston Housing Court before Judge E. George Daher, Chief Justice, regarding the proposed welding of penthouse roof doors at both developments.

The developments had jointly filed an injunctive relief complaint against the BHA, questioning the legality of the BHA to weld the roof doors shut without a permit and also because the original 1936 Building Department ordinance required the developments to have a second emergency egress. Both groups claim that such welding denies tenants a second means of

egress in case of fire.

However, shortly before the tenants' associations and the BHA were to present their cases before Judge Daher, the two parties reached a temporary agreement, which will be honored by both parties until a second court appearance, scheduled for November 12th and 13th.

Essentially, the agreement includes the following conditions. One, the roof doors at the Orchard Park Development, which have already been welded, be "unwelded" by Monday, October 7th at 5:00 p.m. Two, the padlocks on the roof doors, which exist at the Bunker Hill Development, be removed. Three, the access to the roofs in both developments in case of emergency will not be barred in any way, pending the November 12 - 13, 1985 court date. Four, any meeting with rela-

vent city departments by the BHA regarding this matter, which is not attended by both parties, will require written notification and the submission of copies of any proposals to the tenant associations' attorney within 48 hours of the meeting. Five, the BHA will determine definitively whether it does or does not intend to seek to obtain a building permit in the time between now and when the case is heard again in court. Lastly, the parties otherwise waive no rights or remedies by this agreement.

The complaint, initially filed by the Bunker Hill Tenants Task Force, was joined by the Orchard Park United Tenants Association when the BHA postponed scheduled welding at the Charlestown Development, but welded the "penthouse" roof doors at Orchard Park instead.

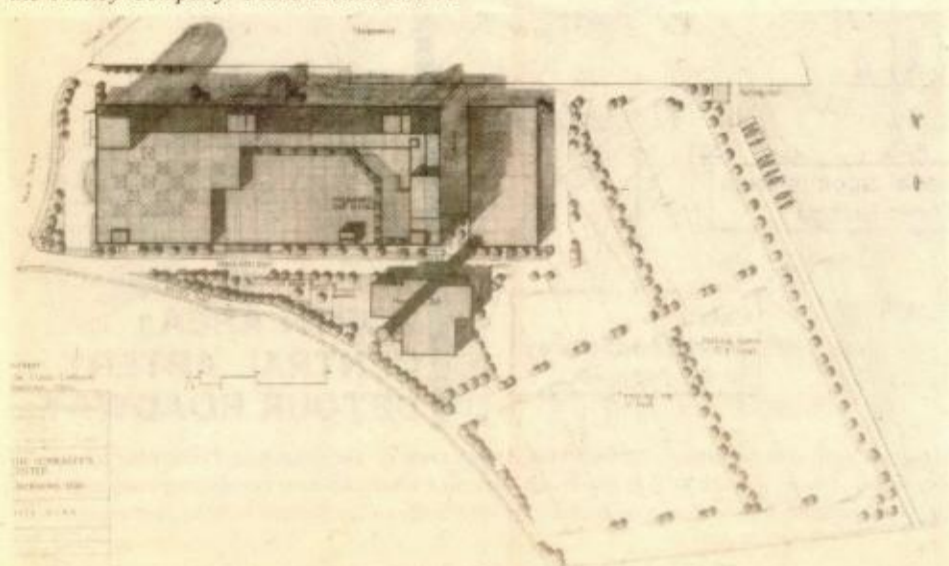

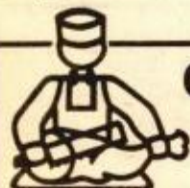

North Area / Central Artery Detour Plan For City Square Area

At the recent North Area community meeting, held on September 10th, a model of the proposed detour roadways was presented. The scale model showed the plans for routing traffic from Boston, Route I-93, and the Tobin Bridge when construction of the North Area/Central Artery improvements begin.

This transportation improvement project is funded primarily by the Federal government and will involve approximately \$150 million dollars in construction costs. The project will improve traffic flow and make the Charles River Bridge safer by creating a longer merge and weave distance and by building new loop ramps south of Rutherford Avenue. The overhead ramp connections in City Square will be removed and replaced in tunnels under City Square.

Over the next six years, construction in and around City Square will necessitate detouring traffic away from areas of the tunnels and the roads approaching the Tobin Bridge. The consultant team for the area north of Rutherford Avenue, headed by H. W. Lochner, Inc. and Louis Berger & Associates as the joint venture Berger-Lochner,

has developed a temporary detour system that will be a major structure built to accommodate north and south-bound traffic as well as local traffic.

The detour roadways will consist of both new and existing roads, and the first segment will begin to be constructed in mid-1986. The temporary detour facility will begin to be used by mid-1987.

The first construction will be on the approaches to the Tobin Bridge, while traffic headed north on Route 1 continues on the present roadway. Construction of the north segment of the detour roadway to and from the Tobin Bridge will begin while traffic continues to use the existing north and south-bound highways.

The Route 1 southbound detour connector to I-93 and

downtown Boston will be built and will carry traffic from the Tobin Bridge when the detour structure is completed. After the new Tobin Bridge approaches are completed heading north and south, traffic will be diverted from existing roads onto the new roadway. At this point, the existing Route 1 north will carry both north and southbound traffic, with traffic heading south merging with I-93 via the new south-

bound detour connector.

After the entire structure is built by mid-1987, construction of the tunnels can begin. As the tunnels progress from

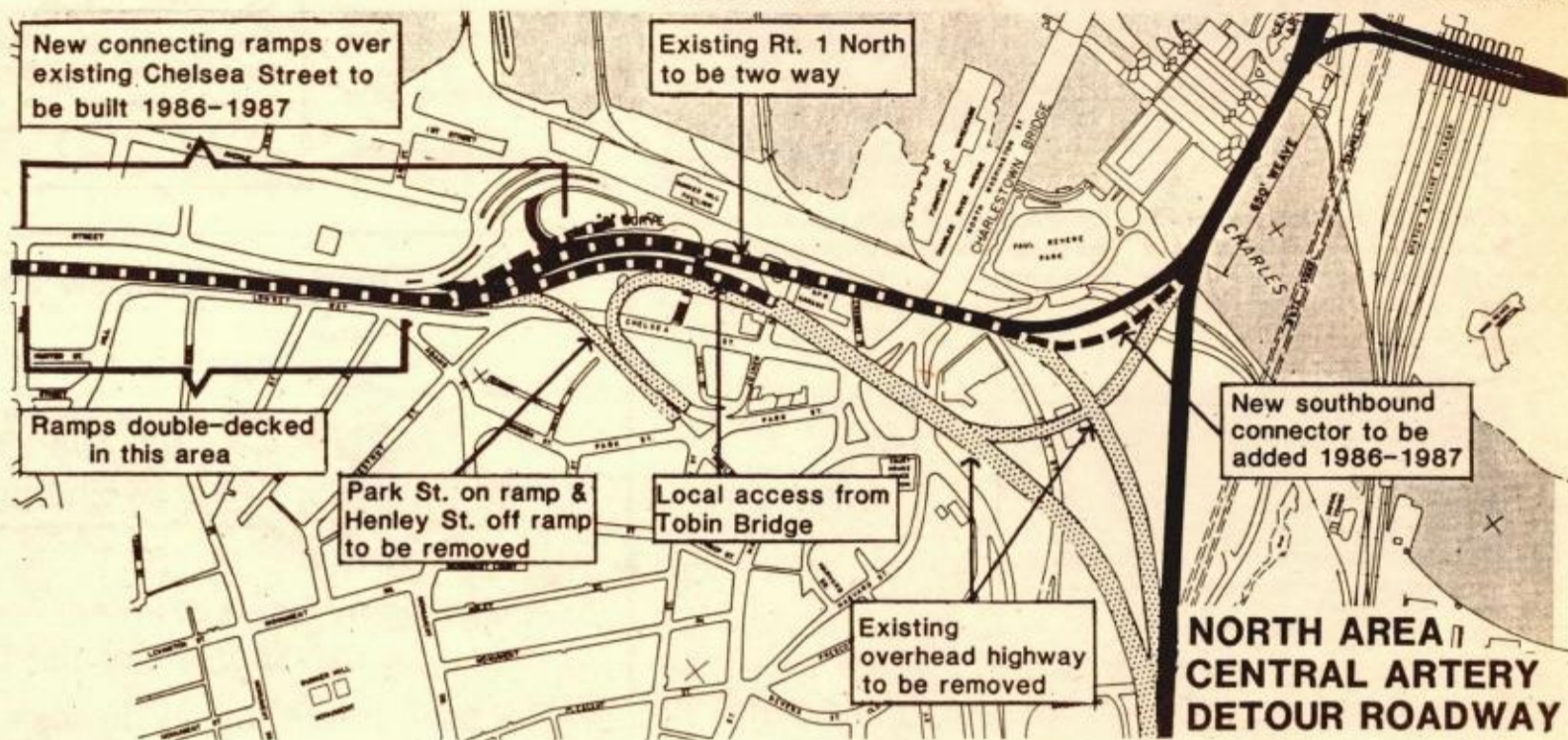
road leading from Gray Street will be built. This will allow local access to be maintained.

The detour structure will



City Square toward the Tobin Bridge, the extension of Gray Street will be cut off by the tunnels and a new access

be used until the permanent roadways and tunnels are completed in 1991, at which time it will be demolished.



THE ABOVE PLAN show the proposed detour roadways to be built as part of the North Area / Central Artery project. Beginning in 1986, new ramps connecting the existing Route 1 north to the Tobin Bridge will be built. Route 1 north will become two-way and when the new connecting ramps are completed, traffic will be removed from the existing Route 1 south, the ramps will be removed and the tunnels under City Square will be constructed.

Jean Marie Puliafico Awarded Supplementary Quinn Scholarship

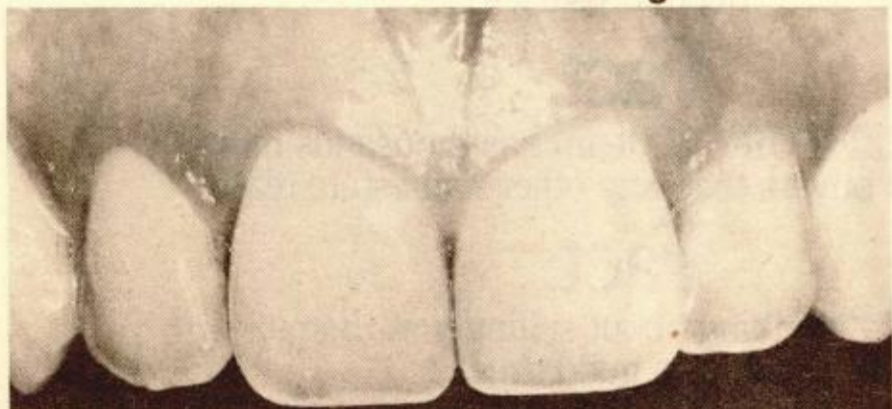

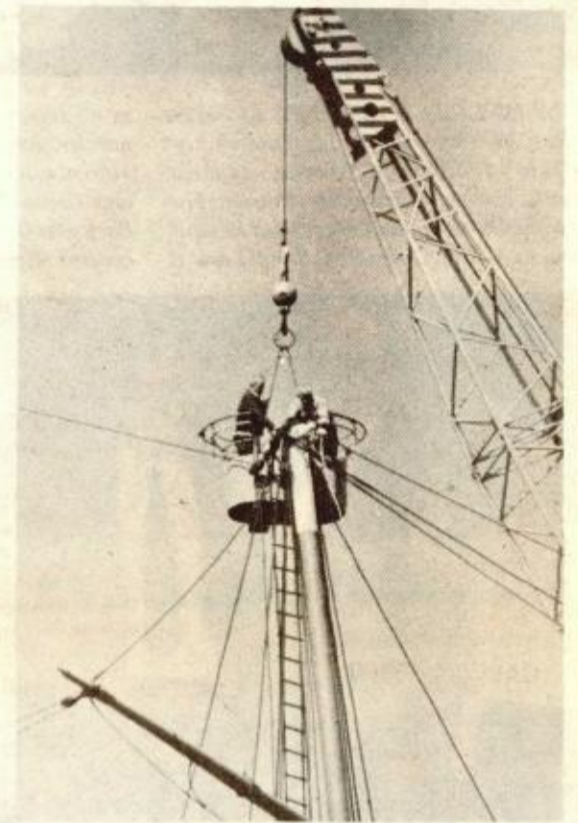


Hurricane "Gloria" Deals Brush To Charlestown

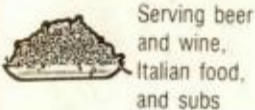

FACTS ABOUT DRUGS — F.A.D.

There are many young parents who used marijuana when they were teens. Some have stopped using marijuana, and some are continuing to use it. This is also true of the other drugs: cocaine, valiums, uppers, downers. Their children are growing up with pills and pot and alcohol all around them. And these same parents would be very upset if they knew their children are experimenting with drugs.

"Alcohol is different," we say. "Everyone tries drinking when they're teens". We make excuses for the drinking adolescent, and we hope it's only drinking. But times have changed, and our kids are testing and using and abusing all the other drugs. Are we getting so used to drug abuse that we are now saying, "Everyone tries pot when they're young — its isn't a problem".

It is very important for parents who have used drugs themselves, whether now or in the past, to look at the history of their own use of abuse and examine why they used drugs and what effect is had on their lives. Why did they stop or why do they continue to use? We can only deal effectively with our children in this area of drug use if we have allowed ourselves to look at our own use and the patterns that were important in our homes growing up.

Tiny Tots Opening Delayed

To "Tiny Tots Program" Supporters:

There has been some confusion as to the status of "Tiny Tots" in Charlestown. I would like to take this opportunity to update residents as to what we are doing to make sure this very worthwhile program continues.

As you know, Tiny Tots operated for years at various sites in the neighborhood and for the last few years at the Golden Age Center on Main Street. Many Charlestown families felt secure in bringing their tots to Marge Coughlan and Dot Collins each day. They were guaranteed a warm, caring atmosphere where their children could play with others their own age. Charlestown Community Schools, the Mayor's Office and Boston Community Schools are committed to seeing Tiny Tots serve Charlestown families.

Our problem this year rests with the licensing of an appropriate site for the Tiny Tots Program. For the last couple of years, a dialogue has been on-going between the City of Boston and the Massachusetts Office For Children regarding the necessity for bringing Tiny Tot sites and staff under Office For Children licensing regulations. This year the Office For Children mandated that Tiny Tot sites be licensed. Unfortunately for us, the Golden Age Center could not meet these regulations without substantial rehabilitation. Therefore, start-up of Tiny Tots has been delayed while we seek a new site acceptable to Office For Children guidelines.

We think we have found a new site. During the next couple of weeks, building, fire, and lead paint inspectors will inspect the space and, hopefully, give us the permits required to operate Tiny Tots. Once these permits are obtained, I can assure you that we will work quickly to get Tiny Tots operational again.

Boston Community Schools provide quality daycare services throughout the City of Boston. Charlestown will not be short-changed. We just ask that you be patient and give us the time needed to secure an appropriate site for Tiny Tots so that we don't have this problem again.

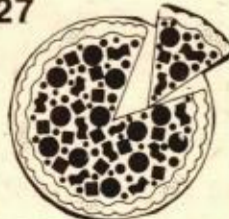

Conway reported that while police are "focusing in on a couple of leads" and do have suspects in mind, no arrests had been made in the incident as of Wednesday noon.
