

I am scared and may need witness protection

Hey [REDACTED] and [REDACTED],

I am not sure what I should do, but I trust that this email will remain confidential between us and not circulated. This all may sound crazy, but please hear me out and read recently released evidence that I have linked here to my tweet. I know [REDACTED] that you have extensive experience as a Federal prosecutor as well as being a federal judge for 6 years. You are aware of the intricacies of the Department of Justice so I trust you will treat this with the utmost importance. I have put my Attorney from the UK that represented me in my lawsuit on this email as well, in case you need information from him as well as my co-worker [REDACTED]. In 2015 [REDACTED] and myself sued [REDACTED] due to its illegal activities that at the time we did not realize how big the problem was, but we knew shady stuff was happening. We sued them for not following labor laws in the UK, we ended up settling out of court in 2015 with their representation from DLA Piper. [REDACTED].
