The COVID-19 pandemic is a public health emergency requiring significant changes to the justice system, including decreasing in-person contact as much as possible. We are here to help. All petitions for Civil Protection Orders can now be done remotely.

- Don't come to court in person! It is contrary to the Governor's order, bad for public health, and not the way to access court services during the pandemic.
- Courts are still open (<u>virtually</u>) to ensure people at risk can get the protection they need. Domestic Violence and Sexual Assault Protection Orders, as well as Weapons Compliance Review calendars, will be heard <u>virtually</u> during the COVID-19 pandemic.
- Below are the ways you can access the court from home. Don't come to court in person!

The King County Prosecuting Attorney's Protection Order Advocacy Program (POAP) is committed to supporting domestic violence victims who are seeking a Domestic Violence Protection Order. <u>Our advocacy services, and access to the courts, can now be done by email and telephone in response to COVID-19 pandemic</u>. All petitioners interested in filing for a Domestic Violence Protection Order who need help from an advocate are encouraged to call or email the POAP offices:

We have tools to help file protection orders remotely. POAP is now piloting a partnership with <u>www.LegalAtoms.com</u>. This easy to use tool has been developed to help a petitioner prepare their Domestic Violence Protection Order petition online using a simple step-by-step format. By using <u>LegalAtoms.com</u> petitioners can do their petition online using this secure tool. Petitioners can then share their petition electronically with POAP advocates for review, consultation, and safety planning, if desired. This free tool is easy to use and designed with the needs of the petitioner in mind and can be used on any cell phone, laptop or desktop computer. Once the protection order paperwork is complete, petitioners can submit the paperwork electronically by email to the court. POAP advocates can review the forms and assist petitioners who need help petitioning remotely. All remote petitions can be emailed to DJA.DVPO@kingcounty.gov . Upon receipt of paperwork the King County Superior Court Clerks office will process that paperwork for a hearing with a Judicial Officer by phone. Petitioners must provide DJA.DVPO@kingcounty.gov a good phone number and email where

the Judicial Officer can reach the petitioner for the temporary hearing and where to send certified copies of any signed emergency orders.

After receiving the temporary order, parties should contact the Family Law confirmations desk (information below) to let them know where they can be reached for the full protection order hearing. Respondents will also be provided information letting them know that they are able to appear by phone.

## **Domestic Violence and Firearms:**

If the person you are filing against has firearms, you can ask the court, as part of your Temporary Order, to order the respondent to immediately turn over their firearms to law enforcement. This order is called an "Order to Surrender Weapons" and can be entered with a Temporary Protection Order (if needed) or at the time the court enters the one-year order (or "full order"). If the person you are filing against (respondent) is an intimate partner (current or former spouse, child in common, current or former dating partner or resided together as intimate partners), then the court **must** enter an Order to Surrender Weapons and require that they be immediately turned in to law enforcement, if the court enters a one year order. Please discuss whether this is something you need to have included in the Temporary Protection Order when you are working with the Protection Order Advocacy Program Advocates. If the court grants this type of order, you will receive a call from the Regional Domestic Violence Firearms Enforcement Unit to follow up with you about the weapons and to help support their safe removal.

Any respondent subject to an Order to Surrender Weapons is ordered to immediately surrender any firearms, dangerous weapons or concealed pistol licenses to law enforcement. They will also be prohibited from purchasing or possessing any other firearms or applying for a concealed pistol license while the order is in effect. The court will order them to appear for a "Weapons Compliance Review hearing" shortly after the full hearing date, to prove to the court that they have followed the court's order.

ALL Protection Order and Weapons Compliance Review hearings will be conducted by phone. Do not come to court in person! Below is a quick checklist to help respondents better understand how to comply with the Order to Surrender Weapons and how to participate in telephone Weapons Compliance Review Hearing.

Please be sure to include in your email the following information:

✓ Your full name

- ✓ Date of your review hearing (this can be found in the upper right-hand corner of the Order to Surrender Weapons Order)
- ✓ The case name (for example: Smith vs. Smith)
- ✓ Your case number (this can be found in the upper right-hand corner of the Order to Surrender Weapons, for example: 19-2-12345-6)
- ✓ A good phone number where you can be reached between 8:30am and noon <u>on the</u> <u>day of your review hearing</u>
