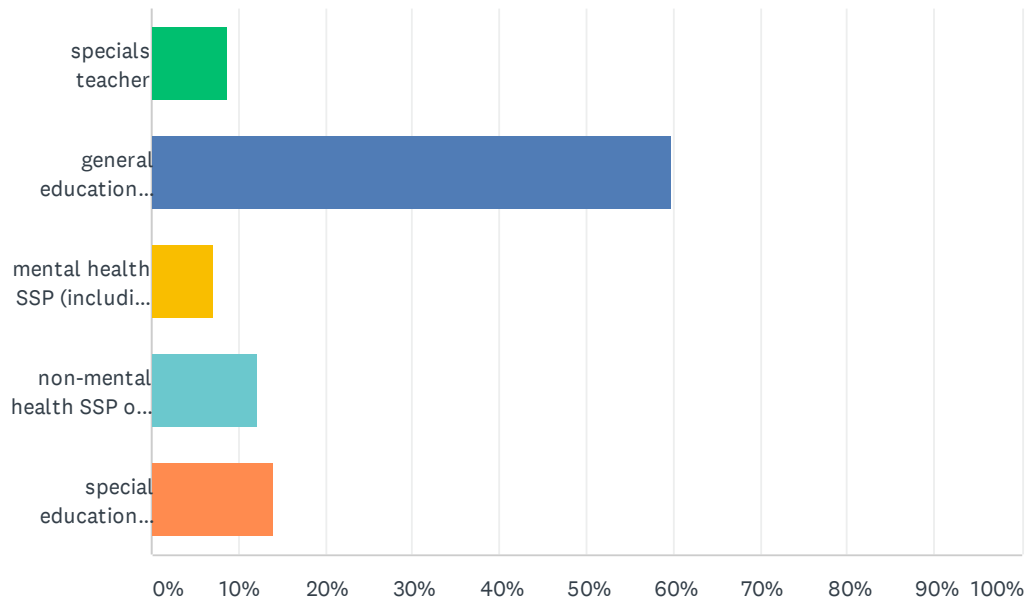


Q1 At the elementary school level, what position(s) will you hold in 20/21? (Check all applicable boxes.)

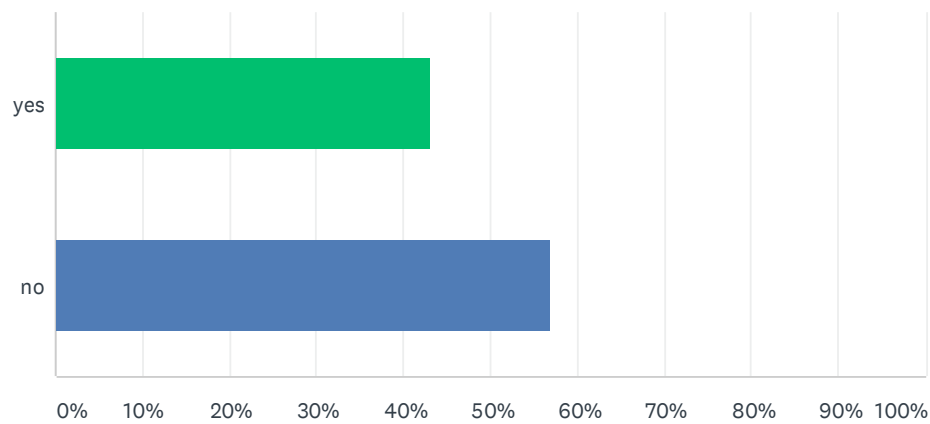

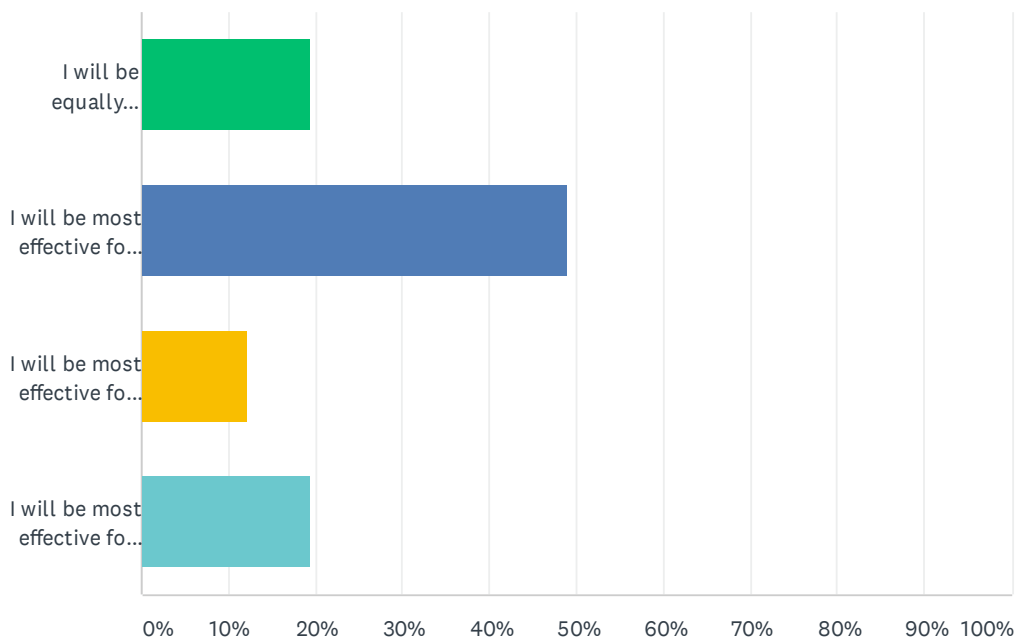

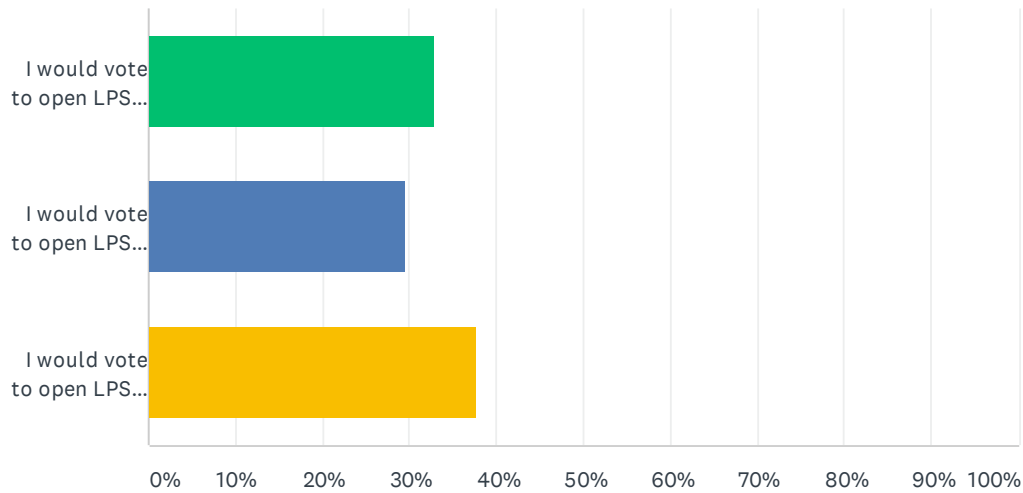

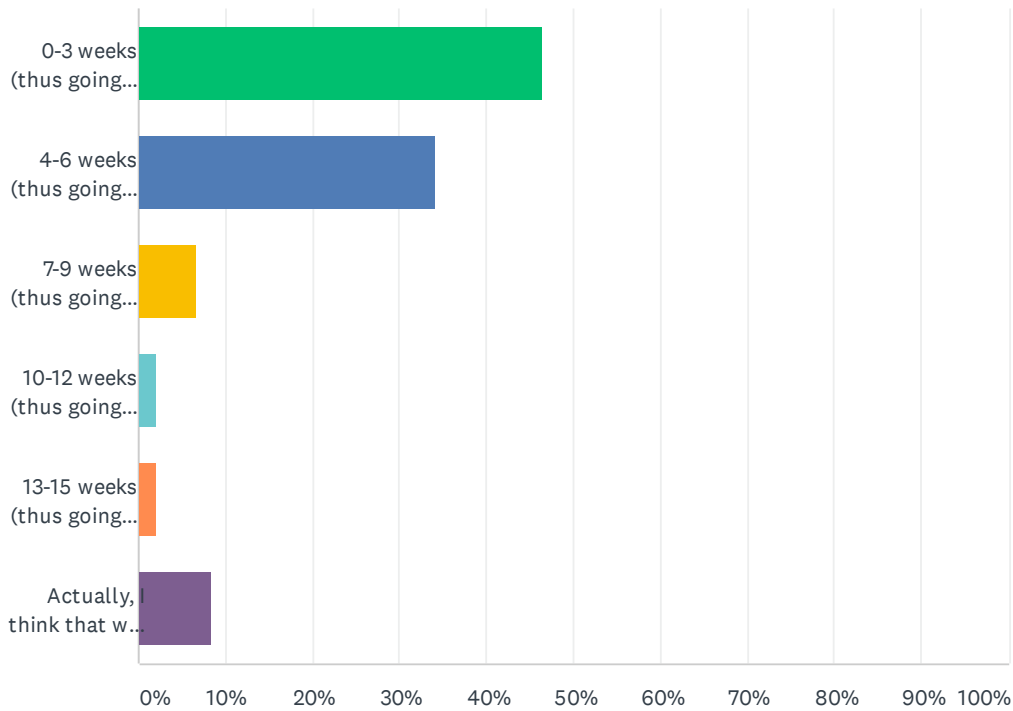
