

# FV Automotive Inc.

## Limited Warranty

This Limited Warranty applies to rebuilt transmission purchased from FV Automotive Inc. Installation and use of the product acknowledges acceptance of this warranty.

### What does this limited warranty cover?

This Limited Warranty covers any defects in material or workmanship under normal use during the Warranty Period. During the Warranty Period, FV Automotive Inc. will repair or replace, at no charge, the transmission or parts of the transmission that proves defective because of improper material or workmanship, under normal use and maintenance. This Limited Warranty is **not** transferable and does **not** cover commercial vehicles including but not limited to taxis, police cruisers, vehicles for hire, etc.

### What will we do to correct problems?

FV Automotive Inc. will repair the transmission at no charge, using new or refurbished replacement parts; or exchange the defective rebuilt transmission with a newly rebuilt transmission.

### How long does the coverage last?

The Warranty Period for any rebuilt transmission purchased from FV Automotive Inc is 1 Year from the date of purchase. A replacement transmission or parts assumes the remaining warranty of the original transmission.

### What does this limited warranty not cover?

This Limited Warranty does not cover any problem that is caused by:

- Conditions, malfunctions or damage not resulting from defects in material or workmanship (including but not limited to installation, adjustments, fluid levels, clogged cooler lines, transmission coolers, TV cable adjustments, TCM, etc)
- Conditions, malfunctions or damage resulting from negligence, improper maintenance or modification (opening the transmission without explicit permission from FV Automotive Inc. immediately voids this limited warranty).
- Damaged or destroyed by natural causes including but not limited to lightning, flood, or other natural disaster
- Theft or loss of the transmission.
- Shipping Charges. The buyer will pay for all shipping charges related to this limited warranty. The buyer shall assume all risk of loss or damage to the transmission while in transit to us and transit back to the buyer.

- Parts outside the transmission. Including but not limited to electrical switches, solenoids, safety switches, sending switches, linkage, throttle cables, valve cables, or wiring systems.

### **What do you have to do?**

To obtain warranty service, you must first contact us to determine the problem and the most appropriate solution for you.

Deliver the transmission, in either its original packaging or packaging providing an equal degree of protection, including any parts or documents that shipped with the transmission to the address specified by FV Automotive Inc. You can contact us by any of the following contact methods:

### **Consumer Protection**
