$\star$ Tax Errors That Are Just Too, Too Common... "It's the little things on tax returns that cause many of the biggest problems for taxpayers," said IRS Boston District Director Francine Crowley.

Here are some of these taxing stumbling blocks to a trouble free tax return, a faster refund and a better fiscal world:

- Who are you? Your name and social security number on your tax retum must match your records at the IRS Service Center, which come from the Social Security Administration. If they don't, your refund due may by delayed until the mismatch is worked out. Name changes due to marriage, divorce, etc., should be listed on the return and reported to the Social Security Administration.

If your name or social security number is inaccurate on your tax return peeloff label make the changes on the label.

- Watch your figures. Be sure they are accurate, on the right lines, and that the decimal points are in the right place, and you use the correct figures from the tax table.
- Be sure your retum is signed and dated (by both husband and wife in the case of joint returns).
- Attach all W-2, "Wage and Tax Statements" and the required forms and schedules.
- Be sure you used the correct filing status.

Be sure you use the correct postage when mailing a tax return and that you include your return address.

## TAXES AND <br> GOOD CORPORATE MINUTES

Writing up the minutes of board of directors' meetings is not exactly a high priority for most business owners. Yet will-documented corporate minutes can provide valuable supporting evidence if your tax positions are ever questioned.
Minutes are especially important where any kind of related-party transactions occur, such as payments, loans or distributions between the company and its owners. For example, the IRS may challenge the amount of compensation paid to a business owner as unreasonable. Corporate minutes that document the factors considered by the board in approving the compensation can be a strong defense against such a challenge.
Another area that receives close scrutiny from the IRS is the amount of earnings that are retained in the business rather than distributed as taxable dividends. A penalty applies to retained earnings over a certain limit unless they can be justified by business needs. Corporate minutes can be a strong piece of supporting evidence if they clearly spell out the reasons that the company needs to retain funds - for example, for purchase of assets or for working capital.

If your company has a tax-qualified retirement plan or a stock option plan, the minutes should show decisions by the board adopting or modifying the plan. They should also document annual decisions on the percentage of contribution to profitsharing plans and any decisions on fringe benefits such as medical reimbursement accounts.

Corporate minutes need not be lengthy, but they should provide a clear record of corporate actions and the business factors that were considered when those actions were taken. You should think of your minutes as a key element of your tax planning strategy.

## Local Parent Fosters Love Of Books At Warren-Prescott School

What happens when a parent of a child wants to share a love for reading with young students? How about a Book Club that kids can't wait to get to?
With little more than a few books under her arm and some spare time, Marybeth Grace, the mother of Jessica Grace, a student at the WarrenPrescott School in Charlestown, has really been turning kids on to the wonders of reading for pleasure.

Once a week Grace and her little troupe of 10 third grade students break out a storybook and take an hour-long adventure into the fantastic world of books. Among some of the books they've read are The Runaway Bunny by Margaret Wise Brown and Benjamin's 365 Birthdays by Judi Barrett.
"The children help decide what books to read," explains Grace, "and they take turns reading to each other. The small group, which rotates with different students every few weeks, makes it really comfortable for them to try out their reading skills
on each other. They respect each other and don't tolerate any interruptions."
The Book Club is an opportunity for the children to challenge themselves in a non-threatening environment, said Grace. "There are no grades given, just a sense of self-satisfaction; it does wonders for their self-esteem."
"Not only are the students learning to read, they are learning other life skills, like listening, respect for others and cooperative learning," said Grace. "Then too, many of the books strengthen social values. Uncle Wil ly and the Soup Kitchen, a story of a grandfather who takes his grandson on a trip through the world of the less fortunate, is a captivating story which focuses on the plight of the homeless."

## Birmingham Named To Panel Studying Convention Center Options

Sen. Thomas F. Birmingham was recently named to a commission that will help determine the fate of a proposed convention center and/or megaplex.

The commission also includes one member yet to be appointed by the governor, and the executive directors of the Mass. Convention Center Authority and the Boston Redevelopment Authority. The members are required to make their recommendations to the govemor and he legislature no later than June 1 .

## DEMOCRATS TO CAUCUS STATEWIDE

Registered Democrats in Charlestown will be holding a caucus on Sunday, March 5, 1995 at 2 p.m. to elect delegates to the 1995 Massachusetts Democratic Convention. Doors open at 1 p.m.

Charlestown, Ward 2 will be electing 12 delegates and four alternates, equally divided between men and women, to send to the Convention. The apportioned number of delegates has been allocated on the basis of a formula giving equal weight to the Democratic Party registration and the average vote for Democratic candidates in the last general elections for Governor and President for which figures were available at the time delegate tabulations were prepared.
Thomas S. Cunha will call the caucus at the Knights of Columbus Hall, 75 West School Street. The caucus is open to all registered Democrats, persons ineligible to register and media representatives. The only persons eligible to participate in any portion of the caucus are those who are registered Democrats in the ward or town as of December 31, 1994. There will be no absentee or proxy voting.

Registration shall remain open until all persons presenting themselves have registered, including any in line or outside the meeting place. The caucus will start promptly at 2 p.m.

Candidates for delegate and alternate must also be present, voting and give his or her written consent to be nominated and that nomination must be seconded by two persons present at the local caucus.

All ballots will be written and secret. Those candidates receiving the greatest number of votes on the first ballot will be elected. Each candidate will be allowed to make a two-minute speech and to distribute on his/her behalf one sheet of paper listing qualifications and ideas.

Slate-making is allowed, but no special preference shall be given to slates. There is no quorum required for the caucus.

There will be no admission or expense charge at the caucus, although donations may be solicited.

Discrimination on the basis of race, sex, age, color, creed, national origin, religion, ethnic identity, philosophical persuasion or economic status in the conduct of the caucus is strictly prohibited.

## Voke Seeks Cap On Tobin Bridge Tolls

Fighting to keep the commute an affordable one, Rep. Richard Voke is championing an effort to cap toll rates for travel across the Tobin Bridge at $\$ .30$ for Charlestown residents. As discussion continues on Beacon Hill regarding the creation of the "Metropolitan Highway System," Voke is angling to relieve local motorists from the cost of potentially higher tolls the new system may bring.
"The bridge has been and continues to be a source of tremendous disruption for our community. While only one way of mitigating the inconveniences Charlestown people face on a day-to-day basis, capping the tolls could save local motorists hun-
dreds of thousands of dollars every year," said Voke. The metropolitan highway system, if created, would combine the ownership, operation and maintenance of the Sumner, Callahan and Third Harbor Tunnels, the Central Artery, the Masspike from Boston to Route 128 and the Tobin Bridge into one integrated roadway system under the Mass. Turnpike Authority.
As Majority Leader, Voke's role in the development of House policy on legislation before it is great. In January, Voke was quoted as saying any such highway bill would get tied up like "rush hour motorists" should Charlestown's issues not be addressed. Pledging to use
such influence, Voke says he is optimistic that a new version of the metropolitan highway system bill would encompass a cap on what can be charged to Charlestown residents should toll rates rise like many transportation experts predict.
Voke is also seeking further considerations in the bill, including the payment of a sum in excess of $\$ 10$ million to Boston as an additional mitigation for bridge operations. However, Voke says the potential sale of the bridge and
any benefit Charlestown may derive from such a sale may not be determined until a later date, as policy crafters are still wrestling with the price the Turmpike Authority would pay Massport in the transaction.
"Charlestown deserves what it is owed and more for the burdens our community has endured. As this issue continues to evolve, I am committed to being there every step of the way to make sure our voices are heard loud and clear," concluded Voke.
