Crime: Civilians killed during the bombing of oil refining tanks at Al-Buraiqa Refinery.

Place: Al-Buraiqa district, Aden governorate Dates: 27, 30 June and 9, 13 July 2015.

Aggressor: Houthis forces "Ansar Allah" and Yemeni Republican Guard

Description: "crime against humanity", according to the conditions and criteria provided for at Rome Statute for the ICC, and a "war crime" according to Genève fourth Convention

provisions on civilians' protection.

Definition:

The crime of Civilians killed during the bombing and burning of oil refining tanks at Al-Buraiqa Refinery, Aden governorate, southern Yemen is crime against humanity and war crime committed by Houthis forces "Ansar Allah" and their allies the Republican Guard, on 27, 30 June and 9, 13 July 2015, against Aden city and its civilian citizens by bombing oil filled tanks at the Refinery using Katyusha and mortars, causing the death three people and injured 12 others and huge fire associated with smokes that covered the city and loss of more than \$.40 million, pollution, and devastating impact on children, aged and women health. Nearby oil port was also impacted as well as state oil company. This bombing was premeditated with full knowledge that the consequences will kill and burn civilians and will displace others outside their district5, in addition to the economic losses and damage to the public life in Aden governorate. Therefore, this is a crime with full conditions of crime against humanity and a war crime with victims being civilians and the economics of the country in general.

Reasoning:

The oil tanks were bombed during four phases:

First bombing; Houthis and the allies bombed the tanks at Al-Buriqa refinery with Katyusha and mortars, targeting the largest oil tank in the Refinery known as tank 24, with capacity of 50 thousand tons, which is one of the largest oil tanks according to the international standards. Following bombing the tank was set ablaze for five days burning out all stored oil (1).

Second bombing; on 30 June 2015, where Houthis forces fired Katyusha and mortars on Oil Port in Al-Buriqa near Al-Buriqa Oil Refinery, injuring eight workers and causing huge



material damages, and consequently stopped work at the port, and relief ships could not use it any longer. Engineering Ali Abdul Kareem director of operations in the Refinery was suffocated to death while he was trying to close the valves and pipes that link the burning tank and other tanks (2).

Third bombing; on 9 July Al-Buriqa Refinery was targeted for the second time with six shells, killing one person and injuring another seriously according to the International Organization for Monitoring Human Rights.

Fourth bombing; on 13 July 2015, Houthis fired Katyusha and mortars on oil refining tanks, hitting two tanks and set them on fire for many days, also hitting houses and killing one pregnant woman, and injuring others including children, according to statement made by Mr. Naser Shaef, media officer at the Refinery.

<u>Initial report on the losses:</u>

A report issued by the Refinery Co., has estimated the quantity of burned crude oil and oil products as a result of the bombing at 143 million liter, and \$.40.768 million as financial losses, and this is initial assessment of the financial loss which might increase (3)

Community reaction:

Aden A-Ghad news website has quoted locals and eyewitnesses that Katyusha and mortars were fired by Houthis forces deployed at Attwahi district in the other sea shore, causing huge fire and smokes, and hitting a number of workers' houses, killing one woman (4).

Officials at the refinery said that extinguishing the fire was very difficult fearing that it might expand to other tanks, causing human catastrophe. Also rendering the port inoperative. Economists also warned that Aden governorate will face fuel crisis and power stations will stop as well as transportation means and water supplies.

Mr. Naef Al-Bakri, Aden deputy governor "that time" said that Houthis and their allies are trying to burn out Aden city and its inhabitants by burning Aden Refinery and oil tanks and facilities/terminal in Oil Port in Al-Buriqa that resulted in poisonous smokes and gases, causing environment pollution which is expected to continue for next years. Also this toxic gases of burning oil caused deaths and injuries specially among people with asthma. He urged the international community to protect civilians in Aden and bring perpetrators among Houthis and Saleh's troops and their political leaders to the ICC accusing them of genocide (5).

Crime Corresponds with the Criteria of Crime against Humanity:

The Advisory Center for Rights and Freedoms sees that this crime was committed systematically and within a plan of premeditated killing within comprehensive attack against thousands of civilian people and workers and against economic facilitates with the intention to



kill them and harm oil economic while they are not part of the military operations, and their facilities does not represent any military risk justifies such crime.

Thereby, defines it as a crime against humanity where criteria of clause (a) of article 7 of Rome Statute of the ICC applies (6). In addition it is a war crime as defined by Genève fourth convention on protection of civilians during wartime.

Need to address this crime:

The Advisory Center for Rights and Freedoms, demands UN Council for Human Rights to consider this crime and refer it to the ICC to ensure remedies and justice for victims and that perpetrators will not enjoy impunity from punishment including soldiers who committed the crime, military commanders who gave orders, in particular the commander of the military group located at Attwahi district, military operations commander in Aden Abdul Kalek Al-Houthi, as well as their political leaders including Ali Abdullah Saleh
