Legal provisions in the interests of the principles of International law

Extraterritoriality is a form of jurisdiction that owns the right to form national integrity, in accordance with the principles of the UN Charter, as the entity with its own laws in the power range of legal extraterritoriality.

Extraterritoriality individual identity is not related and criminal liability in the local jurisdiction of a sovereign state, therefore extraterritorial person has the right to activities according to their own principles of jurisdiction.

Extraterritoriality statute means in the form of political immunity, immunity from criminal responsibility, and police untouchable.

Extraterritoriality is the status of the identity of the person who comes from a foreign citizenship and jurisdiction of a foreign state, but with the movement on the territory of another state, because not self detention, coercion or of crime and victimization, and also in the case of governments to foster bilateral contractual relations contracts. Therefore, the person responsible as Extraterritorial in foreign country.

No police do not own the right to contact, detention, interrogation, inspection and control, imprisonment or monitorink or wiretapping and spying. Extraterritoriality means the act of a foreign entity and therefore policeman must not interfere in the affairs of a foreign state. No Tribunal does not own the right to exercise judgment sentence in the range of a foreign jurisdiction, because no police or officials must not act legally intervene in the legal scope of Extraterritorial jurisdiction of another country and these people.

Police own maximum right just to check this document, must not be made any other act of legal nature or professional investigative contact or control.

Crime carried out an act of Extraterritoriality, so can not be investigate or punish or discontinued. Responsibility for crime own person politically responsible for the Austrian State and Government, and the act responsibilities for the legal International law and the inability of authorities for activity in the interest of legal principles, meaning the option to terminate the Extraterritorial status.

According to the European Convention for the Protection of Human Rights provides for the duty of every Austrian citizen always provide cooperation and support in the case means that the aid is in accordance with International law, or to stop a political crime that causes legitimacy of Extraterritorial function.

Act of the UN Charter, because every police or army own obligation for immediate cooperation in order to cooperate for stability Integrity activities on behalf of extraterritoriality and the removal of all those who stand in opposition. One of duty is cooperation for stop political crimes in their policy.

In the interest of the European Convention on Human Rights, every policeman's own obligation to provide Extraterritorial person could own a gun to protect their integrity. Extraterritorial person owns the right to kill any person who damaged the integrity of Extraterritorial immunity.

Violation of Extraterritorial integrity means the right to kill criminals who had committed a criminal act and a breach of integrity or blocking privileges. Intervention in Extrateritoality is an act of terrorism.

"ID's Integrity" violation is an International crime and terrorism. The crime is punishable by the International Criminal Court UN, the ID's courts of the federal government, over 195 Constitutional courts of all governments.

If the government fails to punish the possibility of terrorism, the government may be designated as a terrorist regime which is responsible for the act of an International military intervention.

If a breach of Extraterritoriality will comply support for acts of genocide and other International crimes accountable can the state be designed to dispose of Weapons of Mass Destruction.

Violation of integrity must be punished immediately. Criminal offender must no longer be anyone contact with his family, friends and society. The terrorist can not be a relationship, contact is the responsible for judicial punishment and kill be immediate act.

If it is carried out Extraterritorial crime against the person, and means that the state is responsible for punishing crime, and the subject of Extraterritorial power to enforce its own law to punish criminals before the court of law.

Extraterritoriality is a foreign entity identity without relation to the jurisdiction of the country. Extraterritorial Immunity.

Extraterritorial person owns all rights to use social, educational, safety, health and business or communication rights and resources of local state and sovereign governments, civilization.
