- 3. Beginning Wednesday, April 29th the Economic Development team will review of applications and provide the list of pending approvals to the Finance Department to assess compliance with licensing and sales tax remittance.
- 4. Approval/Denial
 - a. First-come, first served (60+) applications
 - b. Has the applicant uploaded a W-9?
 - c. Has the applicant uploaded Income Statements form 4th quarter 2019 and 1st quarter 2020?
 - d. Does this applicant meet all eligibility requirements?
 - i. A non-home-based business with a physical address within the City of Littleton
 - ii. A for-profit business
 - iii. A sales and/or use tax producing business
 - iv. Business was in operation on Jan. 1, 2020
 - v. Currently licensed with City of Littleton
 - vi. Business is in good standing with the City of Littleton as of February 1st, 2020 (e.g., no liens, judgments, code violations, etc.)
 - vii. A business with no more than 50 full-time equivalent Full Time Employees (FTE) positions
 - viii. Business has been forced to temporarily close or forced to dramatically limit operations due to the Public Health Orders related to the COVID-19 public health crisis
 - ix. Able to demonstrate economic injury and a need for a grant to help mitigate the economic injury
 - x. Business will use funds for operational needs such as lease/mortgage payments, payroll, utilities, materials, supplies and services
- 5. When review of applications is complete two lists will be identified:
