Congressman Joseph Kennedy Hosts Town Meeting In Charlestown

"There has to be a trust between you and me," Congressman Joseph P. Kennedy told a gathering of over 150 Charlestown residents on Monday evening, February 22nd, at what was billed as a Town Meeting. "There has to be trust that I will be here . . . not only on election day asking you for your vote, but I want to be here on the issues Charlestown is facing. I want to be here with you and stand with you when times are tough as well as when times are good."

Following a welcome by Father Thomas Reilly, pastor of Saint Catherine's, Kennedy opened the meeting, pointing out that there were many in the audience who had assisted him in his election campaign for Congress two years ago. He noted, however, that many present were not involved in that campaign and commended all for their caring about the affairs of their community and country to

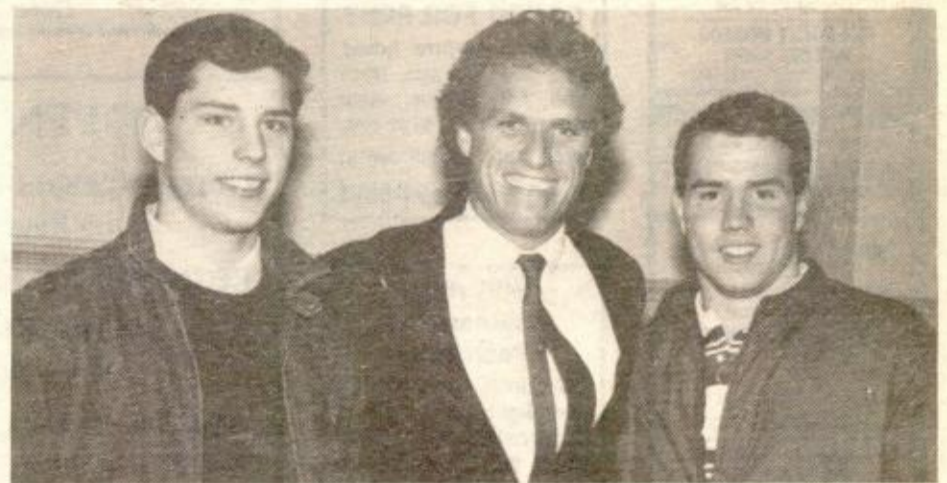

Plans To Develop 127 Main Street Meet With Opposition

"You're not listening to the community," stated Judy Evers, Community Liaison from the Mayor's Office of Neighborhood Service, who voiced the frustration of the neighborhood residents at the Housing and Development Committee meeting held Tuesday evening, February 23rd to review the proposal of Dick Held and Paul Kelly to develop the lot at 127 Main Street, located behind the liquor store at Thompson Square.

Attorney Michael LoPresti, representing the developers, stated in response "I feel I'm listening to the same eight people for the past two years." Thus went the public meeting, with conflict between neighbor and developer continuing until adjournment.

Held and Kelly plan to build a four-story structure, approximately forty feet high, extending between Main and Warren Streets, with twenty-one condominium units, plus two retail spaces on Main Street and parking on the first floor level and underground for twenty-one cars.

Residents expressed their displeasure with the density of the project and repeatedly asked the developer if he would be willing to scale down the size of the project. LoPresti stated that there were no plans to change their design and felt that the developers had made sufficient adjustments since they last appeared before the Board of Appeals, stating "We're going forward with the proposal."

Concerns that the residents felt were not being addressed were the additional residential and guest parking problems this develop-

ment would create in an already over populated area. When asked where will the additional cars go, LoPresti stated "on the street." The mass of the structure was also a concern. Architect William Lamb, a Warren Street abutter, stated that the project was "too bulky" with the only open space being the alleyways between the buildings. Lamb also noted that this design was "out of character with this part of Charlestown" and "this isn't the sort of thing we should create," noting that he didn't see significant changes from the original proposal.

Carol Bratley, also an abutter, stated that "everyone is opposed to a four-story building. You have shifted the design of the facade, but underneath its the same product. The major problem is the number of units. There are too many for that site. Density is a serious problem."

The developers were reminded that the Board of Appeals, when denying the developer's request last June, asked that they go back to the community and work out the problems, something most in attendance felt the developer did not do. As one resident stated, "We can understand that you want to make a profit, but there must be a way to make a profit, make a nice development with less units and still come out with a reasonable amount of money." Another stated that "what you build, we will have to live with for years and years to come."

Traffic in the area was another problem the residents felt was not being addressed. Due to the narrowing of the roadways on

Main and Warren Streets, it was noted that a backup of traffic would occur with residents trying to enter the garage on Warren Street and trucks delivering to the liquor store on Main Street. It was stated that Held had made arrangements with his distributors to use smaller trucks and to schedule deliveries so that only one truck would be at the store at any one time.

Residents complained that LoPresti was not answering the questions posed to him, rather "answering around the problems." At this point Council Chairman Dennis McLaughlin stated that "the Council would vote on the issues, not on what the developer says."

Another concern voiced was the question of any fu-

ture plans to build onto the liquor store. John Bell, Project Coordinator for the Boston Redevelopment Authority (BRA) was asked how many units could be built on this size lot by BRA specifications. When neither the developer, the architect nor the BRA could give a figure on the size of the lot, Bell stated that he'd get back to the community with that information. (Attempts to obtain this information before publication were unsuccessful.)

McLaughlin requested that residents send their concerns to the Neighborhood Council prior to their March 1st meeting so that the members would be better informed on the overall concerns and objections that the residents have with this development proposal.

Another meeting will be set up by the Housing and Development Committee before the Council's April 5th meeting to further discuss the overall concerns of

the neighborhood on this proposal.

A request to defer action on this proposal to a later date will be made at the Board of Appeal hearing scheduled for March 1st. Dates of both the upcoming meeting and Board hearing will be published in the Patriot when the information is made available.

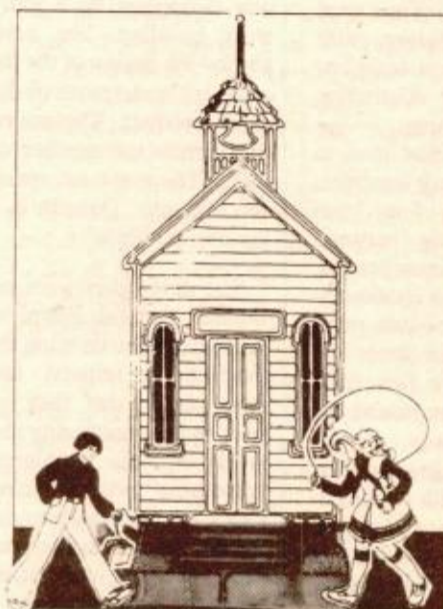
CHARLESTOWN HEADSTART FIRE FUND

EDIC Taking Action On The March 18th Closing Of Amstar

The closure of the Amstar/Domino Sugar Refinery on Medford Street, Charlestown, was the subject of correspondence from Marilyn Swartz Lloyd, director of the Eco-

nomc Development and Industrial Corporation of Boston (EDIC) to Mayor Raymond L. Flynn this past week.

Lloyd stated that the EDIC would be meeting

with the employees to explain the steps that the city and state would be taking jointly in dealing with the closure of this plant, set for March 18th.

She told the Mayor that a Workers' Assistance Center would be set up for the laid-off employees and the state, which directly funds such centers, would propose a separate center at the Domino plant if this is determined to be the most favorable site.

Lloyd stated that EDIC will meet with local company officials, union representatives, staff from the state's Industrial Services Program and the Office of Jobs and Community Services to discuss details of a

Workers' Assistance program. She also noted that EDIC will ask the company to provide financing or in-kind service support.

The EDIC, according to Lloyd, will make arrangements through Amstar's New York headquarters for a physical inspection of the site to determine its potential for new industrial uses.

She also said that a study will be conducted to determine the feasibility of EDIC acquiring the site for subsequent lease or sale to another maritime industrial user and that they would explore various financial options including the use of neighborhood development funds.

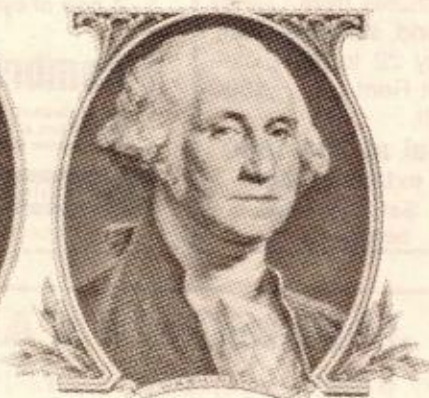

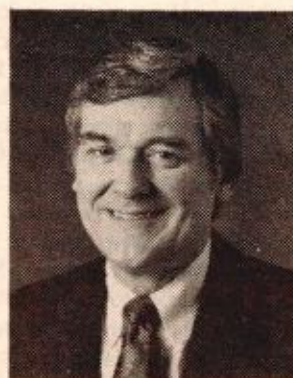

Engineers Consider Revised MWRA Plan

The United States Army Corps of Engineers is soliciting public comments on the revised plan of the Massachusetts Water Resources Authority (MWRA) for water transportation to serve the proposed Boston Harbor wastewater treatment facilities at Deer Island. The Revere Sugar site is now being considered and may replace Piers 48, 49 and 50 in Charlestown.

The application for the federal permit was filed

with the Engineers in compliance with Section 10 of the Rivers and Harbors Act which provides for federal regulation of any work in, under or over navigable waters of the United States and Section 404 of the Clean Water Act which regulates the discharge of dredged or fill material in United States waters, including wetlands.

To assist in evaluating the revised proposal, the Engineers are soliciting public

comments. Written statements should be forwarded to their office no later than March 21. Additional information may be obtained by contacting Karen Adams at

Housing And Development Committee Votes On Parcel P-2A

The Housing and Development Committee of the Neighborhood Council met on Wednesday, February 17 at the Charlestown Working Theater to review design changes made in the proposals submitted by four developers for the Boston Redevelopment Authority (BRA) parcel P-2A, located at the intersection of Bunker Hill and Main Streets, directly behind the Theater and the Charlestown Community Garden. After hearing the design changes from the developers and concerns from the community, the Committee voted on the proposal they felt should go forward to the entire Neighborhood Council for a vote at their next meeting on Tuesday, March 1st.

Council member Moe Gillen, who chaired the meeting, informed the audience that the meeting was being held in response to a Council vote to insure the community and abutters of another public meeting in their neighborhood to review the changes made in the four proposals before the Council voted on the developer they would recommend to the BRA.

Present at the meeting to oversee the presentation by the developers and listen to the concerns of the neighborhood were BRA representatives Larry Brophy,

senior planner, and Housing Creation Team Specialists Bob Rush and John Noone. The Mayor's Office of Neighborhood Services Director Don Gillis, Assistant Director John Riordan and Community Liaison Judy Evers were also present.

Brophy stated that "We're (BRA) certainly looking for input from the Neighborhood Council on which way to go" (with this parcel). "The idea of housing - and affordable housing, there's no question whatsoever about that - is something we would like to do, if possible, this year. I realize it's not going to be a very easy decision to make." Brophy then outlined the procedure the developer would have to go through before receiving final designation on the parcel and stated, "I would expect the neighbors here would like to see the drawings before final designation is made. If asked for a time frame on the process, I would say 14 months on the fast side or 18 months on the slow side, but with a little bit of luck, there could be occupancy within one year."

Don Gillis stated that "the Charlestown Neighborhood Council deserves a lot of credit in handling the number of parcels that have come before them during the past year." Although a

lot of experts got involved with the process, he continued, "the real experts are the folks in the neighborhood who know what they need and what they want for this property. Our goal overall is to get a proposal with the most affordable type of housing you want to provide opportunity for Charlestown residents. We need to move as quickly as possible and are looking to you for your advice."

The Committee vote could not be interpreted as an overwhelming vote of confidence for any of the four developers. Seven members voted for Gate Five Associates, five voted for Myerson/Allen and three voted for Crowninshield Corporation. Charlestown Garden Town Houses (Conroy Development) received no votes.

Although Gate Five Associates received the majority of votes from the committee, their recommendation will now have to go to the full Neighborhood Council for a final vote on March 1st.

The breakdown on the proposals submitted by the four developers are as follows:

- Gate Five Associates: 28 single family units - fee simple. 14 units market rate with two bedroom units at \$210,000 and three bedroom units at \$265,000; 14 units

affordable with two bedroom units at \$86,000 and three bedroom units at \$98,000. (Two bedroom units will consist of 2½ stories for a total of 1,280 square feet and three bedroom units will consist of 3½ stories for a total of 1,900 square feet); 32 on street parking spaces will be provided. The total cost per square foot is estimated at \$70. The 25 percent community contribution would be \$137,721 that would either go to the Life Focus Center, as previously committed, or go back into the project to reduce the cost of affordable units.

- Myerson/Allen:

32 Condos - fee simple, with group ownership of parking. 16 units market rate at \$196,000 (no breakdown on unit sizes given); 16 units affordable with two bedroom units at \$86,000 and three bedroom units at \$98,000. (The two bedroom units will consist of 1,030 square feet and the three bedroom units will consist of 1,400 square feet - no size given for one bedroom units); 52 parking spaces will be provided. The total cost per square foot is estimated at \$82. The community contribution would be \$164,000 (25 percent) that would go back into the project to reduce costs of

affordable units.

- Crowninshield Corp.: 44 Condos - fee simple - six one-bedroom, 32 two-bedroom and six three-bedroom units. 22 units market rate with two bedroom units at \$200,000 (no other figures were given); 22 units affordable with the average price at \$58,000 (no other figures were given); the average size of units would be between 1,500 and 1,600 square feet; 80 parking spaces provided, half of which would be located under the units. The total cost per square foot is estimated at \$62. The 25 percent community contribution would

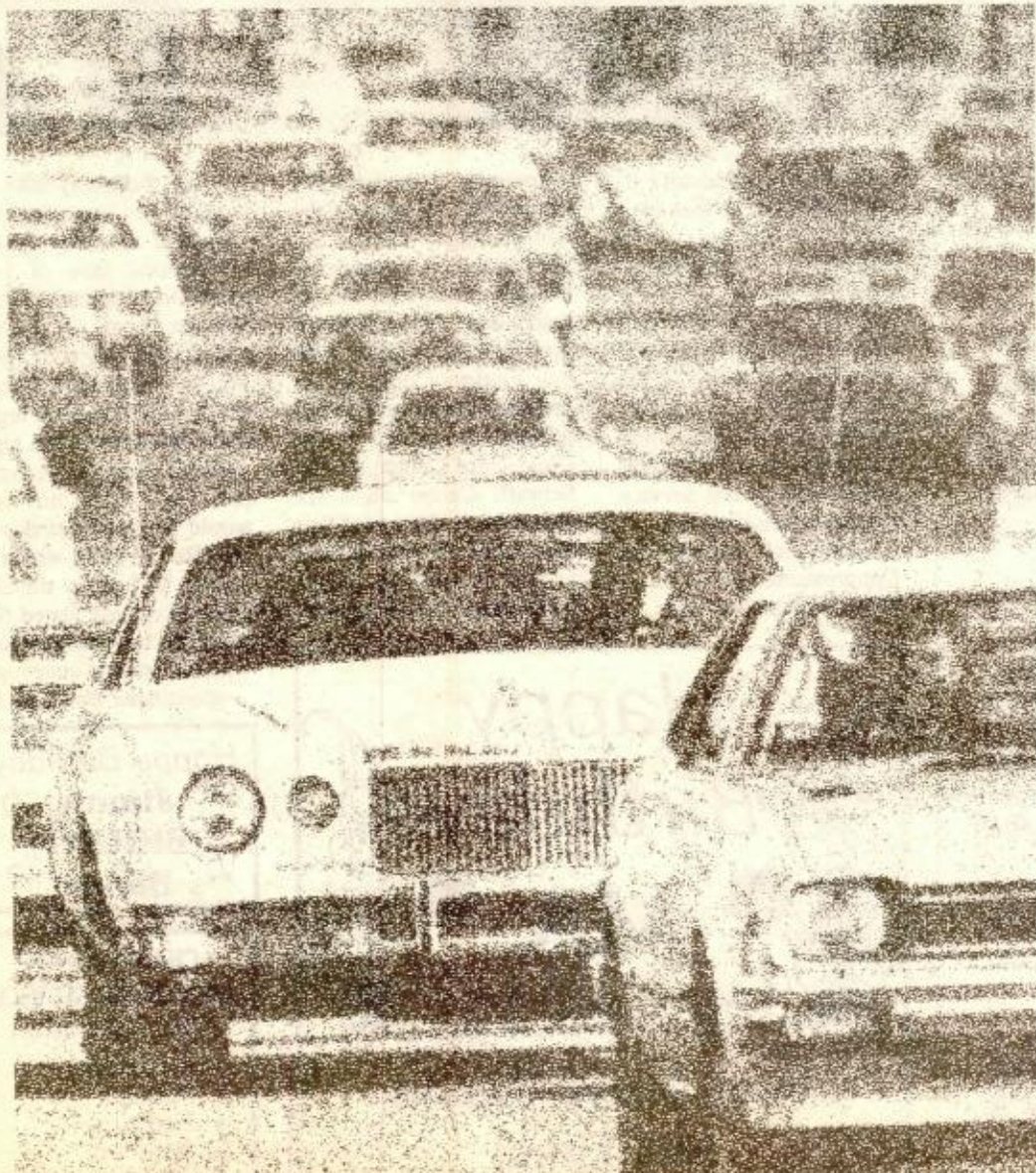

that such a Town Meeting allows him to stay focused on the concerns of the residents — concerns such as affordable housing, health care and education.

The Congressman was critical of the Reagan Administration, stating that every time the Housing Committee, of which Kennedy is a member, proposes a bill to try to do something on affordable housing, they are told there is no money and yet when the issue of Contra Aid came before the House of Representatives, the money was not an argument.

Kennedy told the residents that it "doesn't take guts to stand up and say this country needs a new missile or weapons system, but it does take guts to stand up and try to re-direct the nation's priorities." He gave a general overview of the nation's expenditures, quoting "\$220 billion for servicing the national debt . . . \$300 billion on national defense

. . . \$400 billion on Social Security, Medicare and Medicaid . . . with \$150 billion left for roads, health care, housing and education."

Kennedy touched on taxation, noting that 20 percent of the people at the top of the income bracket earn 47 percent of the wealth in this nation, whereas the 20 percent at the bottom earn only 4.7 percent of the wealth. He stated that he could not say "never raise taxes," but the question is "who is going to be taxed and whether they should pay their fair share" of taxes.

As to priorities, Kennedy stated that it is time that Americans came out and stated that they believe in a strong America. He said that the country should "get a hold of old basic values" in order to make this a country of which we can all be proud.

The first question from the gathering to Kennedy concerned the recent curtailment of the hours of window service by the Postal Service as a part of the federal cut-back. A resident told Kennedy, "Last week I went down to the Post Office [between 1:00 and 2:00 p.m.] and they were closed. I thought I was in Mexico." He stated that he "sat down and wrote a letter" to Kennedy and, as he stood up and passed it to Kennedy, noted that he was hand-delivering it as he didn't "trust the Post Office."

Kennedy stated that residents shouldn't blame the Post Office for the cutback in service. He said that because the Post Office makes money, citing the sale of stamps as the prime source, the federal government is going to utilize some of that money to pay other debts.

from the Congressman's office, later stated that their office has written to the Charlestown Neighborhood Council asking for their assistance in formulating a plan that would be optimal for the community, given the 39½ hour time frame for this Postal Office, and this would then be brought back to the Postal Service for their consideration.

Carol Grace asked the Congressman for his assistance in obtaining funds, in

the amount of one-half million dollars, to rebuild the fire-damaged Old Kent School which housed the Headstart Program. Walsh responded that the Congressman has worked with the Flatley Company to provide a temporary site to relocate Headstart in the Child Care Center at The Schrafft Center on a six month basis. He added that they hopefully will be able to help in securing funds.

Resident Ken Stone ask-

ed the Congressman for support in opposing the proposed locating of the northbound lane of I-93 closer to residential Charlestown as part of the Central Artery project. Stone pointed out that there was a section in the federal legislation that prevented a highway from being built over a park and that this lane would be constructed over Paul Revere Park, which he termed a "heavily traveled area." Kennedy stated that his office has been in touch with federal and state high-

(continued from page 10) way people. He said that he wasn't aware that there was a "law to hang our hat on" in following up on these concerns.

Mount Vernon Street resident Bob Wallace raised the point of drugs being a major issue facing the community. He stated that drugs are destroying our country, our people and especially our children and noted that it was "about time the federal government did something."

Kennedy acknowledged the problem with drugs, noting the fact that he lost a younger brother to drugs and knows the devastation on the family. He stated that ultimately the problem is only going to be solved by the people in the communi-

ties who recognize that drugs are present and deal with that issue. He said that no matter how much money is spent by the federal government to prevent drugs from entering this country, the fact remains that there are tens of thousands of miles of border and drugs would get in. He also pointed out that not all drugs are imported, some are grown in this country.

Tom Cunha raised the question of the bill submitted as the National Community Housing Partnership Act. Kennedy stated that the bill would provide \$500 million to non-profit organizations throughout the country in order to provide affordable housing for senior citizens, the middle income and poor residents.

He said that changes in the tax code have decreased the incentive for individuals and businesses to invest in such housing. This bill is an attempt to get money directed toward non-profit organizations who can build affordable housing at a lesser cost, especially when the cost of the land and developers' fees are waived.

Other issues that were discussed at the meeting included the resignation by the Secretary of the Navy; the Leland/Kennedy bill being introduced in Congress next week to provide aid for the homeless; the prospects of a maritime industry in this country (Kennedy noted it was cheaper to build ships overseas); the trade deficit; military protection of the oil ships in the Persian Gulf; the prospects of

anti-takeover legislation on corporations; benefits for dependents of retired military personnel; question on invasion of privacy with all children over five now having to have a Social Security

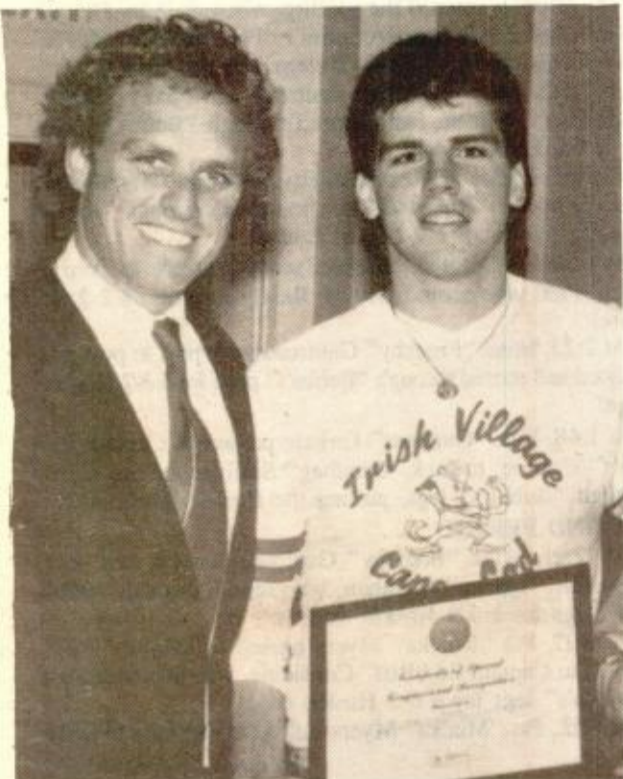
number to be claimed as a dependent under the new income tax law; fuel assistance; the study by Johns Hopkins University citing the loss of hearing from a combination of carbon monoxide and noise; increasing job training programs; and public housing.

Another local issue involved the closing of the Amstar Plant and Kennedy pointed out that his office has been following this closely.

One woman expressed concern about the establishment of a staging area in Charlestown by the Massachusetts Water Resources Authority (MWRA). Kennedy told her that Charlestown is not getting a sludge plant. He stated that all are concerned about a clean harbor and in order to ac-

complish that, a staging area is necessary to transfer construction materials to Deer Island. He pointed out that there will be an end to this project — ten to 12 years — and it is important that the community see that MWRA goes through a mitigation process in order to insure minimal impact on Charlestown. Kennedy stated that his office has been investigating the feasibility of utilizing the railroad and that it is important to minimize truck traffic through Charlestown.

When asked by Mary Walsh what his major frustrations were after a year in Washington, Kennedy reiterated the government's failure to act on his three basic concerns of decent housing, health care and education.

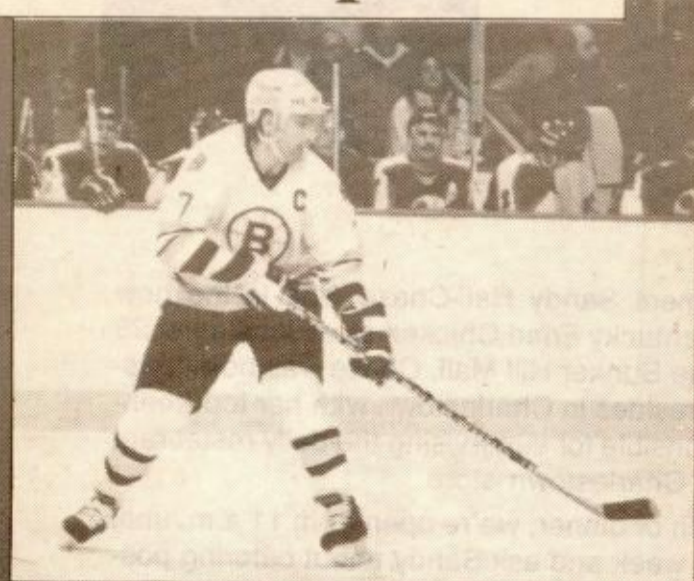

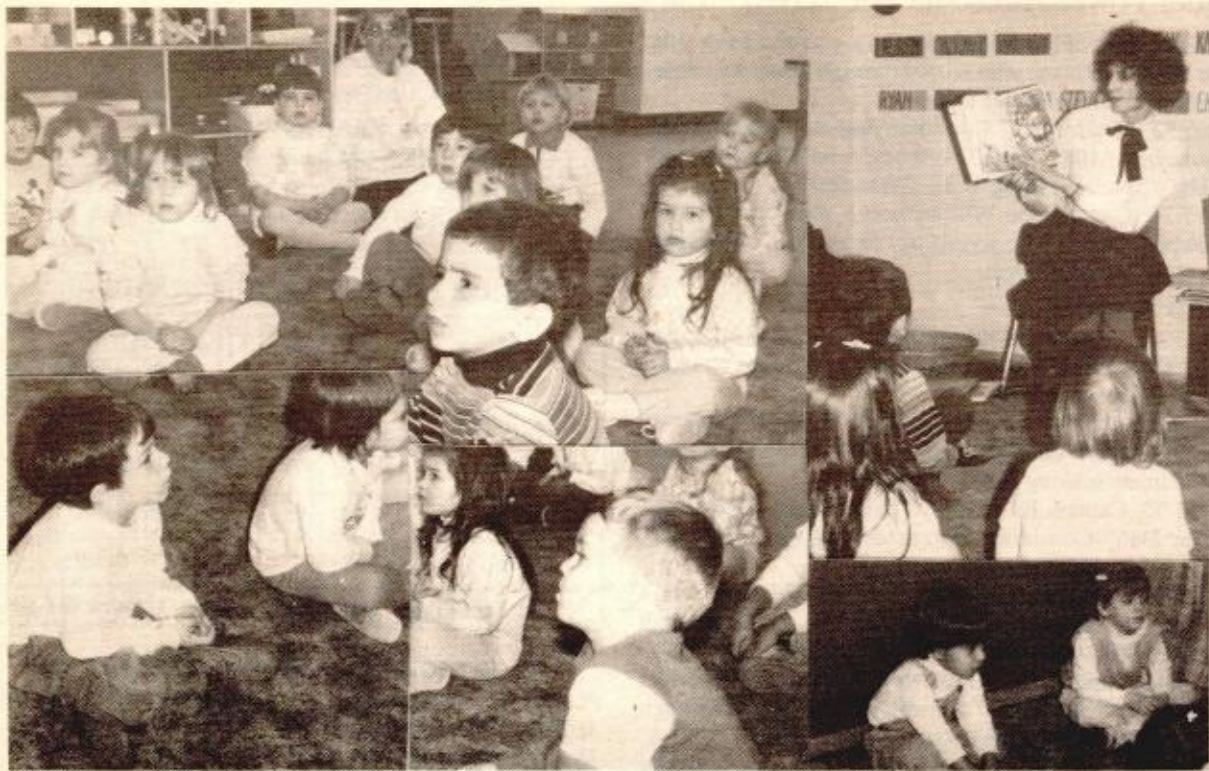

be \$300,000 to go back into project to reduce the costs of affordable units and \$50,000 for Charlestown Working Theater.

• Charlestown Garden Town Houses (Conroy Development): 41 Condos. 21 units market rate ranging from \$210,000 to \$295,000 (no other breakdown given); 15 units affordable, ranging from \$80,000 to \$90,000 (no other breakdown given); five units handicapped accessible, with two and three bedroom units ranging between \$50,000 and \$60,000. (Two bedroom units would consist of 1,073 square feet and three bedroom units would consist of between 1,370 and 1,625 square feet); 41 parking spaces would be provided. The total cost per square

foot is estimated at \$128.58. The 25 percent community contribution would be \$175,500 to go back into the project for affordable units.

All proposals would leave the Charlestown Community Garden at their present location and allow space behind the homes on Baldwin Street for those abutters to have a common area.

It has been a long process. At least seven meetings have been held and all parties involved agree that it is time for a decision to be made as to who will develop this parcel of land. This decision should come at the Neighborhood Council meeting on March 1st at the Knights of Columbus Hall which should prove to be a most critical meeting for the members of the Council.

Commissioner Garvey Responds To Problem Of Construction Debris

Dear Councillor McCormack:

I'm writing in response to your recent letter regarding construction debris dumped on Boston Housing Authority property in Charlestown.

Department personnel who inspected the site indicated that some, but not all, of the debris was temporarily stockpiled by contractors connected with the I-93 project. In an effort to quickly alleviate the problem, however, the Department directed the general contractor to remove all of the debris. This work was completed by the end of the work day on February 2, 1988.

Unfortunately on the morning of February 3, three additional piles of debris were discovered on the site, dumped by unknown parties. The B.H.A. has been notified of this situation and has indicated that they will assume responsibility for this problem from now on.

The Department has notified its contractors that dumping of debris will not be permitted at this location. We will continue to make every attempt to monitor the area to prevent any additional dumping in the future.

Thank you for bringing this matter to our attention.

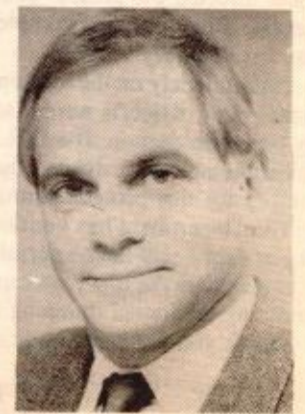
Appointed To Israel Bond Post

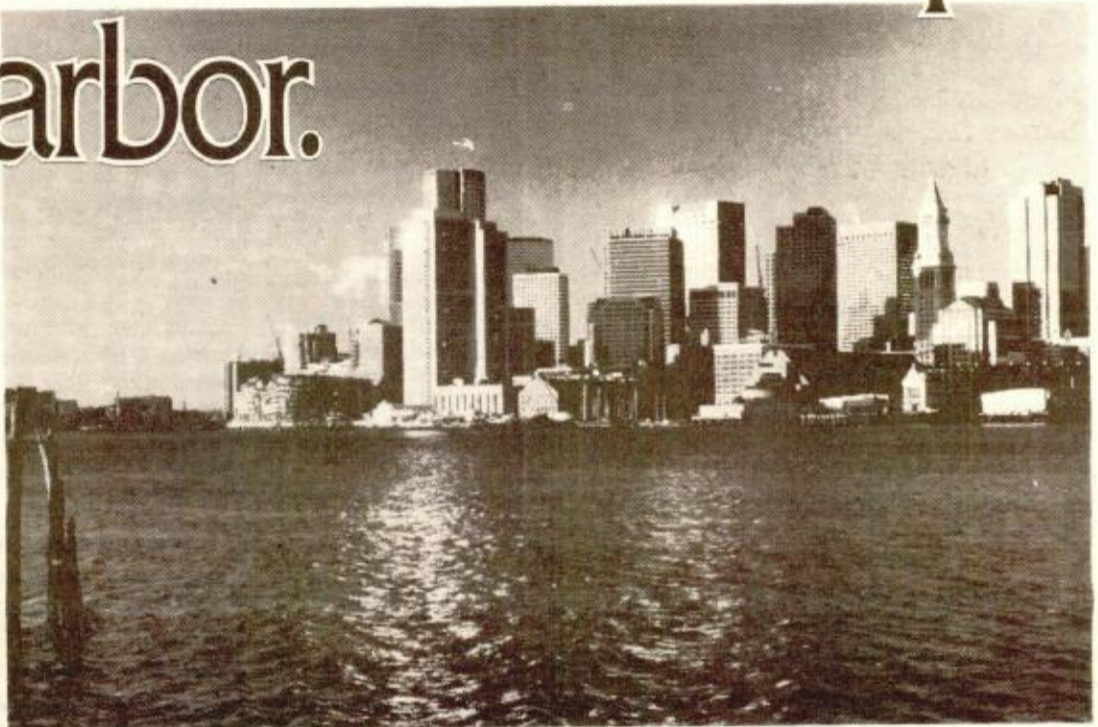

SOCIAL SECURITY NEEDS HELP IN FINDING SSI RECIPIENTS by Peter Toland Social Security Manager in Boston

The Social Security Administration could use your help. It's trying to get a message to people who are aged, blind, or disabled, but it's a difficult task. The message is: "If you're 65 or older, blind, or disabled with a limited income and resources, you may be eligible for supplemental security income (SSI) checks."

SSI is a Federal Program administered by the Social Security Administration. Its basic purpose is to assure a minimum level of income to people who are aged, blind or disabled and who have limited income and resources. In Massachusetts an individual must have a monthly income of less than \$488 and assets totalling no more than \$1,800 to qualify for SSI. These levels are naturally somewhat higher for couples.

SSI isn't just for adults, but many parents are unaware that their disabled or blind children may be eligible. SSI is for anyone who is disabled or blind with limited income and resources. It makes no difference how young a person is.

Some elderly people may be aware of the program, but are afraid to apply for fear that a lien will be placed on their home. Social Security does not put a lien on the home of anyone getting SSI.

People don't need to be completely destitute to get SSI. For example, they can own their home. In fact, under certain conditions and within certain limits, people can own other things: a car, insurance policies and personal or household goods, for instance. People also can have some income from a Social Security check or job, for example — and still may get part of the payment.

Being eligible for SSI means more than just getting monthly checks. SSI recipients are often eligible for Medicaid, which can help pay health care expenses. They may be eligible for food stamps and other social services.

If you know someone who might qualify for SSI payments, do them a favor — tell them to call Social Security and ask about SSI, or call the Kennedy Center at 241-8866 and arrange an appointment with the Social Security field representative.
