## American Legion State High School Oratorical Contest On Sunday

The stated finals of the Department of Massachusetts, The American Legion High School Oratorical Contest will be held on Sunday, March 8 at 2 p.m. in the Preble Room, Building 5, in the National Historical Park section of the Charlestown Navy Yard.

According to Contest

Chairman James W. Conway, four students, winners of the four zones throughout the state, will compete for the state championship. The winner of this contest will travel to Indianapolis, Ind. in April to take part in the national contest for a first place prize of \$18,000.

The students will deliver an eight- to 10-minute ora-

tion on some aspect of the United States Constitution. These presentations will be followed by a three- to five-minute speech on one of four amendments or articles of the Constitution which will be chosen at random at the conclusion of the students prepared orations.

Residents are welcome to attend this event to hear these outstanding young orators. Persons attending are asked to be in the hall before 2 p.m., as no one will be admitted during the orations.

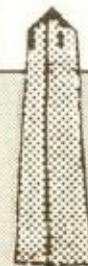

## 'Rosie The Riveter' Film Series At The Charlestown Navy Yard

Boston National Historical Park is celebrating Women's History Month with free weekday noon-time showings of various documentary films about "Rosie the Riveter," symbol of women industrial workers in World War II. The films will be shown throughout the month of March at the Charlestown Navy Yard Visitor Center on Constitution Road, formerly known as the Bunker Hill Pavilion.

Many women worked in shipbuilding, welding and riveting in support of the effort on the American home front during World War II. Over six million

women nationwide took on industrial jobs that had been held by men who left to fight on the front lines of the war. Over 8,000 women worked in the Charlestown Navy Yard alone during World War II.

The presentation schedule is:

**Mondays and Fridays** - *The Life and Times of Rosie the Riveter*. This film explores, through interviews and period footage, the experiences of several women as they worked in industrial jobs during the war and their lives afterwards when the men came home from the front lines and reclaimed these jobs.

**Tuesdays and Thursdays** - National Archives Films: *Women in Defense*, *The Hidden Army* and *Glamour Girls of 1943*. These films document, through much original footage, women working in industrial jobs and the advertising that encouraged them to take such jobs. Also, *Good Work, Sister!* This film chronicles, through interviews and original photographs, the experience of several women who worked in the Kaiser Shipyards in Portland, Oregon during the war.

**Wednesdays** - *Good Work, Sister!* and *There's No Such Thing as Women's*

*Work*. Produced by the Women's Bureau of the U.S. Department of Labor, this film explores women's changing work roles from 1900 to the present.

All programs will run approximately 50 minutes and are free and handicap accessible. Free parking is also available. Additional showings are available on request until 4 p.m. daily.

In addition to the weekday programs, *Rosie the Riveter* will be shown at 3 p.m. on weekends during the month of March.

## Skating Fund Raiser Scores Gold For School Scholarship

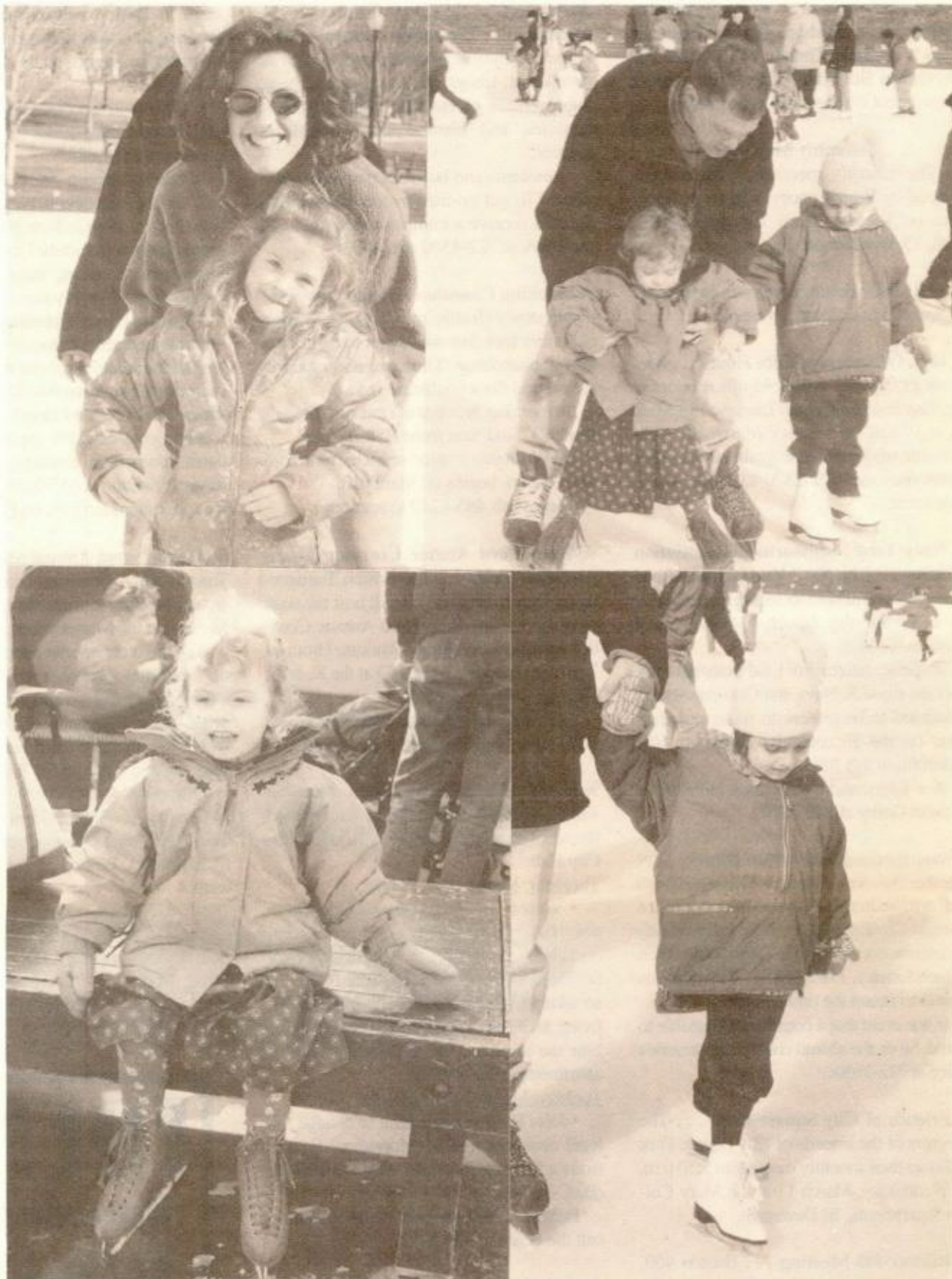

### HOW TO REDUCE YOUR CHANCES OF AN IRS AUDIT

No one wants to face a tax return audit. And, in fact, fewer than 2% of the more than 100 million individual tax returns filed annually ever are audited. However, the IRS counts on the ever-present possibility of an audit to make our tax system work.

The key to reducing audit risk lies in knowing which areas may cause IRS computers to select your return and in anticipating challenges in those areas.

Most returns are selected for audit through a special computer program that scores each return for audit potential. The program looks at a number of different areas, including your income level, the types of income reported, the amount of your deductions relative to your income and to the national averages, the character of your deductions and the schedules on which they are reported.

Although specifics of the audit-screening program are closely guarded by the IRS, the Service does disclose areas of interest to them. Some examples include home office deductions, entertainment expenses, deductions for charitable contributions of property, hobby-type businesses, personal expenses claimed on business returns (such as on Schedules C or E), and underreported income by businesses that deal largely in cash. In recent years, more lower-income tax returns have been selected for audit, largely due to IRS concern for erroneous claims of the earned income tax credit. Another recent audit target announced by the IRS is the personal service corporation. These are employee-owned corporations in the fields of accounting, engineering, law, health, actuarial science, consulting, architecture and the performing arts.

Don't deny yourself a legitimate deduction out of concern over the chance of being audited. The best approach to take to avoid an audit is to prepare or have your return prepared with great care and to keep careful records for all items on your return. ## Boston Irish Build Monument To Famine

One hundred and fifty years after thousands of Irish immigrants fled to Boston to escape starvation and disease wrought by Ireland's potato famine, the city's Irish community is building a memorial in their honor. A \$1 million park dedicated to the famine generation is being constructed along the city's Freedom Trail, symbolic of what the Irish and other immigrant groups sought when they came to the United States.

The Famine Memorial park will officially open in June 1998, and will be located at the corner of Washington and School streets, near downtown crossing and across from the Old South Meeting House, which is a stop along the city's Freedom Trail. Tourist officials estimate that over two million visitors walk the trail each year.

The park will feature two sculptures by artist Robert Shure, one depicting an anguished family on the

shores of Ireland, in the depths of their tragedy, and another depicting a newly arrived Irish family stepping ashore in Boston, filled with hope and determination. Shure designed the Korean Veterans Memorial statue in the Charlestown Navy Yard.

The Boston Irish Famine Memorial committee is led by Thomas J. Flatley, a Boston area real estate developer who emigrated from County Mayo and who built and developed numerous commercial and residential properties throughout New England, including The Schrafft Center at Sullivan Square.

Flatley convened the Famine committee in April 1996, comprised of business leaders, writers, scholars, clergy and representatives of greater Boston's Irish-American organizations. The committee has worked diligently since then to raise the necessary funds to build the 6,000 square foot park.



A ceremony to mark the future site of the park, held in October 1996, was attended by then-president of Ireland, Mary Robinson, who noted Boston's historical role as a uniquely Irish-American city.

Flatley hopes the Famine Memorial "will serve as an inspiration for all immigrant groups who struggle to overcome adversity,

and render insight into poverty, bigotry and intolerance."

The struggle of the Irish, and their ultimate triumph, is one of the compelling stories of Boston history, and has been documented by committee member Thomas H. O'Connor, whose book, *The Boston Irish: A Political History* describes the immigrants' odyssey

from "wretched foreigners" to accomplished leaders over the past century and a half. The high point of their struggle for acceptance was John F. Kennedy, a descendent of the Boston Irish Famine generation, becoming the first Irish Catholic president of the United States.

It was a difficult transition, according to historians. The Irish were initially treated with hostility and resentment from some Bostonians, and "No Irish Need Apply" signs were common in store fronts and in newspaper want ads for several decades in the 19th century. But eventually the Irish transformed themselves, entering mainstream society first through politics but eventually working their way into business, law, medicine, academia and entertainment.

Mary Woods, project manager, said that donations are also coming in from ordinary citizens "who feel compelled to

participate in this important initiative to honor their ancestors."

Committee members hope the Famine Memorial will remind people that famines continue to decimate populations around the world today, and that society has an ongoing obligation to eradicate hunger. They hope to create an endowment to honor relief agencies and individuals working in famine areas.

"The Boston Irish Famine Memorial," Flatley said, "will be a permanent testament to the courage, faith and fortitude that the Irish, and the human race itself, so often display in the most trying conditions. That is a history all of us share."

## Warren-Prescott Students Perform 'The Tempest' For Friends Of The Charlestown Branch Library

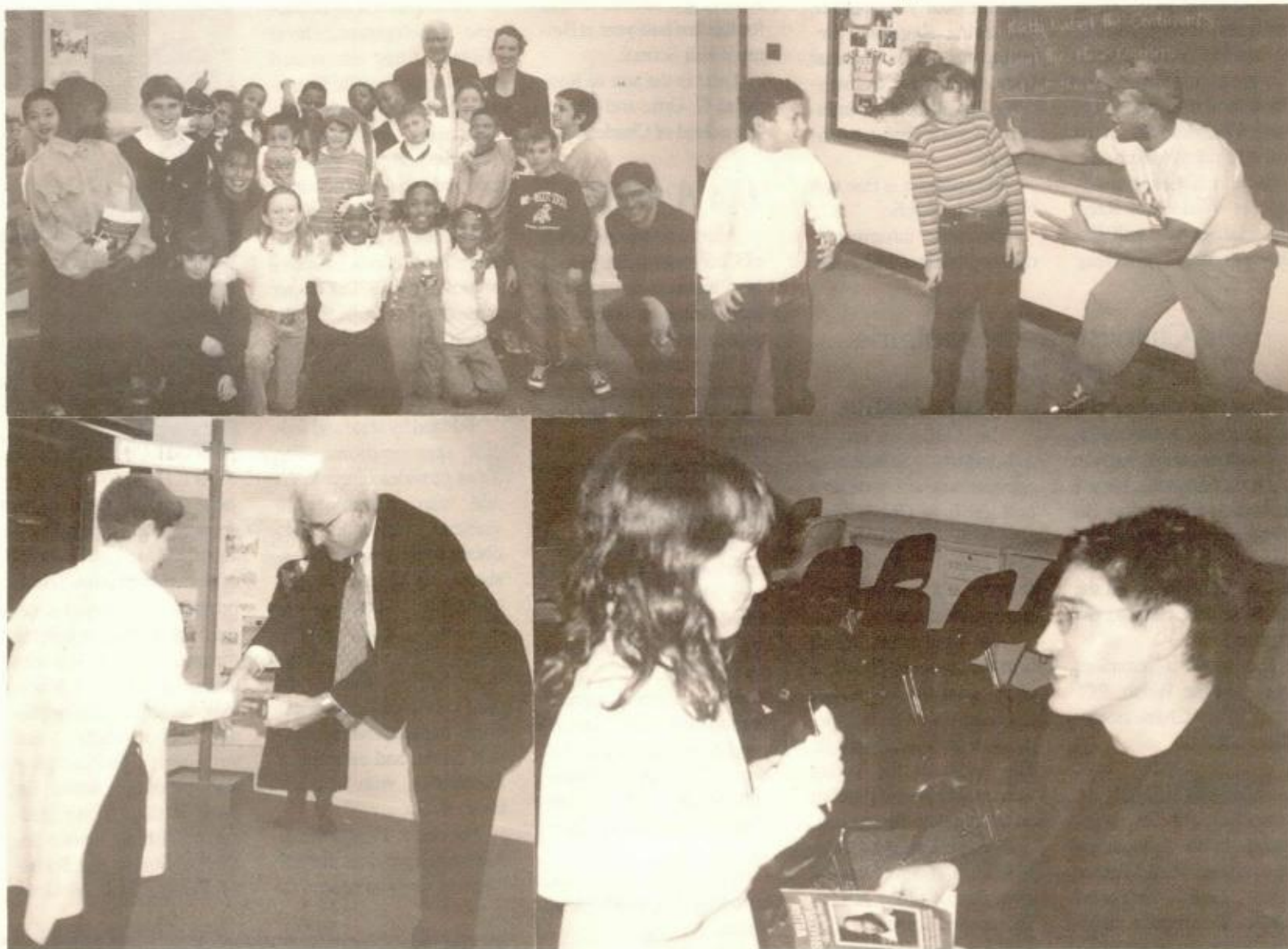

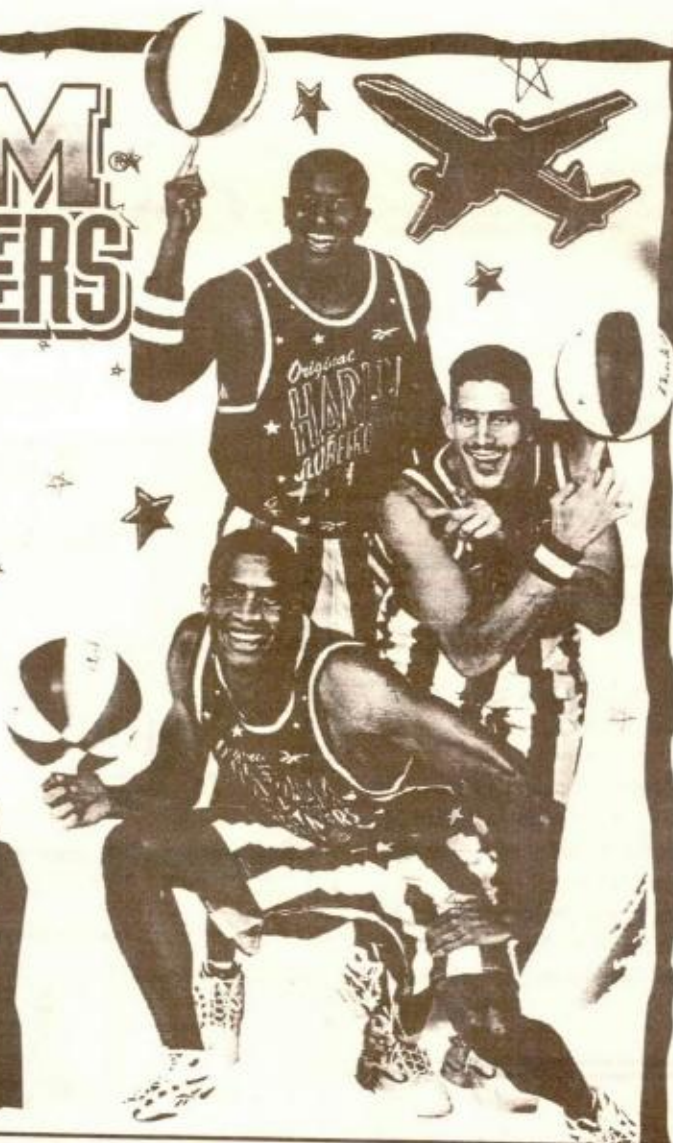

## Look For Me In A Newspaper Near You

To the editor:

In all my years of writing newspaper letters, I have probably written on everything from A to Z (well, maybe not exactly. I don't think I ever penned one on zebras and zoo life, but yet I may). However, this time my letter is about letters to the editor.

I'm hitting two milestones this year. In May I turn the Big 5-0, but first I celebrate March 3, for it was 30 years ago on that date back in 1968 when my first letter to the editor was published in the old Boston Sunday Advertiser. It was one paragraph long and, of course, I was criticizing someone for something they did or didn't do. The first letter led to a second one in the Record American and after that I stopped counting them. But that theme re-occurred - blaming someone for something, eh?

I can remember I was 19-years-old living at home with my parents over in East Somerville when my mother decided she wanted to return to her hometown. In 1975, my parents moved to Winthrop Street, across from Engine 50. Judge Garrity and forced busing was on everyone's lips during those days. Even before 1975, my letters attacking Garrity's tyrannical (yup, that's what I called it back then) court edict were already being sent to Gloria at the Patriot.

Gloria will attest that I sent lots and lots of letters to her for the Patriot over the years, and she printed some of them. In 1981 when Engine 50 was threatened to be deactivated by Prop 2.5 cuts, I got involved with the Peoples Firehouse Committee and penned a weekly firehouse column during

the month-long firehouse occupation.

Even after I married in 1984 and left Charlestown for the South Shore, it didn't stop me from writing letters to the Patriot. You could take me out of Charlestown, but not Charlestown out of me.

Over the years I've calmed down. Back when I was 19 and 20-something, I took everything too seriously. With age came wisdom and a good sense of humor. Back then I thought I was always right. Now I know I'm only mostly right. I still write letters and cause trouble from time to time as was seen last fall when I stuck my nose into District One politics. Someone told me I should take my writing to the South Shore newspapers and leave Charlestown alone, but I can't do that and why should I?

And as far as my sense of humor goes, it definitely comes from the Irish half of my family. My mother had it, my uncles had it and I have it. Life is too short to personalize your anger. I follow the advice of Kurt Vonnegut Jr. who once said, "Laughter and tears are both responses to frustration and exhaustion. I myself prefer to laugh, since there is less cleaning up to do afterward."

This month, I plan on beginning the next 30 years of letter writing because like James Michael Curley I want to live 150 years, too. Finally, don't forget to look for me in the newspaper letters column in a paper near you.

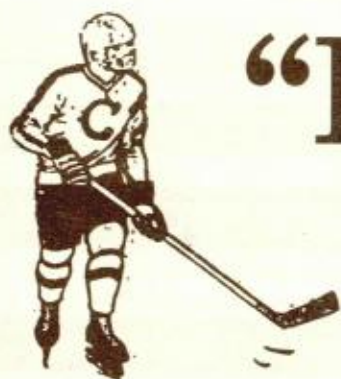
