*"One of the evolutionary provisions that I abhor is New York Times v. Sullivan. If the people really wanted such a loophole, the states should have voted separately. For the Supreme Court to say that the Constitution requires [that ruling], that's not what the people understood when they ratified the First Amendment; At the time it was adopted, nobody thought that the First Amendment would encompass the ability to libel somebody. Who told Earl Warren and the Supreme Court that what had been accepted libel law for a couple hundred years was no longer?" - Justice Antonin Scalia*

The case, which was decided in March 1964, essentially held [journalists could libel a public figure](#) as long they don't do so with "reckless" disregard for the truth. And while Scalia acknowledged that might be a good system for public discourse, he said the Supreme Court had no business adding that new interpretation to the First Amendment.

*"No kind of immigration restriction is unconstitutional, The U.S. government can exclude a foreign national on any basis. The statutes are clear: immigration is different from all other aspects of the law. The Supreme Court has ruled we can enact laws against foreign nationals that would not be permissible to apply to citizens. The courts historically have no role in these decisions. If a President Trump was able to enact his Muslim moratorium, it's unlikely for the [Supreme] Court to reverse 100 years of legal history and overturn it. It would be giving foreign nationals civil and constitutional rights to do so." -Jan C. Ting*

### **Correction: Alleged Kalamazoo Gunman Blames Uber App: 'Took Over' Like 'Artificial Intelligence'**

Alleged gunman Jason Brian Dalton blames the February 20 Kalamazoo shooting spree on an Uber smartphone app for drivers, which he says took control of him like *"artificial intelligence that can tap into your body."* According to the [police report](#) filed on the shootings that killed six, Dalton told police *"he is not a killer and he knows that he has killed."* He said the Uber app *"has the ability to take you over"* and that *"it feels like it is coming from the phone itself."* He told police *"he really did not know how to describe that."*

Dalton told the officers that his alleged actions were inexplicable to him, and that is why he kept talking about an *"artificial presence."* He said he did not have a concealed pistol permit and did not normally even carry a gun; that he *"kept his guns locked up at home."* Dalton told police that color changes on the Uber app screen are what set him off. He said *"that when the app changed from red to black that is when he started having problems."* At one point, Dalton said he thought the app wanted him to have a shootout with police, but the colors changed from black back to red and *"he stopped his thought."*
