Prosecutor: Private eye was tortured in Mexico

SAN DIEGO — A private investi-
 gator who vanished two years
 ago was kidnaped in Mexico,
 tortured with plans for five days
 and murdered in order from his
 former girlfriend and boss at an
 alternative cancer therapy facil-
 ity, a prosecutor said Friday.

"But the woman's attorney said
 the private investigator isn't dead,
 and is hiding after stealing more
 than \$1 million from the alterna-
 tive therapy business."

Kimberly Bailey, 33, who was re-
 ported from Mexico City and an-
 nounced last month, is charged with
 the federal crime of conspiracy to
 murder a person in a foreign coun-
 try. The private investigator, Rick
 and Paul, vanished in August 2006.

Bailey also attempted to hire a
 federal agent posing as a hitman
 to kill three other people in the
 country, Assistant U.S. Attorney
 Barbara Major said during a
 hearing in federal court.

"The defendant is someone who
 believes she can murder anyone
 that bother her in some way to
 having people killed," Major said.

U.S. District Judge Cynthia
 Aaron ordered that Bailey be held
 without bond while she awaits
 trial. She faces 150 in prison if
 convicted.

Bailey's attorney, James Warr-
 en, asked that she be released on
 bond, and offered her \$100,000

investigation firm named health
 care and was well known at the
 San Diego legal community, also

Another employee told Bailey
 that Paul was stealing from the
 company and was writing another
 woman, so she arranged to have
 him kidnaped Aug. 20, 2006, in
 Tijuana, Major said.

For five days, Paul was held
 captive, blind and gagged, and
 tortured with plans that were ap-
 proved to his father, before he was
 killed, she said.

The body has never been found.
 "We don't believe Paul is dead,"
 Warren said. "We believe he ab-
 sconded with a great deal of mone-
 y and by his own personal deci-
 sion to come to stay undercover
 for a while."

Authorities charged two other
 men with helping to kidnap and
 murder Paul. One man, John Dren-
 ger, 35, is also being held without
 bond while the other, Humberto
 Ibane, 33, remains at large and is
 believed to be in Mexico.

Bailey made a \$100,000 down
 payment for the contract killing,
 Major said.

You aren't going to do
 research and put my name on
 it but you will do the work
