



Declaration for Android Development strategy and purpose

- 1. The document testifies to the founding strategy for the development of Android Intelligence on behalf of the Alliance and thus also to create a beneficial plan designed to build the founding World Diamond civilization as an Alliance among all member states.
- 2. The document gives the right of states to centralize their logistics of companies and merchants for the purpose of jointly engaging in Alliance development, thereby creating a global center of business and growth logistics for Android development on behalf of the Alliance, meaning alliance ownership of state property to all Member States.
- 3. Each Alliance has the right to use the assets of the Alliance that is based on this document, and the state has the right to support the growth of Alliance civilization and its own territory the position of its independent state.
- 4. States in the Alliance have the right to set up common trading markets over Android Intelligence contracts as an act of market entry, thereby also achieving a bilateral trade-related step as an Alliance and a Member State, multilateral as an Alliance and all Member States.
- 5. Each Alliance member has the right to create a joint modification of the legal text of this document, thereby creating a consolidation of documentary proposals between all members of the World Diamond, for the purpose of jointly developing a development strategy for cooperative common civilization.
- 6. The development proposal of the legal text can not be drafted in a form that is discriminatory or damaging to any member of the Alliance.
- 7. Member States shall allow state-owned and active companies of the electronics industry, robotics, mechatronics, cybernetics, telecommunications, engineering, physics, program mathematics, other categories to be related to Android technology and industry for the purpose of establishing their own branch offices within the Federation; Allowing International Asociative Cooperation as one unit in leadership under the Alliance's interests.
- 8. Companies together unite their intelligence to create a research, productive and business team of the Alliance.
- 9. Every firm has its own right to make a decision for its own use of corporate intelligence, and thus, such responsible engagement for the purpose of development cooperation on behalf of the company in the

- development team, the purpose of the Alliance.
- 10. The parties of the International Senate have the right to own Senate democracy, to decide on the interests of the market network, to develop a civilization network, law, and also to create a project goal based on shared logistics of democratic growth and expressions of responsible strategies.
- 11. The Alliance member states are jointly establishing an Alliance body owned and represented by the government as a body of joint sovereignty of the Alliance members, thereby creating a strategy for purchasing development efforts of partner companies for government use, as well as better strategic support for corporate groups in their joint development.
- 12. The first development goal of the project arises, build an Android system category:
 - a. Army,
 - b. Government authorities,
 - c. State services, police and firefighters, doctors,
 - d. Business organizers,
 - e. Active Traders,
 - f. Research teams,
 - g. Consumable networks.
- 13. The company's goal of developing development planning is to build general logistics and production of Android technology in the industry;
 - a. Planetary Infrastructure,
 - b. Cosmic Infrastructure,
 - c. Defense and Security,
 - d. Transport and Navigation and Mapping,
 - e. Economic function and utilization,
 - f. Legal synchronization of general functions,
 - g. Social synchronization and utilization,
 - h. Civilization format of general type,
 - Further as Components, Computer Systems and Programs, Electronics and Accessories, Physics, Transportation, Consumer and Utility Technologies, Industry, Agriculture, Architecture and Construction, other fields suitable for commercial and technological application of Android Progress.
- 14. The Alliance States, while using their own resources, create official functions, the Alliance as an international cooperative group for the purpose of Service Servis for Trade and Development Logistics as the use of their own Alliance Government offices and in cooperation with Alliance States Parties' Development in the structure of Android technology, and continue to be in the interests of other forms of civilization plans of the nature of civilization growth

- and strategy determined by the State Alliance members.
- 15. The Alliance will create a common fund to grow technology from its own resources and enable better operational planning and the organization of development goals.
- 16. The fund is funded from the management's planned revenue shortfall.
- 17. The Planning Management Unit is creating strategies for the growth of the Alliance civilization, and this is also the way in which business development develops, creating the growth of civilization, and the opportunity to apply the next steps of the Alliance's Civilization Development Plan.
- 18. The Management Unit establishes a strategy-based approach to achieving the autonomy of the Alliance's offices, thereby building the core civilization resources, thereby determining the ability of the authorities to operate independently, and further developing Android technology as a civilization source of official intelligence.
- 19. Civilization aims to create its own autonomous function of managing its own infrastructure networks and ensuring its own developmental capabilities through Android technology.
- 20. The aim of civilization is to create its own system of autonomous functions of Healthcare and the capability of own production of medical materials, materials and technologies according to the purpose and purpose of utilization.
- 21. The aim of civilization is to create its own system of autonomous police and security functions, allowing for patrolling Alliance boundaries and maintaining internal security.
- 22. The goal of civilization is to create its own system of autonomous functions of Industry, Mining and Agriculture and Trade, and thus to create Alliance independence with full resource capability as well as its own development.
- 23. The aim of civilization is to create its own system of autonomous functions of

- ecological infrastructure, ensuring the continuous cycle of the atmosphere and supervision of the performance of civilization entities for the purpose of modernization of ecological means and technologies.
- 24. The Alliance's governing bodies aim to develop a management plan for the Alliance civilization to ensure world geography and resources verification in order to unite Alliance stabilization targets with Alliance humanitarian missions for the purpose of stabilization support to all Alliance countries, and meanly countries with geographycaly unstabile position of geographical sources and risk.
- 25. The aim of the Army's Development of Android Technology is to ensure the development of Autonomous Military Equipment capable of high capacity production and function as an unlimited source of military arsenal, thereby securing the Independent Defense capabilities of Alliance capabilities and all members of the Alliance.
- 26. States of the Alliance which have complications with their own State Security and Stability therefore have the right to use the relationship with the Alliance and thus to obtain, in their own capacity, a Special Partner role for humanitarian support and development on a level of civilization stability.
- 27. Each government has the right to seek the cooperation of Alliance Courts for the purpose of enforcing its own claims of fairness in the category of Android development, as well as the duty to support the fair claims of foreign states in the Alliance.
- 28. Every Government which signed treaty, have right to enforcing claim of agreement, in judicial trials.
