



Notice of Intent/Impose and Use Passenger Facility Charge

The Lehigh-Northampton Airport Authority intends to file an application with the Federal Aviation Administration (FAA) to implement a Passenger Facility Charge (PFC) for selected projects scheduled for implementation between Federal Fiscal Years 2018 and 2023.

The following projects are included in PFC Application 18-08-C-00-ABE comprised of both "Impose Only" (proposed development) and "Impose and Use" (completed or currently underway) projects. The Authority is seeking FAA approval for reimbursement of local Airport funds required for each project.

The following is a brief overview of the application:

- Level of proposed PFC for each project: \$4.50 per eligible enplaned passenger.
- Proposed charge effective date: August 1, 2020.
- Proposed charge expiration date: June 5, 2033.
- Total estimated PFC revenue: \$23,381,196
