Storm Causes Extensive Damage To St. Catherine's

Last weekend's rains devastated the three underground boilers at St. Catherine of Siena Church and Rectory and Charlestown Catholic Elementary School. Damage initially left the heating system, a portion of which is 100-year-old, completely incapacitated.

An incredible nine feet of water submerged the heating plant and forced St.

Catherine Pastor Father James DiPerri to cancel school indefinitely on Monday. Emergency temporary measures applied to one of the boilers by archdiocesan engineers and PJ Kennedy Heating of Quincy, however, allowed for full attendance and classes on Tuesday.

Father DiPerri's earliest cost estimates were in the tens of thousands of dollars

to replace the system that provides heat for the school, church and rectory. Damage also includes roof repairs in the rectory and the church's bell tower.

Because of the extent of water damage and the heating system's age, Father DiPerri said that the entire heating system has been completely lost. Replacing the equipment is expected



to require a serious search for funds.

"This is a disaster for the entire community," Father DiPerri said. "We're especially concerned about our young people. They and their families depend on the school." In spite of the weather and its serious damage, Father DiPerri said Charlestown's people answered the church's call for help. Water was pumped out promptly and efficiently through the efforts of several quick respondents. Tom Hickey of Hickey Remodeling, and a Charlestown Catholic parent, joined Daniel Greaney and Jim Bichekas of the city's Real Property Department with hoses and pumps to drain the water from the plant. Judy Evers of the Mayor's Office and retired firefighter Marty O'Brien Sr. were on hand.

"The long-term damage is extensive,

however," Father DiPerri said, "we're relying on the goodwill of the good people of Charlestown to help see us through this."

Father DiPerri said that in the end, repairs will leave a better system than what was there before the storm. "There is a great optimism," Father DiPerri said.

Community And Friends Join In Celebration Of The New City Square Park

(continued from page 1) tem, a Paul Revere memorial and an obelisk has been returned to the site honoring the men and women who served the nation in World War II.

The formal portion of the celebration, which took place on Oct. 6, opened with a procession of members of the Friends of City Square Park and their invited guests, led by the Color Guard of the Ancient and Honorable Artillery Co. to the Washington Post March by the U.S. Navy Band from Newport, R.I.

The Ancient and Honorable Artillery Co. has historic ties to Charlestown as they were chartered by Gov. John Winthrop in 1638 and were, in fact, owners of the Great House in June 1775 when it was destroyed by the British during the Battle of Bunker Hill.

Raising the flag in the new park were Cmdr. Robert L. Gillen, USN (Ret.), the only Charlestown-bom commander of "Old Ironsides," and James W. Conway, Past National Historian of the American Legion and chairman of the Charlestown Veteran Committee. Charlestown resident Nancy Armstrong sang the National Anthem.

Ken Stone, governor of the Friends, welcomed the gathering. Stone related that the celebration was for the near completion of the three years it took to design and build a park and it was for the last 15 years to have the elevated highway replaced by a tunnel. He went on to say that "what makes this day so special is that City Square has now come full cycle with a new history about to be written."

Stone praised the town's residents who "cared enough to participate in the public processes to bring us to where we are today."

Stone reflected on a bit of the history of City Square and then spoke

patory democracy works!"

about Rep. Richard Voke who "deserves special recognition for his truly crucial role in bringing City Square Park to life." Calling him "Richie," Stone stated that "he has served Charlestown with skill success and honor at the State House for nearly two decades. Now, as he nears the end of his final term as state representative, it is fitting and appropriate that City Square Park nears its opening since the park will be one of Richie's lasting legacies to Charlestown."

According to Stone, it was Voke whom residents went to for help to fund and build a park in City Square. He added that Voke obtained \$4 million for the design and construction of the park and was able to see that those funds remained in place during some "dark financial days for the Commonwealth."

Stone introduced Jay Ash, former chief of staff for Voke, praising him for his efforts on behalf of the residents.

Voke then stepped to the lectern, telling the audience that for many years he has been a student of and a participant in government. He noted that the secret to good government is the people, adding "a partici-

He stated that the people of Charlestown fought 15 years ago consistently working, donating time and effort, to see it to fruition. He noted that the North Area Task Force became the Friends of City Square and formed subcommittees to work on various aspects of the project and the result was this "masterpiece," a tribute to Charlestown and her people. Voke particularly sin-

gled out Stone for the "sac-

rifice of his time, effort and

livelihood."

Peter Looney, chairman of the Charlestown Neighborhood Council, spoke briefly of the history of City Square with the presence of the military and longshoreman. Looney said that the park will carry a message for the next 200 years - "Welcome to Charlestown."

Peter Webber, commissioner of the Department of Environmental Management, was a state senator and one of the five votes on Voke's conference committee approving the park. Webber said the Friends spoke "eloquently and positively" on a park. He praised the Halvorson Co. for their vision in producing the design and Mc-Court for carrying out the design in the construction.

Also speaking were Boston City Councillor Diane Modica; Trudy Coxe, secretary, Executive Office of Environmental Affairs; and Charles Kostro, deputy commissioner, Mass. Highway Department. Introduced were Mon O'Shea, interim president, Bunker Hill Community College; John Burchill, superintendent, Boston National Historical Park; and Hon. Peter Agnes, presiding justice, Charlestown District Court.

Stone told of Charlestown's long-standing special relationship with the U.S. Navy and, as the U.S. Navy Band played the Navy Hymn, Chaplain Ronald Kreiensieck of the USS CONSTITUTION, blessed the park. This was followed by a cannon salute from the ship and the lowering of the flag which was presented to Stone for safekeeping by William Foley, chief of interpretation of

the Boston National Historical Park.

The day had begun with a brunch at Olives restaurant to benefit the park's maintenance fund. The afternoon included a tasting party with local restaurants participating, music by the Bridgewater Antiphonal Society and the showing of a slide show produced by Larry Miller on the history of City Square.

The Celebration Committee was headed by Marilyn Votaw and supported by a long list of Friends.



DEFER TAXES BY SELLING AN OPTION

If you should give someone an option to buy your property, there's a tax benefit you should be aware of.

Let's say you own a piece of land that you want to sell. Your neighbor is interested in buying the land, but can't commit for two years. You might give him an exclusive option to buy the property at any time during those two years at an agreed price, charging him \$5,000 for the privilege. You can pocket the \$5,000 and not pay any taxes on it until he exercises the option or the two-year period expires.

If your neighbor lets the option expire, you'll be taxed on ordinary income of \$5,000. If he exercises his option and buys the land, the \$5,000 will be included with the purchase price in calculating any capital gain or loss. Either way, you'll have had the \$5,000 for up to two years without being taxed.

But watch out for a few key points. First, the option must be unconditional - you must commit to sell at the agreed price if the option holder chooses, while he retains the right to exercise the option or walk away. Second, avoid changing the terms during the option period. If you do, the IRS may say that the old option lapsed and was replaced with a new one. You'll then be liable for tax on the original option payment. Third, be very careful if you structure the deal as a lease with an option to buy. If the terms suggest that the transaction was really an outright sale, the IRS may recharacterize the option payment as taxable interest on the deferred payment.

Demolition Planned For Domino Sugar

Representatives of the Flatley Co. updated the community on the demolition plans for Medford Street's former Amstar-Domino Sugar Refinery at an Oct. 17 public meeting held by the Charlestown Neighborhood Council Development Committee at Bishop Lawton Hall on Bunker Hill Street.

An additional Flatley
Co. presentation of plans
for the former Brockway
Smith building at 465
Medford St. was postponed to an unspecified date.
Flatley's expected tenant
was no longer interested in
occupying the site.

According to Charlie Cummings of the Flatley Co., the demolition permits should be secured within a month. The work, from start to finish, would be completed within two months, ideally by February 1997. An estimated \$1 million preparatory clean up of hazardous materials has readied the site for removing buildings directly related to refining sugar.

Slated for demolition are the refinery building, storage silos, tower, power plant and the chimney. Cummings said that the project will be a "selective demolition" without implosion. Some of the work will be accomplished with wrecking balls. Approximately one of the two months will include removing debris by tractor trailers.

Residents asked about such concerns as rats, loud work after normal hours and community relations.

A predemolition rodent control is required to receive the permit, and Cummings said that he expected less of an impact at Amstar-Domino Sugar than what the Schrafft Center required in its redevelopment from the candy factory to Flatley-leased space.

Neighbors will be able to reach project representatives through Flatley's 24hour answering service at its Charlestown telephone number, 242-2700. Satisfactory responses to any complaints or concerns about work on the property will be made. Cummings also said that the Flatley Co. would always be willing to meet with the community about any ongoing concerns with the site's redevelopment.

Committee Chairman

Tom Cunha was assured by Cummings that hazardous materials had been cleaned up and that the steam boilers stored in the power plant presented no added dangers. Site security would also be more intensive during the demolition project than otherwise, Cummings said, with a bonded company located on the property.

Committee member Jim Conway asked specifically about long-range planning with incoming Flatley tenants encouraging good relations around jobs for residents and union labor.

"We want to see some sort of relationship where the tenants have to be a good neighbor," Conway said, "be labor-friendly and deal with us on jobs."

St. Martin Street resident Moe Gillen had questions about the impacts on the long-discussed Medford Street state haul road, Massport's concurrent demolition at the nearby former Revere Sugar site and Sullivan Square traffic.

Cummings said that the haul road was still in the state's design and planning hands but did not see Flatley's work interfering with

the concept. The Revere Sugar Refinery work differs from that at Amstar-Domino because Revere Sugar's is a total demolition. Flatley's project should have fewer impacts on abutters than those nearer the Massport work, and Cummings said that Sullivan Square traffic created by the demolition project was expected to be minimal as debris will be trucked north on Route 93 to New Hampshire.

Gillen also raised his and other older Charlestown natives' sentiments for Flatley somehow recognizing that it inherited nostalgic Dewey Beach. Cunha deferred discussions of any beach re-creation, open space or memorials to this Charlestown cultural highlight until specific tenants expressed interest in occupying the site.

In a motion made by Conway, the committee agreed to recommend to the full council at its Nov. 12 monthly meeting that it "endorse in general the concept presented with the idea that they will be neighborhood friendly and that the Flatley Co. return with progress reports to keep abutters apprised."

Sergeant Runs Away With Top Honors

Baseball, October, World Series . . . The World Series returned to Yankee Stadium this week, and I must admit I've enjoyed all the post-season play. Baseball in October is something very special. Rushing home to see the games, especially the afternoon games, is great. The Regional Telecasts" are history, and we could stay focused on one game at a time.

For me, October baseball has meant some real live, up close and personal experiences. Working at Fenway Park does this to you. My photo album has some great memories. I have been most fortunate to have attended World Series games in 1967, 1975 and 1986 in Boston, as well as series games in 1977, 1978 and 1981 in New York.

Looking back at '67, the Impossible Dream Year, the price of admission to the St. Louis Cardinal-Boston Red Sox was \$8 for reserved grandstand, and \$2 for bleachers. The head-line prior to Game 7 was "Lonburg and Champagne," but in the end it was Bob Gibson who wore the ring.

The first World Series of my working Red Sox career was 1975, and the memories included the "game of all games," number six, and Carlton Fisk, El Tiante, Dwight Evans' gamesaving catch, Bill Lee and the Full Moon, Manager Johnson and a pitcher names Burton, and the fans trying to storm the right field gates, aka the Alamo. In the end, Cincinnati proved to be the very big Red Machine.

In 1977, the New York Yankees defeated the Los Angeles Dodgers. Mr. October, Reggie Jackson, was the man, and in Bleacher Section 51, Row V, Seat 16 in Yankee Stadium, sat Bob D, awed by the three-home run performance of Jackson. Believe it or not, I bought the ticket at the window. It cost \$4.

The only year I left Fenway Park mad was 1978. Thank you, Bucky Dent. The Yankees would defeat Los Angeles again, and I remember calling home after the final out, saying, "guess where I am!" In 1981, Los Angeles and New York would meet again, and I made what had become my annual trek. The Dodgers got their revenge and took the Championship Crown.

The scene would switch in 1986. Shea Stadium was the place to be, and a couple of co-workers and myself made the trip of all trips! We journeyed to New York without plane reservations, no place to stay and no tickets! We caught all four games at Shea, and if you thought it was tough watching games six and seven, being in the stands was even tougher. Even now when I think about it, I find it hard to believe that we were there. It was an adventure to remember, something which I would never trade away!

World Series make great memories and I have my share.


Vote No On Question 2


