

## **Genuine Staff Report on ChibiBerry**

As stated in TeamTyler's report:

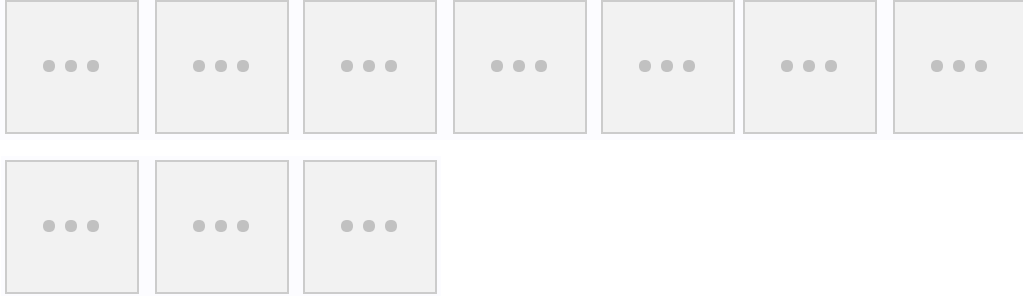

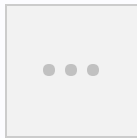

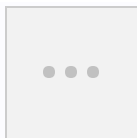
