Introduction

Preface

In January 2017 announced former migration minister Morgan Johansson (S) to the governments is not going to give Crime Prevention Council (BRÅ) the task of developing fresh statistics on criminals descent. This despite the fact that it's been over a decade since the last reporting ten and Sweden's demographics changed dramatically since then. Regeringens unwillingness to produce official statistics sowed inspiration to study I now completed. I got more inspiration of Police Peter Springares acclaimed Facebook Post following month.

In the following months, I wondered which would be the best approach, and in May I started to collect judgments. As the study progressed, I published two articles, which can be viewed as preliminary studies. I felt quite satisfied after the second article, but the knowledge they will not drop the idea that I wanted to get a complete picture of the situation, which became an ambition to study all criminal sexual offense convictions in Sweden for the past five years. I had the preliminary known it was going to be over four thousand judgments, I probably would have given up, but by working methodically every day, I came to a complete cataloging the end of September. I added the following month at statistical runs in the database and writing lyrics.

Dedication

I want to dedicate the survey to the staff at the Swedish district courts and the operators on the Swedish Tax Agency, who put countless hours of my requests. Their silence acting in offentlighetsprincipens service strengthened my faith in both law and democracy.

purpose

The aim is to give an overall picture of the provenance of convicted sex offenders in Sweden during 2012-2017 to show the differences between the country groups, to show trends over time and to confirm if many spontaneously think about foreigners and sex crime really does. I, who conducted the survey, a Sweden Democratic approach and does not claim to be impartial, however I do claim that the source data are consistent with reality and are statistically significant.

While BRÅ report on crime by foreigners studying the background of people ***suspects for the crime, seeing this survey only to persons sentenced for sexual offenses by the Swedish courts.*** There is therefore in my view no scope for interpretation of the various factors that criminologists often want to discuss because each case is assessed by the court and the accused was found guilty.

In addition, deep dive this survey in the statistics compared to Council for Crime Prevention report GE nom to make country of origin and type of crime, including regarding persons born in Sweden with one or both parents born abroad. Otherwise, it is easy to get a distorted view when a category as "born in Sweden with a foreign-born parent" does not differentiate between someone with a Norwegian mother and someone with Ugandan father to take a theoretical example.

The survey is structured so that it begins with an overview image, then studied the results in more detail and then take up other topics.

Summary

It summarizes the main conclusions of the investigation of short factual pieces.

Overall sex crime

- The proportion of Swedish men with two native-born parents convicted of sex crimes have, in proportion to other groups declined since 2013, and sjunkt sharply in the past two years.
- Afghans convicted of sex crimes has proportionally increased sharply since 2015; 2017 is almost every tenth convicted sexual offender Afghan.
- Despite an explosion in the reception of Syrian men commit the more than one-third as many sexual crimes that Afghans.

coarse rape

- Men with non-European descent commits 84% of coarse rape; Swedes comes in fourth place in the number of individuals convicted for that crime, for Afghans, Iraqis and Somalis.
- Country groups with the highest factor / likely to commit rape is in turn Algerians, Afghans, Tunisians, Moroccans and Palestinians.
- Nearly two out of three rough rapes committed by asylum seekers or men given a residence permit (not counting EU citizens). Every fourth rape committed by first or second generation immigrants.

rapes

- Men of European descent are committing fewer assault and gang rape than men with origins from all other regions.
- Swedish men with two native-born parents have committed 4.4% of rapes in the past five years.
- Most rapes in terms of individuals committed in the order of Somalis, Eritreans, Algerians, Iraqis and Gambians.
- Country groups with the highest factor / probability of committing assault rape are Algerians, Kenyans and Gambians.
- Most rapes are committed in Stockholm, Hudiksvall and Eskilstuna. Malmö comes first on the 8th and Gothenburg on the 17th.

group Rape

- 90% of gang rapes are committed by men with non-European derive income. Every fourth rapist who acted in the group are Afghans.
- Swedish men with two native-born parents have committed 6.7% of gang rapes in the past five years.
- Most rapists who acted in the group have been convicted in Ystad, Eksjö and Uppsala. Gothenburg is in 11th place, Stockholm 16th and Malmö 21st.

sexual molestation

- Foreigners harasses sexually Swedes to a much greater extent than other foreigners, in the investigated cases in which the plaintiff is not confidential.
- Nicaraguans, Algerians, Afghans and Palestinians have the highest factor / likely to commit sexual molestation.
- Half of those convicted of sexual molestation punishable only by fines. 91% of sentenced avoid prison.
- Men of European descent are committing the greatest extent other forms of sexual assault than tafsnig. More than three-quarters of Africans convicted of sexual assault have been groped.

Prostitution

- Most convicted of pimping, 57%, are Romanians. It sentenced more than twice as many Romanians for pimping than Swedes.
- The majority of the victims of procuring foreign women from the same country as the coupler.

gay Rapes

- The proportion of homosexual rape of total rapes has risen dramatically since 2015. The past two years, every ten rapist convicted of raping another man.
- The past two years have rapists that group raped men become by far the most common category of homosexual rape.
- Gang rape against men is 85% committed by Afghans and 15% of Iranians.

Other

- Adopted men - from almost any country groups - sex offenders more often than not only the Swedes, but also non-adoptees from the same group of countries.

Glossary

To avoid unnecessary repetitions of each chapter summarized this use of terms in the survey.

Bibrott - Judges are categorized by the most serious sex offense. Convicted bibrott are re- dovisade in the source data, but is not included in the survey as they would give a skewed representation in relation to convicted offenders. Bibrott have a big impact on the condemned penalty. Therefore, the statistics on sanctions only reliable for the main offense as **the lowest common denominator**. *Example:* One can be sure that a number of rapists sentenced to two years in prison, while those who are sentenced to three years in prison may also have been convicted of other crimes that draws up the penalties imposed value. Sentencing is complex because it is influenced by many factors. It would be difficult for an outsider to investigate criminal in detail in a way that would provide meaningful statistics and therefore take this examination only the penalty at a superficial level.

Factor - Percent offenders convicted of a specific crime divided by the male population percentage of foreign born. *Example:* Moroccans constitute 3 105 offenders convicted of gang in this investigation, corresponding to 2.86% of breaking. They also constitute 0.57% of men living in Sweden who were born in another country. $2.86 / 0.57$ gives a factor of 5.02. Swedish men, defined as men born in Sweden with two native-born parents, represents 69.23% of all men living in Sweden, and factor in the example becomes 0.10. Current population figures published by Statistics Sweden. I single out groups with few perpetrators Factor chart due to statistical uncertainty.

Regions - One-handed man's broad cultural geographical provenance. It can be Europe, Asia, South America, the Mena (Middle East / North Africa) and Africa (sub-Saharan). Unclear cases are reported separately when they occur. Regions are used to give a quick overview.

The regional breakdown is in most cases obvious, but some cases may be mentioned for the sake of clarity. Europe includes in this context, except Sweden, although countries can be said to belong to the European cultural sphere such as the US, Canada and Australia. Afghanistan belong to Asia, Pakistan and Turkey to Mena. South America comprises in this context, Central America, Mexico and Cuba. There is also a vague category, which besides men from the unknown land also includes those with two foreign-born parents from different regions as well as a few from the West Indies who could not sort in the region. There are men whose country is not possible to state but rather the region, such as men with one parent born in Palestine and a native of Iraq.

The division is to some extent a subjective question but I have tried to make it as transparent as possible. It is possible to divide the regions into more categories with tighter criteria but I prefer to present few regions combined with detailed statistics for individual countries. It is namely to reason back and forth on Mexico to be counted for the region South America or Australia to the region Europe, but whatever had regional statistics barely changed barely a thousandth as very few perpetrators are from those countries.

Regions charts do not differentiate between offenders who are born in Sweden with an output kingdom born parents, but they counted for the foreign parent's descent. Initially, one might think it gives a misleading proportion but in these cases the perpetrator lends its foreign-born parent representation in the demographics. *Example:* Sentenced an offender to an Iraqi father and Swedish mother, it means still that the offender's father is listed are

SCB statistics that foreign-born. Of counting does not remove the error altogether, but since the SCB does not report what country a person of foreign-born parents come from, there is no better alternative.

In-depth statistics on residence status recognized male with a foreign-born and native-born parent separately.

The residence status - Describes the shape of the right convicted perpetrator men have to be in Sweden. The status does not say anything about the perpetrators descent, however, says a lot about the difficulties ten to get the expulsion request granted. There are four forms of foreign nationals and five of the Interior in the survey.

Immigration law makes no exceptions for any country doomed from. There are examples of both a Norwegian deported and a British citizen who was sentenced to deportation to prevent that, he settled in Sweden after serving his sentence.

Foreigner - A foreign national who is not registered population in Sweden and has no special right to stay here. Most are illegal, either because they have stayed despite the expulsion order or by being taken to Sweden without applying for asylum or any other regulatory contact. Some are best described as tourists.

Asylant - An asylum seeker foreigner who has a temporary right to stay in Sweden during the period of investigation. They are easy to distinguish because they have called the coordination number, which resemble personal but the last digits of the birth date is the 31st

UHT - Foreigners are given residence permits. They are distinguished by their social security number without Swedish citizenship. Most have sought asylum but there are also other forms such as work permits.

EU / EEA - An alien who is a national of an EU or EEA country, giving them the automatic right to stay temporarily in Sweden for work or study.

Immigrant - A foreign-born man who has been given Swedish citizenship.

Two foreign parents - It is known as second generation immigrants, where the offender is born in Sweden (or arrived as young children) whose parents were born abroad.

A foreign parent - An offender who was born in Sweden with a parent born in Sweden and the other abroad.

adopted - A foreign-born man who adopted to Sweden, almost always to two parents born in Sweden. According to Statistics Sweden count this group of foreign-born in their population and are sometimes for a very large proportion of those born in a particular country; South Korea is a good example.

Two home parents - A man born in Sweden whose parents were also born in Sweden. Country Group Swedes in this study refers to this status, while other studies gladly take more categories to dilute the crime statistics for people with partial or total foreign origin.

rape Category - A definition of how a rape carried out. For rubric rape are three main categories: Classic, rash and Assault. Relevant case is categorized further as the Group or Homo. Of child rape are also the categories Children and statutory to distinguish children and teenagers in the statistics. Stats rubriceringar does not take into categories, but the categories are only used for the deeper analysis of the statistics.

Classic - The prevailing paradigm of rape of a man by force, restraint, coercion and / or threats to compel the sexual acts against the victim's will. It is the enkilt common category of rape.

Eliminated - A type of rape that started when the victim was defenseless of sleep, alcohol, drugs or medical causes and either completed, under the conditions or arrested when the victim revived. If the rape continues GE nom restraint so after the victim woke counted instead as a classic.

Assault - A narrowly defined category, where both perpetrators and victims are completely unknown, and there was the rape directly or close to the time for the meeting and also took it through restraint, threats and / or violence. The basic criterion is that there is a category of rapes that are impossible to guard against. If in doubt, I have cat- goriserat rapes classic to follow the prevailing paradigm of assault rape as when a foreign offender attacking a woman on a forest road, pulling her into the woods and perform sexual intercourse by force or restraint.

Group - When more than one perpetrator together and in concert rape victim. There are gray areas where the two perpetrators parallel raped different women at the same time, or when offenders "take turns" raping a woman alone in a secluded place without consensus. To follow the prevailing paradigm of group rape, in which a man holds a woman while the other rapes her and they then switch places, I have not categorized the gray area cases gang rape.

Homo - rape where the perpetrator and victim are the same sex. The category is not suckler nad saying anything about homosexuality in general. Gay Rapes say no more about gay than other rapes says about heterosexuals. On the contrary, it appears this type of rape often involve domination and humiliation than gärninsmannens sexuality. This is especially true for the further sub-categories Group and Assault.

Statutory - A svenskifiering the established American expression *Statutory*, which means voluntary sexual action-is between people in their early teens and those over fifteen. It appears that older men and girls in their early teens having consensual sexual acts with each other, but the vast majority of these were for guys in their late teens who had mutual sex with young girls. Some cases even 15-16 year old guys who had sex with 12-year-olds, but where the line is drawn to the guy's age to the category- wise to count as legal.

Example: A few Roma "married" when the girl was 12 years old and the guy was in the upper teens. After his conviction for rape of a child dropped the couple was still "married" and had brought their own children.

The most distinctive of statutory rape is precisely voluntariness and reciprocity, and the incipient sexual maturity that comes with adolescence. Overall, it is far less damaging psychological impact on the person than when the sexual acts are not voluntary. The adverse impact on the young person is considered by most to rise as the offender's age. It seems reasonable to believe that it is more harmful for a 16-year-old guy to be branded for life with the judgment Rape of a child than for a 14-year-old girl to have sex with her boyfriend. I believe there should be room in Swedish legislation for a so-called Romeo-and-Juliet-law where the legal system allows young people aged 13-17 years, for example, have their love life in peace as long as it is based on reciprocity and voluntariness of both parties.

Children - Sexual acts against victims aged 12 years or younger, except for a few cases where the victim was just 12 years and the perpetrator 15-16 years, but not if the offender was 17 or older.

Våldtäktstyp - a definition of the deeds performed. They are in order of either vaginal, anal, oral or finger / object. The type goes after the most serious offense, as an oral rape may also have meant the fingers of the victim's sex and vaginal rape could have meant all other deeds. The ranking is necessary to avoid a large number of categories.

Helsingborg District Court sentenced a Swedish man to five years in prison for having voluntary sexual intercourse with her partner's daughter from the time she was 14 years old.

A few weeks later, the same District Court sentenced an unaccompanied Afghans to have paid a 13 year old girl to sleep with him. The Afghan, who have claimed to be 15 years, received the sentence for young offenders.

General statistics on crime

The most common crimes

Of the more than four thousand sentences in the survey belong to the main offense in almost every one of the 20 most common classification area. So-called bibrott where such an offender is convicted of both rape and sexual assault, only counts as the most serious offense. The precise distribution of judgments seen in the table below.

Judges per year

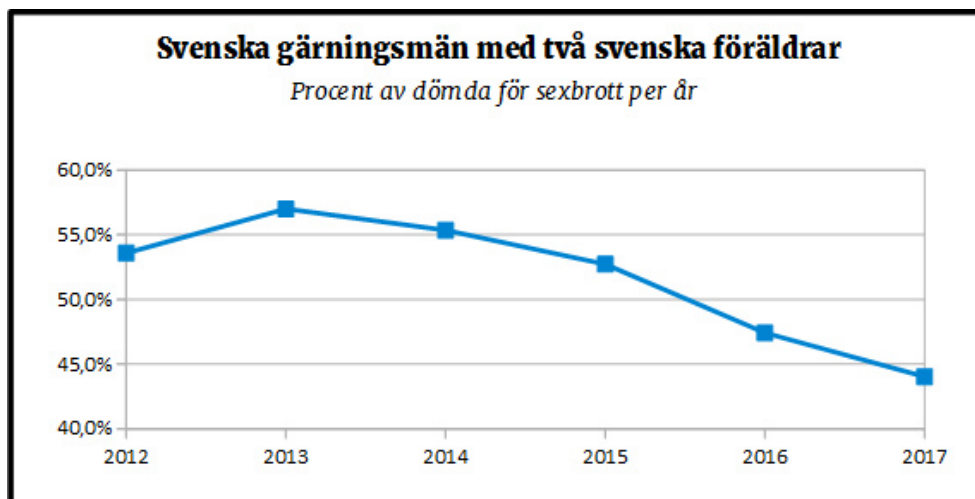
The survey contains a different number of judgments from year to year. The difference is particularly strong for 2012, as criminal convictions discarded after five years, and for 2017 because the survey was done before the last quarter.

The survey does not include all sex crimes convictions even if it was ambition. The explanation is complicated, but explained in chapter *If the survey*. Therefore, you can not make an absolute comparison to reported crimes, according to the National Crime Prevention Council's statistics, but my understanding is that about 5% of reported sex crimes result in conviction.

Demographic change of sex offenders

The Swedish-born male population, with two native-born parents, has remained at a constant level of 3.47 million in recent years. Just as many are born to die and difference are hundreds of individuals. However, this male population share of offenders convicted of sexual offenses has fallen sharply in recent years. There is a dramatic difference from 2015 onwards. From a level of 53-57%, the level in recent years has dropped to 44-47%. The trend is a clear effect of migration disaster, which grew in strength during 2014 to explode during, 2015.



The number of non-European men living in Sweden has risen steadily over the years, The exception syriers meteoric rise.

The percentage of those convicted of sexual crimes differ from demographics. The group of Afghan men have

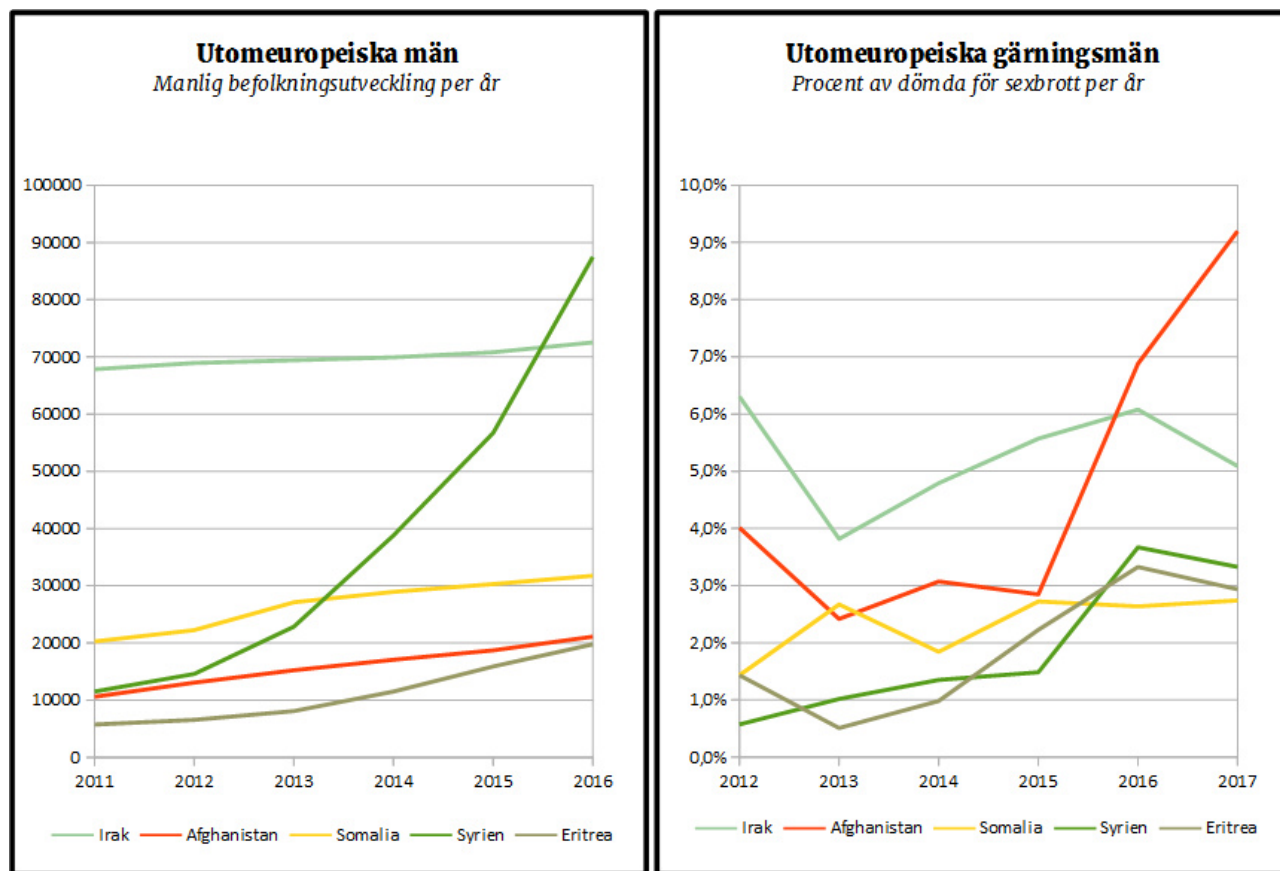
increased almost linearly while the number convicted of sex crimes soared. However, not the number of convicted Iraqis and Somalis percentage increased more than can be explained by the increase in population. The amount in this case is always 100%, so the increase in Afghan offenders does not automatically mean that such Iraqis and Somalis committed fewer sex offenses.

The table shows figures for indoor and overseas groups with the most doomed input divider while the charts on the next page shows the development of overseas groups.

The charts show the evolution of population and condemned by country in recent years for the largest overseas groups. They are a visualization of the table on the previous page.

While the group of men born in Afghanistan has increased at a steady pace the Afghans share of convicted sex offenders soared from 2015 onwards. This may indicate differences in which Afghans who have sought asylum in Sweden in recent years.



It should be noted that the percentage of each year's participation of a whole, therefore the decline curves are not interpreted as a group commit fewer crimes, but rather that the group's share of total offense falls. *Example:* If Chinese people committing three rapes in 2016 and three rapes in 2017, while Estonians are committing three rapes in 2016 and five rapes in 2017, China's curve point downward for 2017. (In fact, neither the Chinese or Estonians convicted of any crime of rape in this study.)

Percentage of Swedes and foreigners each court district

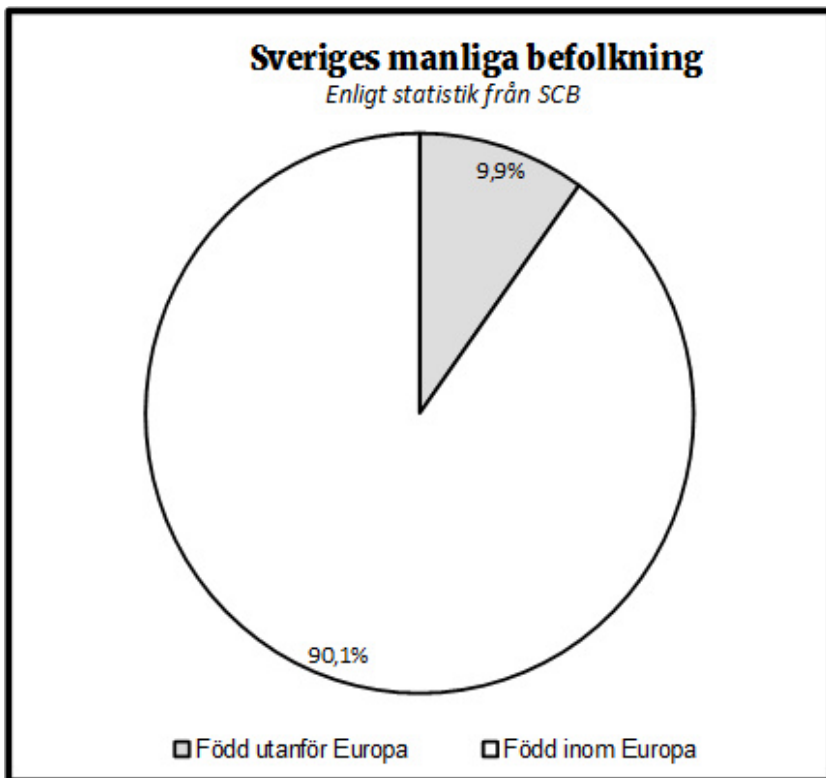
The table compares the proportion of Swedish men with two native-born parents convicted of any sexual offense during 2012-2017 with the percentage of men with foreign backgrounds. Proportionally sentenced most foreign sex offenders in the metropolitan areas of Stockholm, Malmö and Gothenburg - except for Eskilstuna, which thus get past Gothenburg in the list.

Swedish men with two native-born parents make up 69% of the male population in Sweden, according to figures from Statistics Sweden. Only three court areas, Norrköping, Alingsås and Gotland, reaching thus Swedish men over their share of sex offenders compared to their share of the population.

Data missing for Norrtälje and Haparanda. This list does not distinguish which country a man of foreign origin coming from, but comparable to country groups shares of rubriceringar reported later.

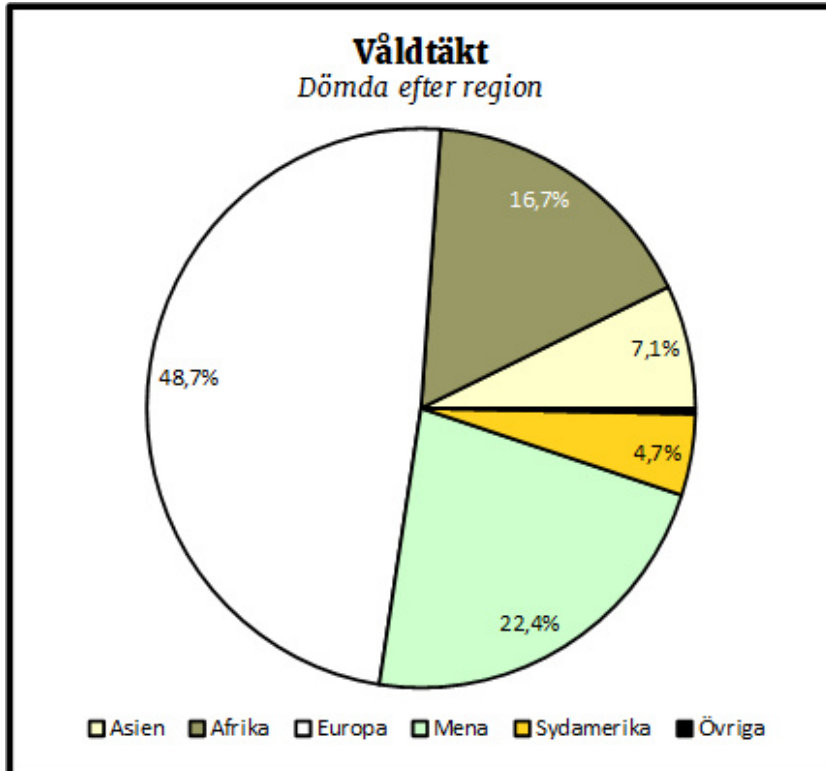
The European group with the largest male population living in Sweden is Jugoslavi- one, followed by Finland and Poland.

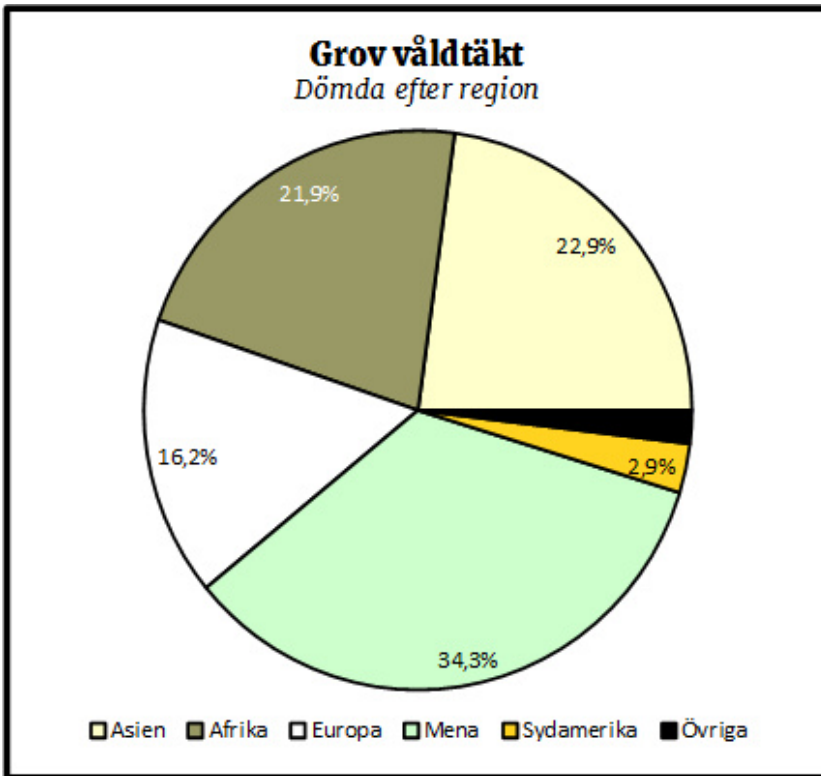

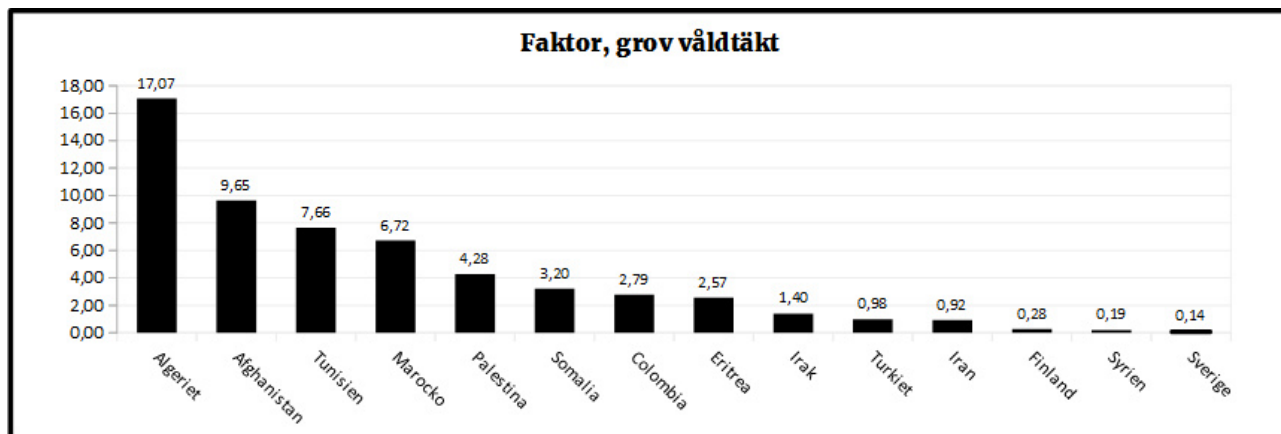
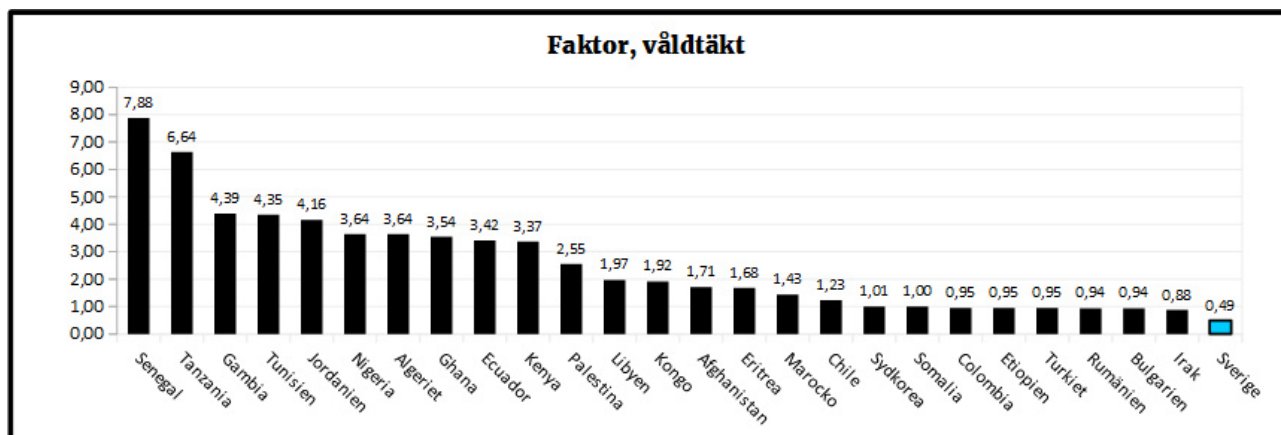
In Sweden live 5.01 million men, according to figures from Statistics Sweden at the 2016 year end. 3.47 million of these are wholly Swedish, defined as those born in Sweden with two native-born parentage; they account for 9.5% of offenders convicted of Aggravated rape in recent years. While living there 21,093 men born in Afghanistan in Sweden; offenders from the group stands for 22.9% of those convicted of Coarse rape.

This difference in demographics and row number is best illustrated by groups factor, which is produced by **dividing the percent convicted of crimes with community's percent of foreign born**. *Example: Afghan male* constitutes 22.9% convicted of Coarse rape and 2.37% of men born abroad; $22.9 / 2.37$ gives a factor of 9.66. At the same time wholly Swedish men 69.23% of the total number of men living in Sweden, with 9.5% convicted of Aggravated rape is wholly Swedish men by a factor of 0.14.

Calculation of factor include only groups of countries where there are several men convicted perpetrators, otherwise the indication is misleading. A good example is the conviction of a man from the small African country of Mali; there are only 87 men from that country living in Sweden. The man is therefore itself of one percent of the male population in the group, which would give a soaring factor.

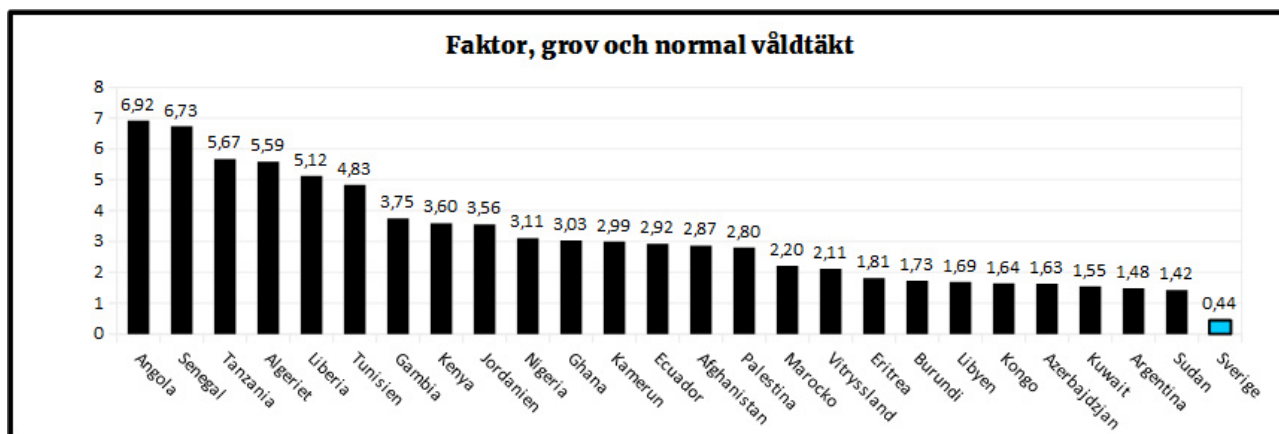
Charts show groups of countries with the highest factor, sometimes including Sweden comparing value. The tables on page then displays all groups that have at least 2-3 convicted perpetrator men depending on how many groups of countries are represented in the statistics.

You can see the factor as an indication of how likely you are to a man from a rural group convicted of a crime and therefore impact on sexual statistics of continued migration from those countries. Alternatively the effect of a return migration from the groups would receive.



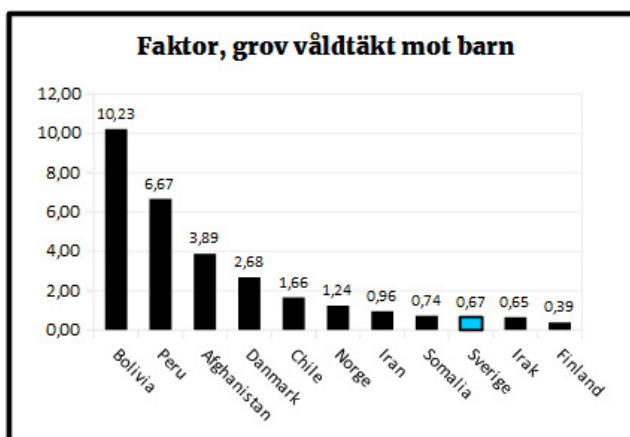
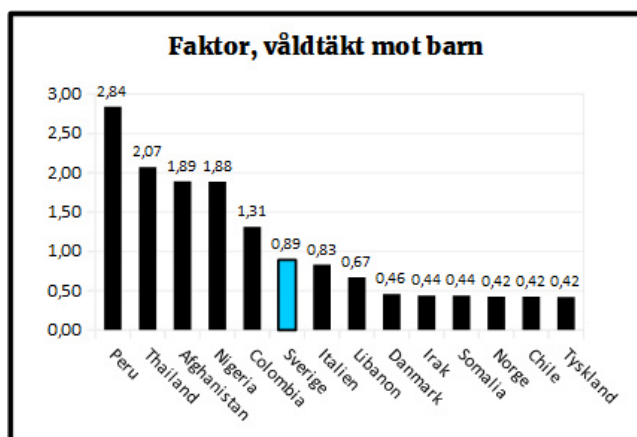
The individual groups of countries most frequently convicted of the rape of the normal level in relation to the size of the group is Senegalese, Tanzanians and Gambians as they most often convicted of aggravated rape are Algerians, Afghans and Tunisians.

Because it is so different the groups with the highest factor in rape and rape of a normal extent it might be interesting to weigh the two classification area, which is not as easy as it sounds when the survey covers more than six hundred rapes and more than a hundred rough rape. The balancing shows that Africans and North Africans are mostly likely to commit rape of adult victims relative to the size of the group. Country Groups that proved most likely to rape children differs in several respects compared to other sexual offenses. On the other hand, it is four times high risk of a Danish convicted for serious crime compared with Swedish men. Neither group, however, is near the top of any list - that is, for example, 3.8 times more likely that a Bolivian commit rape against children than a Dane.

Rape of a child does often, but not always, consensual sexual acts between men and boys in their early teens. Aggravated rape against children can mean both the rape of young teenage girls by force, threat, coercion or restraint and regular pedophiles top grip on young children.

Penalties for rape

The tables show the number of penalties imposed by legal classification. In total there are 614 convictions for rape and 94 for rape. Minimum sentences for the rape of the normal rate is usually two years in prison, which is also the single most common penalty of 28% of their sentences. For it can be aggravating and mitigating circumstances. The perpetrator's age is also an important factor in sentencing.

To reach the higher the penalty, it is almost exclusively of multiple rapes, either against the same victim, or against multiple or severe bibrott. The 10-year sentence for aggravated rape included eg coarse involuntary manslaughter, where the victim's husband was killed by robbers who broke into their home. The nine-year sentence for the same classification was the media called "party planner" and "chef" who drugged and raped several young women, which in any case was once gang rape. The third maximum sentence of 8 years 6 months was an isolated incident where the perpetrator ripped home a housing speculator, held her captive in his apartment and raped her brutally for many hours.

Penalties of child rape

The tables show the number of penalties imposed by legal classification. In total there are 440 convictions for rape of a child and 75 for aggravated rape of a child. Minimum sentences for rape against children, as well as for the adult victims, two years in prison and it is also the single most common penalty of 16% of the penalties. Next comes three years imprisonment, imposed in 13% of penalty.

In three serious cases have gone right over the actual maximum and sentenced to twelve years in prison. All about vaginal rape of young girls for several years.

The most common penalty for gross rape of a child is 7 years in prison, which is imposed in 19% of cases, followed by six years in prison as convicted in 16% of cases.

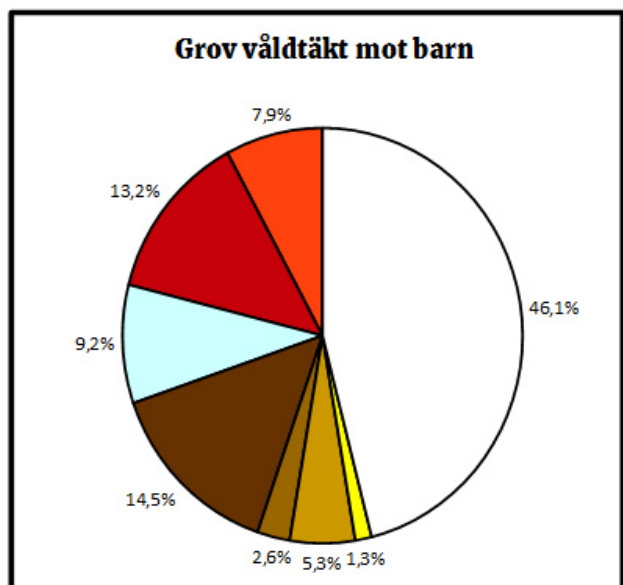
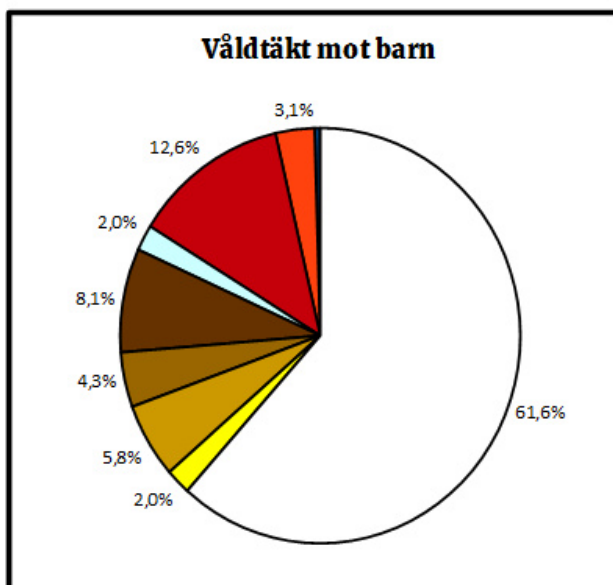
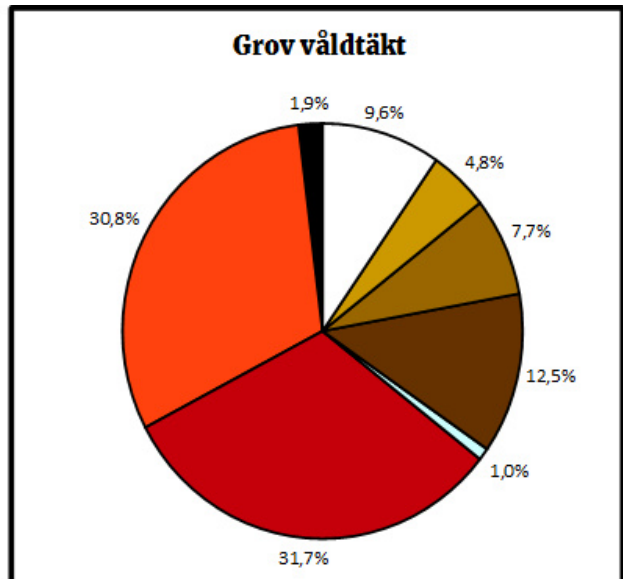
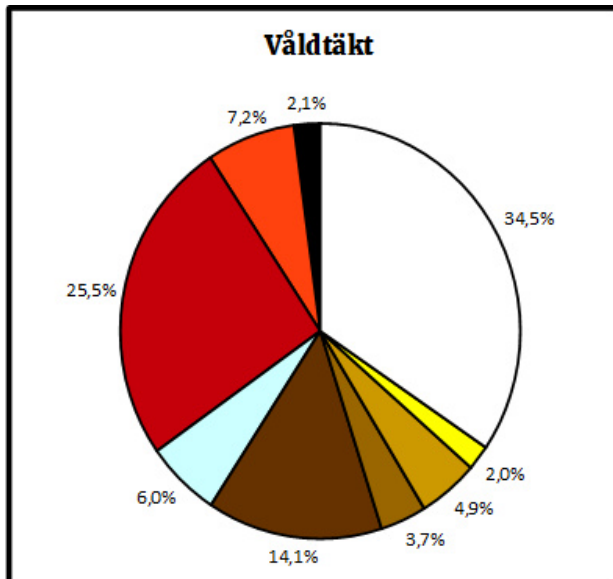
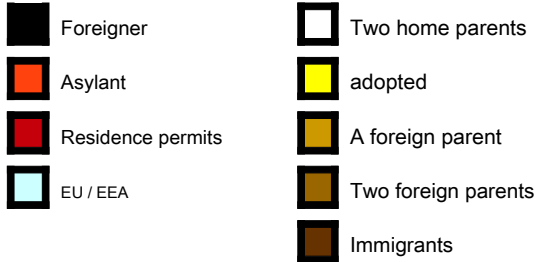
The residence status of offenders convicted of rape

What stands out in the analysis of the perpetrators residence status of the most common sexual crimes is that two-thirds of gross rape (62.5%) committed by asylum constants or of men given a residence permit. Without the latter years of mass immigration had thus majority rough rape is not done - notwithstanding a continued massive overrepresentation of men with immigrant background.

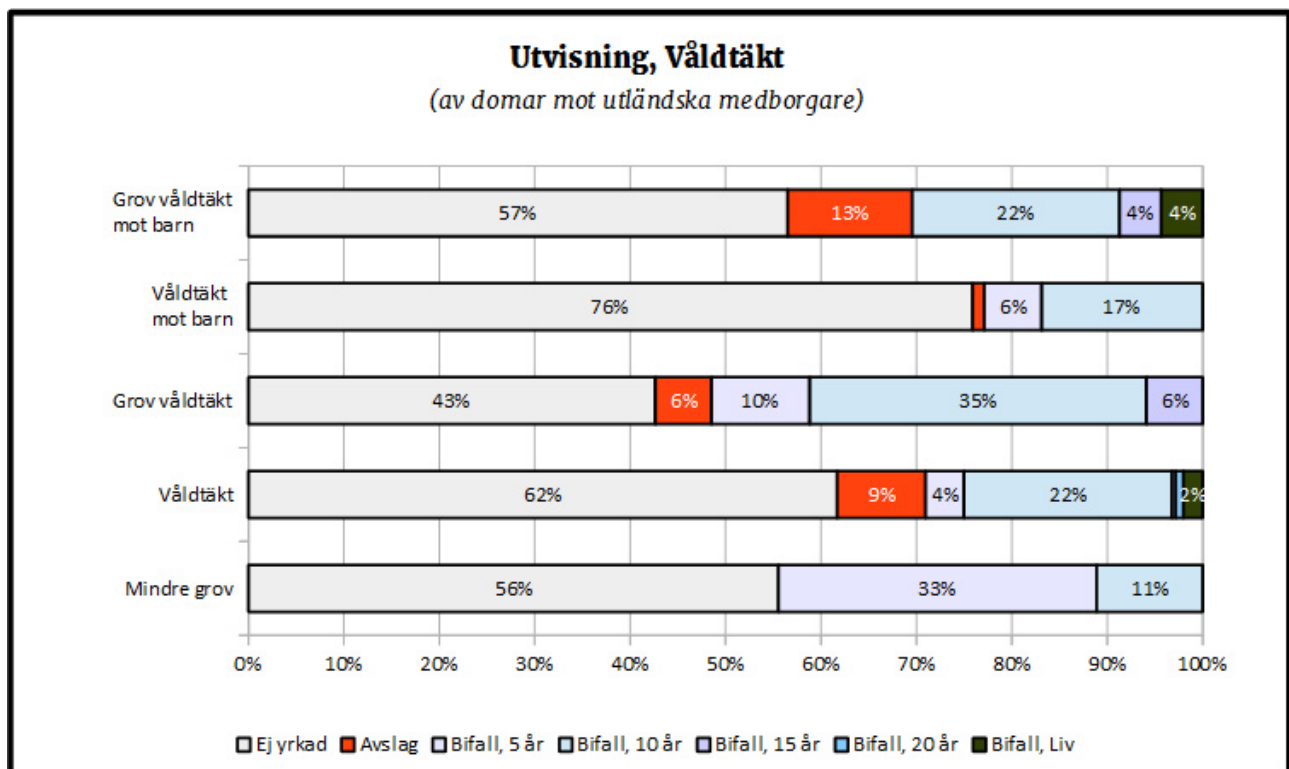


Expulsion as part of the sentence for rape

The prosecutor claims not even the expulsion of part of the judgment of the majority of rape convictions of foreign nationals. Only for a classification demanded the expulsion of more than half the cases. It may seem unfortunate, because the prosecutor seeks expulsion usually receive applause.

When the deportation claim is granted in rape convictions is the most common time period for samt- league rubriceringar 5 years. The time begins to run when the judgment becomes final, as an alien who is sentenced to two years in prison and five years of deportation can return three years after his release.

There is one case where a rapist sentenced to 20 years of expulsion, representing 0.4% of expulsions of rubric Rape and are thus less common than lifetime expulsion. It is possible to speculate on the reasons why prosecutors seldom calls for the expulsion of foreign nationals convicted of rape or sexual crimes in general. The basic condition for the prosecutor to make a claim for expulsion is that a non-Swedish citizens have committed a crime that is punishable by imprisonment and that he be sentenced to a more severe punishment than a fine. An earlier sentence of fines imposed, however, at a later prosecution, could influence the assessment of the risk of further crime. In the case where the question of expulsion arises also requires that it be assumed that the alien will commit further crime in this country or that the accused crime is so serious that he or she should not be allowed to remain in the country.

The possibility of expelling independent of relapse risk related to the seriousness of the crime. As a general guideline stated that the crime should normally have a penalty of one year in order to lead to deportation on that basis. "

It is natural to have different views on expulsions of sex offenders. Some seem like they stay in Sweden for some kind of racist concern for future foreign victims in their homeland, which they consciously or subconsciously value higher than the Swedish victims. One can, however, think it should be possible to agree to deportation issue always be decided by the court and that power will not continue to lie with the individual prosecutor.

Prosecutors tend to seek the expulsion as part of the punishment against rapists who lack Swedish citizenship differ depending on the court area. For rape convictions in Blekinge, Gotland, Kristianstad, Lund, Lycksele, Södertälje and Värmland prosecutors ALD rig called for the expulsion of foreign rapists. For Gavle, Hässleholm, Luleå and Skellefteå prosecutors contrary, never refused to demand the expulsion. 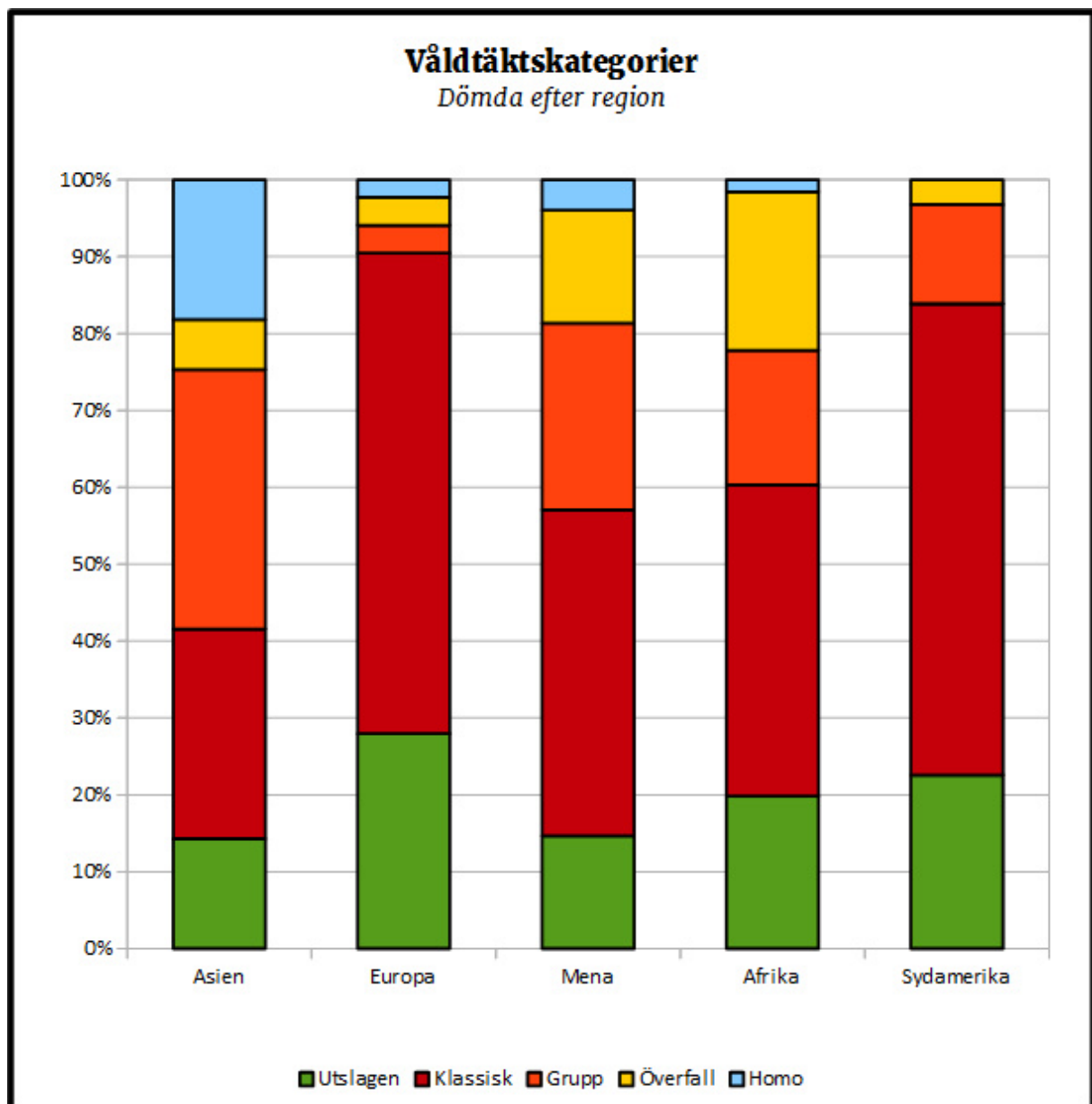

More than half of all rape convictions is the classic paradigm of rape - the enforcement of sex by force, restraint or intimidation. Just over one in five occur while the victim is knocked out of sleep or other causes while one in ten are assault rape. Every six convicted rapist has acted in the group, while homosexual rape is a small fraction of the total judges of rape. Regional chart shows the major differences.

The figure is interpreted as: Of all offenders with origins in Asia convicted of rape, 40%

participated in the gang rape, but convicted rapists with origins in South America has not been convicted of rape of a male victim.



The table below is a more detailed version of the bar graph showing the proportional distribution of rape categories per group of countries, including the country groups of 4 or more rape convictions. Rape of both normal level and the rough is included.

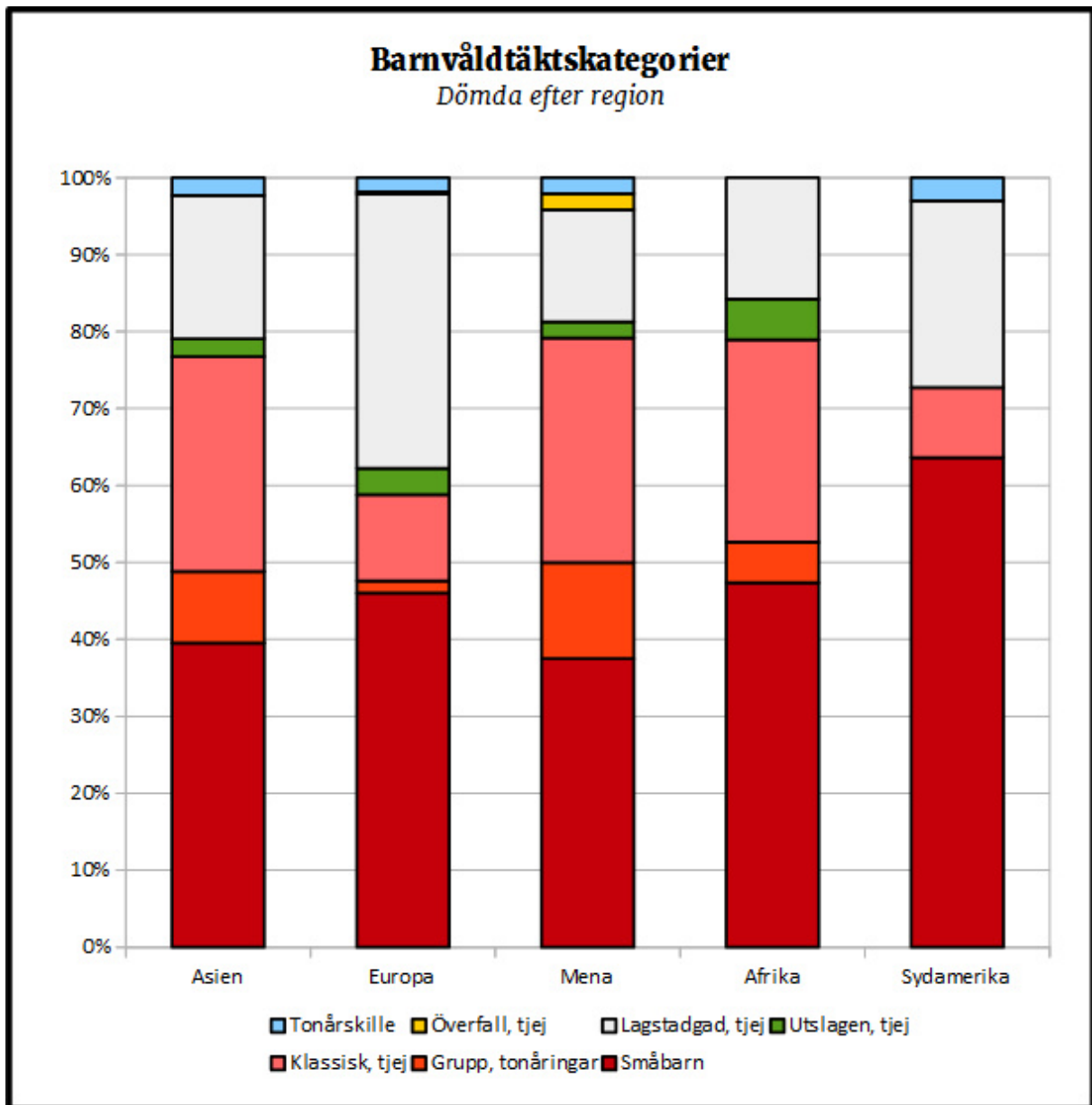

Child rape, two additional categories, *statutory* where the documents have been voluntary, but the victim 13-14 years *children* where the victim was 12 years old. 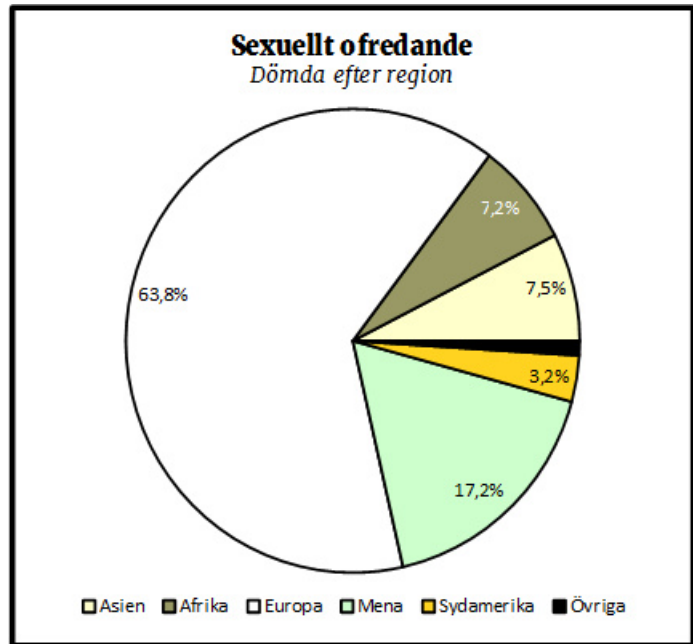

Sexual assault is a broad category of offense that involves a variety of works devoted to violate the integrity of victims. It stretches all the way from men like The transmitter der penis picture to his former wife to pedophiles in the bathhouse paws little girls on sex- et, from men who shout sex words against a female colleague of badgers' rush toward teenage girls at summer festivals. In short it is a classification covering all acts judiciary judges are mild in comparison to other sex crimes but still serious enough to be illegal.

Statistics show that the perpetrators of European descent have committed nearly two-thirds of sexual molestation. The second largest group is men with descent from the Middle East, who commit a little more than six crimes in this category.

The victim of sexual assault

Unlike many other sexual crimes covered not usually victims of sexual molestation of privacy. This makes it possible to study the victims of this crime. I have for privacy reasons not made any deeper research, but I have noted the victims' names and divided them into two broad groups of Swedes and foreigners.

It is in this context equal which foreign country the victim comes from, for example, both Norwegian and Iraqi women are counted as foreign, because the deeper research in off- clean not been made, but based on how their name sounds. It is probably obvious why a narrower categorization of victims of descent is not made.

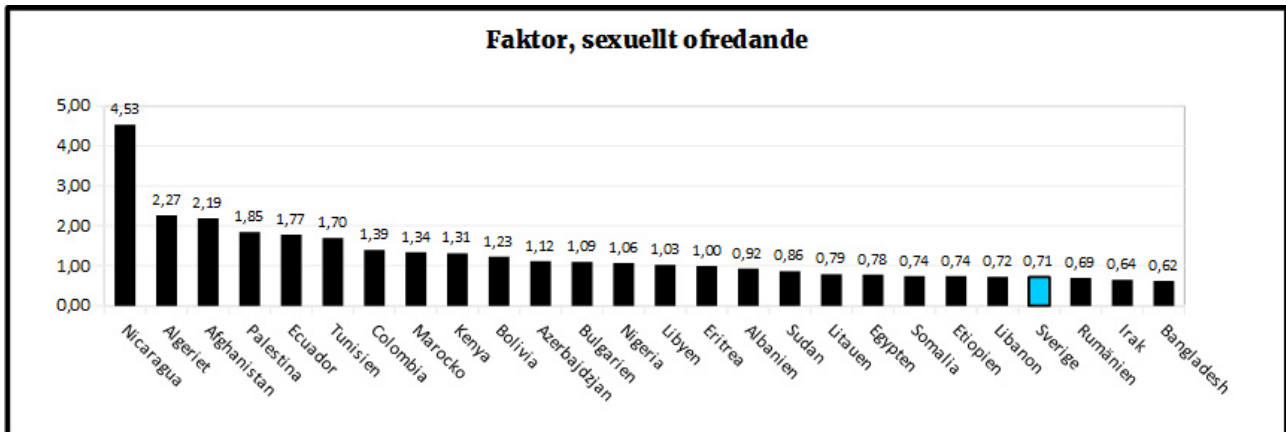

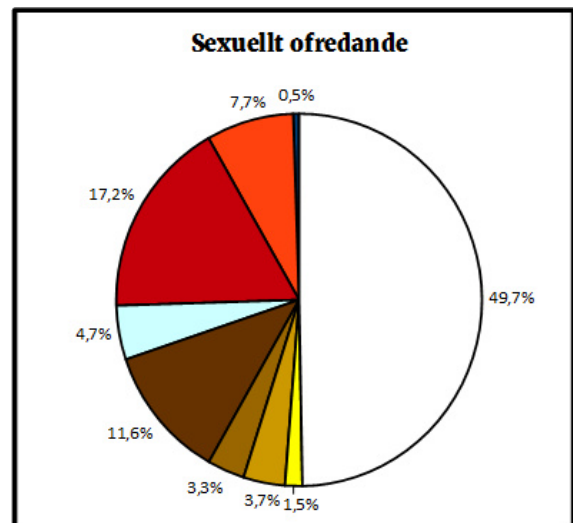

The residence status of offenders convicted of sexual assault

Compared to the residence status of rapists committed a uniform percentage crimes in this category of men with an immigrant background and men who have sought asylum or been given a residence permit. It can be seen as an indication that the behavior is not affected by any integration measures, even if a relatively low proportion perpetrated by second generation immigrants, compared with rape crimes.

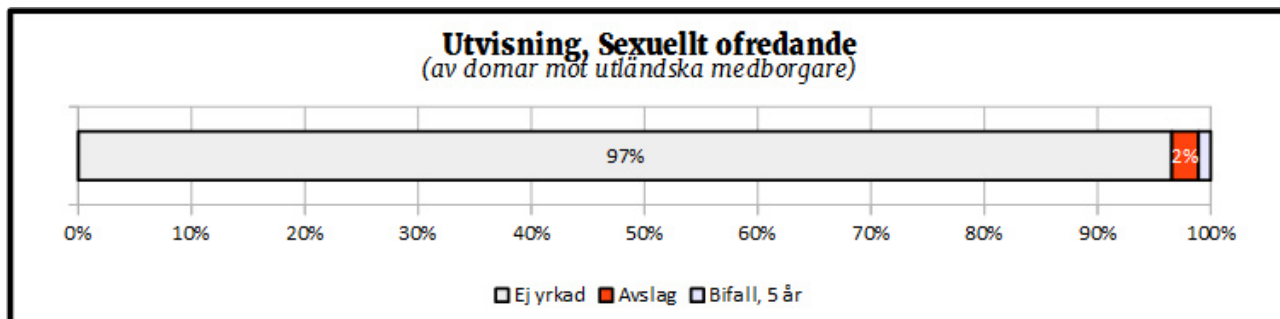

Expulsion as part of the sentence for sexual assault

Of convictions for sexual assault against foreign citizens demanded the expulsion of only 3.43% of cases. Two thirds of the requests are rejected. In total, only 1.07% of foreigners convicted of the crime of deportation.

Statistics show that although the penalties for sexual harassment is very rare, it is for prosecutors to current rules both strength and acclaim.



Nigerian Babajide was convicted in 2013 of having groped and harassed 16 women. The sentence was probation + community service. He was sentenced again the following year when he juckat against two other women. The punishment became more probation + community.

Penalties for sexual assault

Half of penalties imposed sexual assault, 49%, results in only a fine. 91.27% of these sex offenders shall not be sentenced to one day in jail.

The three hardest punishments typically due to the serious bibrott drawn up penalty value. The punishment of 2 years 3 months included, among others attempted aggravated assault, the 1 year 6 months rebuilding also included Coarse a woman, while the punishment of 1 year 3 months probably consisted mainly of Preparation of devastation endangering the public.

The harshest punishment where sexual harassment was single rubric is one year in prison. Sexual assault can be said to often be at the bottom of a chain rubriceringar sought by prosecutors. The higher the penalty touches the second rubriceringar as sexual assault and attempted rape but does not reach the classification are in a legal sense, according to the Court's assessment.

Not counting the three judgments which bibrotten pulled penalty the value of the maximum, these over fifteen hundred convictions resulted in a total prison time of 34 years 9 months. It gives a rough prison time of 8 days for each judgment in case of sexual assault.

Categories of sexual molestation

Most judgments where sexual assault is the main offense has been examined and categorized by the type of offense committed. It had gone to sort by even more categories, but the main purpose was to sort tafsningar in a separate category from other molestation.

The crime covers many types of documents, sometimes a combination of the same judgment. Therefore, the categories are ranked on a scale where the most serious offense determines the category.

Tippet is most serious because it directly violates a victim physical integrity. It has four categories:

Tippet against sexual parts - When an offender groped someone's breasts, buttocks or sex (be it with the hands, wrote or objects), or when a perpetrator forced the victim to vidöra his sexual parts.

Småtafs - When a perpetrator touched the victim's body other than the sexual parts, or forced the victim to touch his body. Case in point is to rub someone's thighs or kiss them against their will.

Homo - All streamer with a gay character to the victims from their teens and up.

Children - All streamer against victims aged 12 years or younger, regardless of gender.

Flashing is deliberately exposing genitals, graded severe if the perpetrator also masturbated for the victims.

Flukt is when the perpetrator previews, or surreptitiously filming, someone who is naked. Also includes acts done by force, for example, that someone pulled down a woman's bra to see her breasts. Since 2013 classified secret filming for his own crime Offensive shooting, which also includes a few other situations of secretly filming.

Speech are forms of harassment that occurred through comments and obscene gestures in the physical presence of abusive sexual words of incitement to sexual acts.

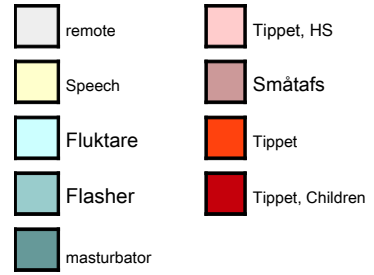
remote is the category that are at least serious and includes all acts done remotely. Most of these crimes are sending sexual text messages, penis pictures, and the like but can also mean sexchattande with underage victims.

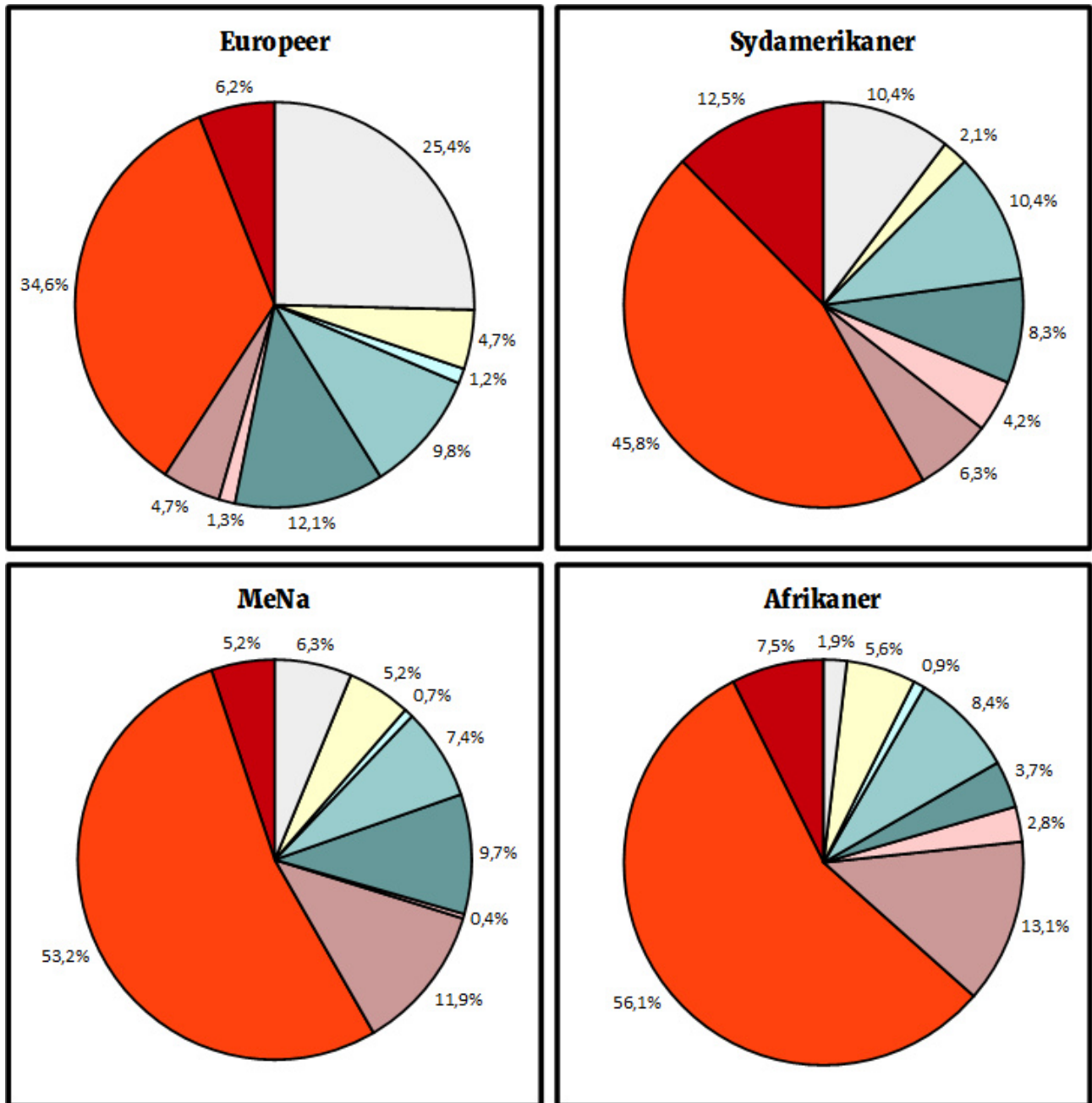
Categories of sexual molestation by Region

European men have about a quarter offenders at a distance, a quarter is flasher, while half have groped. Men from other regions have increasingly groped - for Africans more than three quarters.



South Americans and men from the Middle East condemned for roughly the same proportion of the streamer, around two-thirds. However, condemned the South Americans to a greater proportion of having groped children than all other regions.

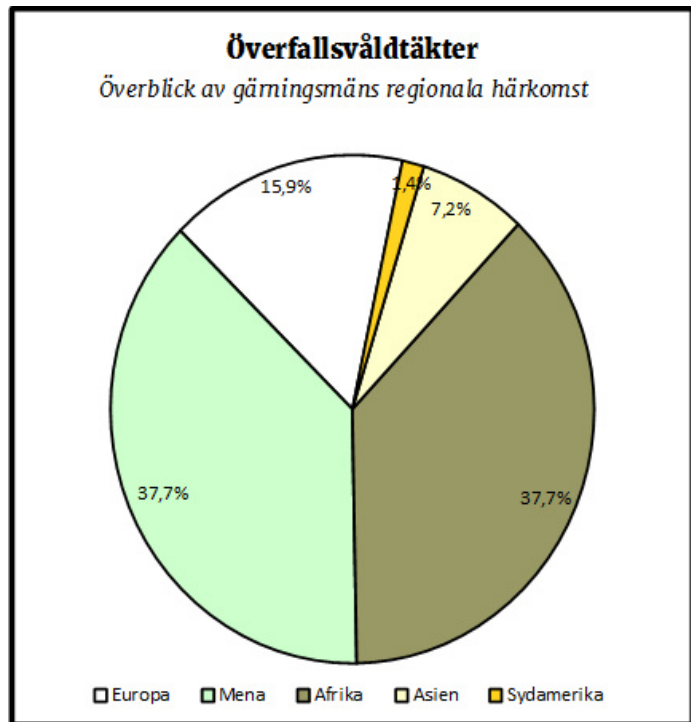

It is difficult to rate the levels of hell for rape victims, but this type is close to the deep bottom. They are often characterized by violent force before the rape even begin, expressions of hatred against a wild stranger that is difficult to understand. Sexual satisfaction seems often come second, instead, they are driven by a morbid desire to destroy another person's life.

This sexual terrorism, which disseminates insecurity and restricts the freedom of far more than the victim herself, gets another frightening dimension, it is difficult to protect themselves against them. Few women expect the doorbell can plinga one evening and the outside is a completely unknown man, prepared to brutally rape them.

I have used a narrow definition of rape attacks. Firstly must perpetrators and victims be completely unfamiliar to each other



Anna gick home alone through Söderhamn one night after she stopped working. The Syrians came up behind her and followed her for a while.

She changed the way but the man continued to follow and gave her then two punched in the face. She fell down, then he kicked her hard in the head several times.

The man released her and said in the electricity supply Swedish, "fuck". He then pulled out the woman in a forest, tore off her clothes and raped her vaginally.

After the incident, she had a lot of pain in the face and could not see himself in the mirror for weeks.

The prosecution had not called for the expulsion. The Court of Appeal reduced the sentence of 3½ years to 3 years.

A regional overview of all rapes shows that three quarters are committed by men from the Middle East and Africa, while the perpetrators of descent from the rest of the world share the remaining 24.6%. Overview weighs however together both regions and types of assault rape. The deeper the statistics further on this type of rape reveals interesting differences between the groups.

One early evening in August 2015 was a woman on romantic outing by the sea with a male friend when she was going to go and buy some food and drink.

Somali pulled down the woman's panties and raped her first vaginally, then anally.

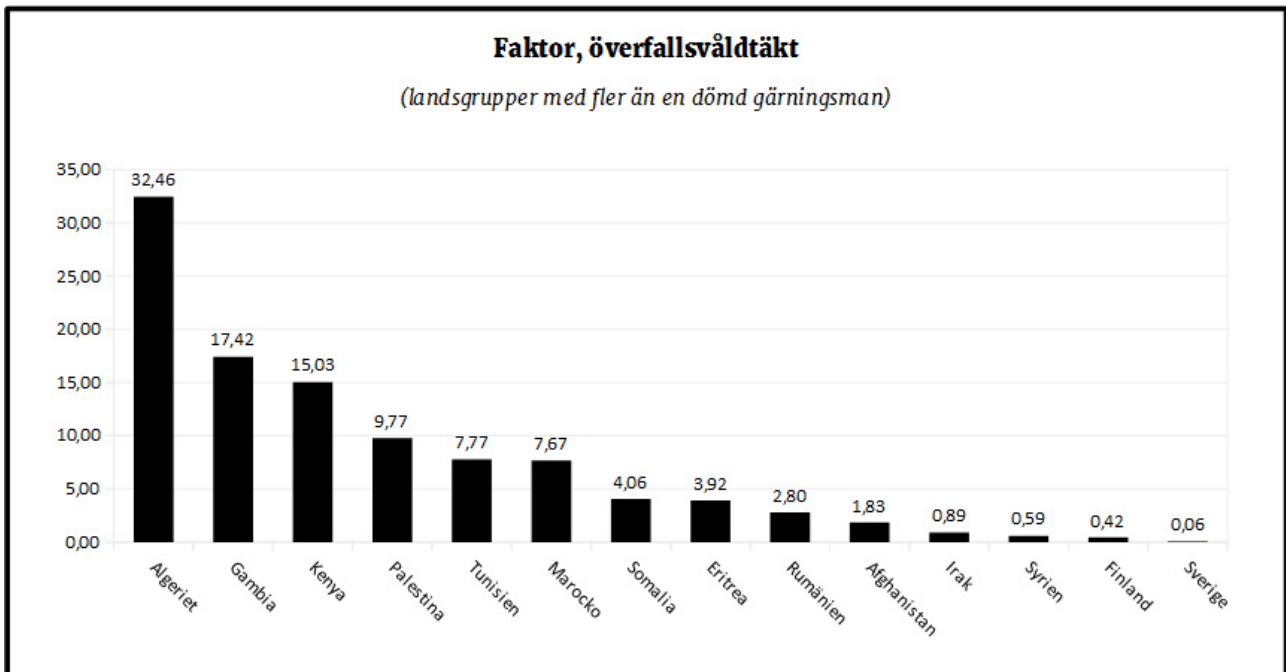

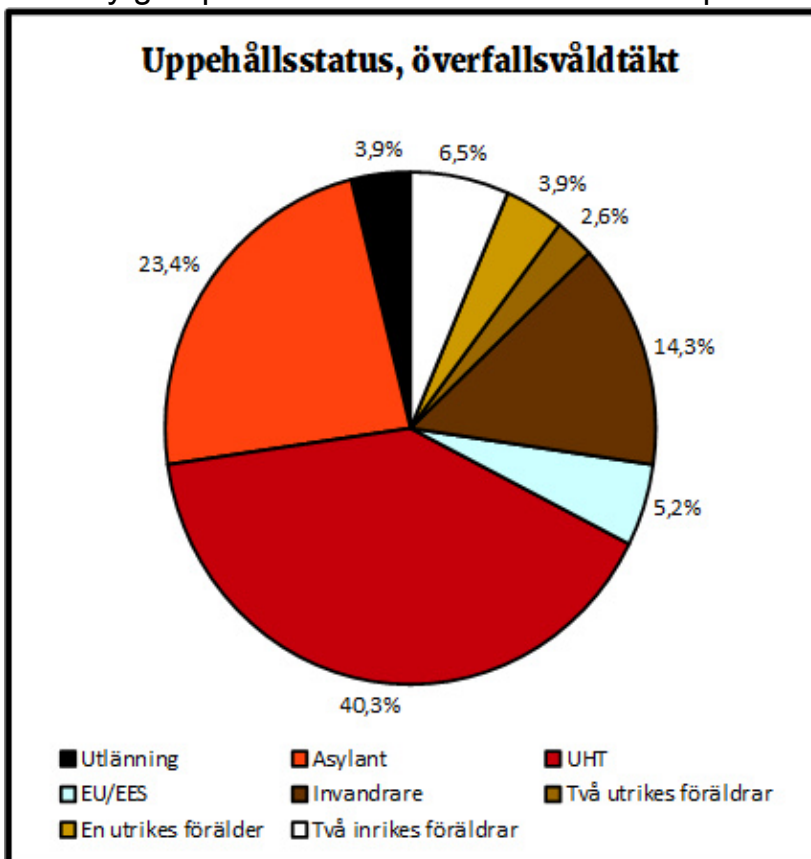
Country groups factor for rapes

It is unimaginable 541 times more likely that an Algerian man commits assault rape than a Swedish one. At the same time, it is clear based on the factor that this is the most unusual type of rape Swedish men convicted of.

All country teams got a place in the chart, so a separate table was not needed.

Nearly two-thirds of deeds istrator convicted of assault rape, 63.7%, is seeking asylum or have a residence permit. Just over one in four,

27.3% are Swedish citizens most of whom either have immigrated themselves or have one or two parents who made it. Detailed figures can be seen in the chart to the left.

The table below shows the proportion of the assault to the total number of rape convictions for each court areas. More than one in four rapist sentenced by the Stockholm District Court has thus assaulting a foreign victim. Hudiksvall (Gävleborgs) ends up not long afterwards, then follow Eskilstuna (Södermanland) in third place.

So it is possible to observe that living outside metropolitan areas are not a guarantee to prevent rapes, but judging by the statistics are some areas safer than others from that particular regard.

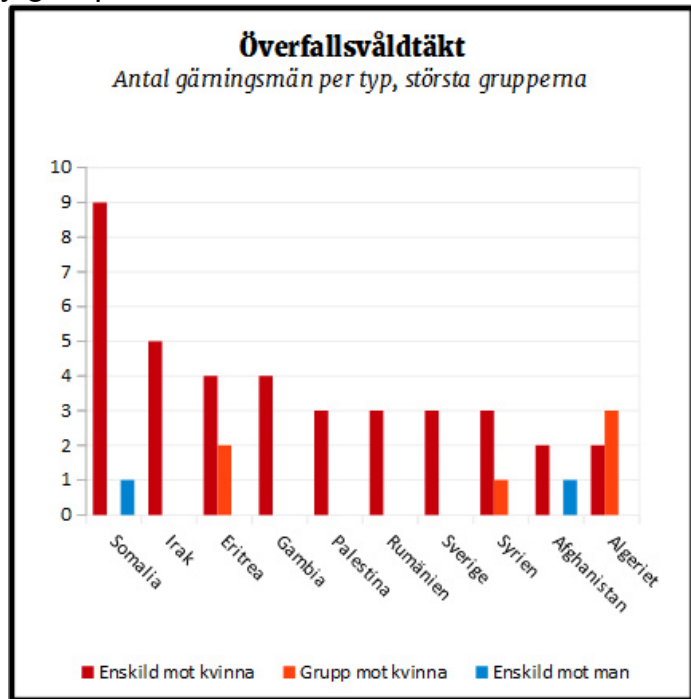

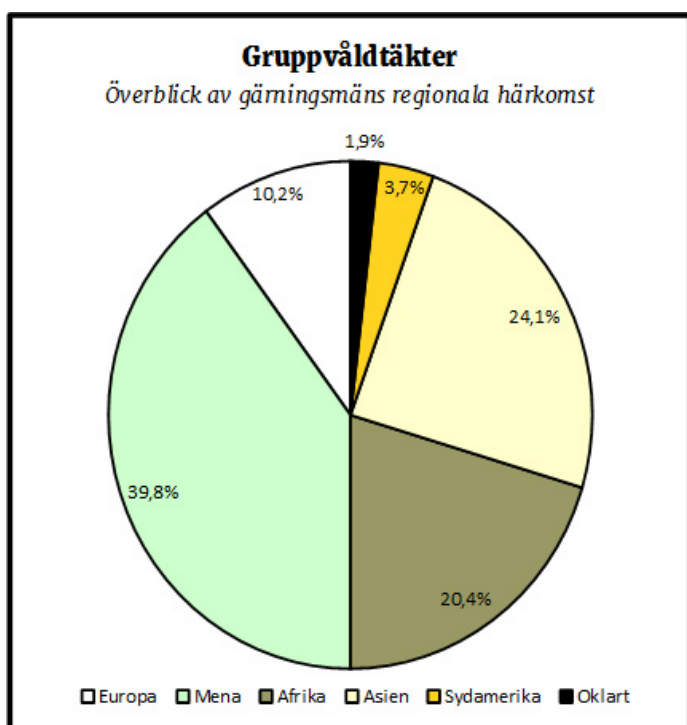

The diagram to the left gives a regional overview of rapists convicted of raping in groups. It shows that 40% committed by men with origins in the Middle East, one-fifth of African men and a quarter of men with origins in Asia. Asians in this case is synonymous with Afghans. Some perpetrators are men Bolivian and Colombian descent, while some additional com- more from the unknown land.

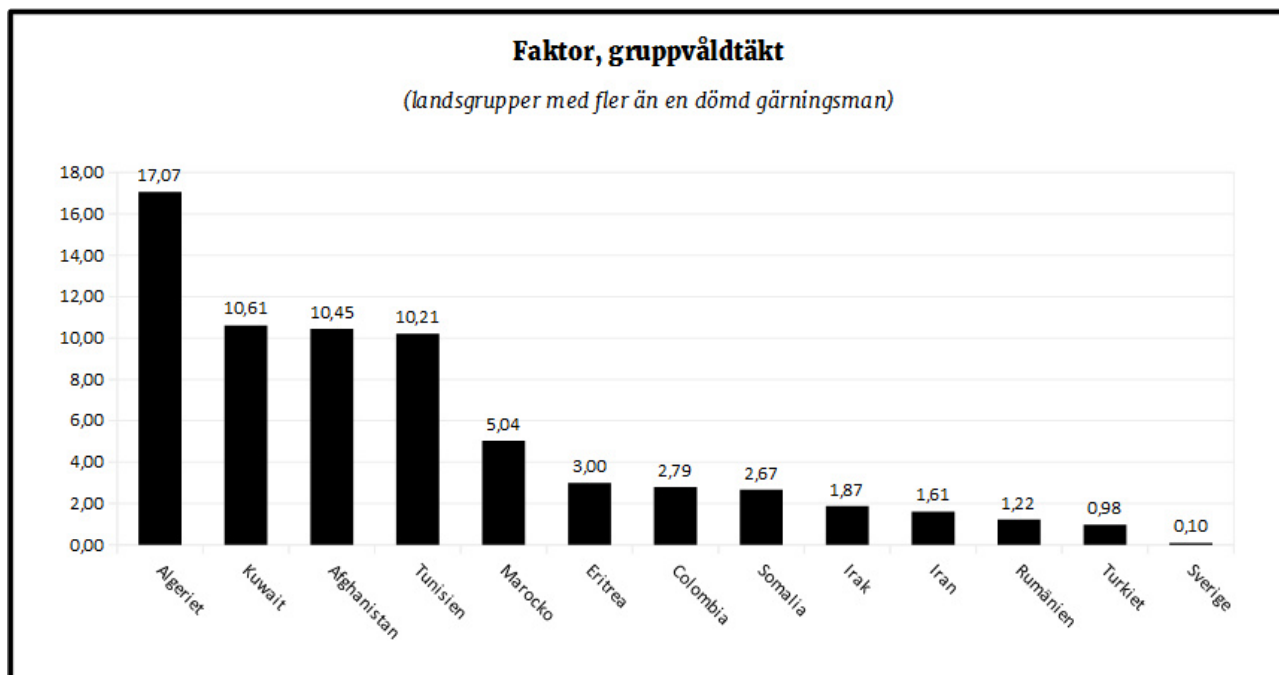
"Of the people who were suspected of gang rapes during the 1990s, 58 percent of Swedes, 32 percent of immigrants (born abroad and registered in Sweden) and 10 percent of people who were not registered in Sweden. The Swedish people na had a quarter of immigrant background (at least parent born abroad). "

BRÅ report focuses on crimes reported, not convictions in this investigation. According to the survey's definition of Swedish men as those born in Sweden with two native-born parents were committed ie 43.5% of gruppvåldtäkter 90s of Swedish men against 6.7% during 2012-2017.

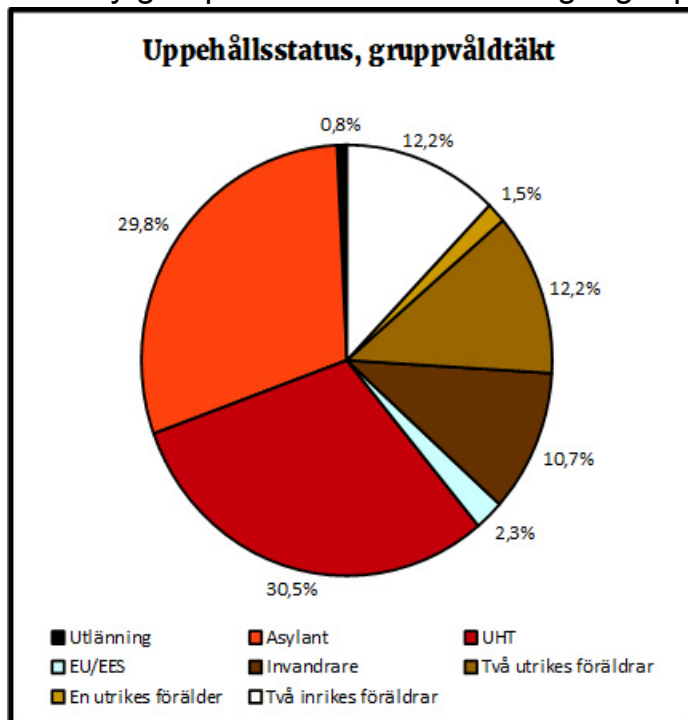
Country groups factor for gang rape

Like the previous chapter also topped the list of highest factor of Algerians. It is 60% higher risk of Algerian group rapes over the next three groups. The difference between swedes and algerier is astronomical 16,970%. It almost gives the impression that the Afghans have a modest factor of more than ten thousand percent better than Swedish men.

Many Arabs both born and lives in Kuwait as guest workers. It is unknown how many convicted belong to the indigenous population in the oil-rich gulfstaten, antagningsvis relatively few when compared to other Muslim in the countries whose citizens do not have occurred at all in the survey.

Over 60% of offenders convicted of gang rape are seeking asylum or have a residence permit. One third are Swedish citizens; Out of them, two-thirds are either themselves immigrants or have parents who made it. Detailed's figures shown in the pajdiagrammet.

There is a marked difference compared with the corresponding figures for the rapes. For one thing, the all-Swedish group twice as big, and performed many gang rapes of Swedish citizens compared to the previous type. The table below shows the proportion of rapists acting in groups to the total number of rape convictions for each court areas. Ystad peaks unchallenged this list, followed somewhat unexpectedly Eksjö (Eastern Michigan), before we get into a real metropolitan area of Uppsala. So it is possible to observe that living outside metropolitan areas are not a guarantee of avoiding gang rape, but judging by the statistics are some areas safer than others from that particular regard.

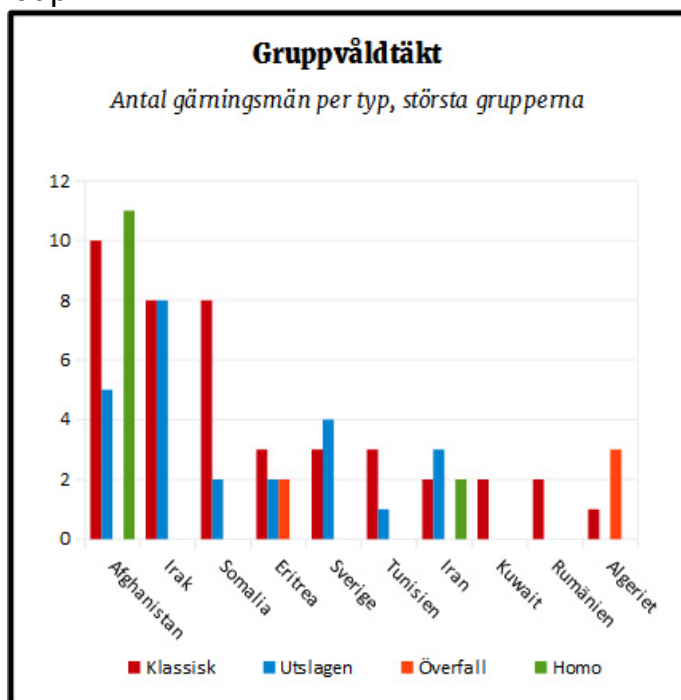

Afghans are unchallenged leadership that group of countries with the most doomed gruppvåldtäkts- male - 85 convicted is 26 Afghans. Iraqis, however, has been convicted of anything more gang rapes where the victim is a woman.

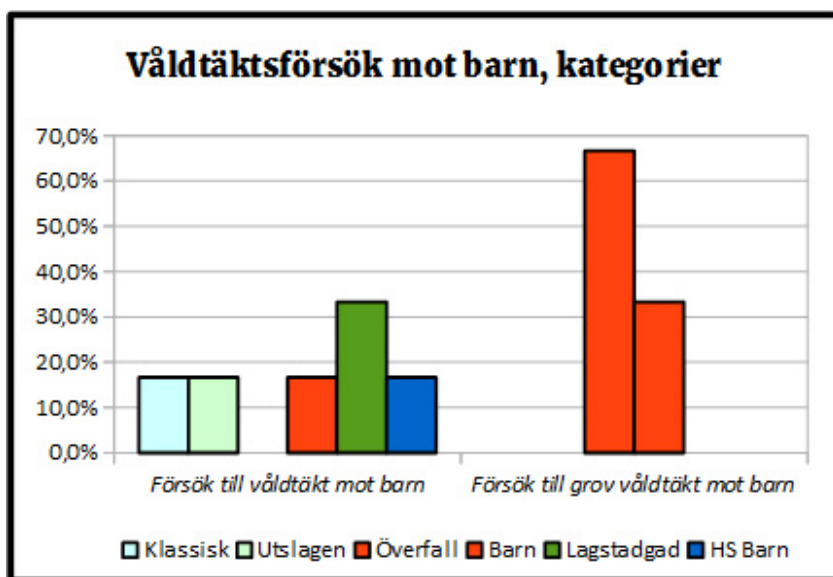
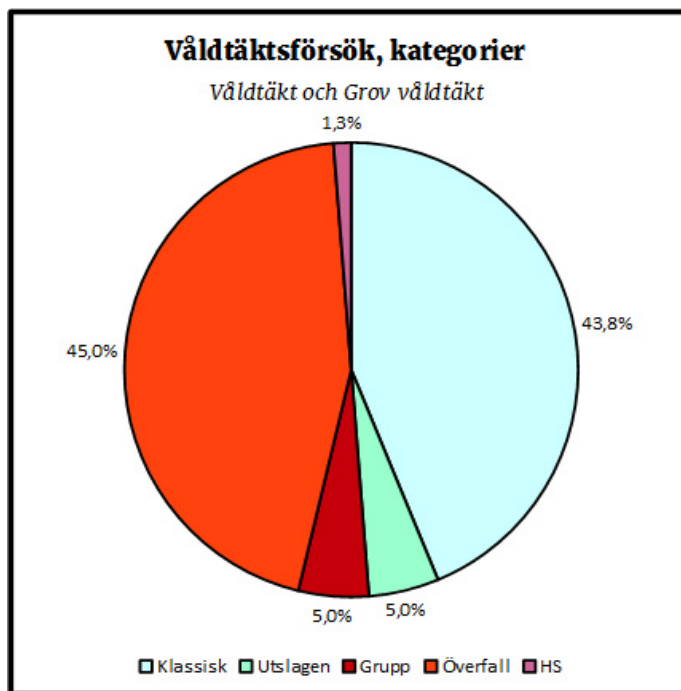

Attempted rape

Around half of attempted rape against adults, assaults against women of foreign offenders, which in these cases successfully averted before the rape is completed. It belongs to the circumstances of offenders who fall victim outdoors have a higher chance of being stopped by witnesses.

The second half of scarce rape attempt targeting a stroke victim, whether it is alcohol, sleeping or other causes.

There is also a relatively small part AN offenders who participated in the gang rape but deemed not fully participated in the rape and therefore convicted of attempted crime.

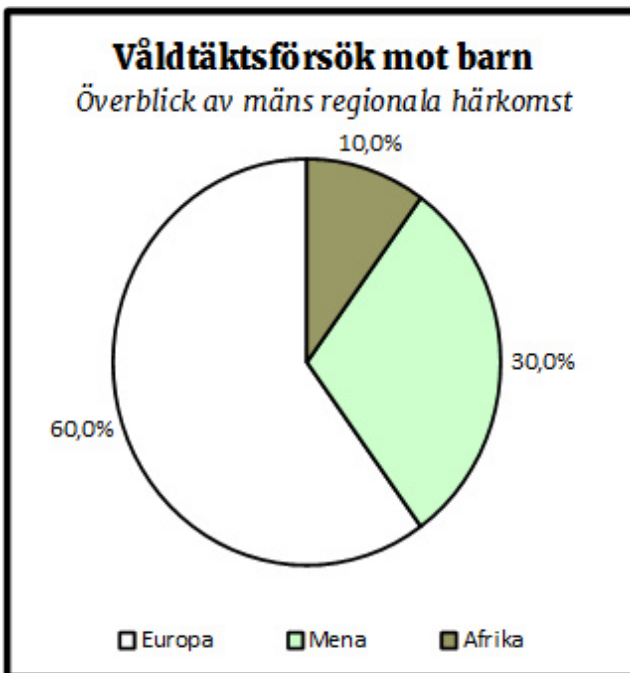
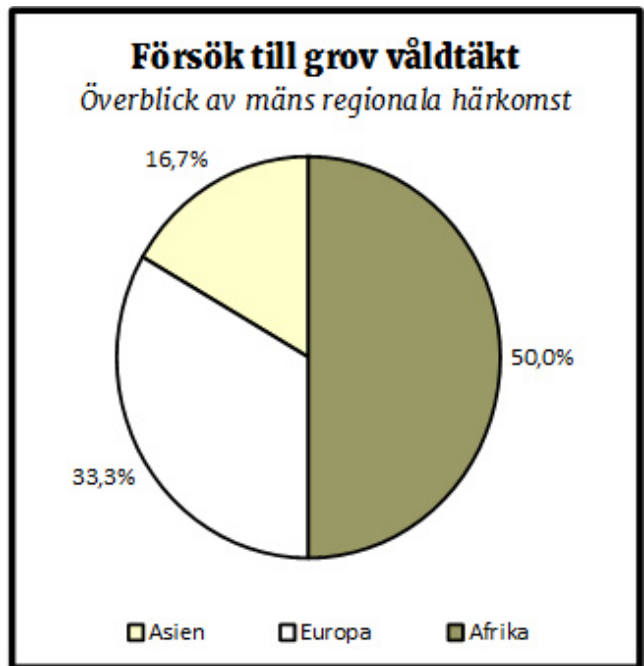
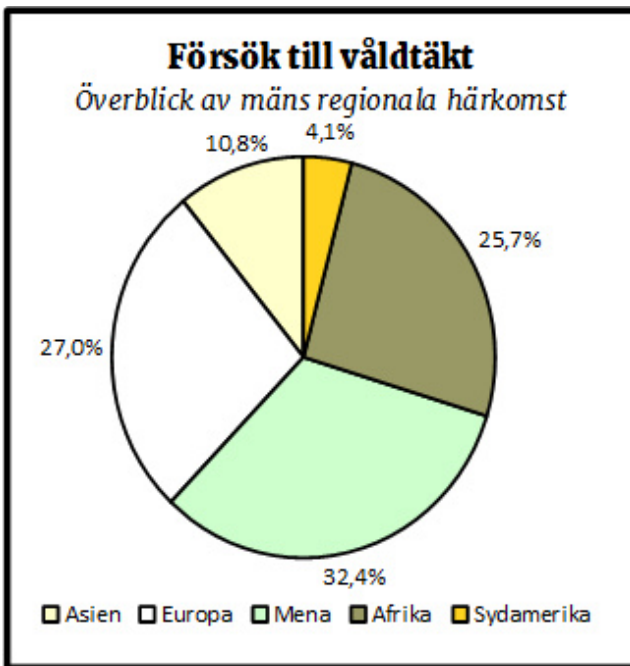

Expulsion as part of våldtäktsförsöksdom

Prosecutor seeks not expulsion in almost half the cases concerning the attempted rape of the normal rate, even though the accused is not a Swedish citizen.

The culprits expelled in more than every three cases (36%), but with only five to ten years. Then they can return and seek asylum again, according to current regulations.

There are two serious attempts crimes committed by foreign nationals. Deportation claim was rejected in one case but granted in the second decade.



A night out in Multicultural Sweden, August 4 2015. Sandra and her friends Sammy and Tobias had been at the pub. On the way home through the city park, they met an Afghan who wanted to treat them to spirits. They ignored him. Tobias sat in his car while Sandra peed behind a hedge. When Sammy saw the man from the past.

Soon after slamming the man to Sammy in the head with a liquor bottle so he falls down. Sandra starts screaming but soon got yourself a blow in the back of the head. Afghan lay then on her and tried to rape her.

During the trial, the prosecutor insisted on the penalty, which was rejected by the law because they saw AN Afghan had strong links to Swedish society.

The most common straffer for those convicted of attempted rape is one year in prison, then penalty of up to two years. Mean sentence is 1 year 3½ months. Some cases have also been sentenced to three years, which is also the most common punishment for serious rubric.

The average value of the penalty for attempted rape is two years 6½ months. (Closed juvenile were not counted in the averages.)

Coarse attempted rape against children which resulted in the prison consisted of three judgments that advance shared out according to the chart below.

After a nice night on the town with friends during the holiday season in 2015 walked the woman in the early morning home alone through Stockholm. The comrades had traditionally partied at several venues in the city. Suddenly she felt someone pulled the jack collar from behind, soon after she was punched in the head that was so hard that she fell down. Lying on her stomach, she was flooded by more punches to the head. Death Fear grabbed her before she lost consciousness. When she came round, she lay still on the ground in the middle of winter, the panties were on their knees and purse away.

The technical investigation led to a man from Uganda and stated that African had ejaculated in violence before the rape even started. Rodney Court of Appeal sentenced to five years in prison for attempted rape and robbery. The African had been given citizenship in 2002 and could not be expelled.

There were no more party nights on the town for the woman. Panic attacks came limiting both her freedom of movement and social interaction.

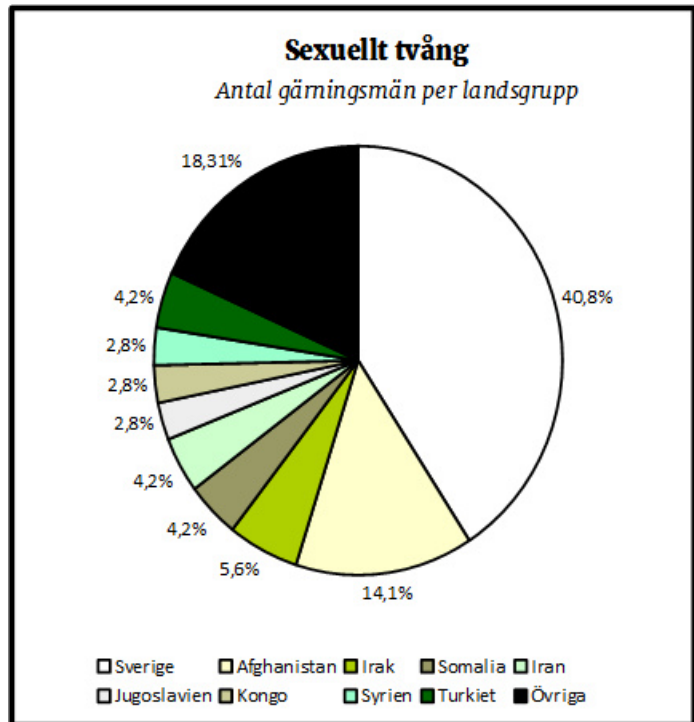

The National Agency for Family and parenting support (MfoF) has supported the survey with statistics on how many children adopted to Sweden. Agency statistics were not disaggregated by sex, but a simple half is estimated to come close to how many adoptees who probably were boys. (SCB for detailed statistics, but only from 2000 onwards.)

The statistics, however, was divided annually, so it was possible to set a breakpoint in the past year, offenders born occurring in crime statistics as the basis for the survey. In other words, I did not take the adoptees born in 2002 or later because they do not appear among the doomed. The groups that were included are those with the most convicted perpetrator men who are adopted.

Children adopted to Sweden counted as foreign born in the SCB statistics. The table below shows both the proportion of the male population for each country group's adopted, and the proportion of convicted offenders from a certain group are adopted. *Example: 8.2% of Bolivian men living in Sweden were adopted by Swedish parents. 16 men with Bolivian descent have in this survey been convicted of sexual offenses. Of these 16 bolivians convicted of sexual was two adopted, which corresponds to 12.5%.*

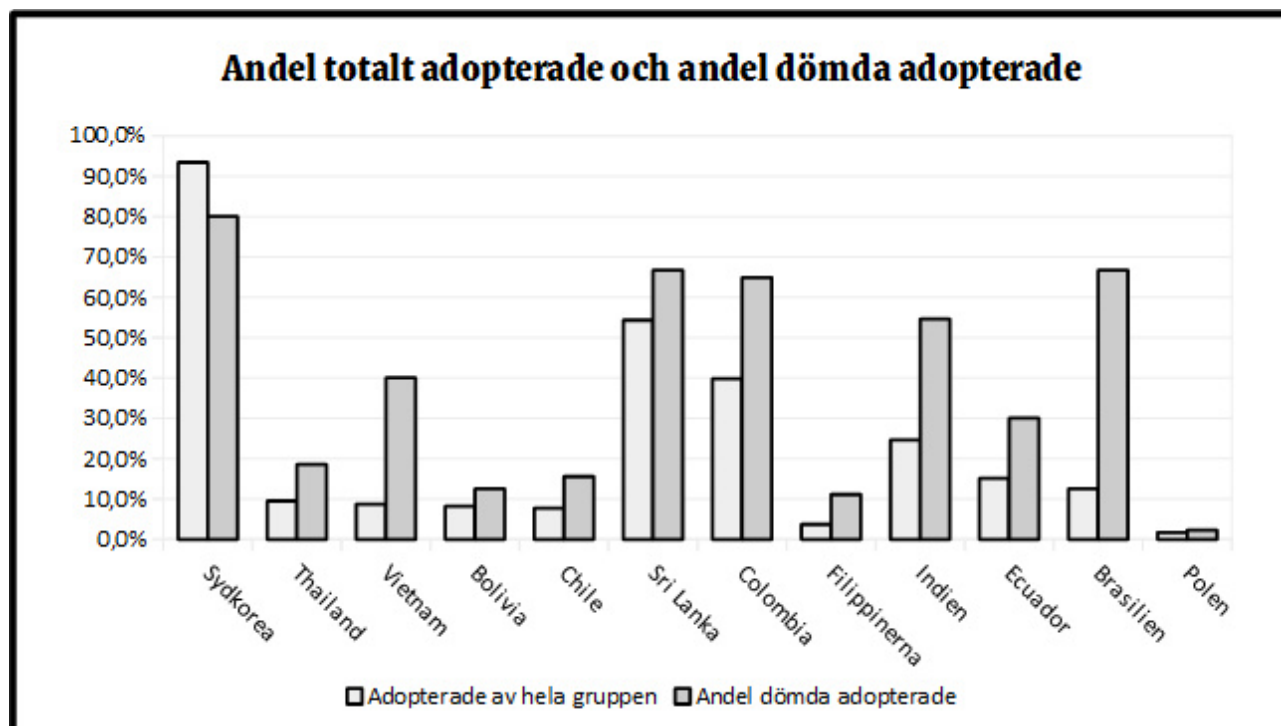

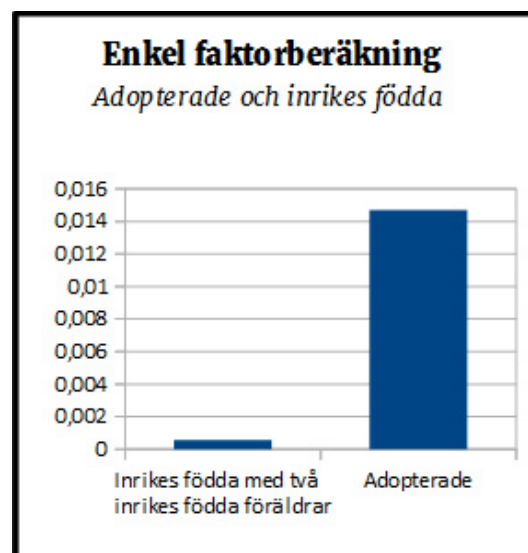

The study thus shows the surprising conclusion that adoptees offenders commit sex crimes to a greater extent than non-adopted men from the same group of countries. This relationship holds for almost all country groups, whether the men were born in Vietnam, Chile, Poland or any other country. The only exception is South Korea. The differences are clearly visible in the diagram, which illustrates the percentages from the table.



In 2002 lived 3,765,938 men with two native-born parents in Sweden, according to Statistics Sweden. 2150 convicted sex crimes in this study have been described preceded by men from the group, which is a little more than half. At the same time 15,579 men until 2001 adopted from the countries mentioned above; 229 sex crimes committed by adopted men from those countries.

A simplified factor calculation thus provides that it is 25 times more likely to be adopted men convicted of sex crimes than native-born men with two native-born parents.

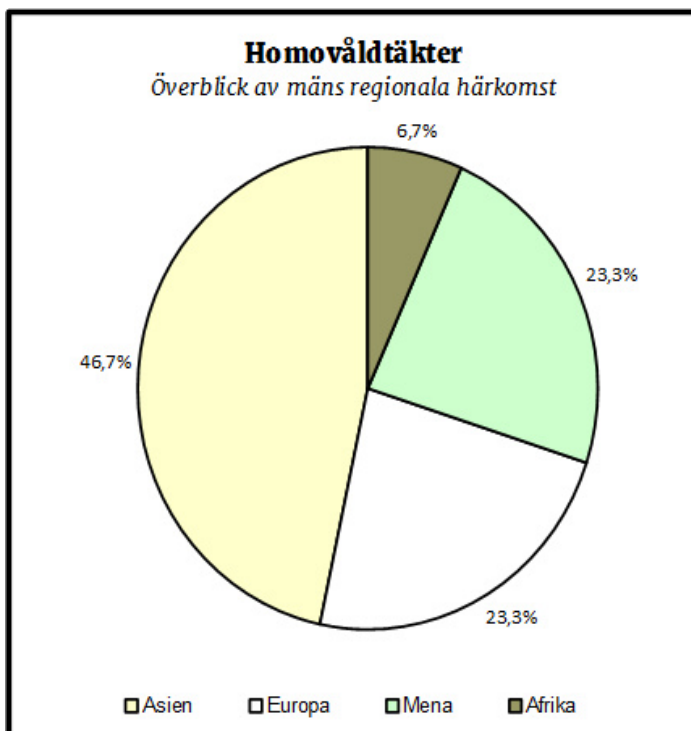

The regional overview shows that men of Asian descent have committed half of homosexual rape in recent years. Asian descent in this respect is synonymous with the Afghans, who are the only group of countries from the region appeared in lesbian rape.

Remarkably, the other way is that no men with South American here- komst convicted for this category of rape. Although Africans have a low frequency

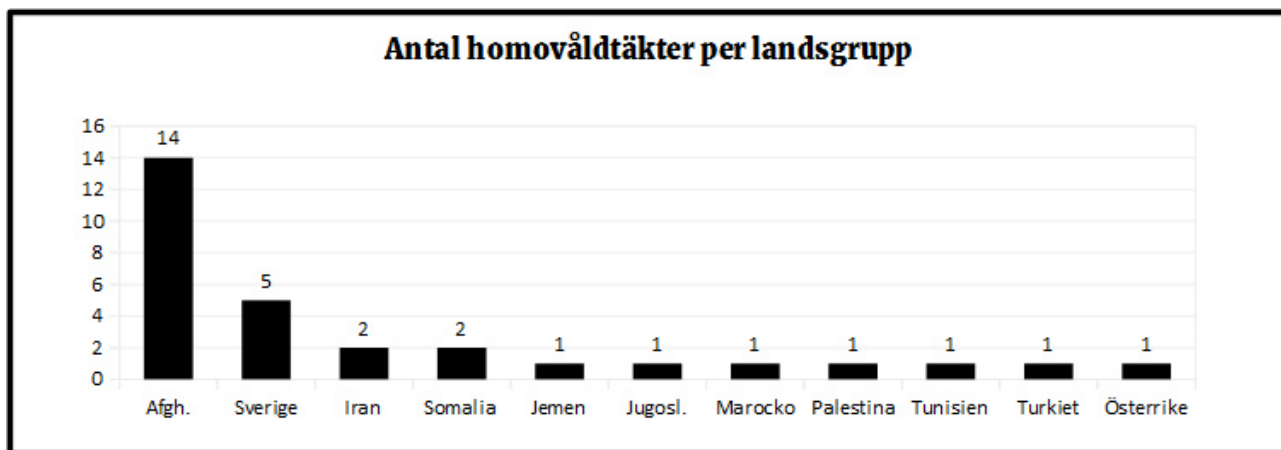

Put simply, it said Afghans commit half of homosexual rape while Arabs and Europeans committing a quarter.

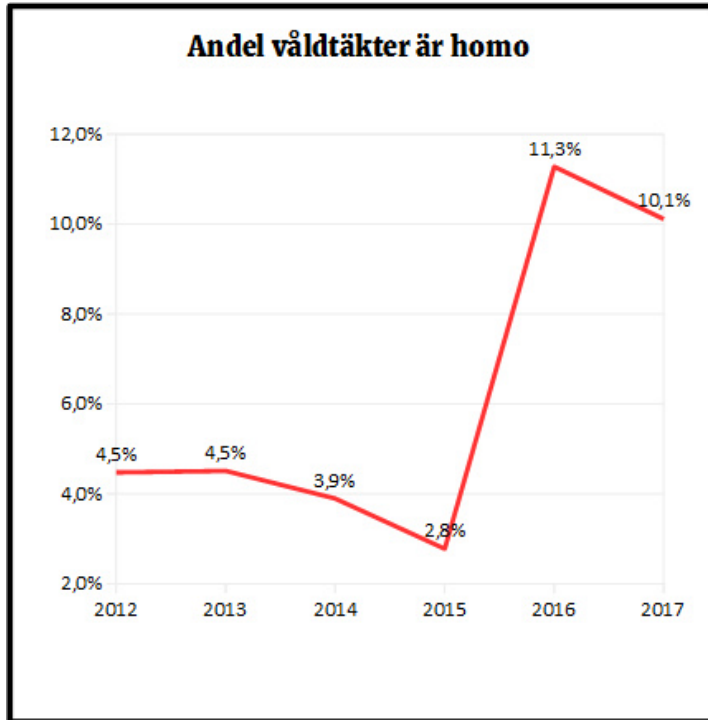


Country groups' share of homosexual rape

Homovåldtäkters share over time



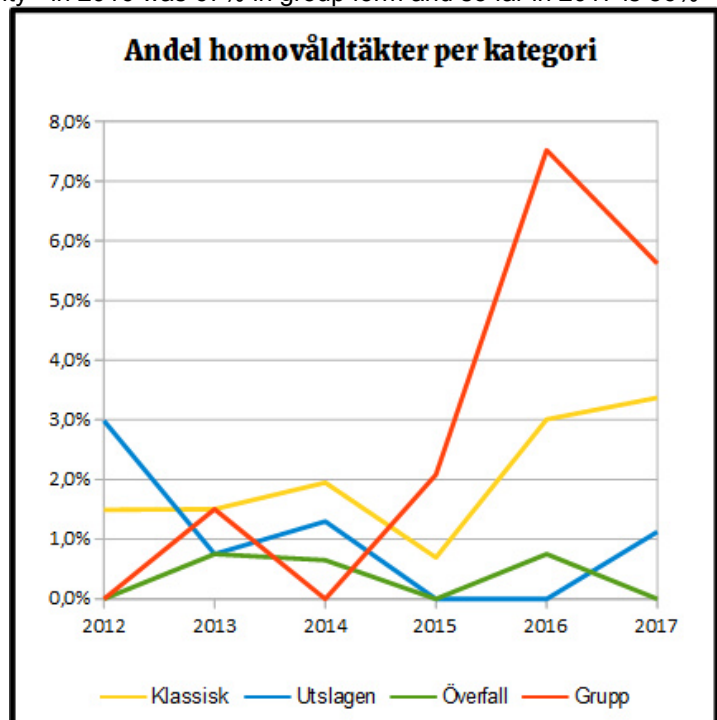

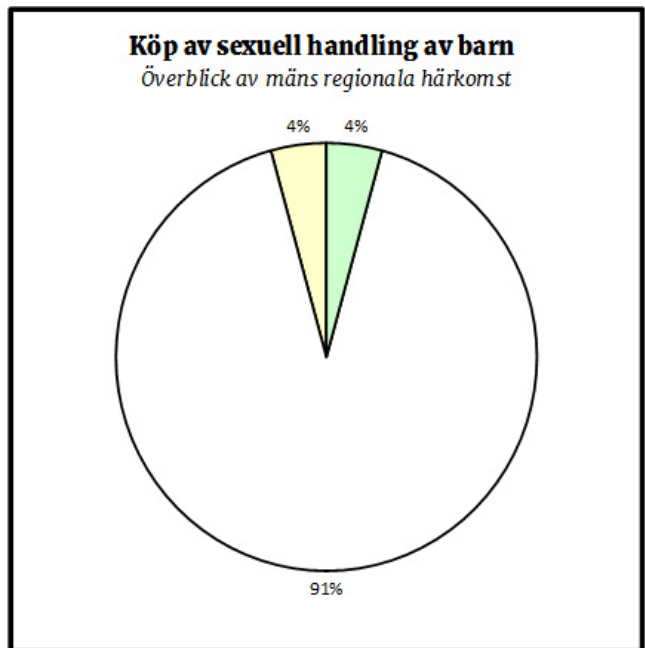
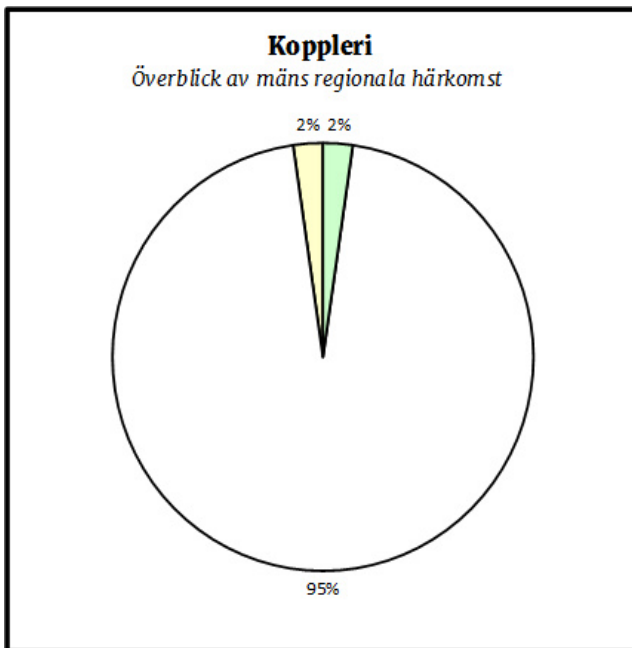

Prostitution

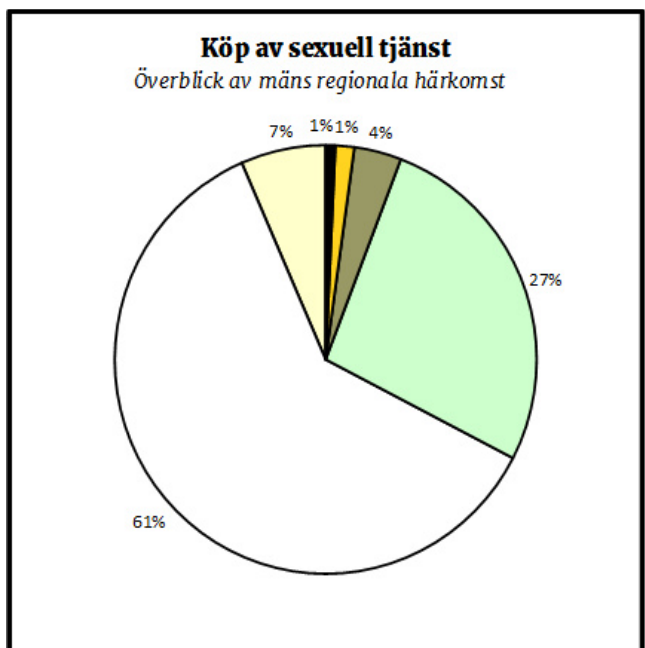

Broken down by country, 57% of men convicted of pimping offenses in recent years, Romanians, while they represent only 0.72% of those convicted of buying sexual services. Although then 95% of pandering crimes committed by Europeans are Swedish men for only a quarter.

Judges for the purchase of sexual services is spread across many countries and groups suggest that the crime is a widespread phenomenon. The preponderance of Iraqi men, the number of individuals, however out of the statistics.

For similar offenses against younger prostitutes, purchase of sexual acts from children, is the representation of the Swedes out of the statistics. Children in this context means people between 15 and 18 years. Since the sexual authority in Sweden starting at 15 years and in the case of voluntary action, it is thus the actual payment is illegal.

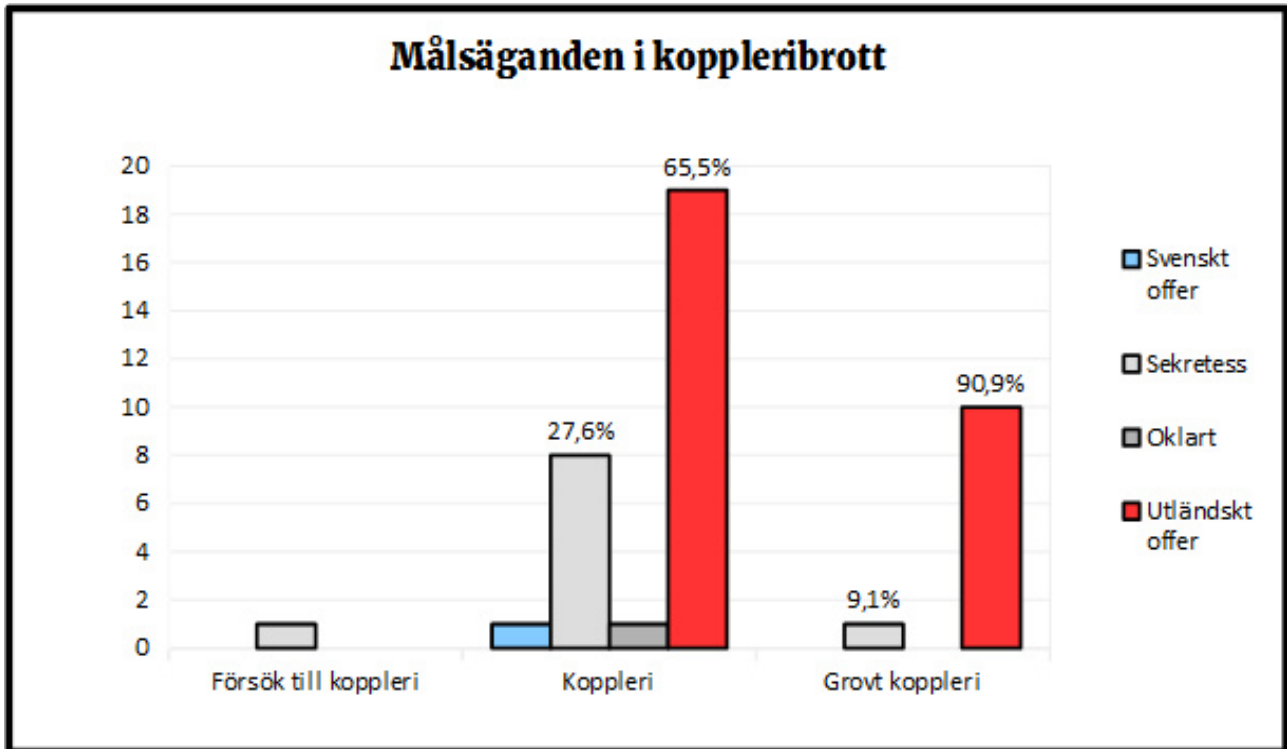

The plaintiff in procuring

Pimping is one of the few sexual offenses where the plaintiff's identity as a rule, are not subject to confidentiality, which allows the study of the victims. I have respect for the victims not dug very deep, but the categorization is based on the names and circumstances mentioned in each sentence.

There are plaintiffs in 41 of 44 procuring and their wide ranging descent distributed as the chart below.



91% of the victims of judgments gross procuring is foreign, and almost two thirds of victims in procuring of the normal rate.

The statistics reflect a common practice among mainly Romanian men to travel here already with women prostitutes from their homeland to sell sex. The men arrange accommodation, manages the contact with customers and posting ads on escort sites. However, it is also frequent that women from the men's home country lured here under the pretense that they will work with the cleaning and the like, but well ahead, they become deprived of his passport and set the switch's control.

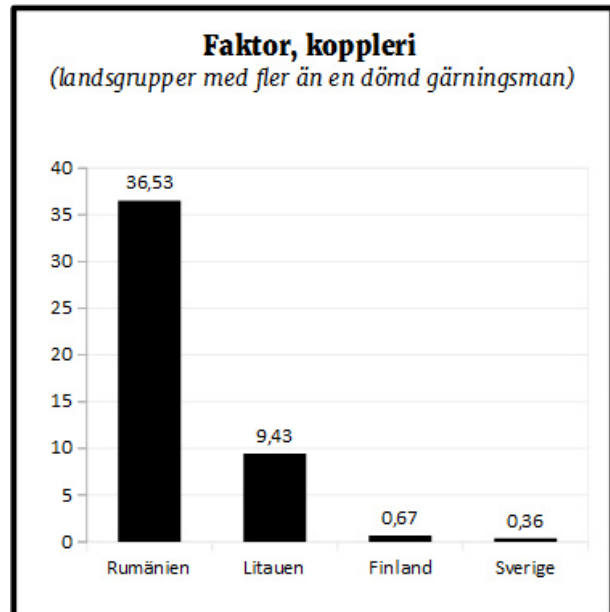
As stated in the country, the statistics are far from anyone convicted of procuring Romanians but similar approach has also been used by other groups of countries.

Country groups factor for prostitution offenses

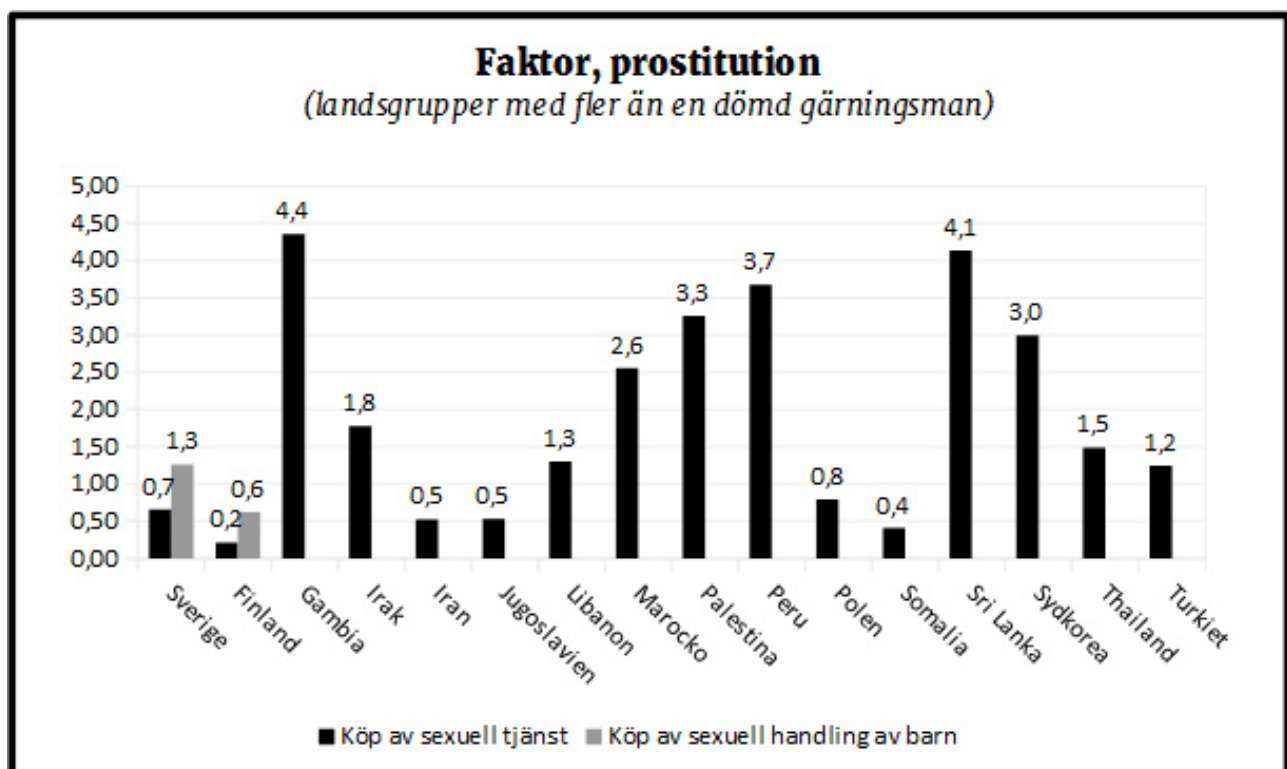
Through what appears to be organized and systematic prostitution brought here by the Romanian women have also Romanian male one inconceivably high factor of 36.53 for procuring. In other words, over a hundred times more likely to be a Romanian man sentenced for procuring than Swedish.

Although Lithuanian men have a high factor of what it seems, the same causes but to a much smaller scale than organized Romanian prostitution.

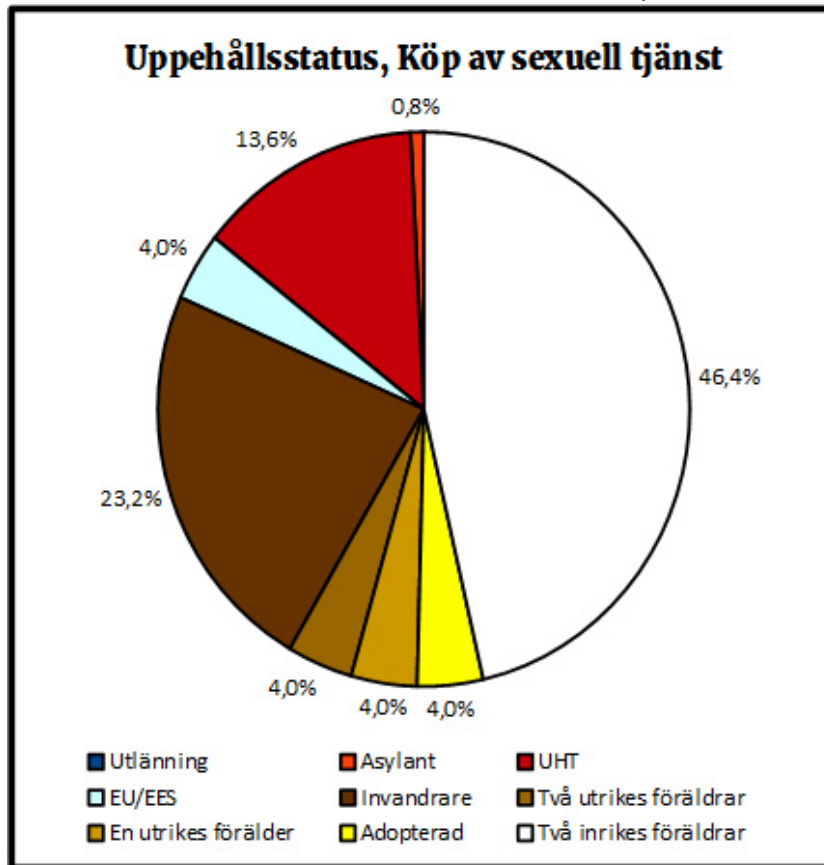
Swedish men, on the other hand, a maximum factor of the offense purchase of sexual acts from children. Those most likely to buy sexual services by adults is in turn Gambians, Sri Lankans and peruvianer. This crime, however, is distributed relatively evenly across many



groups of countries and the biggest reason for the speech, the male population size - Iraqis thus has a relatively low factor, even though they are the largest group of buyers of sex second only Swedish men, in terms of individuals.



The residence status of offenders convicted of sex purchases



Every other sex buyers is Swedish, which is not surprising given the statistics that have already been reported. More surprising is that every seventh man sentenced for purchase of sexual services is asylant or have been given residence permits and therefore in most cases, their livelihood from the Migration Board.

A third of the sex buyers are immigrants in the first or second generation.

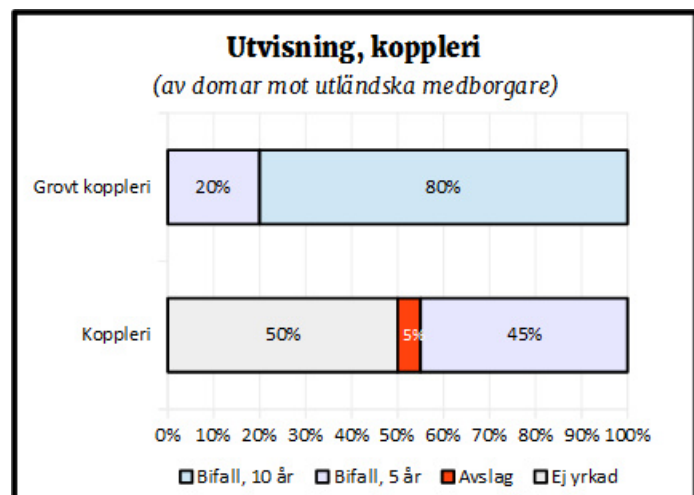
The residence status of the other two classification are, procuring and purchase of sexual acts from children, is irrelevant when most crimes in the categories committed by Swedes and other EU medborgare whose status is evident by their country group.

Expulsion as part of koppleridom

Procuring a particularly high frequency of both requested and granted the expulsion part of the sentence. 45% of foreign nationals convicted of the normal degree of procuring expelled - for the coarse rubric- ring it all. There are several reasons for this, one is that most convicted foreigners are EU nationals and there are no impediments to enforcement of deportation connections to those countries.

No requests for deportation have been made for any of buying sex crimes, which is probably due to the Prosecutor from the outset sought only fines and

which does not include the possibility to claim deportation. The statistics for expulsions are otherwise only offenders who lack Swedish citizenship.



Penalties for prostitution offenses

The most common penalty for procuring of the normal degree is a six month prison with relatively even spread both over and under the other prison. Those who are sentenced to prison for procuring sheep averaging just under nine (8.83) months imprisonment, to divulge the length of the penalty, split by offenders who are sentenced to prison.

Most convicted of Aggravated procuring gets two years in prison, which is the minimum punishment for this category. The mean prison sentences is just under 2 years 2 months (2.18).

Courts can sentence up to eight years in prison for serious crime, but the penalty values will not be in the vicinity of the upper layer. You can ask what would be required to courts would impose penalties on the scale that legislators made available.

Offenders who buy sexual services of young people sentenced in most cases to probation, corrective, but prison sentences occur and then in an even spread of penalties. Those who are sentenced to prison for the purchase of sexual acts from children get averaged nearly five months (4.75), while those convicted of attempted crime will have three and a half months. Counting together rubric cars will average about 4 months 1 week (4.3).

No convicted of buying sexual services of adults in this study have been sentenced to prison. The penalty can be statistically rounded to only a fine.

The survey detailed study sexual assault, rape and child rape because these crimes, in that order, are the most common judges. The majority of sex crimes convictions have any of the three specific classification area. Coarse rape crimes are uncommon, but are included because they are relevant to the rape of the normal rate. It makes both crimes interesting in themselves and also lend themselves to deeper statistics. There are other relatively common sexual crimes that may be of interest to mention.

Less rape

Some rape is considered less serious. The study includes 40 judgments under the rubric, compared with 616 judgments grouped under the normal degree. The penalty will VAN course, one year in prison over two years for the rape of the normal rate. This often involves brief chain of events and / or abuse

occurred when the victim put to sleep. Rubric is sometimes used in the crime convicted, but often it is mentioned only in the grounds that the offense is considered less serious.

Both Europeans regional group and particularly Swedish country group as judged more often for the less serious form of rape compared with coarser rubriceringar. Swedish men, which constitutes 69.23% of the male population does not reach up to the same representation for this form of rape, either.

Of the 761 total rape judges, both less coarse, normal degree of rough, they are less serious rapes only 5.3%, and would have very little impact on the statistics of the coarser classification area.

Child pornography offenses

Europeans share of convicted of child pornography offenses is near or even slightly above the percentage of the population, which is 90.1%. Swedes country group is above its share of the male population, which is 69.23%. For these crimes, therefore, there is an over-representation of Europeans and especially the Swedes.

Table of country groups counting only groups with more than one person convicted. The three classification were for child pornography offenses - small, normal grade and coarse - are counted in the tables.

Exploitation of children for sexual posing

The offense usually takes place by offenders capable young victims to pose for pictures as they then send, or directly in webcam. Sometimes posing pictures or movies created in the physical presence, but then "trumfas" crime usually of felonies in the survey.

Nearly four out of five convicted offenders are Swedes with Swedish-born parents, which, like child pornography offenses gives an over-representation in relation to the male population size.

It is possible to speculate on the causes of Swedes over-represented in these crime rubriceringar. One can see a correlation that Swedish men increasingly passive commit sexual offenses. The definition of passive differs obviously from crime to crime, but the general impression is, for example, that Swedish men increasingly capable young victims pose via the internet while abroad increasingly committing physical rape of the same type of victim.

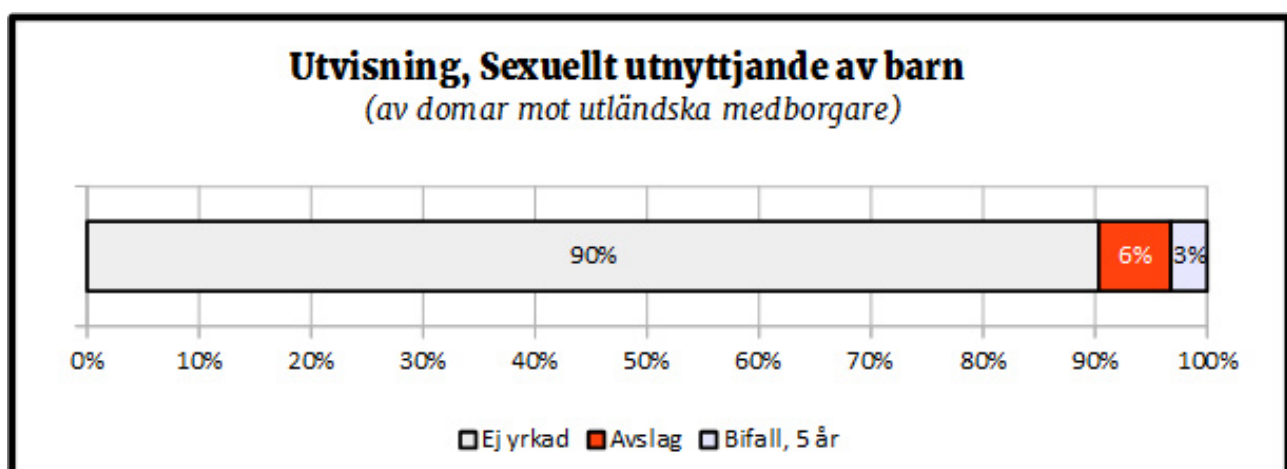
Prosecutors have not claimed the penalty under any circumstances for the three classification are attempts, normal and rough committed by foreign nationals.

Sexual exploitation of children

Like the rubric Rape is a *less rough* variant Rape of a child the like of the variant called the sexual exploitation of children. Courts judges sometimes under this rubric when the age difference between the perpetrator and the victim is minor and the sexual acts are voluntary. Swedish male reaches almost up to their share of the population, therefore against the Europeans as a whole is under-represented compared with other regions.

Only 3% of judgments result in expulsion. In nine out of ten cases against foreigners seeks prosecution even deportation if convicted.



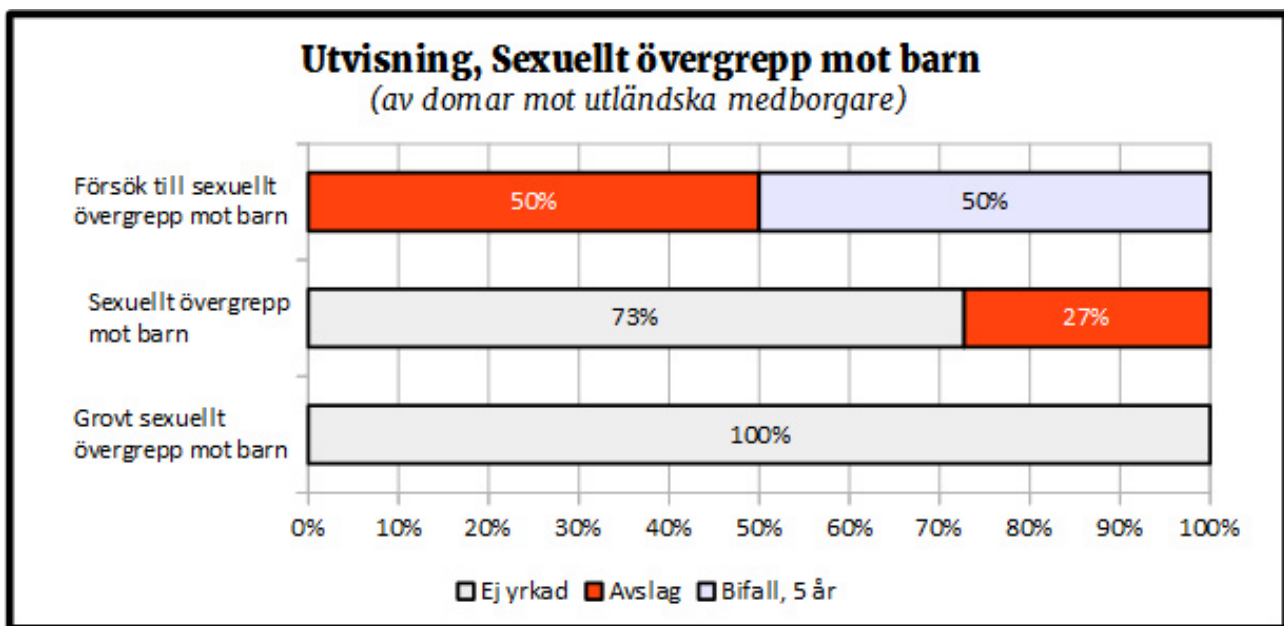
Sexual abuse of children

This classification can be said to be between sexual ofredan- and the Rape of a child. With a total of 179 judgments, including attempts offenses and serious crime, it is less common than the total of 529 judges for the categorization are Rape of a child. It is rare that a prosecutor seeks deportation of foreigners convicted of this crime, and in only one case of attempted crimes, have been given expulsion acclaim.

about the survey

The survey is based on the conviction District Court convictions for sexual offenses issued between 2012 and 2017. The guilty verdicts have been discarded. I have also sorted out judgments where the offense was reclassified as not being sexual crimes, such as sexual molestation convicted of molestation, except for some isolated cases that still have sexual imprinting. The case has thus understood the debt issue but the court changed the rubric of offender convicted of what the prosecution originally requested.

Courts cull criminal convictions after five years, which means they can not take part in digital. Therefore, the examination generally only judgments of the other half of 2012. While lacking judgments of the last quarter of 2017 because the survey was done before then.

The study includes 100% of all sexual judgments from 40 of 46 dishes thing during the time period. No data are available for Haparanda and Norrtälje District Court because they refused to cooperate. The few convictions are from the courts is derived almost exclusively from the courts of appeal. Judgments of the four other things dishes are represented in varying degrees, according to the following summary; rape convictions in this context means all variants of the rubric, such as the attempt, rough, less coarse and against children.

Courts of Appeal

When more current information was available from the Court of Appeal judgments, the judgments given preference. It happens that the appeal courts change an acquittal, and then I sorted them out. Data were deleted for individual offenders acquitted in the Court of Appeal in the judgment with more than one perpetrator. It is common for a suspect acquitted in both the District Court and Court of Appeal and then was no judgment whatsoever.

Courts of appeal have shown different degrees of cooperation; Svea, Gota and Northern Norrland has been very instrumental, Skåne and Blekinge somewhere in the middle, while Norrland and Västra barely wanted to cooperate at all.

Issues and challenges

District courts have so-called target list where all the trials noted. The first step was to get to sent me such lists from the respective district court. Courts lacks a coherent policy for this. Both the spirit of cooperation and expertise to develop a reliable list varies from court to court. Sometimes there is not even a uniform policy in the same district court, but they give different answers depending on who is responsible. Some things dishes deselect columns with reference to the Data Act other things dishes sends all the columns. Some just sends lists in PDF format, while others broadcast in Excel, which is easier to handle; I developed some expertise in the conversion of PDF tables to Excel, which undoubtedly was an interesting challenge.

By district arbitrary handling of målförteckningar provides a measure of uncertainty, so when I state that the study has 100% of sexual offense convictions from 40 of the 46 district courts, it means 100% of the judgments I am aware of. Goals that may not been in målförteckningar was invisible to me. A recurring problem has just been to some district courts sent målförteckningar where judgments clearly lacking. I realized that because I sometimes asked for a collection of sex crimes convictions court its choice chronologically, and then been able to compare with målförteckningar and is satisfied that the missing. District courts have been unable to provide any justification for the missing target numbers and because I myself am not familiar with how their målförteckningssystem work, I have also no explanation.

A further problem is that målförteckningar often lists only the most serious offense, followed by the abbreviation "mm" to indicate the indictment contains more rubriceringar. A typical example is the crime of aggravated a woman who often trumps Rape in målförteckningar. I can only take note of a certain number of judgments of each district court free of charge and it has rarely been an opportunity for me to look deeper into the "more". I have taken some steps to alleviate the problem, which is to request target number where it is grouped under "rough kvinnofridskränk- equipment, etc.," and asked the courts to choose sex crimes convictions in chronological order. Unfortunately, the failure of judicial decisions for this reason beyond my control and can not be completely solved. However I do not see that the loss would have no statistical impact one way or the other. I have the impression it is around 10% probability that gross violations of women also contains rough classification and the judges have been included in the survey.

Women convicted of sex crimes can also be said to be a problem in the sense that I'm not sure if they should be included or not. They account for roughly a conviction of 500. They are included in the source data, it presents so few people that it is not meaningful to compile statistics on them.

Discontinued polities

To obtain factor for a group I compare with how many men were born in a particular country live in Sweden, based on data from Statistics Sweden. A statistical problem is that many are born in countries which have since broken up. This is particularly true of Yugoslavia but also Czechoslovakia and the Soviet Union.

My first thought was to distribute eg the 33440 men living in Sweden with the birth of Yugoslavia on the different countries that exist now. SCB informed me, however, that it is impossible to find out how these groups were distributed across the country. The same problem applies to any individual who was born in the brief polity Serbia and Montenegro. Therefore, I simplified the statistics in the case so that all offenders born in countries belonging to the former Yugoslavia are compared with the combined population. This applies regardless of whether the perpetrator had been born in such a country before or after the formation of the state of Yugoslavia broke up.

Furthermore, I imposed a male born in the former Soviet country on Russia group. Finally, I divided up the group born in Czechoslovakia and imposed a half of the Czech Republic and half of Slovakia.

I confess that it is not a perfect solution, but it is the only solution that is available in the absence of deeper statistics on groups born in the state of thought that no longer exists. It is unfortunate because the propensity to commit sex crimes appear to differ drastically tightened specifically different parts of former Yugoslavia.

adoptees

Offenders according to the Tax details have Swedish names, were born abroad but whose parents were born in Sweden can be assumed to be adopted. Adoption Status is otherwise confidential and the Tax Agency does not confirm or deny the task. There are certainly cases where foreign offenders switched to Swedish names, but their parents were not born in Sweden. I compare doomed to statistics from the National Agency for Family and parenting support, MfoF; they do not differentiate between boys and girls, because I halved their figures for the number adopted from the country.

What can be compared?

The study focused on convicted offenders, which can not be directly compared with the number of reported crimes. A rapist can be convicted of two rapes in the same judgment, the other two convicted rapists to the same gang. Sometimes sentenced a tafsare for crimes against multiple victims, sometimes sentenced tafsare several times at separate trials for crimes against individuals. How is the flasher who pulls her sex to a group of women, it is a crime or is it more? I reached early realization that if I had the ambition to map crimes so carefully study had taken an unreasonably long time. This type of study should be made of good, with all the resources and tools belonging to mandate an authority.

All ages given in the survey applies when the judgment was given in court regardless of where the offenses occurred. This is also to avoid unnecessary complexity. Even if there are convictions for crimes committed as far back as the 90th century, so it can be assumed norm is one or at most a few years' delay from the opportunities for crime.

Lagändringars effect on the statistics

Rape law was tightened in 2013 so that the victim no longer needed to be in *helpless* state, but it is enough *particularly vulnerable* situation. This expansion affects the assessment of cases in this study were included in the category rash. Europeans and especially Swedes commit this category of rape to a greater extent than other groups, because one would have expected that the Swedish men's share of convicted rapists would increase over time, but this has not been the case. On the contrary, the proportion has fallen sharply over the past two years.

sentencing

Usually, only the most powerful penalty in the survey, so if an offender is sentenced to one month in prison and probation falls later removed. Sentenced person to probation and various probation saving interventions are counted only probation. It is to simplify the statistical run and that it does not play a very big role compared to the more powerful penalty.

Unusual crime

When the study is trying to cover all sexual crimes, it is natural that some odd crime brings. One example is the Sexual intercourse with an offspring, ie voluntary incest between adults. I have not looked closely at these crimes because they are judged so sporadically that well Constantly little can be said about them. The rare crimes (maximum two convicted cases) are:

Incitement of rape against children / child rape / rape Attempted procuring

Attempts to less aggravated rape

Aggravated sexual abuse of dependent person Complicity in rape against children / child rape / rape complicity in grave procuring Complicity purchase of sexual services Complicity sexual abuse of children Sexual intercourse with descendant

Conclusion

According to the National Crime Prevention Council 6720 reported rapes in 2016. This means that if you put 80 minutes to read this study has managed to be another rape anywhere in Sweden. Only a fraction of reported rapes, an estimated one in twenty, leading up to the trial.

It is partly a question of resources and severe punishment, but largely rape epidemic an imported problem. The parties that made possible the present situation was through BRÅ previous reports fully aware of the dangers of mass immigration from the third world. They thought it was worth the increased suffering of the indigenous people so that they could build their multicultural utopia, the hell that others are now trying to put things right.

As I mentioned in the introduction, I do not claim to be impartial in the matter, but I claim that the source data is correct and that the selection of judgments are fair and as complete as humanly possible.

I assume, however, that the survey will either try to be exceeded to death, or relativized by imagination all available means. Relativists struggling but uphill since the survey only includes convictions where the debt issue is not open to interpretation. Usually study reported crimes and then relativists use imaginative concept of "increased propensity" to meet the facts of the gate. It is so popular imagination the term "murdered kerta" is rarely used after it became widely known how much of the criminal elite minions stand for. Phenomena such as increased propensity and unreported cases are obvious, but

that is characteristic of criminologists is that they use concepts as tools to adjust the statistics for your own taste. This survey is based solely on the facts.

Relativisternas uncrowned king Jerzy Sarnecki took enough price when he was in the Metro in January 2016 tried to argue that foreigners overrepresentation of rape would be due to socioeconomic factors. One may wonder what research is based in reality would show that poverty gives men the desire to rape women. Marxists as Jerzy Sarnecki sees crime as a kind of class struggle and appears motivated by preventing effective solutions rather than reduce crime.

It runs contrary to relativize the other way with a much stronger foundation. How many prosecutors use their power to influence the statistics by setting the bar lower for the prosecution of Swedes than foreigners? It can be both a conscious choice - the front walk of deportation statistics how many prosecutors do not even think foreign rapists to risk expulsion - but also unconsciously, they feel pressure from the top to try to shape the crime statistics as the politically correct image.

Forensic Medicine investigations have shown that around 80% of the so-called ensamkomm- spirit refugee children have lied about his age. There have been many serious consequences for society, one of which is that these men enjoyed heavy penalty discount and avoid deportation if convicted of a crime. After several years of the age of bluffing is a class difference emerged where these are treated with kid gloves while Swedish men of the same age, or for that matter the second generation of immigrants, punished properly under the current legislation. There is a huge legal scandal that age bluffing foreigner can get away with a one-year youth care for rape while a Swedish sentenced to six years in prison for the same crime. It may seem that both should be punished with 20 years in prison, but that's another discussion.
