PPTA ELECTIONS 2021 CANDIDACY FORM

Thank you for your interest in the Philippine Physical Therapy Association (PPTA) ELECTIONS. This year, we shall be electing six (6) and five (5) members of the Board of Officers (BOO), and Board of Directors (BOD), respectively.

Minimum Qualifications for Members of the BOO:

1. Should be a Lifetime Member of the PPTA;
2. Should be a Member of Good Standing* for at least two (2) years prior to nomination with no outstanding record that shall cast doubt on nominee's integrity; and
3. Should be a practicing physical therapist for at least three (3) years prior to nomination.

Minimum Qualifications for Members of the BOD:

1. Should be a Lifetime Member of the PPTA;
2. Should be a member of Good Standing* for at least three (3) years prior to nomination with no outstanding record that shall cast doubt on nominee's integrity;
3. Should be a practicing physical therapist for at least five (5) years prior to nomination; and
4. Must have previously held a position as Officer or Member of the Board of Directors of the Association, or a position of responsibility in any government or private agency involved in the practice of the physical therapy profession.

*The PPTA COMELEC shall determine the Member of Good Standing status based on the criteria set by the PPTA Membership Committee (2012), which states that:

To be a member of good standing, any two (2) of the following criteria should be satisfied:

- i. Two (2) years from the date of PPTA membership registration (default active member status)
- ii. Attended at least one (1) of the last two (2) conventions
- iii. Participated in the last elections
- iv. Attended at least one (1) of the last two general assemblies
- v. Active member of an existing SIG certified by the SIG Head

Reminders:

1. Incomplete information and requirements will not be processed for validation.
2. Period of submission of candidacy forms and other requirements: Oct 15 - Nov 6.
3. Period to contest list of possible candidates for BOO and BOD: November 7 - 13.
4. Last day of withdrawal of candidacy is November 13.
