It starded with European Coal and Steel Community. From the beginning it


was a union of corporations. The corporations lead, don't they?



After the fall of socialism in Europe, provoked by the errors of Gorbachev and the communist parties the peoples from Eastern Europe were attracted with false promises of freedom and prosperity in European Union. To start with, in the nineties the peoples from Eastern Europe were intoxicated with the **slogan** *"democracy AND free market"*. The errors of the ancient communist parties and the treason of their leaders caused the lack of political forces to oppose to this "AND" – which proved the totalitarian essence of the West, which considered the fall of socialism to be its victory in the cold war. To add insult to injury, when the life level crushed (everywhere in East Europe) they found the guilty ones: the communists and the lazy people.



The proletarian internationalism replaced the was by corporation internationalism. As long as the Eastern countries entered EU, the organization became more and more opague and undemocratic. The Eastern countries were considered subordinated ones, periphery of metropola. The role reserved for the new leaders from East – the so called "political class" was to obey and execute the orders from the imperial center – not only from Troika, but also from USA. In Romania the official wooden language used another illegitimate "AND": the goal of the lackeys pretending to govern the country was to integrate us in "NATO and EU". The accent was not on

democracy, but on free market (meaning capitalism); and not on EU, but on NATO (meaning aggression).

Moreover, EU does not care for democracy. Indeed, not only that it tolerates the persecution of communists in the former socialist countries (Hungary, Poland, Baltic states, Czechia, Slovakia and Romania) but the so called **European Parliament tried** equivalate to the communism (meaning the movement for social and national freedom) with its opposite, the fascism. EU does not care about social

justice: it transformed the private debts of companies into sovereign debts of the countries.

More and more openly, the leaders of EU (meaning troika = European Commission & International Monetary Fund & European Central Bank), make outright propaganda against the concept of welfare state. This tendency must be stopped; the sooner, the better.

The Romanian Socialist Party is against THIS form of EU. We demand the abolition of NATO since this organization has become the main threat to world peace and replacing it with an European defense structure. However, we do think that now the European working class, the European peoples have a historical opportunity to act together for a real EU, a socialist EU. We want a new EU which is not directed against Russia, a EU from Atlantic to Pacific. We want a social EU, a EU of peoples, not of bankers. We want a new EU which will help the countries to develop. In a capitalist logic, the former socialist states will remain forever indebted and underdeveloped: if



the state is forbidden to help its strategic industries and research and it relies on "private investors" (meaning thieves) and on tax collection the underdevelopment is sure. Rather the contrary, the states with small per capita income wages should be encouraged to protect its property, debt canceling included. A first step should be cancelling of all debts of sovereign states to private entities. That will be in the advantage of all Europeans, not only in ours, the poor ones. It will stop the immigration and the demographic decline of East Europe.
